#### The Turtle's Revenge.

In this case, however, it was the object of the proprietor to convince his patrons that the soup he served was not going to be made of mock turtle. .

One of his customers, having nothing better to do, began to tease the turtle, kicking it on the head and otherwise tormenting it. The creature endured for a season, but not through Christian forbearance. as the sequel shows. He was merely. waiting for his chance, and that is possibly the secret of some forbearance labeled Christian on the part of human beings.

Finally the restaurant keeper struck him in the neck with an ice-pick and the situation was relieved.

In the case of the turtle, vengeance overtook the right person and nobody is likely to be particularly sorry for him, even if his victim was a somewhat unattractive member of the animal kingdom.


