BY-LAWS ADOPTED.

Citizens Met Last Monday Night in the Interest of the College.

Last Monday evening the representative citizens of Hereford met at the church and adopted the following constitution and by-laws compiled by Messrs. Ferguing Gough, Lipscomb and Witherspo

CONSTITUTION

1. This association shall be known

2. The office said association shall be at Hereford, Texas.

3. The object of the association shall be to build, equip, and maintain an institution of learning of high order at Hereford, Texas, and to operate the means of this association solely in the interest of said object.

4. All contributions of lands, moneys, stocks or other property of whatsover kind shall be controlled by the Directors and used solely in the interest of said Institution.

5. The Directors of this association shall take title to all property donated or otherwise coming into this association in its name, and sell and convey same in the name of said association, to be signed by its President and attested by its Secretary.

6. It shall be the duty of the Directors of this association to raise means, equip and maintain a school at Hereford, Texas, of high order, to execute leases of its property for educational purposes and to generally superintend said school interests without compensation to themselves.

7. Said school shall be unsectarian and undenominational in its character.

8. No church denomination shall be allowed more than two directors on the Board of Directors at any

9. It shall be the duty of the Directors of this association to make an annual report at its regular annual meetings of all its operations for the past year.

10. The officers of this association shall have such powers as are usually exercised by similar officers.

11. The Treasurer shall make a full and complete statement of all moneys received and disbursed by him during each year, to the Directors at their annual meeting and at such other times as the Directors may demand.

12. The Treasurer may be allowed such sums for his services, as the Directors may allow to be paid out of the funds of this association.

13. The Treasurer shall not pay out any moneys for any purpose except on bills duly approved by the ent and attested by the Secre-

The Treasurer shall give and for the safety of the fundsas The Hereford School Association. Lector shall deem necessary.

15. The buildings of this association shall not be commenced until the sum of \$5000.00 in money, lands and other cash assets shall be in the hands of the Directors subject to such enterprise.

16. Five Directors shall censtitute a quorum for the transaction of business.

17. Any offizen of Deaf Smith county may be elegible as a director in this association.

18. This constitution and by-laws may be amended at any time by a two-thirds vote of the citizens by giving 30 days notice by filing with the Secretary a written statement of such proposed amendment.




