Proposed Amendment to the Constitution, to be Submitted to Vote of the People on Tuesday November 4, 1902.

(S. J. R. No. 3.) JOINT RESOLUTION.

Amending Article 6, Section 2, of the Constitution of the State of Texas requiring all persons subject to a poll tax to have paid a poll tax and to hold a receipt for same before they offer to vote at any election in this State, and fixing the time of payment of said tax.

Be it Resolved by the Legislature of the State of Texas:

Section 1. That Article 6, Section 2 of the Constitution of the State of Texas be amended so as to hercafter read as follows: Sec. 2. Every male person subject to none of the foregoing disqualifications, who shall have attained the age of twenty-one years and who shall be a citizen of the United States, and who shall have resided in this State one year next preceding an election and the last six months within the district or county in which he offers to vote, shall be deemed a qualified elector and every male person of foreign birth subject to none of the foregoing disqualifications who not iess than six months before any election at which he offers to vote, Shall have declared his intention to become a citizen of the United States in accordance with the Federal Naturalization Laws, and shall have resided in this State one year next preceding such election and the last six months in the county in which he offers to vote, shall also be deemed a qualified elector; and all electors shall vote in the election precinct of their residence provided, that electors living in any unorganized county may vote at any election precinct in the county to which such county is attached for judicial purposes; and provided further, that any voter who is subject to pay a poll tax under the laws of the State of Texas shall have paid said tax before he offers to vote at any election in this State and hold a receipt showing his poll tax paid before the first day of February next preceding such election. Or if said voter shall have lost or misplaced said tax receipt, he shall be entitled to vote upon making affidavit before any officer authorized to administer oaths that such tax receipt has been lost. Such affidavit shall be made in writing and left with the judge of the election, and this provision of the Constitu-tion shall be self-enacting without the necessity or further legislation.

Sec. 3. The Governor of this State is hereby directed to issue the necessary proglamation submitting this amendment to the qualified voters of Fexas at the next general

election.



Such would be the case, and we say "let her come."

ARE your premises in a sanitary condition? If not, you should clean them up at once. The growth and health of our city demands it.

PROSPECTORS are getting more numerous in Hereford. Should all buy land they would have to be content with their pro rata, which would be about 320 acres.

A PORTION of the county was again blessed with the moisture from the heavens on Sunday. There was not enough fell in Hereford, however, to settle the dust.

We have heard many discussions of late in regard to incorporation and we honestly believe that were an election to be held the town would go for incorporation by a large majority. Senator Tom Platt' is credited with dubbing the president, "His Strenucsity."

Protection is not justice, equity or even fair play; it is favoritism, pure and simple, and who gets it? The rich man, invariably.

Republican leaders are talking of a war cry for the election of 1904 to be "Roosevelt, Revision and Reciprocity." They seem to have forgotten what the three R's did for them on a previous occasion.

A reliable Kansas newspaper says, "there are two strong republican towns in Kansas in which a negro is not allowed to live. One is Norton-ville and the other is Baileyville, the home of W. J. Bailey, the republican candidate for governor."

President Ro sevelt is said to be popular in California; this, too, in spite of the fact that that state is the largest beet sugar producing state in the union, and that the carrying out of the president's pet measure—reciprocity—means an injury to their business. The next two years will show whether this popularity will increase or diminish.

Major W. S. Miller, inspector general of Pennsylvania militia, says there are between 8,000 and 10,000 anarchists in the Shenaudoah coal region, that "it is a veritable hell-hole," and "the most God-forsaken country I have ever seen," which causes one of his critics to reply: "There is ground for more than a suspicion that they are there because they were recruited by agents of the coal barons and imported in violation of our contract labor laws."

A prominent democratic editor, after conceeding the versatility of Senator Mark Hanna, is disgusted with his attempts to manage both the trusts and the labor organizations, and says: "The Cleveland workingmen who applaud Hanna are a disgrace to American citizenship."

A fight between three multi-millionaires and Attorney General Knox, at a leading hotel in Atlantic City, N. J., ending in a draw in which no blood was spilt and no bones broken, is a pointer showing what the legal fight between the Attorney General, and the trusts will amount to—"Much ado about nothing."

Another trust has been formed, with a capital of \$5,090,000, to boom "stogies" and cheroots in the foreign markets. It is to be known as the United States Cigar company. The cutput of the factories controlled by the combine last year was 300,000, 000 stogies, and they hope to very largely increase their sales abroad by combining.

Congressman Babcock, chairman of the republican congressional committee and member of congress from Wisconsin, is getting more notice from the newspapers than any other man connected with the present congress. His shift on protected trusts has caused him to be dubbed the "zig-zag revisionist," a term he is

said to abhor. It is further said he began life as a "lumber-jack" and is now a millionaire. He has just purchased the residence of the late Senator John J. Ingalis, near the capitol in Washington.

Senator Platt of New York is quoted as saying he does not know what the attitude of the republican party will be on the trust question in the coming campaign; but some scheme must be devised by which the voters may be made to believe that the party is opposed to trusts, however, he is against any action that will cut off campaign funds.

Secretary Shaw, of the treasury department, said in his Manchester (Vt.) speech; "The republican party never attempts to defend a tariff schedule, but does defend the protective principle." He might as well have said that a fort does not surrender when one of its guns is dismantled, but by the time they are all knocked "gally-west" it is time to surrender.

Senator Stewart says that he and the state of Nevada are now safely in the ranks of the republican party, hence the chances of their making any capital out of the free-silver idea are no longer considered good by them. Senator Stewart is believed to have been in the silver movement because he thought the west would

favor it and he wanted to be on the victorious side, without regard to any principle involved.

Probably the most effective way to bring out hidden values would be to publish the assessment rendered by every tax-payer in the county. Publicity is a discourager of fraud. When a man who is known to possess wealth of a hundred thousand dollars is moved to swear to the assessor that it is not worth more than five or six thousand, he will consider the effects of having such a statement printed in the columns of his home paper, knowing that it

will be read and commented upon by his neighbors.
