Death of Addison Clark Jr.

The sad news of the death of Addison Clark Jr., which occured on the 5th inst. at Weatherford Texas, has just reached us.

Prof. Randolph Clark, uncle of deceased, furnishes us the following bit of his history:

A. Clark Jr. was born Nov. 1872, at Ft. Worth, Texas. He started life's race not well equipped physically. With unusually bright intellect and an eagerness for study neglected the physical dicipline. At the age of 17 years he graduated from Add-Ran University taking the A. B. degree, in a course that required the ordinarily strong students two more years to complete.

In 1895 he graduated from the University of Michigan taking the degree of A. B. and the same year receiving the A. M. degree. He gave himself no rest. After graduating from Add-Ran University he taught until he entered Ann Arbor. Returning from Michigan University he again entered the school room as teacher. In 1900 and 1901 he filled the chair of Professor of English in Add-Ran University at Waco. During these years he has given himself unstintingly to literary work and won an enviable reputation among the leading journals and magazines as a writer of great merit, considering his age. After a determined fight against disease he died at Weatherford, Texas, July 5, 1903.

In the later part of the winter THE BRAND learned that owing to the delicate health of the subject of the above sketch that he would probably leave. Waco where he was engaged in a successful paper enterprise and so THE BRAND negotiated with him and secured him as editor of THE BRAND. But the ravages of disease were not stayed and to our regret we were compelled to give him up. Young Mr. Clark won a warm place in the hearts of printer boys as well as the manager of THE BRAND and was esteemed by all with whom he came in contact during his brief stay in our little city, and THE BRAND joins the bereft family in this a common sorrow.

Gone to Childress.

Prof. Walter E. Rush, who for the past few years has been identified with Hereford's musical circles, as an instructor of piano and leader of the Hereford Concert Band, left Wednesday for his future home at Childress. During his residency at Hereford he has made many warm friends, including The Brand, and leaves a large class of pupils who exceedingly regret his departure, and who wish for him the great success his talents merit in his new home.

Death of F. C. Malone.


W. S. Higgins,

HEREFORD CONDITIONS.

Practically All the Two Year Old Steers Offered for Sale on the Open Market Have found Purchasers at fair Prices.

H. C. Beall has returned from a business trip to Hereford, where he went about ten days ago to look after a herd of 1200 head of two-yearold steers being held on the open market there by local parties. He reports fine rains over all the country intervening between this city and that point, with the finest promise of good summer grass that the country has ever seen. Cattle that were in thin condition only a few weeks ago are now taking on flesh rapidly, and in two weeks more their owners will hardly be able to recognize them. Mr. Beal says that the Hereford market has been practically suspended for the last two weeks on account of the inability of shippers to get their stuff handled by the railways. With the abatement of Eastern flood conditions and the resumption of business by the railroads, there has been a corresponding improvement in conditions at Hereford and the Northwestern buyers are again buying steers. As a matter of fact, he says that all the steers centered at Hereford have now been sold with the possible exception of two or three small herds, and the buyers are after them. He thinks that the next few days will wipe out the last remnant of the large number offered on the local market, and while the prices have not been altogether satisfactory, the steers have been sold and moved out of the country.-Colorado StockTO ENCOURAGE
