BUSINESS MEN


Of Kansas City Visit Their Patrons in Hereford.



MINIATURE CYCLONE

Struck the Ranch House Formerly Owned by Charley Meyers.

Wednesday evening's During storm a small funnel shaped cloud appeared to be rapidly moving in a northeasterly direction. But little attention was paid to it as a cyclone in this section of the country has never been before known of. At about 6:30 p. m., however, Vance Witherspoon came riding into town on a dead run, and reported that the ranch house formerly owned by Charley Meyers, situated about seven miles southwest from town and occupied by C. C. Wilson, a brotherin-law of Mr. Meyers, and family, had been struck by the storm, which destroyed the house and seriously injured the occupants thereof. Drs. C. P. Estes and R. H. Gough went immediately to the scene of the disaster and remained all night, returning about 10 o'clock the following morning. THE BRAND representatative interviewed these gentlemen concerning the disaster and elicited the following facts:

The storm struck the house, containing four rooms, at about 6 o'clock p. m., utterly demolishing the two front rooms, which was built several years ago and moved from Tulia, and turned the rear part half around.

The family, consisting of Mr. and Mrs. Wilson and four children, the youngest of whom was a 17-daysold babe, were in the front part of the house when the wind struck the house the babe was instantly killed and the mother rendered unconscious from internal injuries and from which she died at 8 o'clock the following morning. Mr. Wilson's back and hips were seriously injured, the right hip being broken, but the doctors think he will fully recover in time. Two of the children, a boy about 9 years old, and a girl, were injured, but not seriously, while the fourth child, a little boy, escaped without an injury. As soon as he could extricate himself from the debris the oldest boy, notwithstanding his injuries, mounted a horse and rode to a neighboring ranch and apprised the occupants of the disaster, whereupon Mr. Witherspoon was at once dispatched to Hereford for the above naned doctors, who at once responded and did what they could to relieve the sufferings of the stricken family.

M. E. Conference.

The M. E. Conference of the Clarendon district convened yesterday and will continue their sessions until Sunday evening. 

TAKES US TO TASK.

We have received a lengthy communication from C. G. Witherspoon taking us to task for our editorial in last week's issue concerning the proposed annulment of the incorporation. Were it an argument in favor of the amendment we would gladly publish it, but as it is but a censure on us for our stand in the matter, we do not give it space as we do not desire to engage in any personalities in this matter, and it was certainly far from our purpose to censure anyone for their connection in the movement for annulment. However, the Judge seems to think that he alone was receiving blame for being on the anti side, though we fail to see wherein he was blamed in the matter. We certainly are fair-minded enough to give everyone a right to have their own opinion on any matter (even though we had the power to prevent it) and we demand the same God-given right for ourselves. However, we publish the following excerpt from the communication, as many seem to be of an adverse opinion in regard to the matter:

Now I wish to say in this public way what I have often stated privately that the "wealthy foreign corporation" which I represent has never intimated in any manner whatever their desires in this matter; in fact if they know anything whatever about the attempted incorporation, or about this movement to annul that attempt they got it from some other source than from me. I have no idea whatever that they know a thing in the world about it. And if its managers did know they are too high toned christian gentleman to try to influence me or control my vote in the matter.

The Judge also charges that those in favor of incorporation are laying all arguments aside and resorting to abuse of those in favor of the annulment. That may be true, but we have not heard of a single case of abuse on the part of the corporationists, or the other side, for that matter, and certainly The Brand does not countenance such acts of discourtesy. Furthermore, we will state that the columns of The Brand are open to either side to present their arguments for or against incorporation.

Some people are hard to please. A few object to the occupation taxes imposed by the City Council as being too high, while others—notably the draymen—requested that they be raised still higher.

"HEREFORD needs incorporation more than does any other town in the Panhandle," said one of her prominent citizens to a BRAND reporter the other day. "She has outgrown the wide-place-in-the-road point and should have a legal status among the cities of the state. Already the incorporation movement has had excellent effects in the abolishment of the hogs running at large—certainly a most disgusting sight. After having had incorporation but a few weeks, to so quickly vote it off would be to show to the world that we are a lot of school boys, who do not know one minute what they want the next, besides demoralizing our chances for obtaining the Baptist college and the attendant influx of well-to-do immigrants. By all means let the incorporation remain in force-at least until it has had a chance to further show its benefits."

THE BRAND has been accused of favoring the corporation from mercenary reasons. We plead guilty. We have invested our all in the city of Hereford and we do not propose to have our up-to-date plant depreciate in value, because of a lack of business, if we can help it. However, we have received all we can hope to receive as far as the city printing is concerned, and if that were all we were looking for to keep our plant busy we would surely be on the side of the antis, as we feel sure that if the antis carry their point there would be another corporation election soon, which would carry, and we would have another opportunity to print the ordinances, and aside from these there is but little printing to be done for the city. But it is for the increased subscriptions, advertising and job work, which we believe we will lose if the antis have their way, that bothers us from our mercenary standpoint.

CITIZENS of Hereford, you are now placed in a position whereby you can give Hereford, the Pride of the Plains and here the most of you have invested your all, a further boost into prominence as a progressive city and thereby enhance the value of your holdings, or you can relegate the city into oblivionmake it but a wide place in the road, as it were. A vote to made permanent the incorporation will accomplish the first proposition. A vote to abolish the incorporation will, we believe accomplish the latter. Which proposition do you favor? We hope you will choose the former.

Solie of the antis make the statement that the City Council had passed too many unnecessary laws for the governing of the city, but when asked to cite one they cannot do it. The fact that the penal code was included in the ordinances seems to be the principal bone of contention, yet they seem to fail to realize that unless this were included every violator of the code would have to be tried in the county court. In order to bring possible offenders into the jurisdiction of the City Court it was necessary that they be included and published with the ordinances. One by one their arguments fall by the wayside.

THE West Texas Stockman says that Hereford is glutted with one and two-year-old steers on the market for sale to northern buyers and that as a consequence these latter are much pleased as they will be able to get these cattle at their own figures. We do not know where the Stockman obtained its informa-



tion, but we do know that at the present time there is but two herds of ones and twos in Hereford which are on the the open market. If two herds of cattle will be considered as such we surely have an overloaded market and would advise northern buyers to come here quick and get them at their own price-providing their price corresponds to that wanted by the owners of the herds.

THE BRAND favors incorporation because we are ever on the side of progress; because we have pride in the city of our adoption, and regret to see its growth retarded; because we wish to see her citizens and business men prosperous (if the latter are not prosperous there is but little show for a newspaper to be prosperous); because we have pride enough in our city to wish to see it kept free from dens of vice; because we wish to see it kept clean from a sanitary standpoint, and thereby keep her citizens in a healthy condition (and we haven't got "it in" for the doctors either); because we honestly believe that our city is too large to be placed in the wide-placein-the-road class and should have a legal status.

ONE of the arguments used by the anti-incorporationists is that the officers at once commenced to arrest people for violating a state law-

that of jumping on and off from moving trains. To those who have been influenced by this argument we would say that these arrests were made wholly at the instigation of the county attorney, upon complaint of no less a personage than one of the railroad officials, who nearly missed his train as a result of this foolish and dangerous practice, on the part of some of our young men, who had crowded the platforms of the cars so that it was almost impossible for this official to board the train.

It is stated that one of the reasons why the antis want to abolish the incorporation is because the City Council did not award the city printing to the "lowest responsible bidder." THE BRAND man asked one of the members of this honorable body if this was true or not, and he replied most emphatically that the City Council "did award the city printing to the lowest RESPONSIBLE bidder." Another argument gone. We will state for the benefit of those who do not understand the proposition of awarding the city printing that THE BRAND'S was the only bid which guaranteed to the Council that the said ordinances would be published in its current issue and that was the proposition (as we understood it) on which the bidding was to be made.

San Angelo's Trouble.

San Angelo is having a trouble similar to that of Hereford. That city recently incorporated but petty jealousies, it seems, have arisen, and it seems to be another case of rule or ruin. Here is what a neighborhood exchange says of the matter, and its sentiments applies equally as well to Hereford:

"Well, it looks as if San Angelo is to throw off her city clothes and become a town again. Pity! We have always felt an interest in the Queen of the Conchos, and were sure she would grow in grace and beauty in her new toga. The trouble, it seems, grew out of the awarding of the city printing. Some of the best citizens there are packing clubs for the "corporato infantum;" but it might be well for people to consider carefully before taking a step that will materially effect the progress of San Angelo. -Ozona Southwest Texan."

The city officers of San Angelo, it seems, have been critised for their official acts and these officers prepared and signed a statement, which was published in the San Angelo Standard, a part of which we publish:

"J. C. Landon, M. C. Ragsdale, Dr. Mays, U. G. Taylor, J. S. Shupert, Jno. Abe March and others were solicited by their friends to be candidates for the council, and had they consented none of us would have been candidates.

There are many reasons why this town should be incorporated. These reasons, however, we will not argue, but as some of the parties mentioned above have seen fit to criticise our actions and impugn our motives in the conduct of the government, we make this proposition:

If a sufficient number of these gentlemen above mentioned to fill the offices of mayor and council will announce themselves as willing to do so, we will all resign and give them our heartiest support. This we believe would be far better than repudiating our debts and advertising to the world that San Angelo has not citizens of sufficient honor and ability to run a city government. Otherwise, we shall stand or fall with San Angelo as her citizens may think proper to vote."

The same status of affairs exist in Hereford, and we believe that Hereford's city officers would gladly resign in favor of their criticisers if they would consent to accept the offices and conduct the affairs of the city. The middle sentence of the last paragraph in the above clipping should be pondered over well by the voters of Hereford, as it applies to Hereford as well as to San Angelo.

A number of northern buyers are in the city, but not as many as have been here at this time in former years, perhaps on account of the unusually cold spring. They are commencing to arrive, however, and it will not be long before our hotels will be full to overflowing.

W. P. Anderson, the well known newspaper correspondent for various livestock papers throughout the United States, was a pleasant caller at this office on Tuesday.

Hereford citizens should commence now to figure on a proposition to provide water for herds of cattle which are driven to this point for shipment each year. It has been proposed that a dam be erected on the Frio, which, with the spring freshets, would provide a sufficient supply of water to accommodate all cattle coming here. Ordinarily the surface lakes have provided this, but so far we have not had a sufficient amount of rain to fill these lakes, though having had plenty for crop raising purposes. It has been estimated that a rock dam on the Frio for this purpose would cost not to exceed \$300, and we believe that this amount invested would bring large returns to our business men, through the increased number of herds which would be shipped from this point. Think it over.

Military Academy.

A dispatch in the Dallas News of Monday says:

Arrangements are about completed with Prof. Maury of Gainesville for the establishment of a military academy at Amarillo. Arrangements have been made for a site for the school, and there seems to be no doubt that the required number of students will be gaaranteed. Buildings costing not less than \$5,000 will be erected.
