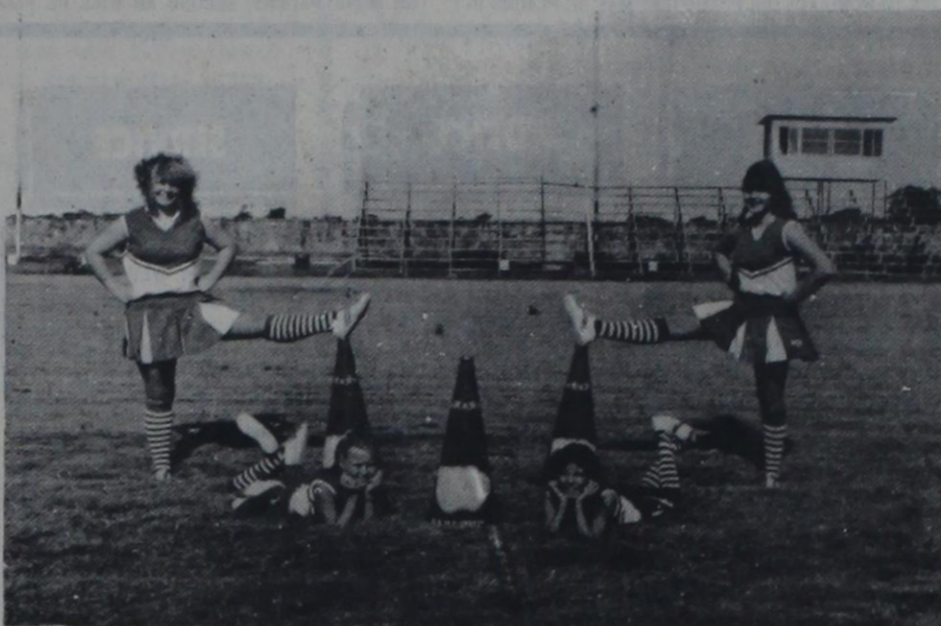
Wildfire Season Is Here

Wildfires often erupt this time of the year due to lightning and careless use of fire. Prevention is the best cure for wildfires, so people who work outdoors and sportsmen should use extreme caution with fire of any kind. County governments should have updated fire fighting plans and should maintain their equipment their equipment in good order. Burned areas should be managed properly and should be seeded with grass if possible to insure a ground cover.

Jury Selection Underway In LeFlore Trial

Testimony isn't expected to begin in the capital murder trial of Charles LeFlore in 91st District Court until late in the week - if then.

The trial got underway Monday when some 400 citizens were called as prospective jurors, and that number was whittled down to 118 (through excuses, sickness and/or other causes), and Presiding Judge Jim Wright ordered the remainder to be grouped into 25s to report on succeeding days for questioning.

Each prospective juror

was being interviewed individually and separate from the other prospective jurors, so it's likely to take a long time to seat a jury.

LeFlore, 20, a Cisco oil field worker, was first indicted in January for the shooting death of convenience store worker Debra Garcia. The woman disappeared Nov. 29 from Quickway Grocery, where she worked, and her body was found in a roadside ditch two days later.

The 91st District Court Grand Jury later re-indicted LeFlore on capital murder charges, for which he is being

tried. The re-indictment was seen as an attempt to have LeFlore's statement admitted as evidence. It had been earlier been refused as evidence by Judge Wright, and he ruled a second time that it could not be entered because of defense testimony given regarding the taking of the statement, at the first motion to consider the statement.

Don L. Wilson is defense attorney and prosecutors are District Attorney Emory Walton and Eastland Attorney Bill B. Hart, who has been named a special prosecutor in the case.

Capital murder carries a maximum penalty of death by injection, while life in prison is the maximum punishment for a murder

Farmer Input Needed For '83 Cotton Program

Cotton farmers have a chance to guide their own destiny by offering suggestions for the 1983 Upland Cotton Program.

Farmer input is needed by Sept. 14 so that the U.S. Department of Agriculture can announce program plans for the coming year around Nov. 1.

"A number of major decisions will be made regarding next year's cotton program, so comments from farmers are vital," said Dr. Carl Anderson, economist in cotton marketing with the Texas Agricultural Extension Service, Texas A&M University System. "A major issue is acreage set-aside."

Farmer input is needed on the following: mandatory or voluntary acreage reduction, paid land diversion, base loan rate for Strict Low Middling 1-1/16-inch

cotton with a 3.5 to 4.9 mike, 1983 target price and the loan rate for seed cotton. Comments should go to Director, Analysis Division, USDA-ASCS, Room 4741-S, P.O. Box 2415, Washington, D.C. 20013.

Anderson noted that the financial implications of a set-aside program are far reaching. "Producing less may well mean that farmers will make more money," he said. "Base cotton acreage would have to be reduced in the range of 25 percent or more to be effective in reducing surplus stocks."

Adverse weather has severely reduced cotton acreage this year so that the crop could be below use levels. That, said Anderson, could reduce carryover stocks and cause the USDA to decide against an acreage set-aside program, which would be a mistake.

Oil and Gas Report



The No. A5 Jim Choate was finished by M.H.W. Inc. of Dallas.

It is a developmental well in the Eastland County Regular Field, 12 miles northwest of Cisco. Drillsite is in a 520-acre lease in Eastland County's SPRR Survey.

Daily potential of 154,000 CF of gas was posted with the Railroad Commission. Absolute open flow was estimated at 210,000 CFPD. The well went to a 3,820-ft. bottom and production will be from perforations 3,599 to 3,603 feet into the wellbore.

Sentinel Petroleum Corp. of Hurst has filed first production figures on a new oil well in the Eastland County Regular Field. The No. 1 E.R. Brown-Funk showed potential to make 15 barrels of oil per day on a 30/64 choke. Tubing pressure came in a 25 PSI.

Pumping 162 barrels of oil per day, along with 220,000 CFD casinghead gas, the No. 2 Pratt was completed successfully in the Stephens County Regular Field by Eldorado Oil & Gas Inc. of Dallas. Drillsite is seven miles northwest of Crystal Falls.

It was drilled to 4,608-ft. total depth and will produce from an interval 3,654 to 3,664 feet into the wellbore.

The location is in a 160-acre lease in the Stephens County's TE&L Survey, A-489.

Petroleum Corp. of Texas, Breckenridge, has filed for permit to drill the No. 13 Curry "B", a 3,300-ft. developmental well five miles southwest of Breckenridge. Location is in a 200-acre lease in Stephens County's LAL Survey. The Curry well is in the Stephens County Regular Field.

At a location 12 miles north of Breckenridge, Ball Production Company of Eastland has finished a new oil producer in Stephens County as a wildcat.

The location is in a 362-acre lease in the Ben J. McGahan Survey, A-106. Bottomed at 4,725 feet, the well will produce from perforations 4,587 to 4,626 feet into the hole.

Bruner Oil and Gas Inc. of Grand Prairie has filed first production figures on a new oil wildcat. The No. 1 J. Trust Buckler showed potential to make 48 barrels of oil per day. Tubing pressure came in at 100 PSI.

The operator has 400 acres leased, with drillsite in Stephens County's TE&L Survey, A-608, eight miles northeast of Breckenridge.

The well will produce from an interval 3,248 to 3,450 feet into the wellbore. Total drilling depth was 4,320 feet.

Flowing 87 barrels of oil per day, along with 108,000 CFD casinghead gas, the No. 1 Ball 1255 was completed successfully in the Reid-McClennon Field by Ball Producing Company of Eastland.

Drillsite is five miles northwest of Breckenridge.

Parker was being held on a July 8 driving while intoxicated charge when he escaped from the Eastland County Jail July 27. He was apprehended about two hours later.

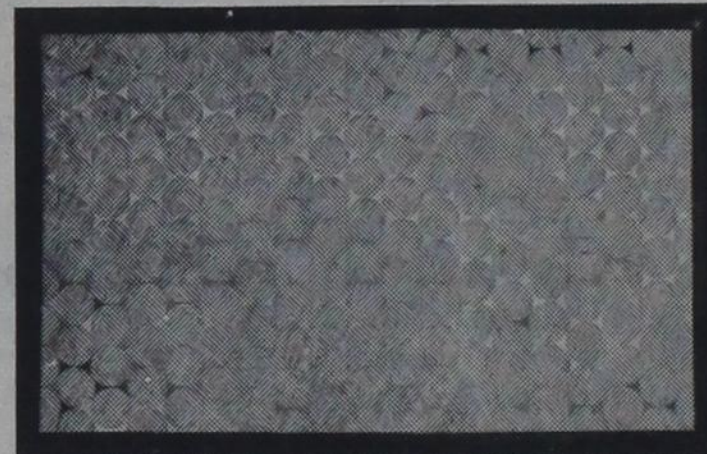
Jim Farrar was Parker's court appointed attorney. District Attorney Emory Walton prosecuted the case.

The Secret of God's Work Is To STAND: Jehoshaphat said, "If, when evil cometh upon us, as the sword, judgement, or pestilence, or famine, we stand before this house, and in thy presence, (for thy name is in this house) and cry unto thee in our affliction, then thou wilt hear and help." Jehoshaphat resorted to the highest authority known to man, and that is the Word of God, What he is saying is, "Lord, the petition that I am about to make is not based on folklore, mythology, the pagan religions of our neighbors, superstition, witchcraft or any form of demon power, but I stand here upon your Word for you have declared yourself to be the god of Israel!" He stood upon the Word! You cannot make a wishful request if you are standing upon the Word of God.

We only deal in wishful thinking in our prayer life when we are not actually sure of what we really want. If you really want your prayers answered, then make it a positive request based upon the Word of God. You may say, isn't that a contradiction? Why would anyone say prayers if

they really didn't want their prayers answered? Simply because they are going through a form of fulfilling a self-imposed spiritual obligation. "Lord, deliver me from these cigarettes!" How many times that prayer has been prayed from an insincere heart that really doesn't want to give up cigarettes.

Record the difference in the tone of their prayer from the time that they are just paying lip service to the habit, until the time they pray when they return from the doctor, and he has just told them that they have cancer of the lungs, and there is nothing that they can do for them. Now we hear a prayer from the depths of their being. Now they begin to search out the Word of God to really stand upon. We have often heard the phrase, "God answers prayer." It would be more correctly stated that "God answers fervent prayer, God answers prayer that is based upon His word." Take the example in the book of Acts.

The Apostles are all gathered together praying that Peter shall be delivered from prison. A knock comes at the door, "Who is there?" It's me, Peter, let me in." They had a hard time accepting the fact that their prayers were answered. The most powerful words in the Scriptures are, "Thus saith the Lord." Here is the stamp of divine intervention and when we are standing upon the Word of God and we are claiming the promises that it contains, we are saying, "Thus saith the Lord."

The C.O. Youngs Attend Leo Reunion

Leo, Texas, a small town in the Southwest corner of Cooke County, was the location of the first Leo school reunion held June 27, 1982, hosted by descendants of two of the first settlers in that area, O.A. Cogburn and a Mr. Puckett, who settled here in the 1860's.

Leo was given its name by Dr. Stamper, of Era, a small town nearby, who said, "The name Leo refers to the lion, an animal of great strength," and he thought it applied to Leo because it is rather a tough place.

Leo is one of the youngest towns in Cooke County and was recognized as such in 1894, but the Leo section in the Southwestern corner of the county was settled prior to the Civil War.

Sunday, June 27, 1982, between three hundred and four hundred people gathered in this unique community for the first school reunion. Among those attending was C.O. Young of May, who went to the Leo school 64 years ago.

Young's sister, Lucy Young, of Colton California, attended the reunion with her brother. She went her first year to school at Leo, in 1922, and was in the "Baby Ray Primer" class; her

parents paid that she might get to go at six years. She recalls her teacher's name was Miss Ninnie, now deceased.

The reunion was held in the Ross Point Community Center near Leo town. Young had not seen many of his friends and school mates in 64 years but they recognized each other on sight; a few had to be introduced before they recalled their names. Everyone had a great time, recalling old times, their baseball games and team as winner in the District, also some fights that some had taken part in, talk, laughter and feasting on the best and most food they had ever seen at one place served to any group was the report.

Lucy Young was happy to meet Inez (Puckett) Barnett, who was a member of her mother's (Mrs. W.O. Young) Sunday School class at the Dixon Creek Baptist Church in 1922, where the Young family attended church.

The Dixon Creek Church was moved to Leo in 1918. Live Oak and Dixon Creek schools consolidated and a building was built in Leo, creating the Leo Consolidated School District, with a

two-teacher school. The first teachers were Miss Willie Sauder and Ester Thompson.

Robert Heilman owned and operated the first community store in Leo, and Tom McBride was the first postmaster. Dr. Petty was the only doctor to ever live in Leo town. Thirty-five was the average number of residents ever to live in this tiny town.

Many farm families lived in the surrounding area' everyone seemed to be everybody's friend and all co-operated and helped each other when help was needed by anyone. The church and school were strong bonds in the area in the early days. Cotton farming was the main crop in these early days until the boll weavils invaded and farmers switched to corn and wheat, cattle and a few hogs.

Gainsville, county seat of Cooke County, and Decatur were where most of the farmers did most of their shopping for clothing and farm equipment. Wheat and corn were taken to the mill to be ground for flour and meal.

Leo had one cotton gin, owned by Mount Dillon and Will Campbell. The gin burned in 1908 and was never rebuilt.

William Oscar Young, father of C.O. and Lucy Young, was born in Little Rock, Arkansas, 1876. At the age of twenty-one he left Batesville, Arkansas, enroute to Texas to join his parents, Mr. and Mrs. Sam Houston Young, who had moved a few years earlier to Wise County that joins Cooke County.

Before leaving Batesville, William Oscar had lived and worked for an aunt, Alice Durfee, who gave

him a horse and saddle to make the trip to Texas. He did a lot of night traveling to avoid the outlaws and Indians. A friendly group met up with him one evening and insisted he spend the night in their camp; being lonely he accepted. When he woke up the next morning these friendly outlaws were gone and so was his horse, saddle and food supplies his aunt had furnished for the trip, making it necessary for him to finish his trip on foot, which took several weeks. Alone and frightened, he was more cautious; the rest of the journey was very hard physically and financially.

In 1902, William Oscar met Pertina Sarah Stout, and married the same year. They were the parents of six children, Charles Oscar, Willard Lee, Elvert Earl, Aubry Edward, Christina and Mary Lucy. All of them attended the Leo School.

Paul Hobby will campaign in Eastland Wednesday

Strake Talk

FREE EDUCATION AND THE UNDOCUMENTED WORKER

On June 15, 1982, The Supreme Court ruled, 5-4, that Texas and other states must provide free public education for the children of undocumented workers—people in this country illegally.

Our current Lt. Governor, Mr. Hobby, was happy with the decision, praising it as the "only rational decision" the court could have made.

On the contrary, I think it was a wrong decision that defied both law and logic.

One of the principal underpinnings of an orderly society is that one should not benefit from breaking the law. All around the world, thousands of people stand patiently in line at our embassies, waiting for legal entry into this country. By its recent ruling, the Supreme Court told these people that, if they are smart, they will ignore our immigration laws, find some other way to enter, and then there's a good likelihood all manner of taxpayer-supported benefits

will be open to them and their families.

We can all feel sympathy for people driven to emigrate by desperate economic conditions. And I believe we should be compassionate toward the children of undocumented workers who are here through no fault of their own. We have been told we must educate these children and we will: it is our duty.

But I am deeply concerned about the effect this will have on our school systems and the quality of education. We have only a certain amount of desks and dollars with which to address the problems of educating Texas' children.

The court was essentially establishing social policy under the guise of ruling on a constitutional question. The result was bad law and bad social policy. It should now be up to the Federal Government to help pay for the mess they have created by not properly policing our borders.

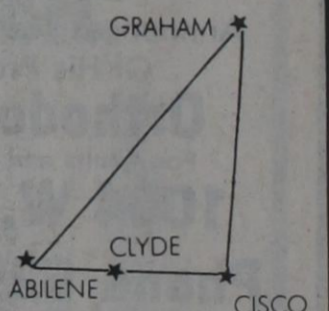
