#### EASTLAND COUNTY MHMR WORK CENTER AT THE CROSSROADS

Did you know that Central Texas MHMR Center has a work activity center for mentally retarded adults in Eastland County? This center is located at 306 W. Plummer in Eastland and currently serves clients from Cisco, Eastland and Ranger. The center is open five days per week, excluding holidays, and the program is arranged to provide work orientation training in order for the clients to become productive citizens in the community. The clients live at home and are taken to and from the center in a Van.

Presently the center has two programs to enable the clients to earn wages. The primary activity is the assembly of small plumbing parts. For this work each client is paid on a piece rate based on the current minimum wage. The other activity is the collection of aluminum products for recycling. The profits from this endeavor are used for the center.


Since its inception, the Eastland Center has been fully funded by the Central Texas Mental Health Mental Retardation Center located in Brownwood. In recent months the Brownwood Center has experienced some budget restraints like all State and Federally funded programs. The direct effect of these budget reductions is that funds from Central Texas MHMR Center are adequate to support the Eastland County Workshop for only half-time for the fiscal year beginning 1 September 1981. Eastland County needs the workshop on a full time basis not halftime. Therefore the following programs are an-


Kay Sockel will be guest speaker for the PTO on September 28, 1981 at 7:00 p.m. in the School Cafeteria.

College Station--Financial concerns of dual-earner

McCormack, on the home economics staff of the Texas A & M University System says daul-income households are here to stay-with numerous financial effects and problems.

One immediate effect is that dual-earner families have incomes 30-40 percent higher than one-earner families.

**Dual-earner families** also have more expenses than oneincome families. Many expenses are workrelated, including meals away from

transportation, recreation, personal grooming items, convenience appliances, more services and housing.

Time is limited for dual-earner families due to competing demands from jobs and family, so these families buy many goods and services to alleviate these time constraints. Often this



### Senate Passes Amended Peanut Bill

The Senate passed on September 16 a peanut bill for the years 1981-1985 after amending the proposal passed on April 30 by the Senate Agriculture Committee. Adoption of the measure followed one and one-half days of debate on the Senate floor and lengthy deliberation and negotiations between growers and Senate farm leaders, according to Ross Wilson, National Growers Secretary. Senate action on the Bill is only the first step. Conmillion tons. sideration by the House of Representatives will be the next phase of the legislative

A Senate vote occuring early on September 16 on whether to table ditional peanuts in exan amendment offered by Republican Senator Richard Lugar of Indiana that would have abolished acreage allotments and poundage quotas in 1982 served as an early warning of further difficulty, Wilson stated. The Senate voted by a majority of 56 to 43 not to table Senator Lugar's amendment. That vote provided a strong implication that the Senate would vote for Senator Lugar's proposal to completley provision authored by dismantle the peanut

However, prior to the vote on tabling the Lugar Amendment, Georgia Republican Senator Mack Mattingly had offered a substitute to the Lugar Amendment that growers considered much superior to the Lugar Bill, but which was inadequate as written, Wilson said. Although the Mattingly Bill calls for abolishment of acreage allotments, it would maintain poundage quotas at a minimum national level of 1.24

Following negotiations between growers and Senator Mattingly a number of changes were made in the Mattingly Bill to insure that production of ad-

cess of the farm base production or from non quota farms does not enter the domestic edible market until the supply of peanuts from quota farms within the farm base production is exhausted. Another change in the Matting-

ly Bill secured by growers is to call for a mimimum support rate of \$596 per ton quota peanuts to be adjusted annually based on increased production costs. Growers were unable to block a

The Mattingly Bill as modified was passed by the Senate on September 16 by a vote of 51 for and 47 against. The Grower Group said the basic difference in the Lugar and Mattingly proposals is that Lugar would have abolished both allotments and quotas while the Mattingly Bill abolishes allotments, but retains quotas in place for the next four years. He said a prolonged effort by growers over the past 16 months had emphasized the retention of both allotments and quotas and that the same objective will be vigorously pursued in the House of Representatives where Farm

#### **ON THE BALLOT**

Senate Joint Resolution 8 proposes a constitutional amendment that would allow the legislature to authorize cities, towns and other taxing units to grant exemptions from ad valorem taxes on an unproductive, underdevel-oped or blighted area in order to encourage its de-velopment. The amendment would also allow the legislature to authorize a city or town to issue bonds or notes to finance this development and to pledge future increases in ad valorem tax revenues from the property in such areas to repay these bonds or notes.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize cities, towns, and other taxing units to encourage the improvement, development, or redevelopment of certain areas through property tax relief and the issuance of bonds and notes.

#### **PROPOSITION NO. 2 ON THE BALLOT**

House Joint Resolution 117 proposes a constitutional amendment that would authorize a person to receive a patent to land from the Commissioner of the General Land Office under certain conditions. Application for the patent must be made within five years from approval of the amendment. The land must be surveyed, public free school land not pre-viously patentable. The person must have a properly recorded deed to the land, which he acquired without knowledge of the patent defect and which title he and his predecessors in interest have held for at least 50 years. The person and his predecessors in interest must have continuously claimed the land and paid the taxes for at least 50 years.

This amendment does not apply to beach land, submerged land, or islands. An applicant may not use this provision to

#### **PROPOSITION NO. 4 ON THE BALLOT**

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing a political subdivision to provide property tax relief for owners of residence homesteads and changing certain property tax administrative procedures."

#### **PROPOSITION NO. 7 ON THE BALLOT**

House Joint Resolution 4 proposes a constitutionamendment that would al authorize the Veterans' Land Board to issue and sell an additional \$250,-000,000 in bonds increasing the Veterans' Land Fund's total bond issuance authorization from \$700,000,000 to \$950,000,-The amendment would increase the maximum interest payable by the state on these bonds from 6% to 10%, and permit an even higher rate, if specified by the legislature.

The proposed amendment will appear on the ballot as follows: "The constitutional amend-ment authorizing the issuance of additional bonds to finance the veterans' land program and to increase the maximum interest rate allowable on veterans' land fund bonds.'
