The Eastland County Commissioners voted Tuesday to buy an optical scan machine that will make election tabulations easier and faster.

This American Information Service equipment was studied at a called meeting Wednesday of last week. It will cost \$30,750 which will include the cost of training operators.

County Clerk Joann Johnson explained that paper ballots will still be used, but it will take only 27 people to count ballots instead of the 89 now employed during elec-

tions. Mrs. Johnson said she has \$9,700 left in her election budget, and this can be applied toward the AIS equipment. She will also move \$15,000 from the book-binding budget to help pay for the scanner. That will leave around \$7,000 to be paid from other funds.

The Commissioners said that methods for financing the equipment project is to get some of those stories told and preserved, the Judge added.

In other business, the Commissioners heard a report from Insurance Agent Ronnie Ledbetter on the Courthouse insurance.

Ledbetter said the county currently has \$1,045,000 insurance on the building.

"But if the building was totaled it would take \$4 million to replace it," he said.

After a brief discussion the Commissioners voted to increase the insurance on the Courthouse to \$4 million. Premium costs will increase from \$11,049 to about \$14,000 per year. The Commissioners and District Attorney Leslie Vance discussed the County Emergency Services. The County is subsidizing the emergency services by \$15,000 in each of the four Precincts. The money has already been spent and the new fiscal year will not begin

The girls, Angela Leach and Debbie Satterfield, both 15, were reported to have gotten in a car with two unidentified black men at a convenience store in Rising Star. A third girl, who was with them at the time, told officers that she had refused to get in the car.

Rising Star Police Chief Lewey Wyatt reported that the ride was solicited by one of the girls and, he added, the girls have run away often. One of them has run away 17 times. Wyatt said they had been

unable to obtain positive identification of the two men, but said they came from a nearby county.

Stalker Law Sought By Petitioners

A major effort has been launched in this area to petition the state legislature to enact a "stalker law" in Texas. Such laws are now in effect in eleven states and pending in as many more.

Petitions asking enactment of the Texas law will be presented to Rep. John Turner on June 15. All citizens of this area and throughout the state are being urged to sign the petitions.

Presently, petitions are located in Cisco at the Senior Center, Police Station, Dixon Auto Supply, Herman's Garage, Dairy Queen, Ranch Restaurant, Cisco Junior **College President's Office** and Mrs. Louise Nelms.

In Rising Star at the bank; and in Eastland, at Wal-Mart, Police Station, Sheriff's Department, Eastland Telegram and Double Vision Restaurant. A number of petitions are also being circulated throughout the state, having originated in this area.

The Sunday Dallas Morning News had an extensive article of the pros and cons of enactment of such a law.

brutally assulted. To stop staling, 11 states-California, Colorado, Florida, Idaho, Oklahoma, South Dakota, Virginia, West Virginia, Utah, Washington, and Wisconsin-recently have

passed laws making it a crime to repeatedly follow and harass another person. Depending on the state and the circumstances, stalking can result in a misdemeanor charge or a felony charge with a maximum punishment of a \$10,000 fine and five years in prison. Although Texas does not have a stalking law, some point out that laws gov-

erning harassment are already on the books. Others say this isn't enough.


Gail Parr, assistant director for public policy of the non-profit Texas Council on Family Violence, says that the council is considering whether a stalking law is needed in Texas. The Council's **Public Policy Committee** will consider the issue when it meets in August.

"There are lots of laws already on the books in Texas that are not being fully implemented-laws that cover different areas of harassment," Ms. Parr says. Those laws define telephone harassment and terroristic threats as Class B misdemeanors with a maximum punishment of a \$1,500 fine and six months in jail.

STATES WITH STALKING LEGISLATION

Eleven states - California, Colorado, Florida, Idaho, Oklahoma, S. Dakota, Utah, Virginia, W. Virginia, Washington and Wisconsin have passed stalking laws. Stalking typically is defined as repeatedly following or harassing another person.





"We're working real hard in Texas with education programs for law enforcement and the judiciary," Ms. Parr says. "That is not to say that the stalking issue is not going to be one that is going to be proposed in January."

There are some who say it should.

"We get a jillion (stalking cases) every year," says Patsy Day, founder and executive director of Victims Outreach in Dallas. "When it happens, you're just up a creek."

Ms. Day says the legal system is "woefully inadequate" when it comes to preventing stalking.

No one tracks the number of Texans who are stalked or how many have died at the hands of stalkers, but in Dallas County

last year, 1,086 requests for protective orders were filed with the district attorney's office. Victims can obtain the police-enforceable writs by paying a \$16 filing fee and appearing before a court master, who presides over legal procedures that

aren't contested. Some though, feel that

the orders don't do much good. Often, stalkers continue their harassment despite the orders. Another problem is that the protective orders cover only relatives or live-in mates.

If you're being stalked by a stranger, you've got little recourse.

You could obtain a peace bond-those cover nonrelatives-but you must have been hurt or threatened. Being followed isn't enough.

"It (stalking) is not grounds to file a peace bond," says Marie E. Villarreal, a Dallas peace bond clerk.

Jennifer Perkins, supervisor of the Family Violence Crimes Prevention Unit for the Dallas County district attorney's office, says that, though the laws governing protective orders and peace bonds need to be improved and expanded, those who feel that they're not worth the paper they're written on are wrong.

"That's absolutely incorrect," she says. "It may have been accurate three years ago, but it's not accurate now. There's lia-

murder, says Sandy Gaylord, who counsels battered women in Dallas. They simply can't take it anymore.

"The other day, I took one woman's guns away from her. She had two guns in her purse," Ms. Gaylord says. "These people have exhausted every legal avenue to try to get the stalking stopped. You call police, and they say, 'Well, there's nothing we can do.' We get that all the time." Lt. Bill Walsh of the Dallas Police

Department's Youth and **Family Crimes Bureau** says that, in the past, police couldn't do much to help stalking victims. But now they will-and docome to their aid, he says.

"If we know that a woman has left because of violence-and she has a protective order against this guy-then we'll take the appropriate action,' he says. "If they call us to the location, and he's already gone upon (the officers') arrival, we can go and arrest him. The officers don't have to be eye witnesses."

And therein, some say lies another problem.

Jeffery Weiner of Miami, president of the National Association of Criminal Defense Law yers, says he doesn't have a problem with coming down hard on stalkers-but he says the new Florida law is unconstitutional and probably won't stand up in court.

enough provisions to allow adequate protection of both the victim and the accused.

"It's always going to be a question of how it's enforced and practiced," she says. "But I think that the goal of the legislation is primarily positive. I suspect that this is going to be a new trend."

Mr. Winer agrees that stalking laws are the wave of the future.

"I guarantee you," he says. "Within the next couple of years, every state will have a stalking law."

In most cases, laws are proposed only after a stalking victim suffers a brutal death.

That's what happened to Shirley Lowery, a 51 year old county bus driver in Milwaukee. After complaining to police several times about a man who had stalked her for a year and a half, she went on March 9 to the Milwaukee County Courthouse seeking a restraining order. There, in a hallway, the man found her and stabbed her 19 times. She didn't even really know him. She had just had the bad luck one day to pick up the wrong pas-

senger. Virginia recently passed its law because of the 1989 killing of a woman named Regina Butkowski. She was kidnapped, shot and set on fire by a stalker. In

Maryland, a stalking law was considered because of Sharon Wiggs, who was

wash manager with a long record of assault charges was sentenced to a year in prison for terrorizing his former girlfriend.

Lanny Brent Curry, a former aerospace engineer in Torrance, CA., is serving three years in state prison for making hundreds of phone calls and sending nearly two dozen threatening letters to a co-worker who had spurned his advances.

James Otis Sims Jr. of Anaheim, CA., was sentenced to 60 days in the Orange County Jail and five years' probation after he pleaded guilty to stalking a woman he once had dated. He stalked her for 12 years before the law was passed. Another case is that of Kimberly Gracyalny. She recently got a life sentence for assulting Los Angeles psychologist David Fox and his family after stalking him. She ambushed him and his family one night as they came home from having dinner, shooting Mr. Fox, his wife and their 7-yearold daughter. All three survived, and the couple's three little boys escaped injury.

Although Maryland doesn't have a stalking law, stalkers may be charged with other offenses. A 30-year-old man was arrested in April after stalking actor Clint Eastwood. Brian Keith Neun was charged with two counts of extortion and making threatening interstate telephone calls. The case hasn't gone to

Meanwhile, in states where the law isn't so clear, some victims wait, wondering if anyone will come to their rescue before it's too late. One Dallas woman, who says she is being stalked by her estranged husband, has given up hoping for help. She's so afraid that she's

Museum Organizational **Meeting Thursday, June 9**



Ciscoans Launch Anencephaly Research And Help Line Of America

By Ruth V. York

The complex, incredible brain is matrix of life, pilot of growth, habitation of conscious and unconscious thought.

But occasionally something goes wrong in the first crucial days after conception, and a baby is born with severe brain and skull abnormalites. Doctors call this anencephaly (an-en-sefuh-lee), meaning literally "no brain" - - a misleading term, since there are no "brainless" babies.

Only 25% to 45% of anencephalic babies are born alive. Of these, almost half die within 24 hours. Only 5% of liveborns survive seven days. An isolated few live past 14 days.

"What causes the developing brain to miscue?" asks Jo Ann Wilks, of Cisco. "We don't know. But it deserves our best medical detective work."

"The reason we say that, " says Alva Nelms, formerly of Cisco, "is that this once rare tragedy seems to be increasing. Why is the Texas rate of anencephalic births up to ten times the national rate? In two and a half years, there were seventytwo such births in a threemile stretch along the Rio Grande River! Texans need to know why."

Alva and Jo Ann are founders of the Anencephaly Research and Help Line of America (1-800-588-6464). This toll-free hotline has two goals.

"First, support to the families," Alva says. "They need a chance to discuss the worries, the fears, the emotional trauma that go with anencephaly. We

"We certainly support that- -but it's simply inadequate, because of the scope of the problem. We feel anencephaly is also increasing across all the eastern half of Texas."

The effects of an encephaly vary. Some preclude life. Sight and mentality are commonly affected. Physical appearance from the eyes up may be "different."

As a consequence, these are the forgotten children of the medical world. Doctors seldom offer parent any hope.

"Traditional medical literature says all infants with anencephaly die within 15 days," Alva notes. "We know that is not true, however- -or need not be true. My own daughter, diagnosed by four doctors as having classic anencephaly, is progressing well after four

weeks." (See box.) There are other isolated examples. An elevenyear-old in New York. A three-year-old in Florida.

A nine-month-old in Austin. Jo Ann explains, "Early

death is virtually assured by the standard medical practice of denving basic care. These babies usually aren't fed, held, monitored, even resuscitated. Of course they die soon after birth!"

THE BIG LITTLE MIRACLE By Ruth V. York

For JoAnn and Farris Wilks of Cisco, memories of holding daughter Toby span two brief hours. For Anne and David Andis of Houston, the moments

ran into five days that they and their children held and cuddled Emma. As a memorial, Anne makes "Emma's Dresses," exquisite labors of love for other tiny victims of anencephaly.

But for Alva and Kerry Nelms, now living in Temple, the memories are running into the future.

In her ninth month of pregnancy, the impossible diagnosis: "Your baby is anencephalic."

Impossible? At first glance, yes.

"Farris is my brother," Alva explains. "It was only a year since his and Jo Ann's daughter, Toby was born. She had anencephaly. If it is rare - 2 or 3 per 10,000 births, as doctors say - I should never encounter it personally more than once in a lifetime. And now it was happening again - to my child!"

Alva and her husband, Kerry, concluded that "there was only one Physician who could really help us. His

suggest sources of financial help. We give care procedures for anencephalic babies. And we offer educational packets about anencephaly and its possible causes.

"Second, we are comiling a research data base. Mother's occupation. Father's occupation. Lifestyle. Diet. Place of residence. Tracing common factors may lead researchers to the cause- or causes."

According to Alva, 95% of families with an anencephalic child have no history of anencephaly. This suggests an environmental rather than hereditary link. Sudden "clustering" such as that in the valley (Cameron County) points to environment, as does a study done in 1990.

That study found that fathers who routinely use solvents- -especiallypainters stood an in-

There are exceptions. Occasionally parents insist on normal care for their anencephalic infants, or assume this care themselves. Some babies receive better care (temporarily) because they are viewed as potential organ donors, as in the widely publicized Baby Theresa case in Florida.

Baby Theresa dramatized the battle over fetal tissue transplantation and research recently debated by Congress. Her family asked Florida courts to declare Baby Theresa "brain dead" so they could donate her living organs for possible transplants. They were twice refused. Though Baby Theresa has since

name, according to the Psalmist, YAH (Ps. 68:4, NKJV). So they named their unborn daughter KeYAHna Faith, and prayed for her wholeness. As word spread, friends, relatives and strangers across the nation prayed with them.

Keyahna was born April 30th at St. David's Hospital in Austin, weighing 11 lbs. 12 oz. She clearly had anencephaly, with exposed brain tissue and an incomplete skull and scalp. Doctors warned she would soon die of apnea - forgetting to breathe. But her breathing, nursing, reflexes and responses at birth were good, and normal in most respects. She was discharged in less than 48 hours.

'The hospital staff was extremely helpful and cooperative," Kerry says.

When respiratory congestion developed later, Keyahna required additional oxygen, special care, and monitoring, but those problems seem to be easing. Bone has formed above her eyes and ears, and her scalp area is increasing.

"Like other newborns," Alva laughs, "she is often hungry, often wet, and always pleased with attention." Between nurses, her parents and six doting siblings, Keyahna gets lot of that.

"She is a great joy and adventure for us," says Alva. Thus a month later, the "big little miracle" is by medical, as well as Kerry's and Alva's standards, a continuing miracle.



An Alternative **To Saving More Is Wiser** Investing

If you could live your life over again, what would you do differently? According to a recent survey, 51 percent of adults over age 65 said they would have saved more money. What's equally important is how they would have saved.

For most savers, the easiest way to invest is to put money in bank certificates of deposit (CDs). The principal is federally insured, and the rates are generally acceptable. The problem with CDs, however, is that the interest they earn is taxable, and inflation eats away at the buying power of the principal and interest. Table A shows (1) the annualized average monthly rates of six-month CDs during 21 reporting periods from 1970 through 1990, and (2) the corresponding inflation rate as reported by the Federal Reserve Board Consumer Price Index. Although CDs averaged a yield of 8.71 percent during this period, inflation was taking away an average of 6.27 percent of purchasing power. What would this have meant to an investor's savings?

Using the averages, \$1,000 would have earned \$87.10 in income (8.71 percent0. At the same time, inflation would have claimed \$62.70 of buying power (6.27 percent). That would have been \$24.39 tax liability, leavng a penny of spendable income after taxes. \$1,000 @ 8.71 percent 87.10 Inflation @ 6.27 percent (62.70) Before-tax income 24.40 28 percent tax liability (24.39) After-tax spendable income \$00.01 Of course, these are averages, which means half of the investors did better, half worse. That's why so many people living on fixed incomes have fewer dollars with which to maintain their standard of living. Perhaps the answer is not to have saved more, but rather to have invested more wisely. TABLE A



Since the 1990 arrival of the Africanized honey bee in South Texas, at least half of the stinging victims-whether by Africanized or European honey bees-have come under attack while using motorized mowers, weed choppers or heavy machinery.

"A lot of people have regular honey bees and in speculated that it is vibration or exhaust that upsets the bees," said Dr. Frank Eischen, a bee researcher for the Texas Agricultural Experiment Station in Weslaco. "I don't know of any data that supports the exhaust theory, but certainly the vibration idea sounds reasonable."

swarming and building hives in recent weeks, people should be cautious while using mowers, motorized weed choppers or heavy equipment.

There are some preventive measures:

* Throughout the season, do weekly patrols of your home to make sure that no bees build a nest close to living quarters.

* Before starting the equipment, scout around the area to be mowed looking for hives.

* A cluttered area, such as a junk pile or dense shrubbery, might be shielding a hive from sight.

* Be aware of culverts or drainage pipes that may be harboring a colony.

* Don't allow grass clippings to be propelled into
