The recipients' faces filled with joy as the two specially designed AmTrykes were brought out of the building.

Both young people suffer from cerebral palsy and have great difficulty in participating in play in outdoor activities. As each was situated into their new AmTrykes, the excitement in the crowd grew and tears filled many eyes. Several times, those in attendance burst into applause at what they were witnessing.

The AmTryke built for Bartenstein was even painted a beautiful shade of purple, her favorite color.

The employees of the spa conducted a Nov. 6 fundraiser, raising money to help purchase the AmTrykes. Various vendors for the spa donated products, then a raffle was conducted and tickets drawn for the gifts.

The spa, owned by Jauna French, gave \$2,500 toward the purchase of the AmTrykes and business representatives say they are inspired to attempt to raise more money since witnessing the donation to Bartenstein and Lopez and their families.

### Garbage, recycling pick-ups resume today

Garbage and recycling collections in Rockwall, which were discontinued earlier this week following the winter storm, will resume today, Feb. 26, according to a City of Rockwall news release.

### County offices to close March 2

Rockwall County offices will be closed March 2 in observance of Texas Independence Day, according to the county's website.

### Citizen Fire Academy scheduled

A 10-week Citizen Fire Academy program, offered to increase awareness in the life of a firefighter, will begin in March. Classes will meet from 6:30 p.m. to 9:30 p.m.

## Rockwall discusses estimated \$367,000 logo change proposal

The City of Rockwall met Mon. Feb. 16, 2015 to hold three work sessions, executive session and a regular meeting at the city hall.

The first work session was to discuss the acquisition of portable furniture for use in the San Jacinto Plaza off the square. The most popular concerns expressed by council members involved stability of furniture during high wind events and security from vandalism and theft.

The second work session was related to initiating an amendment to the Unified Development Code in Article 9 Section 11.1 Tree Fund Administration. The council was asked to expand the ordinance to allow purchase of any type of plant material other than annuals, such as shrubbery, perennials that would have a longer life span; to amend ordinance to allow for the city to pay for equipment and installation and to install irrigation systems.

The final work session discussed and considered city branding issues, including updating the city logo as approved by the Rockwall Economic Development Corporation. Ms. Smith explained the new logo and costs of changing the logo city wide. The estimated cost for changing the logo was approximately \$367,720 with water tower changes as the largest expenditure.

Council member Milder expressed his belief that it's time to change the logo to reflect the modernization of Rockwall.

Qball Designs, of Rockwall, played a significant role in designing the logo.

Chris Lewis asked about contracting with a professional consultant to design the logo. He expressed concerns about including flag colors for different schools and the potential of future changes when more schools are added.

It was clarified that the EDC contracted with Qball Designs for professional services.

Following the work sessions, the city council adjourned to executive session to discuss a concession agreement with Suintex Marina/Suintex

RHCL Marina, LLC; a legal claim involving TF-Harbor LLC v. City of Rockwall, Texas and Rockwall Rental Properties L.P.; a legal claim related to back up of city sewage line in Random Oaks Subdivision; and economic development prospects and potential incentive agreement.

The case TF-Harbor v. City of Rockwall and Rockwall Rental Properties involves a dispute over a lot 7 that is currently used for parking at the Harbor District.

The City of Rockwall passed an ordinance allowing Rockwall Rental Properties L.P. to develop on the lot. Rockwall Rental Properties is managed by Housing Property Realty, which is managed by Randal Noe of Terrell, Texas.

TF-Harbor is owned by Credit Union Liquidity Services, L.L.C. of Richardson.

TF-Harbor claimed the ordinance and development impaired a Contractual Agreement to protect leasehold interests in the Cinemark Lease.

On May 9, 2014, Federal District Court Judge Sydney Fitzwater ordered TF-Harbor's federal law claims and state-law claims dismissed without prejudice, on the grounds that TF-Harbor "did not plead cognizable claims for relief."

On June 6, 2014, TF-Harbor's appeal to the Fifth Circuit Court of Appeals was docketed on May 9, 2014.

On February 9, 2015, the Fifth Circuit Court entered its judgment affirming the lower court's decision.

In other business the city:

- Unanimously approved the consent agenda.
- Heard reports on racial profiling, crime comparison and holiday crime initiative by Police Chief Mark Moeller, as required by state law. Moeller reported a 17% reduction in criminal activity during the 2014 period compared to 2013.

# Fate City Council hears details about new business

The recent Fate City Council meeting on Monday, Feb. 16, at the Fate Community Center included an introduction by City Manager Michael Kovacs of the partnership with Brookshire's grocery store.

The friendship was unveiled after a number of executive sessions that teased the public about the possibility of a mystery business coming to Fate.

Brookshire's representatives Steve Mouldin and Charles Day were present for the meeting.

Council member Jon Thatcher explained that the timetable is still up in the air, but the project should begin as the I-30 overpass is being completed.

The Brookshire's store will reportedly cover around 50,000 square feet.

The council unanimously passed Resolution No. R-843, which supports Resolution No. R-03-15 of the Fate Development Corporation, approving a grant of an economic development incentive to Brookshire Grocery Company. The resolution also approves an economic development incentive agreement between the city, the development corporation and Brookshire Grocery Company.

City Attorney Brenda McDonald advised the resolution "will be published in the newspaper" as required by state law. The Rockwall County News has not been contacted about publishing the related notice.

During the citizen comments, Amy Velez spoke about parking problems in the Fate town center. Velez owns Amy Foster Hair Salon. She said an adjacent business has been displaying a sign "proclaiming parking for Daylight Donuts Only." The feud appears to center around the question of whether a business located in the Fate town center area is authorized to display a sign that restricts parking for its customers only.

"Downtown parking should be free and public, and an ordinance needs to be in place to keep it so . . ." Velez said.

In other business, the council:

- Approved the consent agenda, which included Resolution No. R-841 related to dedication from Benedetto Group LTD, or a Water Utility Easement on property located at 907 Hwy. 66, and Resolution No. R-842 ordering the general election to be held jointly with the Rockwall Independent School District and Roysse City ISD, and administered by the Rockwall County Elections Administrator on May 9, 2015, for the purpose of electing three council members (Places 1, 3 and 5), to the Fate City Council; and other election matters. The City has not published a notice about the order in accordance with state law.
- Approved Ordinance No. - 1400 changing the zoning classification from Agricultural to Planned Development District for Downtown Residential uses with a maximum of two residential lots on approximately .62 acres of land located at 104 Dogwood Trail. The Council amended

the motion to include a stipulation that the front of each residence face Dogwood.

- Approved Resolution No. R-844 in support of the development corporation's declaration to make the approximately 389 acres located at the northwest corner of the intersection of FM 551 and I-30 a mixed development "Project." Kovacs stated that the required notice would be published in the newspaper.

- Discussed, but took no action on Resolution R-845 related to Professional Services Agreement between the City of Fate and Buxton to perform a retail study in the amount of \$50,000 to benefit the "Project" located at the intersection of FM 551 and I-30.

- Unanimously approved Resolution R-846 to conduct a "Design Charrette" for the Project located at the intersection of FM 551 and I-30. The expenditures to conduct the charrette are to be no more than \$10,000.

- Unanimously approved R-847 authorizing Kovacs to renew the Lease Agreement with Rick Brunson for property located at 109 E. Fate Main Place, to temporarily house various City Departments for an additional six month period.

- Approved an interlocal agreement between Rockwall County and the City of Fate for the purchase of public safety radio equipment. Council member Thatcher abstained. Thatcher also doubles as an Assistant District Attorney for Rockwall County.

- Discussed and considered the County Open Space Master Plan. Thatcher expressed concerns about development on flood plains. McDonald advised that an ordinance could be passed to not allow reclaiming of flood plain. Kovacs explained that the flood plain maps were shown to their Brookshire's "friends," and offered development location recommendations.

Thatcher finished by expressing concerns about infringement of property rights.

## New Roysse City Parks & Rec Advisory Board member has high expectations

During the Tuesday, Feb. 10, Roysse City Council meeting, Place 2 Council Member Clay Ellis appointed Mike Chappell to the Parks and Recreation Advisory Board.

This appointment is for an unexpired term ending Dec. 31, 2016.

Chappell spoke to the council, giving them a brief outline of his qualifications and expectations of goals of achievement for his term on the council.

He shared that he and his wife bought the Pullen home, one of Roysse City's beautiful historic homes, last May. Chappell is a registered, licensed architect in Texas. In 2006, he completed his bachelor's of science degree and worked for a firm as a project manager. He went on to complete his master's degree during which time he "studied scores of zoning ordinances and detailed planned developments" in cities such as Midwest City, Oklahoma, Aurora, Colorado, and Pflugerville.

Chappell said that in his visits of the various businesses around Roysse City, he was "somewhat put off by the dilapidated state" of the city's museum, the Zaner Robison Historical Museum on Arch Street. Due to the fact that the museum is a registered historical landmark, not a lot can be done, but work is supposedly being done "with the state on a plan to repair and/or refurbish it to some extent." Safety of those visiting the museum has been of concern for some time.

An avid runner, Chappell also has spent time in the parks and observing and dealing with the sidewalks and pedestrian walk-ways. He says that "in the long term, I aim to help make Roysse City a place that can be traversed safely without the use of an automobile and to create an environment that not only encourages more activity from our current residents, but one that other active citizens would like to call their home."

Dr. Phillip Paul, owner of the Chiropractic Clinic, spoke during the Citizen's Participation period of the meeting. He thanked the council and city staff members for completing a new handicapped parking space near his place of business, so his patients could have easier access to their medical care.

The council voted unanimously, 7-0, approving an ordinance ordering May 9 as General Election Day. Also, unanimously, the vote passed concerning the same day as joint General Election with Rockwall County, Roysse City Independent School District and the City of Roysse City.

The council also agreed to purchase a New Holland B-95 Backhoe for \$73,324. The one the city now uses for construction, street repairs, etc., is worn out and in need of repair at a very expensive price, so the

### Billings is candidate for Fate's Place 5

David Billings has announced his candidacy for Fate's City Council Place 5 in the May 2015 General Election.

"We continue to face many challenges in our community," Billings wrote in a letter released to the media last week.

Held a public hearing about a request for a specific use permit by James Watson of Jackson Automotive to allow for parking of automobiles. The council approved the ordinance after the first reading.

Passed (5-2) an ordinance for a request by Gordon Rockwall Investments, L.L.C. on behalf of Keith Young (Young Hyundai) to amend Specific Use Permit S-107 to allow for a new car dealership on a ten-acre tract of land at the address of 1530 IH-30, after first reading.

Unanimously approved, upon first reading, an ordinance for a request by Lawrence H. Ringley of Ringley & Associates Inc. on behalf of Jill Steger of Steger Dunhill LLC for approval of a Specific Use Permit to allow an automobile rental facility located at 898 Steger Towne Drive. The rental business is under Avis Rental Group.

Held a public hearing for approval of an ordinance for a request by Franklin of the Skorburg Company on behalf of the owner Larry Skorburg for approval of a zoning change from an Agricultural District to a Planned Development District for Single Family and General Retail district land uses located at the northwest corner of FM 552 and John G. Boulevard.

Tabled a request from Mr. Richard and Ceci Chancellor for installation of a 48" tall wrought iron fence in the required front yard located at 705 S.leton Drive.

Tabled a request by Cameron Slown of FC Cuny Corporation on behalf of Tom Kirkland of Tekmak Development Company for the approval of a Specific Use Permit for a hotel located at the southeast corner of the intersection of the IH 30 Frontage Road and Lakefront Drive (second reading).

Discussed and "consider" various bills being proposed in the 84th State Legislative Session and consider authorizing the City Manager Rick Rowley to enter into an agreement with Capitol Insights for support monitoring this legislative session. Capitol Insights is a consulting business based in Augusta, Maine.

Discussed initiating a citizen survey, without a motion, to solicit citizen feedback regarding city programs and services. David White stated if it would be better to put the estimated \$25,000 for the survey contract, toward street repairs, fire department and other important services. Following a heated discussion between council members, Mayor Pruitt recommended further discussions on the subject during an upcoming retreat.

# Lone Star CASA reps join in Capitol event

Lone Star CASA recently joined more than 300 CASA (Court Appointed Special Advocates) volunteers, board members and staff from across the state at the Capitol to speak up for children in the child welfare system.

Seven representatives from the program traveled to Austin earlier this month as part of CASA Day at the Capitol, the one day each legislative session that the CASA community assembles to bring attention to improving outcomes for children and youth in the foster care system.

The Lone Star CASA team met with its local Texas legislators to discuss policy priorities to improve issues in the state's child welfare system identified by the Sunset Commission and to promote the well being of children and youth in care.

"Traveling to Austin and meeting with our state leaders in the Capitol during the legislative session is empowering," said Vickie Nettleton, program director of Lone Star CASA. "We get the opportunity to speak up on behalf of the children we serve and ask our legislators to make them a top priority."

Last year, Lone Star CASA provided more than 60 CASA volunteers to 167 children in Kaufman and Rockwall counties. Statewide, 8,066 CASA volunteers advocated for 23,742 foster children. With 46,823 children in the custody of the Texas Department of Family and

Protective Services because of evidence of abuse and neglect, a CASA volunteer was provided for just over half of these children.

"Urging legislators to support Texas CASA's recommended policies will go a long way to help improve the state's child protection system and to ensure the well-being of vulnerable children and youth," said Vicki Spriggs, chief executive officer of Texas CASA, the state organization that provides funding, training, resources, legislative advocacy and other support for the 71 local CASA programs across the state.

CASA volunteers are trained to advocate for children in foster care. They get to know the child and speak to everyone involved in the child's life, including their family members, teachers, doctors, lawyers, social workers and others. The information they gather and their recommendations help the court overseeing the cases make informed decisions.

CASA Day at the Capitol included a training session for volunteers before they spoke to their lawmakers and a reading of a resolution honoring the CASA community introduced by long-time CASA supporter Rep. John Otto in the Texas House Representatives. Volunteers wrapped up their time at the Capitol by posing for a group photo in the Capitol Rotunda.

By the above stated vote, and actions by the respective representatives, the right of the people to be duly notified of each city action in accordance with state law has been impaired on multiple counts.

The Rockwall County News is the only newspaper legally qualified to publish each required legal notice for the Cities of Royse City, Heath, Fate, McLendon-Chisholm, and Rockwall.

The Rockwall County News meets the criteria established under Texas Government Code Sections 2051.044, 2051.045, 2051.046 and 2051.048 (b) and (c)(1) as a newspaper of general circulation for publication of each required legal notice in accordance with state law.

The Rockwall County News is legally qualified to assist all government units, in Rockwall County, to be in compliance with state law related to publication of each required legal notice.

The representatives of the government units, in their official capacity, have a duty under Oath of Office and Certificate of Commission to select the newspaper in accordance with Texas Gov. Code Subchapter C, Chapter 2051, and to execute each required legal notice in accordance with state law (See also Texas Government Code Section 2051.049).

Any and all adversely affected parties to any action by a political subdivision, in Rockwall County, may file proper legal actions in a Court or Grand Jury of competent jurisdiction, where such political subdivision or representative fails to comply with state law regulating publication of legal notice.

The Texas Declaration of Independence : March 2, 1836

## The Unanimous Declaration of Independence made by the Delegates of the People of Texas in General Convention at the town of Washington on the 2nd day of March 1836.

When a government has ceased to protect the lives, liberty and property of the people, from whom its legitimate powers are derived, and for the advancement of whose happiness it was instituted, and so far from being a guarantee for the enjoyment of those inestimable and inalienable rights, becomes an instrument in the hands of evil rulers for their oppression.

When the Federal Republican Constitution of their country, which they have sworn to support, no longer has a substantial existence, and the whole nature of their government has been forcibly changed, without their consent, from a restricted federative republic, composed of sovereign states, to a consolidated central military despotism, in which every interest is disregarded but that of the army and the priesthood, both the eternal enemies of civil liberty, the everready minions of power, and the usual instruments of tyrants.

When, long after the spirit of the constitution has departed, moderation is at length so far lost by those in power, that even the semblance of freedom is removed, and the forms themselves of the constitution discontinued, and so far from their petitions and remonstrances being regarded, the agents who bear them are thrown into dungeons, and mercenary armies sent forth to force a new government upon them at the point of the bayonet.

When, in consequence of such acts of malfeasance and abdication on the part of the government, anarchy prevails, and civil society is dissolved into its original elements. In such a crisis, the first law of nature, the right of self-preservation, the inherent and inalienable rights of the people to appeal to first principles, and take their political affairs into their own hands in extreme cases, enjoins it as a right towards themselves, and a sacred obligation to their posterity, to abolish such government, and create another in its stead, calculated to rescue them from impending dangers, and to secure their future welfare and happiness.

Nations, as well as individuals, are amenable for their acts to the public opinion of mankind. A statement of a part of our grievances is therefore submitted to an impartial world, in justification of the hazardous but unavoidable step now taken, of severing our political connection with the Mexican people, and assuming an independent attitude among the nations of the earth.

The Mexican government, by its colonization laws, invited and induced the Anglo-American population of Texas to colonize its wilderness under the pledged faith of a written constitution, that they should continue to enjoy that constitutional liberty and republican government to which they had been habituated in the land of their birth, the United States of America.

In this expectation they have been cruelly disappointed, inasmuch as the Mexican nation has acquiesced in the late changes made in the government by General Antonio Lopez de Santa Anna, who having overturned the constitution of his country, now offers us the cruel alternative, either to abandon our homes, acquired by so many privations, or submit to the most intolerable of all tyranny, the combined despotism of the sword and the priesthood.

It has sacrificed our welfare to the state of Coahuila, by which our interests have been continually depressed through a jealous and partial course of legislation, carried on at a far distant seat of government, by a hostile majority, in an unknown tongue, and this too, notwithstanding we have petitioned in the humblest terms for the establishment of a separate state government, and have, in accordance with the provisions of the national constitution, presented to the general Congress a republican constitution, which was, without just cause, contemptuously rejected.

It incarcerated in a dungeon, for a long time, one of our citizens, for no other cause but a zealous endeavor to procure the acceptance of our constitution, and the establishment of a state government.

It has failed and refused to secure, on a firm basis, the right of trial by jury, that palladium of civil liberty, and only safe guarantee for the life, liberty, and property of the citizen.

It has failed to establish any public system of education, although possessed of almost boundless resources, (the public domain,) and although it is an axiom in political science, that unless a people are educated and enlightened, it is idle to expect the continuance of civil liberty, or the capacity for self government.

It has suffered the military commandants, stationed among us, to exercise arbitrary acts of oppression and tyranny, thus trampling upon the most sacred rights of the citizens, and rendering the military superior to the civil power.

It has dissolved, by force of arms, the state Congress of Coahuila and Texas, and obliged our representatives to fly for their lives from the seat of government, thus depriving us of the fundamental political right of representation.

It has demanded the surrender of a number of our citizens, and ordered military detachments to seize and carry them into the Interior for trial, in contempt of the civil authorities, and in defiance of the laws and the constitution.

It has made piratical attacks upon our commerce, by commissioning foreign desperadoes, and authorizing them to seize our vessels, and convey the property of our citizens to far distant ports for confiscation.

It denies us the right of worshipping the Almighty according to the dictates of our own conscience, by the support of a national religion, calculated to promote the temporal interest of its human functionaries, rather than the glory of the true and living God.

It has demanded us to deliver up our arms, which are essential to our defence, the rightful property of freemen, and formidable only to tyrannical governments.

It has invaded our country both by sea and by land, with intent to lay waste our territory, and drive us from our homes; and has now a large mercenary army advancing, to carry on against us a war of extermination.

It has, through its emissaries, incited the merciless savage, with the tomahawk and scalping knife, to massacre the inhabitants of our defenseless frontiers.

It hath been, during the whole time of our connection with it, the contemptible sport and victim of successive military revolutions, and hath continually exhibited every characteristic of a weak, corrupt, and tyrannical government.

These, and other grievances, were patiently borne by the people of Texas, until they reached that point at which forbearance ceases to be a virtue. We then took up arms in defence of the national constitution. We appealed to our Mexican brethren for assistance. Our appeal has been made in vain. Though months have elapsed, no sympathetic response has yet been heard from the Interior. We are, therefore, forced to the melancholy conclusion, that the Mexican people have acquiesced in the destruction of their liberty, and the substitution thereof of a military government; that they are unfit to be free, and incapable of self government.


The necessity of self-preservation, therefore, now decrees our eternal political separation.

We, therefore, the delegates with plenary powers of the people of Texas, in solemn convention assembled, appealing to a candid world for the necessities of our condition, do hereby resolve and declare, that our political connection with the Mexican nation has forever ended, and that the people of Texas do now constitute a free, Sovereign, and independent republic, and are fully invested with all the rights and attributes which properly belong to independent nations; and, conscious of the rectitude of our intentions, we fearlessly and confidently commit the issue to the decision of the Supreme arbiter of the destinies of nations.

# Rockwall-Heath Hawks go into playoffs following 1st loss

Rockwall-Heath's shot at an unbeaten season has ended, but the Hawks still have a chance to win the 5A boys' basketball state championship.

RHHS was considered a sacrificial lamb in Saturday's warm-up game at Cedar Hill, ranked fourth in the Texas Association of Basketball Coaches 6A poll.

The Longhorns have four players at 6-foot-6 or taller; Rockwall-Heath's tallest starter is Kelden Pruitt, listed at 6-5.

However, the Hawks darn near came away with their perfect record intact. They led Cedar Hill (26-3) by two points entering the fourth quarter, but the Longhorns rallied to win 67-60.

Camron Talley put in 25 points, and had help from Jackson Zivney's 13 and Jeremiah Sandidge's 10.

The Hawks (28-1) had been scheduled to open the playoffs Tuesday with a Bi-District game against Carrollton Newman Smith (16-12), but the icy weather postponed that game at Lake Highlands for at least another night.

Scoring leader Jackson Zivney is Rockwall-Heath's only senior starter. He was joined in 2012-13 by three freshmen - his brother, Talley and Sandidge. Each of the four is scoring more than 10 points per game for the high-scoring Hawks, ranked eighth in the TABC 5A poll.

They helped RHHS reach the playoffs for the first time last season, but the Hawks still are looking for their first playoff win.

Now a long postseason run, no more than a pipe dream at the beginning of the season, is a possibility.

The most difficult part of the playoffs could be getting out of Region II. If Rockwall-Heath reaches the regional semifinals, the likely opponent would be Dallas Kimball, with a tall frontcourt and a No. 6 state ranking.

Surviving that game could mean a regional final against No. 1 Lancaster, featuring former Rockwall big man Elijah Thomas, or No. 7 South Oak Cliff.

RHHS had pleased a Senior Night crowd on Tuesday, Feb. 17, by defeating Terrell 88-40. In that game Jackson Zivney had 19 points. Nathen Stover came off the bench to score 14, Talley and Tyler Zivney put in 13 apiece and Sandidge had 11.

Eldridge was the runner-up to Pearland's Jaden Belling by just second in the 200-yard individual medley. The RHS senior finished in 2:02.30. She also swam the 100 butterfly in 55.11 seconds to second to state champion Austin Westlake's Victoria Edwards.

Eldridge also swam the anchor leg behind freshman Amanda Arms and sophomores Jasmin Sani and Kayla Maxwell on the 200 free relay team that placed sixth. Of Rockwall's 79 points, Eldridge produced 40 1/2.

Armstrong placed fourth in the 50 free (23.63) and 13th in the backstroke (58.01).

The RHS boys were 52nd in the state, with senior Noah Day scoring points for placing 12th in the 100 backstroke in 51.73.

**GIRLS' BASKETBALL:** The Lady Jackets advanced to the Region II-6A quarterfinals with a 51-31 Area-round victory over Highland Park Friday at Mesquite Potet.

RHS (27-6) faced the possibility of three consecutive games at Davis Field House in Dallas. The Lady Jackets were scheduled to Irving MacArthur (24-10) there Wednesday, weather permitting, winner would advance to the regional semifinals at the Davis House on Friday and possibly to Saturday's regional final.

Sara Williamson's 23 points included 15 in the fourth quarter.

The Lady Scots (17-11) stayed with RHS for much of the first half. They trailed 14-8 before three steals boosted Rockwall's lead to 20-10. Only once after that did HP cut the lead to fewer than 10 points.

"I probably don't give the defense enough credit," RHS head coach Kasie Brewer said. "As a coach, I see the holes."

**WRESTLING:** Brandon Hyde and Andrew Hyde placed third and fourth in their weight classes as Rockwall took 13th place in the 6A boys' state championships last weekend.

All three finished with 3-2 records at Garland's Curtis Culwell Center. Smith (33-11) lost the 106-pound third-place match to Austin Bowie Christian Moreno by fall in 1 minute, 41 seconds. Hyde (45-7) defeated Amarillo's Talen Erwin 9-6 in the semifinals at 132, but lost 15-7 to Ed in the third-place match. Taylor (36-12) lost the fifth-place match at 132 to San Antonio Churchill's Tim Edmonson, the Region IV champion, a 6-0 decision.

RHS' first girl wrestler to compete at state, freshman Jackie Mote, won one of three matches at 165. She defeated Arlington Martin senior K. Beasley, the Region I champion, 7-2. Mote's one point gave the Lady Jackets a tie for 68th in the state.

**BOYS' BASKETBALL:** In the final regular-season game Feb. 20, Rockwall was headed toward a third overtime and a possible fourth consecutive victory and playoff berth.

Then the whistle blew with 0.5 second remaining, Garland Lakeview Centennial's Markel Johnson made a free throw and the Patriots came away with a 70-69 win and the District 6-11A championship.

RHS (12-17, 7-7) left the Lakeview gym a game behind Tyler Lee's district's final playoff berth and with the Yellowjackets' season on the line. The Jackets had a four-point lead during the second overtime, but Lakeview (19-10, 11-3) rallied.


