




THE SHADE OF THE UPAS.

For twenty years the cloud of the old bond issue has hung like a pall over the town of Colorado as deadly in its blight as the shade of the upas tree. It has paralyzed our energies, darkened the future, blasted hope and destroyed civic pride. We have worn into deep ruts, and move only in the line of least resistence. Years ago, Colorado had an equal chance with Abilene to become the leading town of west Texas, but has set still for a quarter of a century and allowed the chains of debt to sap its strength and break its spirit.

Can any one imagine the town of Abilene, under precisely the same conditions, sitting with folded hands, dying with dry rot, because a law suit involving several thousand dollars threatened it? Not much. It would have won out, hands down, whether the bonds had to be paid or not. Abilene would have come out of such a hole easier than a politician can change his principles; and today, the plucky city of Abilene is so far ahead of all other towns in west Texas they can't hear her foot steps. But for the deadly blight of the old bond issue, Colorado might be enjoying the same degree of prosperity and growth.
