MITCHELL COUNTY, TEXAS.

The people of this county are encouraged to all settlers in this county and to those who have been forced to leave this county because of the drought.

On Monday night the school board met in session with the following members present: N. J. Phenix, Chairman; E. Rogers, A. J. Yoe, R. M. Webb, J. H. Bedford, J. L. Munn, J. H. Payne, J. H. Bedford, J. L. Munn, J. H. Payne.

trying to get an opinion from men living in various portions of the county. Here are their versions:

F. L. Aycock moved here from Arkansas in 1899, bought one-half section of land 9 miles northwest of Colorado for \$1000. In the year of 1900 planted 21 1-2 acres of cotton, gathered 15 bales, sold at an average of 7 1-2 cents, also 12 acres of corn, making 10 bushels per acre. Kaffir corn and Maize extra fine. 1901, 36 acres in cotton, 10 bales, corn nearly a failure.

1902, 36 acres cotton, 7 1-2 bales. This year the boll worm came. In July his cotton promised a bale per acre, corn was light, feed stuff very heavy making 50 bushels Kaffir corn per acre. 1903, 36 acres cotton, 9 bales, corn very light and feed crops light.

1904, 36 acres cotton, 9 1-2 bales, feed crops very heavy. 1905, Mr. Aycock sold his farm for \$2000, thus doubling his money, and bought a section

1 1-2 miles West of Colorado at \$2.50 per acre. This land is now worth \$20. Last year he planted 33 acres in cotton and got 23 bales and sold at 10c. Feed crop extra heavy.

These years included several hard ones, yet Mr. Aycock has averaged 1-3 bale, has made money and hired most of his work done. He considers this a fine cotton country and a sure feed crop country.

Ben Horn, 4 1-2 miles northwest of Colorado, bought in 1900 a section for \$2.50 per acre, now worth \$15. In 1900 he planted 40 acres cotton and made 23 bales and good corn and fine feed crop.

1901 50 acres in cotton, 39 bales; corn 30 bushels per acre and fine Kaffir and Maize. 10

acres last year not picked at all because could not secure help. Picked up to and including March 1902, 27 acres in cotton, 7 bales, corn only 10 bushels.

1903, good crop, 35 acres in cotton 18 bales, corn 20 bushels and big crop of feed. 1904, Fairly good crop, 30 acres in cotton, 16 bales, and 50 bushels good sound corn per acre.

1905, 40 acres in cotton, 27 bales, and 30 bushels corn per acre, 11 acres in Kaffir corn that threshed 1000 bushels. 1906. Have now up and growing 50 acres in cotton, 13 acres in corn looks fine and a crop is nearly certain. 1 consider this equal or better than any part of Texas for farming and one man can raise more crop than three men can gather.

J. H. Bedford from Fannin county, came here in 1903, and bought one-half section of land 5 miles north of Colorado for \$7 per acre, now worth \$20 to \$22.50 per acre. He considers this the

best cotton country in the world, as one man can handle 75 acres here in cotton.

1904, 80 acres in cotton, 22 bales, finished planting 19th day of June and had 30 acres in a new fancy seed that was no good; made fine corn, 30 bushels per acre, and fine feed crops.

1905, 120 acres in cotton, 44 bales, and did not get it all picked, also experimented with new seed; some of this crop made from 3-4 to a bale per acre.

1906, have this year 120 acres cotton and 12 acres in corn. John Mahoney from Hill county came to this county in 1901, and bought one section 17 miles north-east of Colorado for \$5 per acre, now worth \$20. 1902, opened up farm, only

feed crop planted, and it was good. 1903, made good crop, big rain in July brought the boll worm; plenty of feed raised.

1904, 20 acres in cotton, 7 bales and more feed than could gather. 1905, 20 acres in cotton, 12 bales and tons of Kaffir corn and Maize. Had six acres in June corn, made 50 bushels per acre, good sound corn.

1906, 60 acres in cotton, 10 acres in corn, prospect fine. 1 consider this a better farming country than Hill county and lots easier, says Mr. Mahoney. He pays considerable attention to cattle, poultry and hogs and is making easy money.

J. L. Munn in 1901 bought one-half section 10 miles north-east of Colorado for \$3 per acre, would not sell at any price. Mr. Munn came from Earth county and made good corn the first year on sod land.

1903, 25 acres in cotton, 13 bales, corn 35 bushels extra good quality. 1904, 25 acres, 14 bales; corn light on account of hot winds. 1905, 40 acres in cotton, 31 bales and 30 bushels corn per acre, good average corn.

1906, have 35 acres in cotton and 10 acres corn. Good prospect but a little late. 1 consider this a much better farming country than Erath county.

Cuthbert, located in the north-west part of Mitchell county, says to the homeseeker: "When you visit our country you will see some of the finest farms of the entire West. It is one of our citizens who is now planting his 15th crop and who during the 14 previous crops has always averaged one-half bale of cotton per acre. For seven years we have had a successful gin. Last season's output was about 1550 bales of cotton. We have a telephone system which ramifies the nooks and corners of our community. We have a quiet, sober, law-abiding class of citizens. We pay our taxes and serve as jurors for the other fellow's benefit. Those of us who have farms to rent out have no trouble in securing a good class of tenants long in advance of the seasons. Applications are threefold more than the number of farms to let. Prospectors for 1907 are beginning to roll in and he considers himself lucky who secures a place amongst us."

A writer from the San Angelo country south of us, says: "L. P. Baugh will begin this week harvesting his wheat crop. He will use three harvesting machines and twelve or fifteen men. Mr. Baugh has 400 acres of Bayou valley land in wheat, and it will make about 20 bushels to the acre. He has recently cleared 500 acres more land and next year will have more than twelve hundred acres in wheat."

We publish the above and will mail out about 400 extra copies this week to farmers in the central part of Texas to show them that we have a farming country, and what can and has been raised. If anybody doubts the above figures they can address the farmers named above at Colorado and they will verify what they have here said. Come to Mitchell county.

Cotton Shipments. The total cotton shipments from Colorado to date is 16,316 bales, while at this date last year the total shipments including Colorado, Signal Mount and Westbrook were only 9,592 bales. The freight receipts for May this year were \$14,033, while May of last year were only \$8,000.

At the express office agent Hensley informs us the May increase of business was \$800 over that of the same month last year, or any previous year in this city, which goes to prove the rapid growth and prosperous condition of our section of the country.

Court News. The grand jury re-convened Wednesday 13th and adjourned until Wednesday 20th. The State of Texas vs Wm. Hughes, manslaughter; tried and acquitted. The State of Texas vs John DeMoss was called for trial and the defendant arraigned, but was postponed on account of the illness of a witness. The State of Texas vs Henry Wilson for cattle theft resulted in a mistrial. The State of Texas vs Paul Williams charged with assault with intent to murder, was set for trial today. W. K. Felker vs T. & P. R. R. Co. et al. agreed judgment for \$18.00 and cost for plaintiff.

Marriage License. Clifford Hart and Miss Addie Conaway, on the 9th. Campbell Club. Last Friday night quite a good crowd of our citizens came together at the court house and organized a Campbell Club. A. S. Henry was made president, J. T. Harness vice-president, L. W. Sandusky Sec. and G. B. Harness asst. Sec. All were very enthusiastic and all agreed to work and vote for Mr. Campbell as the next governor of Texas. Judge Homan was called on for a speech and as he always does, called forth much applause. Seventy-five names were added to the club roll and of course they all claim that Campbell will be the man. "Rah for Campbell!"
