



### THE BLACK APPOINTMENT

There is considerable agitation over the country over the appointment of Hugo Black as associate justice of the Supreme Court on account of h s alleged membership in the Ku Klux Klan, but this very likely will blow over and nothing will be done. This should have been investigated before he was appointed and after appointment the Senate should have made an investigation before confirming the appointment, but there was an effort made to delay the confirmation until such time as the senate could go into the matter, but the usual majority ran roughshod over the minority and made the confirmation.

We do not bel eve that Mr.Black should have been appointed, not much because of his membership! in the Ku Klux Klan but because of his ideas of taking possession of private telegrams and letters in an invest gation in the last congress without any authority of law. Placing him on the bench where the legality of such things must go for hearing, and the fact that a prosecuting attorney rarely makes a good judge is about all that can be said about Mr. Black's ability.

There is no possibility that he will be removed as impeachment charges must originate in the house of representat ves and voted by a majority before any charges can be filed and after charges are filed and an indictment found , it will have to go to the senate and the senate sitting as a court will hear the evidence and it takes two-thirds of that body to vote a conviction, so it can be seen that impeachment would be impossible un ler the circumstances. We do not doubt that Mr. Black is a member of the Klan, but we feel just about like Ray Tucker when he said, "the Washington woods are full of ex-clansmen-the appointees of southern congressmen since F'. D. R. 's triumph in 1932. If Justice Black were asked to resign and the same rule applied to his kinspirits at the capital, the government would be depopulated. There wouldn't be enough men to man the pumps of the ship of state-an extremely practical consideration."


