

PROPOSED CONSTITUTIONAL AMENUMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 8, 1960. HOUSE JOINT RESOLUTION NO. 6 proposing an Amendment to Sec-tion 11. Article XVI of the Constitu-tion of the State of Texas, so as to rive the Legislature authority to classi-fy loans and lenders, licennee and requ-late lenders, define interest, fix maxi-mum rates of interest, and provide for a maximum rate of interest of ten-per centum (10%) per annum in the abases of legislation setting maximum rates of interest; providing that the rate of interest shall not exceed six per cent (6%) per annum in contracts per cent (6%) per annum in contracts where no interest rate is agreed upon: providing for the right of appeal and trial de novo in the event any regula-tory agency cancels or refuses to speat tory agency cancels or refuses to grant any permit; providing for the neces-mary election and the form of the ballots; and providing for the neces-

Section 1. That Section 11, Article XVI of the Constitution of the State of Texas be amended so as to here-after read as follows:

"Section 11. The Legislature shall "Section 11. The Legislature shall have authority to classify loans and lenders, license and regulate lenders, define interest and fix maximum rates of interest; provided, however, in the absence of legislation fixing maximum rates of interest all contracts for a greater rate of interest than ten per contram (10%) per annum shall be desimed usurious; provided, further, wast in contracts where no rate of in-




