

Bond Election Scheduled Nov The citizens of Wolfforth will be building to house the city's **Wolfforth Voters Reject All** asked to vote on a \$41,000 general fire-fighting equipment and an obligation bond issue November emergency ambulance.

With only 184 out of 889 registered voters casting a ballot, Wolfforth citizens joined other Texas voters in defeating any attempt to revise the state Constitution by voting 9-1 against all eight propositions.

The city council unanimously passed a resolution in September to resubmit the issue to the public after it was voted down 42-60 in a July election.

At that time, Wolfforth voters passed a \$40,000 bond to obtain a new fire truck but defeated the \$34,000 bond for the building to house it.

Mayor G.A. Edwards Jr. explained that the Federal Housing Administration would not approve the fire truck bond until the engine was housed. The new fire truck is currently kept outside the city limits at R&C Welding.

"We've got to build a place here in town for it, or rent a place here in town. We'd be glad to rent a bay at a filling station, but there's just nothing big enough to put a fire truck in," Edwards said.

The bond, if passed, will provide funding for a metal building 40 by 100 feet, heated, insulated, and equipped for maintenance of the new fire truck and an ambulance.

Edwards said the garage would be located at 4th and Delta Streets and would also house the city's garbage truck and other municipal equipment now stored outside.

chief, said the city had the trained emergency medical personnel.

"The reason we don't have the ambulance is there is no place to put it," he said. "We got the people to man the ambulance. We are registered with the state of Texas."

Rosales explained that besides the six qualified people, five more were in training at Lubbock Christian College and would graduate int eh first week of November.

"We are the only town in Lubbock County which (now) qualifies for an ambulance," Rosales stated.

Edwards said the city needed an ambulance to give the people of Wolfforth faster service.

"We know that it's going to take 30 minutes to get an ambulance here (from Lubbock) to pick a patient up," Edwards said. "If we can cut that time down, we feel we might save some lives."

Edwards said the reason that the November bond issue cost \$7,000 more than the one defeated by voters last July was that this bond provided for a larger building. In July, Edwards reported, the city was not sure they could get the ambulance.

He estimated that tax rates on city residents may rise 15 cents from \$1.10 per thousand to \$1.25 in order to create a sinking fund sufficient to redeem the bonds when they become due.

Clarence Kelley is Lubbock C of C Banquet Speaker Tuesday Night

Eight Proposals by 9-1 Margin





Clarence M. Kelley, acting director of the FBI told members of the press gathered at the Hilton Inn that evidence in the Patricia Hearst case "will speak for itself." Kelley was in Lubbock to address the annual Chamber of Commerce banquet held in the Municipal Coliseum Tuesday night.

Clarence M. Kelley, acting director of the FBI, expressed his concern that public scrutiny and criticism of the agency's domestic security operations would "undermine the trust Americans have traditionally planned in the FBI."

Kelley, the keynote speaker at the Lubbock Chamber of Commerce annual banquet Tuesday night, asked the American people to decide who posed the real threat to American liberty.

"You must decide whether it is the FBI or extremists and terrorists who menace Americans' 200 year tradition of liberty," Kelley told the estimated 1100 people gathered at the Municipal Coliseum.

Kelley, who took office July 3, 1973, said that present criticism of the agency is a result of actions the bureau took "in extraordinarily turbulent times."

The danger is that restraints which would limit the agency's domestic security operations could be enacted by Congress, he said.

However, Kelley said the FBI welcomed the guidelines on domestic security proposed by the Department of Justice.

Quoting Attorney General Levi, Kelley said that those guidelines "accept the proposition that in limited circumstances carefully controlled FBI activity which directly intercedes to prevent violence is appropriate."

The FBI director said he remained convinced that "legislative guidelines should be established specifically permitting (the FBI) to act promptly when domestic security is imperilled."

Kelley took issue with a news report which said that only four convictions resulted from 676 domestic intelligence investigations in 1974.

Citing agency work leading to the arrest of an activist who planned to bomb two blocks in an unidentified city, and the break up of a ring of arsonists responsible for 15 arsons in New Haven, Conn., the former Kansas City police chief said that agency accomplishments deterred arsonists, terrorists, and assassins.

Kelley stated that bombings had increased from 24 in 1973 to 46 in the first six months of 1975.

The American people stand to be the losers if legislation is enacted which will prevent the agency from using "investigative techniques essential to doing our job," he said.



One thing can be said about Texas Tech football this year (among others): it isn't dull.

At times it gets downright exciting. Take the Florida State game, for instance. It was the opener and there were few ho-hum moments.

Then came New Mexico and it was far from causing ennui to set in. Forget Texas. Oklahoma State was exciting, too. Forget Texas A&M. Arizona was a nailbiter. Some of the SMU game was, too. And no one went to sleep during the Rice game.

In fact, Steve Sloan, didn't you know that it was Homecoming and some of your fans might be prone to heart attacks? Anyway, your Raiders pulled it out to the delight of all Tech fans.

There were anxious moments, though, when the Raiders continued to show generosity above and beyond the call of duty. Three second half fumbles and a pass interception really aided the coronary disposition of Raider exhorters.

Two Tech fumbles led directly to Rice touchdowns and the pass interception led to the field goal. That's 17 points on three turnovers and few teams can enjoy that type of generosity.

The Raiders turned one Rice fumble-the only one-into a touchdown and an intercepted pass led to a touchdown. In fact, the third quarter was a fluke in that Tech scored seven points and didn't run a single offensive play in the first 7:13 of the quarter.

Sloan listed six key things in the game at this post-game conference: (1) Tech's not being able to score just before the half ended; (2) Green's intercepted pass for a score; (3) Jordan's punt fumble; (4) Rice having to settle for a field goal; (5) the 72-yard touchdown pass play; (6) Tech's long drive without a pass that ate up the clock.

That drive, of course, was stopped at the 12 on the third fumble and averted a probably score that would have iced down the game and made Rice's 84-yard drive meaningless.

Steve observed that Tech probably should have taken the wind instead of the ball at the start of the game. As for the consistent rushing game by Rice, he said that some of it was due to poor tackling and some of it was due to the ability of the Owl backs.

As for the mistakes the Raiders still make, he said that it was no specific area that breaks down each game and he is mystified as to why this is true. "Turnovers," he said, "have really hurt us." Amen.

Steve left the decision up to Tommy Duniven on the goalline play with three seconds left, because he, Sloan, couldn't see how much yardage was needed.

Tech, at the time, was out of timeouts, and Steve said that "we probably should have taken a penalty and gone for the field goal."

Steve also thought that the defensive work at the close of the game nay well have given the Raiders more confidence.

This week the Raiders have the unenviable task of playing a team, TCU, that has lost 18 straight games. It may seem strange to be worried about a team with that record, except for two things: Every losing streak has to end and the Frogs usually always play Tech an outstanding game.

Sloan was asked if he had ever played against a team that had lost 18 straight and he replied that he couldn't recall a single incident.

Hunting Can Be A Safe Sport

Considering the thousands of men and women who are roaming the fields and woods with high-powered rifles during hunting season in Texas, it is not too surprising that a few hunters fail to return home alive each year. Others return with a serious gun shot wound that requires extensive medical treatment.

The primary cause of hunting accidents is carelessness. The hunter who blazes away at anything that moves runs a big risk of bagging a fellow hunter. The professional hunter will know what he or she is firing at before pulling the trigger. The hunter must never forget that any weapon capable of killing birds and animals also can kill humans.

When getting your hunting gear together, be sure to include a "hunter orange" jacket or vest. Even a cap in that distinctive color provides some protection.

Here are some other suggestions for a safe hunt:

Never cross over or through a fence or climb a tree with a loaded gun. It might fall and discharge.

Even a small bore rifle has considerable range. Know where your bullet will stop before pulling the trigger.

Keep guns away from children. Never leave a weapon unattended without unloading it.


Always carry a gun so that you can control the direction of the muzzle if you stumble. Keep the safety catch on until ready to shoot. Always be sure the barrel is clear of obstructions. A barrel clogged with mud or snow may burst.

Guns and alcohol don't mix. If you like a nip around camp, wait until you're through hunting for the day and all weapons are unloaded and cased.

Treat guns with respect at all times. They may be loaded, despite all precautions. Thus, never point a weapon at something unless you plan to shoot it. Hunting is established as a safe





to pay the annual interest and to create a sinking fund sufficient to redeem said bonds as they become due?"

Section 2: That paper ballots shall be used for said election, A.C. McWhorter, Alternate Prewhich ballots shall be prepared in accordance with V.A.T.S. Election Code so as to permit the electors to vote "FOR" or "AGAINST" the aforesaid proposition which shall be set forth in substantially the following form:

"The issuance of \$41,000 general obligation bonds for the construction of a public building"

The word "FOR" and beneat it the word "AGAINST" shall be made to appear on the left of the proposition. A square shall be printed on the left of each of the words 'FOR" and "AGAINST", and each elector shall place an "X" in the square beside the statement indicating the way he wishes to vote.

Section 3: That for purposes of this election, the entire Town of Wolfforth, Texas, shall constitute one election precinct and the Town Hall in said Town is hereby designated as the polling place for

said election.

On election day, the polls shall be open from 7:00 a.m. to 7:00 p.m.

Section 4: That the following named persons are hereby appointed officers of the election:

Joe Fletcher, Presiding Judge. siding Judge.

The Presiding Judge shall appoint two qualified clerks to serve and assist in holding said election; provided that if the Presiding Judge herein appointed actually serves, the Alternate Presiding Judge shall be one of the clerks.

Absentee voting shall be conducted at the Town Secretary's office in the Town Hall, in accordance with the provisions of V.A.T.S. Election Code, Chapter 5.

Section 5: All resident qualified electors of the Town shall be permitted to vote at said election. In addition, the election materials enumerated in Senate Bill No. 165, Acts of the 64th Legislature, Regular Session, 1975, shall be printed in both English and Spanish for use at each polling place and for absentee voting.

Section 6: That a substantial

copy of this resolution and order shall serve as proper notice of said election. Said notice shall be posted in the election precinct and at the Town Hall not less than fourteen (14) full days prior to the date on which said election is to be held, and be published on the same day in each of two successive weeks in a newspaper of general circulation in said Town, the first of said publications to be made not less than fourteen (14) full days prior to the date set for said election.
