### Ropes.

About midnight a tornado was sighted northeast of Plains moving toward Levelland, and another 12 miles south of Littlefield moving toward Anton. Later the report came that the Plains tornado was sighted near Sundown. None of these tornadoes did any damage as they missed the towns they were near.

However, at that time there was a rolling black cloud, filled with perpetual lightning, coming in from the west. It was at this point that the tornado alert was sounded in Ropes. This cloud, too, changed its course, and it was at this time that the sirens went off in Lubbock and people were advised to take all precautions and prepare for possible tornadoes. This alert was lifted at 1:20 a.m. Heavy rain and hail fell in the south part of Lubbock. In Ropes it was quiet, with not enough wind to move a paper sack. It was quiet, so quiet that it caused you to pause and thinkthe barometer was below the danger point and it made you feel depressed.

limits of Meadow-it was a bad wreck but no one was injured.

Monday showed about the same pattern of storms with the exception that there was but one tornado and that occurred about three miles west of Sundown, knocking down twelve light poles and destroying some out buildings.

The rain in the Ropes community started in the neighborhood of the Foster store and moved in a northeasterly direction, giving the Farm Center community another pasting. Joe Durham, who lives south of Wolfforth, reported that the rain was heavy in his vicinity, and that roads were blocked -it was accompanied by a heavy hail.

A highway patrolman, who was near the Farm Center Gin when the storm swept past, stated that the rain and hail were so heavy he

LEMON ICEBOX CAKE

7 pkg. lemon pudding and pie filling
% cup sugar
2 cups water
7 egg
% cup PET Evaporated Milk
7-oz. angel cake (6 cups)

NORTHERN

Mix well in a 2-qt. saucepan the pudding and pie filling, sugar, ¼ cup water and the egg. Stir in gradually the remaining 1¾ cups water. Cook and stir until mixture comes to a full, all-over boil and is thick, about 5 minutes, Take from heat. Cover and cool. Chill milk in ice tray until almost frozen around the edges. With fingers, tear angel cake into inch pieces. Put the ice-cold milk in a cold quart bowl. Whip with cold rotary beater or electric beater at high speed, until stiff. Then fold into cooled pudding. Fold cake into pudding mixture. Put into 8-inch square pan. Chill until firm, about 3 hours. Cut into squares to serve.
