Mrs. Roslyn Watson was appointed Carson County Tax Assessor-Collector by County Commissioners in a regular session Monday morning, June 11. Judge Jay R. Roselius administered the oath of office at 11:20 a.m. as several county officials and friends witnessed the event.

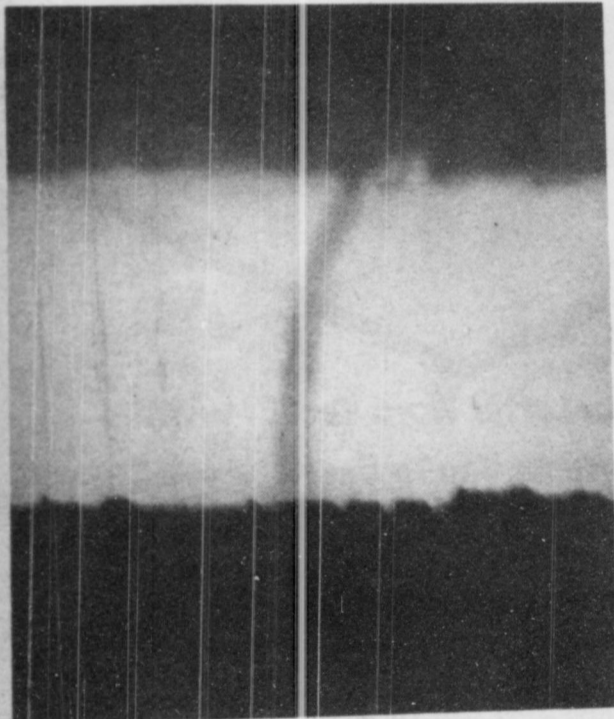
The office vacancy was created by the recent death of Lloyd Sterling who was elected to a four-year term in the 1988 General Election. Mrs. Watson's appointment, as required by law, puts her in office until the end of 1990. The Carson County Democratic Committee is scheduled to meet in the near future to select a candidate to put on the November General Election this year, and to be elected to complete the two remaining years of the term.

Mrs. Watson has been employed at the Tax Office for 16 years, and has



been Chief Deputy for the past 5-1/2 years. She and her husband, J.G. Watson who retired this spring after serving 35 years as Vocational Ag instructor at Panhandle High School, are parents of three grown children and have two grandchildren.

Tornadoes Dance Around Groom



Tornadoes and thunderstorms skirted across the Panhandle, but no damage was reported, authorities said.

Tornado and thunderstorm warnings were issued for parts of Carson, Randall, Armstrong and Gray counties late Friday. Other thunderstorm warnings were issued for Deaf Smith, Hartley, Donley, Hutchinson, Castro and Moore counties.

Six funnel clouds were reported in Carson County, three of which were reported to have touched the ground. One of these was on the north side of Panhandle near the Pantex Plant. Hail also was reported in Panhandle.

In Gray County, tornadoes were reported to have touched down between McLean and Groom on Interstate 40, five miles east of Pampa and

Court Asks Postal Service For Lower Rates

Carson County Commissioner's Court met in regular session on Monday, June 11, 1990 with all members present.

Action taken during the meeting included the Sheriff's department budget being amended \$12,000 in the following

areas: car maintenance, jail operation (for upkeep of prisoners), and telephone.

Also, the Court passed a resolution asking the Postal Service in Washington D.C. to consider giving local governments a lower postal rate for their mail. This savings would lower the cost of operation, thus reducing the cost to local taxpayers.

Four applications for the appointment of Carson County Tax Assessor-Collector were considered by the Court. A decision was made to appoint Roslyn Watson stating, "Mrs. Watson has over 15 years experience in the Tax Office and should do a good job."

At a previous meeting, the Court was accepting bids on a dozer for Precinct #2. The Court was informed Monday that no bids were received and Comm. Smith stated "that he did not feel it was financially feasible to make the purchase at this time." The purchase will be looked into again in the future.

In other action, the Court approved the combining of the Emergency Management Coordinator's job with that of the County Judge's secretary. This arrangement was made in order to eliminate a separate position in the Emergency Management program, and the state will also reimburse the County some cost of the operation.

Protest Hearings Begin June 25

Property owners in the Carson County Appraisal District will have an opportunity later this month to protest proposed appraisals of their property for local taxes. The district's appraisal review board (ARB) will begin hearing taxpayer protests on June 25, 1990 from 9:00 a.m. to 11:30 a.m.

After the ARB concludes its hearings and approves final property appraisals, local governments will use these appraisals to assess property taxes for 1990.

The ARB is a group of citizens who live in the appraisal district and who are appointed by the district's directors. Their responsibilities are outlined by the Texas Constitution, which requires that property be appraised equally and uniformly and that exemptions and productivity appraisal be properly granted.

Property owners may appear before the ARB to protest any of these specific actions of the appraisal office:

- *the appraised or agricultural value of the property;
- *unequal appraisal of the taxpayer's property compared to other property in the district;
- *inclusion of the property on the appraisal records;
- *denial of a partial exemption, such as a homestead exemption;

*denial of agricultural-use, open-space, or timber productivity appraisal;

*determination that agricultural or timber land has had a change-of-use and is subject to a rollback tax;

*identification of the taxing unit or units in which the property is located;

*determination that the taxpayer is the owner of the property;

*any other action of the appraisal office that adversely affects the property owner.

Dianne Lavake, chief appraiser for the district, outlined the steps by which a property owner files a protest with the ARB. This must be filed by May 31 or within 30 days after the taxpayer is mailed a notice of appraised value by the chief appraiser, whichever is later.

However, if the ARB sends a property owner a notice of any other kind of change in the appraisal records, or if the chief appraiser issues a prior-year omitted property notice, the property owner has only 10 days from the mailing date to file a protest.

Official forms for a notice of protest are available at the appraisal district office.

"A letter from the taxpayer is also acceptable," Lavake said, "as long as it identifies the property owner and the property that is the subject of the protest and indicates dissatisfaction with some decision or action of the appraisal office."

Each protesting property owner may offer evidence or argument, either in person

or by filing an affidavit with the ARB. Property owners should be aware that the ARB has no authority over tax rates or taxing-unit spending and will not hear protests on these matters.

The ARB will schedule hearings as property owners file protests and will inform them of the time, date, and place of their individual hearings at least 15 days before the scheduled date. Lavake said that protest hearings will be held for one day and that the ARB expects to approve the final appraisal roll on approximately July 20. State law requires the ARB to review and approve the appraisal records by July 20, or when not more than 5 percent of the total property value in the district remains under protest.

Flag Day Is June 14

"On this day our nation commemorates two events which are so much a part of our tradition and so much a secret of our success. They are events which precede, and give meaning to, many of our other holidays. Today we observe the 215th birthday of the United States Army and the 213th birthday of the American flag," said Lt. Col. Charles S. Beeson, Army recruiting commander for the state of Oklahoma, the Texas Panhandle and southwest Kansas.

How appropriate it is that these two birthdays be celebrated on the same day. For throughout our long and proud history, the Army and the flag have constantly been together. Soldiers have long protected the flag from danger and destruction. The flag has long inspired soldiers to accomplish feats that might have seemed impossible. History gives ample testimony to that relationship.

When the fight for freedom began at Lexington, Mass., on April 19, 1775, America was simply a group of disorganized colonies. There was no Army, no national flag, no recognized leader.

"What we did have was just a group of farmers, merchants, craftsmen and other banded loosely together in local militias. Hardly a force that would instill fear in the British Army. Hardly a threat to the King's rule, the greatest Army in the world at that time.

"Yet this group of unorganized colonials would kindle a fire. At first just a little smoke, then a few flames! Soon a blaze of epic proportions would sweep the colonies and it would not be extinguished until freedom was achieved in America.

"However, the fire would never have grown if an Army had not been created. Unity was needed--the unity of an organized fighting force led by a strong leader. Thus, on June 14, 1775, the Second Continental Congress adopted the militia of New England as its 'Continental Army' and appointed a committee to draft 'Rules and Regulations for the Government of the Army,'" continued Beeson.

On that same day, the Congress resolved to add citizens of other colonies to the Army. The resolution read in part:

"Resolved that six companies of expert riflemen be immediately raised in Pennsylvania, two in Maryland, and two in Virginia;... That each company, as soon as completed, shall march and join the Army near Boston, to be there employed as light infantry, under the command of the Chief officer in that Army..."

The very next day, that chief officer of the Army was named. Congress appointed a Virginian by the name of George Washington. The newly created force had the leader it so desperately needed. The rest, as they say, is history.

"It's the history of famous battles from Yorktown and

Gettysburg, to Guadacanal and Normandy. It's the history of strong and exceptional Army leaders such as Andrew Jackson, Ulysses S. Grant, John J. Pershing and Douglas MacArthur. It's the history of sacrifice and struggle by millions of Americans who've worn the Army uniform in every decade of our existence.

"And as those millions of Americans trained to be soldiers, as they endlessly drilled and marched on parade fields, they could always look up for inspiration when things got tough. They could look up to the nearest flagpole and see waving in the wind a vivid reminder of their country--the Stars and Stripes," said Beeson.

The Army was already two years old, and had been through a number of battles, when the American flag was born. The Continental Congress authorized the Stars and Stripes as our national flag on June 14, 1777. Thereafter, it quickly became a proud and visible symbol of our struggle for freedom.

When George Washington first saw the flag being flown above his Army he was struck by its beauty and symbolism. He is reported to have said: "We take the stars from heaven, the red from our mother country, separating it by white stripes, thus showing that we have separated from her, and the white stripes should go down to posterity representing liberty."

From then on, much as siblings do, the Army and flag grew up together. As the nation expanded its borders westward, the Army was the forefront. So, too, was the flag. When a threat against America arose, the Army marched to the battlefield. So, too, did the flag. And when the country assumed a role as world power and defender of

democracy, the Army was there and so was the flag.

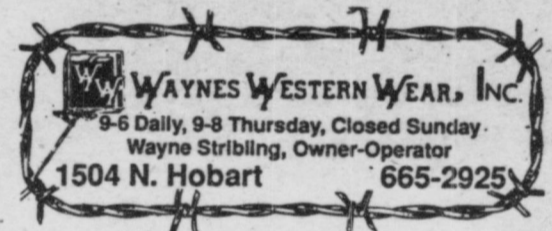

 Southwestern Bell Telephone Company has instituted a Class Action Lawsuit seeking judicial approval of a settlement reached in Docket No. 7297, an inquiry of General Counsel of the Public Utility Commission of Texas into possible overcharges which occurred between September, 1976, and February, 1987, due to rounding practices, on bills of intrastate WATS/800 customers sent by Southwestern Bell and other telephone companies which concur in Southwestern Bell's tariff. The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant," and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

O. Box 650376, Dallas, Texas 75265-0376, to request a WATS Refund Information Package. The WATS Refund Information Package will contain further information regarding the lawsuit and eligibility for a refund, a description of documentation required to support a customer's claim for refund, and a refund claim form to be filled out and submitted requesting a refund. 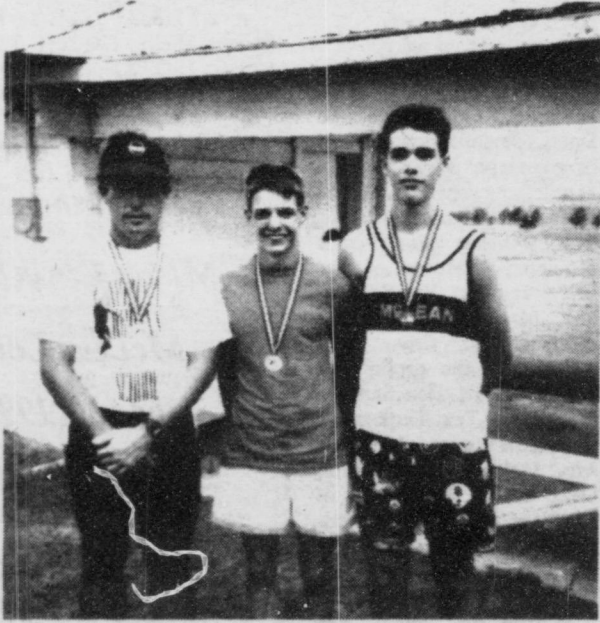
Mrs. Billy Joe Skipper requested that stop sign be put up at Second and Kingsley intersection. The council voted to first try yield signs facing North and South.

David Hauck Charged, Investigation Continues

A 19 year-old McLean man was charged with sexual assault Thursday stemming from a violent Tuesday morning attack on a 17-year old girl.

David Kane Hauck was arraigned on the charge Thursday in Pampa before Precinct 1 Justice of the Peace Bob Muns.

Muns on Tuesday had arraigned Hauck on an aggravated assault charge connected with the same incident. Hauck remained in the Gray County Jail late Thursday in lieu of bonds of \$15,000 and \$50,000.

The victim was listed in satisfactory condition Thursday at Northwest Texas Hospital in Amarillo, a nursing supervisor said.

Law enforcement officials, Gray County Sheriff's Deputy Wayne Carter said, responded to a call at a McLean residence about 7 a.m. Tuesday.

Investigators found the woman in the house suffering from multiple head

wounds, Carter said. She was transferred by ambulance to Coronado Hospital in Pampa and later transferred to Northwest Texas.

Carter said the woman was moved from the intensive care unit to a private room Thursday.

Hauck is accused of sexually assaulting the woman, then beating her repeatedly with a wooden chair leg, Carter said.

The owner of the house was asleep in a bedroom at the time of the attack, Carter said.

The case is still under investigation, he said. In addition to Carter, investigators are the Gray County sheriff's office, Precinct 4 Constable Jim McDonald and Gray County Department of Public Safety Trooper Ron Shank.

Carter said information will be turned over to Gray County District Attorney Harold Comer.

OLD ROUTE 66

The saga of "The Mother Road," or Old 66, started in the early 1920's as the automobile was developed. 1926 seems to be the year Old 66 was born. Paving and roadbed work went on until 1937 before being completed. Although varied terrain and unexpected conditions were met daily, politics impeded completion more than anything else.

The exact length of Old 66 seemed to vary from time to time, as routes were continuously being changed. It is spoken of as being 2400 miles. In Texas, we have 178 miles, depending on what year you measure it.

We started with a dirt road from Groom to McLean. It crossed and recrossed the Rock Island railroad several times, and the

ditches and roadbed are still visible along our north boundary fence here on the ranch. We have found fenders, wheels, a clay beer bottle, strange pieces of metal and other items that we know must have come from travelers.

One old timer raised in Groom told me that every Sunday during the summer, he would load up all the girls he could get to go, and they would come to Alanreed and buy watermelons. He showed me a particular draw and trees where they would stop on the way home and eat the watermelons. This trip took all afternoon and top speed was 25 MPH downhill. Later the road was changed to the north side of the railroad, and eventually designated as Highway 66.

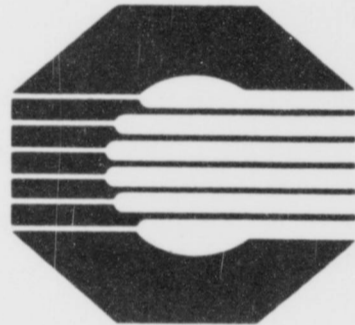

Donations Reaching Goal For Moving Conway Community Church

Seventy-eight years ago a determined and dedicated group of women living in and near the little town of Conway on U.S. Hwy. 60, east of Amarillo and south of Panhandle (west of Groom; north of Claude), conducted a door-to-door campaign to raise funds for the construction of a church in their community. The response they met reflected the need for their goal. The 35' x 45' wooden church was dedicated in 1913.

Today it still stands--unused for the past 23 years, but silently echoing with memories that keep it warm. What will its condition be next year?

That question concerned several people a couple of years ago and they set their sights on the goal of the building's preservation.

Seeking advice from Don Markham, director of the Carson County Square House Museum, the group launched a drive for support in the fall of 1988. Through letters, word of mouth and newspaper articles, they have been able to contact many people who had past connections with the little church asking them for help in the financial part of the project.

Today, less than two years after the project was started,

the response is growing. Plans are to move the original structure to a plot of land adjacent to the Square House Museum in Panhandle and restore it. The restoration committee, chaired by Melba Miller of Panhandle, is also endeavoring to replace as many of the original furnishings as possible.

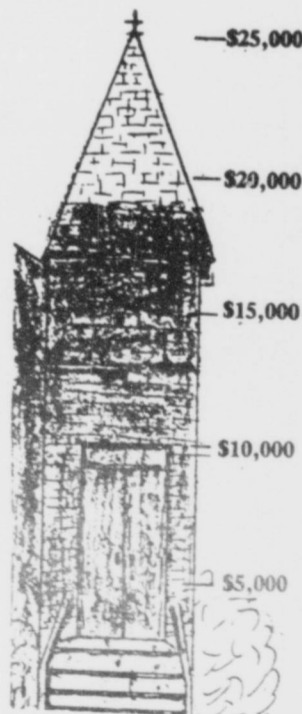
Moving the church was deemed the best way to preserve it. Being near the museum will be protected from vandalism, can be maintained on a regular basis, will become another part of history to be viewed by museum visitors and will also be designated as a place for small weddings, wedding anniversary celebrations in which couples renew their vows, or a place of quiet personal worship in a non-denominational atmosphere.

It was recommended that \$25,000 be raised before anything could be done toward the actual moving of the building. The first big boost to the goal was the land, purchased and donated to the project by Agnes Howe of Panhandle.

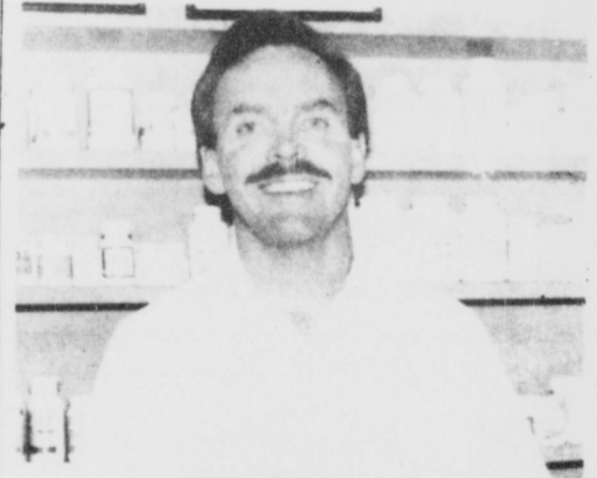
Recent donations in the form of memorials have created a lot of excitement for those who have taken the project to heart. As indicated in this "goal

sketch" of the church, over \$17,000 of the \$25,000 is "in the bank" and the dream is coming very close to reality.

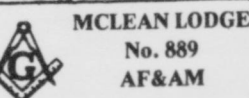
