The mascot will try out at the same time as the cheerleaders, but will perform a different routine. To save time, the mascot will be considered and referred to as part of the cheerleading team with the same rules applying to the mascot as well. If there is no one elected as mascot, the cheerleading team will consist of only six High School cheerleaders for the next year.

Cheerleaders are a vital part of GISD. They are very important in establishing and maintaining school spirit and morale. They are expected to be true school leaders and to set the example for students at GISD at all times. The school spirit of our school depends very much on the

The cheerleaders have a faculty sponsor who accompanies them with transportation provided on official out-of-town all games and who will be with them for all in-town games. (the principal will act as cheerleader sponsor if the sponsor cannot be present).

General Guidelines for ALL, cheerleaders:

1) CHEERLEADERS ARE TO:

Plan the Α. advertising of games with signs, announcements, etc.

B. Plan and carry out the pep rallies.

Wear the C cheerleading uniforms that have been approved by the cheerleading sponsor when representing GISD at any athletic contest.

D. Lead cheers at athletic contests.

E. Work cooperatively with each other and the sponsors to provide unity

among all cheerleaders. CHEERLEADER 2) CAPTAINS:

The cheerleader sponsor will choose a cheerleader captain after elections are made. The choice will be based on the leadership ability, attitude and work ethic of the newly elected cheerleaders.

3) ABSENCES FROM GAMES/CONTEST:

Cheerleaders are to be present at all required games, that is, all Varsity and home Junior Varsity games, unless the sponsor or principal specifically instructs you in not going. If a game is to be missed, the sponsor should be notified personally at least one day before the game to be missed. Failure to do so will result in a one week's suspension from cheerleading duties; the third failure to do so will result in the cheerleader being removed from cheerleading duties for the remainder of the year.

4) ABSENCES TARDIES FROM PLANNED PRACTICES **OR MEETINGS:**

Cheerleaders are to attend all practices and meetings as called by the sponsor or cheerleader captain. If a cheerleader is more than 5 minutes late without excuse by the sponsor, it will be considered unexcused an absence from cheerleader practice. The second and third - missed practice without approved excuse will result in the cheerleader being suspended from cheerleader duties and privileges for one week; the fourth unexcused absence from practice may result in

removed from cheerleading duties and privileges for the remainder of the school year. Failure to contact the sponsor is considered an unexcused absence regardless of the reason.

5) Cheerleaders participating in sports will be released from cheerleading duties to participate; they will be required to up hold their responsibility as cheerleaders when it does not interfere with the sport in which they are involved.

6) Cheerleaders are to refrain from smoking, chewing, drinking of intoxicating beverages, drug usage, or being in the possession of tobacco products, alcoholic beverages of any kind or drugs. Cheerleaders are to refrain from any conduct that is unbecoming as a young adult during their term of office (this includes immoral conduct). Failure to follow this rule may result in immediate removal from cheerleader duties and privileges for the remainder of that term of office.

7) Cheerleaders are to attend school regularly and not cause disruptions at any time; if a cheerleader is truant from school, disrupts class/school, etc., a two week's suspension from cheerleading duties and privileges may be assessed for the first and second violations with permanent removal from cheerleading upon the third violation.

8) Cheerleader eligibility will be determined in accordance with UIL guidelines.

9) Cheerleaders are to attend one cheerleader camp (determined by the principal and sponsor) in

Practices the summer. before cheerleader camp will be scheduled and all cheerleaders are to attend unless excused by sponsor and or principal.

10) All cheerleaders are to be courteous, fair and respectful to opponents. They are to set good examples for all spectators and fellow students. They are to treat others as they expect to be treated.

11) Cheerleaders are to follow all rules and regulations that govern all other students at GISD. Failure to do so may result in removal from cheerleading duties and privileges for the remainder of the school year.

12) Possible expenses for cheerleaders may be \$350 at the most for uniforms. Half of the amount for the uniforms will have to be paid on or before the day the order is made.



Amendment To Animal Ordinance An Ordinance Providing For An Amendment To the Groom City Code To Prohibit Livestock

Within The Corporate Limits Of The City Of Groom

Be It Ordained By The City Council Of The City Of Groom, Texas:

SECTION 1: That Chapter 3, Article 1, Section 3-1 of the Groom City Code be amended to read as follows: Section 3-1: Unlawful to keep livestock within City Limits.

A. It shall hereafter be unlawful for any person, firm or corporation to keep or maintain any livestock within the corporate limits of the City of Groom. As used in this Ordinance, "livestock" means cattle, horses, goats, and other domestic animals generally used or raised on a farm.

B. The prohibition against livestock being kept within the City Limits as described in paragraph A above shall not apply to the following:

(1) All livestock owners who are legally keeping or maintaining livestock within the City Limits at

the time of the passing of this Ordinance; The exemption described in the foregoing paragraph B(1) applies only to existing livestock owners as long as they own the property where the livestock is currently being kept or maintained at the time of the passing of this Ordinance;

The exemption described in the foregoing paragraph (1) is not transferable or assignable to any other person, firm or corporation.

(2) Lots Nos. 22, 23, 24, 43, 44, 45, 46, 72, and 73, in the Original Town of Groom, Carson County, Texas, as shown on the recorded map or plat of said town are exempt from the provisions of this Ordinance.
