## Appraisal District Salaries Bite Into Budget

The Carson County Tax Appraisal District is to hold a public hearing on their proposed budget for the 1994 fiscal year. The hearing will take place August 12, 1993 at 9:00 a.m.

The Appraisal District collects taxes for each school and city in the county; whereas cities and schools used to use their own secretaries and business managers to collect local taxes, it now takes four additional full time employees and a total budget of \$217,945.00 to get the same job accomplished.

In their proposed 1994 budget presented to taxing unit officials dated April 15, 1993, Donita Herber, chief appraiser, spells out some of the line item justifications for changes although no dollar amount increases are

noted

Salaries take the biggest bite out of the budget totaling \$106,760.00 including benefits such as retirement, group health care, workman's compensation, unemployment insurance and plan A medicare.

Chief Appraiser, Donita Herber, is a Level III appraiser as of March 1993. Her salary will include a \$1,000.00 raise, making her total wages \$29,000.00. Mike Darnell, a Level IV appraiser, will receive \$22,000.00 in '94 increasing his salary \$1,000.00. Nila Burgin a Level III Assessor/Collector will also receive a \$1,000.00 raise if the budget is approved making her salary \$20,000.00. Debra Arnold is the district's registered tax collector and mapping. She will receive the largest increase of \$1,500.00 placing her salary at \$17,500.00.

In addition to salaries the appraisal district has a \$450.00 per month car allowance which amounts to another \$5,400.00 per year

expense.

Travel and training costs mount up to \$5,500.00 per year.

Accounting and auditing takes the next biggest bite out of the budget with

\$29,000.00. Data Processing is expected to be increased \$400.00, due to the addition of a terminal in Herber's office, for a total of \$19,400.00.

A summary of the appraisal district budget follows:


The total amount of the proposed budget is \$217,945.

The total amount of increase over the current year's budget is \$-0-.

The appraisal district is supported solely by payments from the local taxing units served by the appraisal district.

If approved by the appraisal district board of directors at the public hearing, this proposed budget will take effect automatically unless disapproved by the governing bodies of the county, school districts, cities, and towns served by the appraisal district. A copy of the proposed budget is available for public inspection in the office of each of those governing bodies. The proposed budget may also be viewed at the appraisal district office.

## As The Interstate Turns . . .

## Carson County Sheriff's Report

By Loren Brand, Sheriff County The Carson Sheriff's Department is currently investigating prescription drug overdose which occurred in Fritch. A teenage female was transported to the Borger hospital for treatment in the matter.

Our department received a report of persons from Missouri attempting to defraud local residents by tricking and intimidating them into buying lightning rods and roofing work. In one case, residents had issued a check for over \$4,000.00 for services to be performed by the suspects, but they were able to put a stop payment on the check before it could be cashed. These suspects were identified as two white males in their mid to late thirties, driving a white pickup loaded with roofing materials. The pickup has Missouri license plates. While we believe that the suspects have left the area, residents are encouraged to call the Sheriff's

Department when you are suspicious of persons using aggressive sales methods. Our department is also investigating reports telephone solicitors attempting to gain credit card numbers to use for donations in support of a law enforcement organization. Once again, when you have questions, please give us a call and we will attempt to investigate the organization to see if it

is legitimate or not. Sheriff's Department officers were called to assist at a truck fire on Interstate 40 and for a car fire also on Interstate 40 (the calls were unrelated). No injuries were reported.

A woman called the Sheriff's Department to report that her ex-boyfriend had broken into her home and assaulted her. Further investigation revealed that the woman had given false information to our department and that she was the assailant in an assault which had taken place earlier that day. The

male declined to press charges.

Arrests received at Carson County Jail this past week include: 1 - DWI, 1 -DWI Commitment, 1 -Assault w/Injury, Warrants and 1 Unauthorized Use of a Motor Vehicle.

Our department is currently assisting the Department of Human Services/Child Protective Services with newly reported investigations of familyrelated sexual and physical

The Sheriff's Department is investigating incidents of cruelty to animals in the Fritch area. These cases have involved gluing small animals eyes shut and attempting to hang the animals or beat them with boards. We have a suspect in the cases and are attempting to gain sufficient evidence for prosecution.





## McLean School District Budget Allows For \$4,255 Per Student

Despite a 1.2% drop in property values, school trustees raised tax rates to produce 9.5% more revenue last year. School budgets were increased \$1.5 billion last fall for a total of \$18.7 billion. The total budget averaged \$5,284 per student. Classroom teachers received one dollar in four of the additional sperding. Schools added 17,007 employees - an average of one new employee for each 4.8 additional students.

The figures come from the latest issue of "Hench Marks 1992-93 School District Budgets in Texas", at publication of the Texas Research League, an Austin-based, educational corporation engaged in governmental research.

An average of \$4,255 per student for current operations was budgeted last year plus \$337 for repayment of debt and \$602 for capital outlay.

McLean ISD's budget provided \$6,568.45 per student for current operations, \$80.54 for debt service, and \$8.45 for capital outlay based on 207 students enrolled in October

The average base salary for classroom teachers paid by McLean ISD in October 1992 was \$26,221. plus supplements for the career ladder. The average for administrators was \$43,287., and \$32,038. for other professional support employees (librarians, counselors, nurses, supervisors, etc.).

Four dollars in each five were spent for salaries. Statewide payroll expense averaged \$3,439 per student, as compared to \$4,895.58 in McLean ISD. Payroll expense is determined by salary levels and staffing patterns.

Taxpayers provided one teacher for 9.6 students in McLean ISD while the statewide pupil-teacher ratio was 16.1 to one.

School districts and county education districts imposed a property tax at the rate of \$1.405 per \$100. of appraised value, which value averaged 98.6% of market value (selling price). The "true tax rate" was \$1.385 (\$1,405 times 98.6%) Locally, the statewide. McLean ISD imposed a rate


of \$1.374 including \$.894 by the county education district. Property was appraised at 101.0% of its market value making the true rate \$1.388 per \$100. of market value (selling price). The report points out that the calculation of a true tax rate based on market value rather than on appraised value is necessary to make a valid comparison of tax levels with other schools.

The tax on a house that would sell for \$80,000. in McLean ISD would have been \$1,271. If the homeowner were eligible for homestead exemptions, the tax would have been \$1037. That compares with statewide average tax bills of \$1,078. and \$854. respectively for an \$80,000. house.

Last year McLean ISD's revenue from the property tax increased by 16.0 percent for 1992-93 as compared to a 9.5 increase statewide.

Local property taxes plus state aid totaled \$5,391. per student in McLean ISD as compared to \$4,243.

The Second Place Individual Carcass came in with 15.5 square-inch ribeye, 0.24 inch backfat, Low Choice and a 1.11 yield grade.

The state and local share of the foundation program averaged \$3,144. per student last year and was \$4,141. in McLean ISD. Local school districts can levy property taxes to enrich the foundation program. Enrichment last year averaged \$822. per pupil to which the state added an average of \$433. per student to guarantee the tax yield in property-poor districts. Enrichment by the McLean ISD was \$1233.; the state guarantee added \$360.

For the coming school year, the local share is increased from the 82-cent rate by county education districts to an 86-cent rate levied by school districts. The percentage homestead exemption and freeport goods exemptions voted for CEDs will terminate. The legislature increased state aid an average of \$3,990. for each addition student as compared to an average of \$1,825 for all students last year.

Adults and children over the age of 6 months need not be concerned about drinking water from the tap. An excess of Nitrate intake by an infant under the age of 6 months may reduce its available oxygen supply and possibly produce "blue baby" symptoms. Parents are advised to find other sources of drinking water such as bottled water, for their infants under 6 months of age. All doctors and hospitals in the area have been notified of this situation. The city will offer to provide bottled water of acceptable quality to pregnant women and to infants under 6 months of age for cooking and

drinking purposes.
