Groom Says Yes To Amendment 17

Mayor Alfred Homer of the City of Groom today expressed support Amendment Number 17 on the November 3 general election ballot. The Mayor said that Amendment 17 must pass if Texas cities are to successfully face the liability insurance crisis which has plagued municipal government for several years.

Amendment 17 empower the state legislature and not the courts, to determine how much liability a city has for each of its activities. Some municipal activities, known as 'governmental' activities, are subject to limits of liability. For other activities, known as "proprietary" activities, the city faces unlimited liability.

This amendment will finally bring some predic-tability to the municipal in-surance marketplace," the Mayor said, "because it will allow the legislature to specifically determine which activities are governmental and which are proprietary. I believe that with predictability will come stabilized insurance costs."

Historically in Texas, the courts have decided whether a municipal function was governmental or proprietary "Each court decision changed the playing field," the Mayor said, "and insurance premiums continued to climb, if coverage was available at all."

The Mayor noted that premiums for municipal liability insurance have skyrocketed in recent years, and pointed out that taxpayers suffer when municipal insurance rates increase, because taxpayers ultimately pay the premiums. "We believe that over the long term, Amend-ment 17 will help hold costs down." the Mayor said.

The Texas Municipal League, of which the City of Groom a member, resoundingly endorsed passage of Amendment 17 at the League's Annual Conference in Fort Worth on Oct. 10.

Local law enforcement officers spent most of Monday investigating a number of incidents of vandalism that occured in Groom Saturday night and early Sunday morning. Officers expected to file criminal mischief charges against several

The juveniles destroyed flower beds at the Church of Christ, chopped down two trees on lots owned by Cobb Britten and stole a number of pumpkins from residents' porches and smashed them in yards throughout town. Two road signs near the school were also ruined by

Officers suspect that juve-

niles arrested Saturday night in White Deer are responsible for the acts of vandalism in Groom as well. In White Deer, Halloween decorations in the front yard of the Al McComb home were stolen as well as a number of pumpkins, past their prime, being smashed in yards of White Deer residents. The McCombs stated Monday that they planned to file charges against the youths arrested Saturday night in connection with the incidents but also requested that the youths be required to do community service as restitution.

The matter has been turned over to juvenile authorities for prosecution.

Texas Yoters Go To **Polls Tuesday To** Vote On Amendments

Voters state wide will have an opportunity next Tuesday to vote on a record number of proposed constiamendments. Voting in Groom will be conducted at St. Mary's Hall from 7:00 a.m. to 7:00 p.m. There will also be two referenda on the ballot. Propositions to be considered on the ballot are as follows:

SB 86: Provides for retaining the State Board of Education as an appointed rather than elected-body. Unless voters approve this proposition, the board is scheduled to return to an elected group with equal representation throughout the state of Texas in 1989.

SB 15: Legalization of





Longino Recalls Career As Combat Pilot During World War II

The following is the second is a series of articles about McLean's veterans The stories are being run to commemorate Veteran's Day, Nov. 11th:

If you want to meet some one who has probably been in just about every state in the union, you should talk to Ted Longino. The son of a Methodist minister, his mobile way of life started out in infancy and has continued through his adult years.

He was born in Burgir, Ky. but after only one year made his first move to Kempton, Ind. By the time he was a teenager, he was in Texhoma, Okla. where he began high school. During his sophomore year, he ard his family moved to Hamlin, Tx. where he graduated in 1937. His family had moved school but his grandmother and sister had stayed with him in Hamlin until he graduated.

After high school, he joined his parents in Munday, Tx. and worked for a dry goods store. Enrolling at McMurry College he alternated between working and going to school until May, 1942 when he joined the

Longino applied for the Aviation Cadet Program in Abilene. Because of a long waiting list, he had to enter the infantry and wait for an opening. He was first assigned to a base in Mineral Wells and later transferred to Wichita Falls

where he went through basic

After boot camp, his appointment to the aviation program still hadn't come through so he served a hitch at a base in Fort Myers, Fla. Finally, in Oct. 1942 he was notified that his appointment had finally come through and he reported to San Antonio. After arriving there, he went through testing to determine his aptitude as a pilot. He passed the exams and went from San Antonio to Nashville, Tenn. and then to Stanford, Tx. for training as a pilot.

After this initial training, he moved to Enid, Okla. for more training and testing and was then assigned to bombers. After one more training hitch in Frederick, Okla. he graduated form the with the rank of Second Lieutenant.

His first post-graduate stop was in Dodge City, Kan. where he was trained to fly a B-26 twin-engine bomber. Then, it was on to Dalhart where he flew in a tow-target squadron. As Longino explained it, "We would fly a B-26 towing a white target which would be shot at by B-17 heavy-bomber gunner crews for practice." Longino says that as a joke the gunners would always say, "We can see the target planes but what's that white thing dragging behind it." After gunnery practice, Longino's crew would drop the target off and fly back up

and simulate fighter attacks against formations of B-17's. The fake attacks would be filmed and the school instructors would use the film to see how well the gunners

Later, Longino was trans-ferred to Pueblo, Colo. where he also worked in a tow-target squadron. After a while, members of the WASPs (Women's Air Force) took over these duties and Longino's squadron was split up and released for combat duties. He went back to school in Murfreesborough, Tenn. to train as a pilot for a B-24 four-engine bomber. After training was completed, he went to Lincoln, Neb. to pick up a crew and then all of them trained as a crew in Tuscon, Ariz. After one last stop in Top-eka, Kan., to pick up an airplane, the crew was assigned to go overseas in

Longino's plane stranded by bad weather in Bangor, Maine but eventually took off for the trip overseas. They stopped in the Bahamas to refuel and then took off with 23 other planes for a trip to the Azore Islands in the Atlantic Oc-

Before leaving the Bahamas, Longino said, the weather officer had told the bomber crews that a weather front was coming through but would pass through quickly. The crews took off and soon hit what turned out to be a killer storm. Longino and his crew flew on instruments for six hours at night because the storm was so bad. Because of a communications blackout the planes couldn't use the radios to get a fix on their positions, and the clouds were so thick that they couldn't use the stars to figure out where they were. As Longino said, "It rained, hailed, sleeted and snowed. Once during the night, we got caught in a downdraft and the plane fell 8,000 feet in 30 seconds."

The storm was so rough, he said, that "out of the 24 planes which started on the trip, six had to turn back and six safely reached the Azores. The other 12 planes were never heard from again."

The arduous trip lasted 12 hours but finally Longino's plane made it to the Azores. The crew got to rest briefly and then took off for their next destination, Africa. From Africa they made their way to Italy where they were involved in combat from Dec. 1944 until May, 1945.

Monthly Checks to City **Show Slight Increase**

State Comptroller Bob Bullock recently sent checks totaling \$55.3 million in local sales tax to 904 cities levying the one-percent city tax. This year's payments are down by 5.5 percent overall compared to payments made by October of 1986.

McLean's check for this period was \$1,282.22, up from \$1,135.19 for the same period last year. However, year-to-date payments are still down. Payments to date for 1987 are \$15,067.61 compared to \$15,987.56 for 1986 a drop of 5.75 percent.

As has been the trend all year, Gray County as a whole showed a decline: \$1,000,535.90 for 1987 compared to \$1,199,997.01 for 1986. This is a decrease of 16.62 percent.

Pampa's revenue declined by 16.73 from \$1,178,621.29 in 1986 to \$981,479.47 in 1987. Lefors continues to suffer the biggest loss: \$5,387.76 in 1986 compared to \$3,988.82 in 1987, a decline of 25.97 percent.




