# Mayor, Two Council Seats Open For 1993 Election

Before long voters in the Groom area will be turning their thoughts to the spring elections.

Filing will open for positions on the School Board and City Council beginning February 16 and continue through March Qualifications for potential candidates are that they have been a registered voter in the district for 30 days and a resident of the state for 60 days.

On the school board Tony Treadwell and David Britten hold the seats that will be up for grabs.

Tony Treadwell told the News, "I will not run."

David Britten stated, "I do not intend to run if someone else will file for the position."

Although, this is pretty early to be deciding, candidates should be thinking about it.

At the City level, voters will decide on Mayor as well as two council member slots. Ronny Fields and Jerry Thornton are the two who's terms will expire.

# **Pat Ashford Retiring** After 13 Years Service

City Secretary, Ashford, presented her formal letter of retirement to Groom City Council members last week. Ashford has been the "pulse" of City government since 1980 replacing Gail Hanna. Her retirement will become effective on July 1, 1993. City Council will begin taking applications for the position immediately. A called meeting has been set for February 2nd for consideration of applicants. The regular meeting on February 9th will include the announcement of the replacement.

A probationary period of 6 months will be required, along with a starting salary of \$1,000.00 per month for three months increased to \$1,200.00 per month after that time.

In other business the American with Disabilities Committee gave a report to the City Council, and all of the requirements of the act are being worked on. Parking areas will

marked as soon as weather improves. The need to make the library rest room wheel chair accessible was discussed and will get ruling from the state office. Mayor Jimmy Britten dismissed the committee, and all future needs will go before the City Council.

Mr. and Mrs. Meaker met with the Council to discuss fencing and car port. The Council asked that eight foot be taken off carport as agreed to December 12, 1991. The Council will discuss this at a later date with Mr. Meaker.

A public hearing was held regarding property at Section 93, SE Part and Block 1, Lot 9 of Homen Addition. The property is being brought in compliance at this time with the City and the City will not take further action at this time.

The board unanimously voted to adopt the 1991-92 audit.

A \$9,000.00 exemption for those over 65 on the tax roll was unanimously approved.

Word has been received that Mrs. O.P. Blackwell fell while visiting her daughter and son-in-law in Clarksville, Texas. She fractured her hip.


Granddaughter, Marcia Conrad, reports that she is doing well and has been moved out of ICU.







### SHERIFF'S REPORT

By Loren Brand, Sheriff

Once again, we have experienced a week of inclement weather resulting hazardous road conditions. Sheriff's deputies assisted the Texas Highway Patrol on a number of traffic accidents over the past week. Although some injuries were reported, there were no fatalities as a result of these accidents.

Following indictments of the Carson County Grand Jury, one subject was formally arrested for Theft Over \$20,000.00 and one for Indecency with a Child.

The Carson County Sheriff's Department is working with the Tempe, Arizona Police Department investigating the theft of a van from Tempe. stolen van was found in a field near Conway. The van had been stripped and peppered with bullet holes. The vehicle will be stored in Panhandle pending further investigation.

The Sheriff's Department is investigating a continuing case of vandalism at the State Highway Department comfort station near Groom. A suspect has been observed and we are following up on the information.

This past week, two subjects were arrested in Shamrock for their involvement in the death of a motorist on I-40. The two suspects had been

hitchhikers on the Interstate. I would like to bring this matter to your attention and again remind everyone travelling the interstate to

dealing with hitchhikers, stranded motorists and anyone else you encounter on the highway.

We are privileged to live in a county with a minimal crime rate by comparison to some of our neighbors. Although our crime rate has been rapidly increasing, the most prevalent problem we encounter is suspects/offenders from other jurisdictions. people we have been dealing with are very One suspect dangerous. apprehended in Groom was wanted for Aggravated Assault and Rape and was also wanted for questioning in a series of homicides of elderly women. Another suspect left his vehicle in Conway after killing his uncle in North Carolina and fleeing to California. This man was holding three hostages and taking them into the mountains to kill them when he was apprehended by the California Highway Patrol.

My point is that your safety is the primary concern of my department, the Texas Highway Patrol and all other law enforcement agencies. To provide for your safety we need your cooperation. Please report any sightings of suspicious person or to our We will department. investigate the calls to see if the persons are wanted or if they genuinely need assistance. FOR YOUR OWN SAFETY, do not pick up hitchhikers and do not stop for what appears to be a stranded motorist. Let our officers make the





# Alanreed ISD's Fate Sealed

Voters in Alanreed face perhaps the toughest decision any community ever has to make, that is, to answer the question as whether or not to close down their school. Except it is not really as clear cut as all that. The no win situation will leave Alanreed with no school no matter how the voters cast their ballot.

The election will take place on January 16 from 7 am to 7 pm, in the Alanreed Gymnasium.

If they approve abolishment of the district, county commissioners in Gray and Donley Counties will then assign the territory that once made up Alanreed ISD to nearby setupol districts; McLean and Lefors most likely.

However, what will happen if the voters say, "No"! We don't want to abolish our school!"

According to go. Superintendent Billy Bob Adams there are a couple of options, "Voters could for a consolidation

election with any other school district except McLean."

That issue was decided in November and January when Alanreed residents rejected consolidation with McLean. That particular issue could not come up again for three years.

Another option would be to vote the measure down and then leave the District in existence, but not have school next year. At the end of the year the county commissioners would then decide which school district would get what territory, essentially the same thing that will happen if the question passes.

Mr. Adams stated, "My main concern now is what will happen to the Community of Alanreed." He had no comment to the preference of which school district the student would

"About half of our students live closer to McLean, and half live closer

The current budget of about \$250,000 will finish

out the year for Alanreed. "We send 100% of our tax dollars to the CED," said Adams "We get 30% back. Pampa contributes 100% and gets 140% back... McLean gets 130%.

Out of our budget we pay tuition for our high school students to attend school in McLean. We pay the cost of their transportation, as well.

The same fate found another small town, Lela, last year. This spring their dormant school district will be divided as seen fit by the county commissioners.

Another problem is what will happen to the buildings belonging to the school system. They can't be donated to the town because they are not incorporated.

Adam's is hoping that who ever takes them over will care enough about the community to maintain the buildings.

# **Board Approves Energy Program**




#### Windbreak Trees Offered




