Groom Volunteer Firefighters ROAD CONSTRUCTION AHEAD Spend Fourth Of July Fighting Blazes In Carson, **Armstrong County**

Firefighters deserve a medal that kept them busy from Friday through Monday. However, firecrackers were not the cause of most of the trouble that kept the Groom-McLean men operating in shifts almost around the clock.

Three weeks of 100+ weather has the countryside dry as a tinderbox just waiting for a spark. Momentum began building Friday with median fires and grass fires. In all the Fire Department responded to 13 calls on Friday. A spectacular lightning storm caused several CRP grass fires and set several bales of hay to blazing out at the feedlot.

Saturday, the firefighters responded to five calls including a small grass fire

in the alley at 4th and Ware. Highline wires had fallen and sparked the blaze. They also were called to Armstrong County to help with an out of control brush

"They (Armstrong County) have lost between 12,000 to 15,000 acres, and has been declared a state of emergency," stated Fire Chief Tony Treadwell. "The

Groom Volunteer fire burns out of control, much like you see in the after this weekend's events California fires. When it gets down in the breaks of the canyons there is not much you can do. Cedar trees explode like bombs."


The men saved two houses Saturday and lost one to the blaze. The house that was lost belonged to a doctor from Amarillo who used it as a weekend retreat.

No one in this part of the country has equipment to fight this kind of fire," he continued, "The best we can do is wait until it comes up out of the canyons."

One of Groom's firetrucks nearly met with disaster. The Army tanker was in some pretty rough country when the vehicle died. Efforts to restart the truck were in vain. Finally, with the threat of fire closing in around them they had to abandon the truck. Just in the nick of time, Tony Treadwell and John Bohr made it to the vehicle, jump-started it and got it out just before it was engulfed in flames.

With as little as four to eight hours sleep in 48 hours the firemen were glad to see this July 4th end.







On Friday, June 3rd two Oklahoma youth were arrested on I-40 near Conway for Possession of Drug Paraphernalia. Both men pled guilty before Justice of the Peace Phyllis Tyler. POOL SENTENCED

Roy Lynn Pool, formerly of Groom, pled guilty to one count of bank fraud in connection with two area financial institutions. She was sentenced to 15 months in prison Wednesday in Amarillo's U.S. District Court.

Roy Lynn Pool, 39, also was ordered to pay \$134,190 restitution to an AmWest Savings Association in Pampa and \$12,750 to The First National Bank of Panhandle.

According to court documents, Pool devised a scheme to fraudulently obtain money, funds and credits owned by AmWest and The First National Bank of Amarillo.

Pool, using her position as bookkeeper and secretary for the owner of several businesses, including a cattle company in Groom, deposited checks payable to the businessman or the cattle company into her own accounts at AmWest, documents say.

The paper's last rate increase was in 1986, almost eight years ago.

Chief Deputy Lovell Kennard worked with the Hutchinson County Sheriff's Department in the investigation of a Hutchinson County burglary. 



HEALTH BREAK

A major burn is a horrifying injury, requiring painful treatment and a long period of rehabilitation. It's often fatal or permanently disfiguring and incapacitating, both emotionally and physically.

In the U.S., about 2 million people annually receive burn injuries. Of these, 300,000 are seriously burned, and more than 6,000 die of burn injuries, making burns the nation's

third largest cause of accidental death. Burns can result in complications such as respirator distress, hypovolemic shock, anemia, malnutrition, and infection.

If a burn victim is under age 4 or over age 60, he'll have a higher incidence of complications and, consequently, a higher risk of death.

The following guidelines allow you to determine a burn's severity:

* First degree - Redness appears, and the patient will complain of pain. Damage

is limited to the first skin layer.

Second degree Blisters and mild to moderate swelling develop, and the patient will report pain. The first and second layers of skin are damaged. * Third degree - White, brown, or black leathery tissue and inflamed vessels, although no blisters appear. The first and second layers of skin are damaged.

* Fourth degree Damage extends through deeply charred subcutaneous tissue to muscle and bone. If burns are minor, immerse the burned area in cool water or apply cool compresses. Give the patient Tylenol or other analgesic to help relieve Avoid placing ice pain. directly on burn wounds because the cold may cause further thermal damage. Any burns other than minor burns should be treated professionally. Take the victim to the hospital



"As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FmHA emergency loan", Farmers Hesse said. participating in the PIK or Federal Crop Insurance programs will have to figure in proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be accepted until February 7, 1995, but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly over into the new farming season." Hesse said.

FmHA is a credit agency of the U.S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognized farmers who work at and rely on farming for a substantial part of their living. Eligibility is extended to individual farmers who are U.S. citizens and to farming partnerships, corporations or cooperatives in which U.S. citizens hold a majority interest.

Farmers Are Good Welders

By Delbert Trew It seems that all coffee

shops have some pretty good welders present. Most are pipe line welders who have passed all kinds of tests. The dialogue of their accomplishments reach the point to where something needs to be done.

Recently, at the now famous Alanreed Coffee Shop, this point was reached as the residing welders approached the ridiculous. As the son of the man who purchased the FIRST acetylene "generator" in Ochiltree County, now owned by a professional welding shop, and the son of the man who purchased the first D.C. army surplus, 200 amp Lincoln, stolen welder in that county, and as the eldest son of a cowboy who wouldn't touch either one of these with a ten foot pole, and was told at the age of 12 years old, to run both, I felt I had to respond.

After about 10 seconds of thought, I issued a challenge. I would or 248-740

challenge any welder to a contest based on my experience.

The rules would state specifically: A pull-type Gleaner-Baldwin combine would be parked in the thickest patch of grass burrs known. The resulting weld would then be judged and tested by the neighbors. So far, after three years,
