### Commissioners Amend Current Budget For Cost Overruns

Carson County Commissioners, in regular session last Monday, Sept 12, discussed two areas in which the current budget has been exceeded.

The Sheriff's Department is having to pay a greater amount than expected for overtime for deputies. Office supplies and education have also cost more that expected.

The Clerk's office has exceeded the amount approved for part-time help.

The court approved amending the budget in order to take care of these additional expenses.

Lynn Cowden visited with the Court concerning a county road north of Skellytown. He expressed his desire to keep the current asphalt road which is in need of repair. Commissioner Kotara will consider the situation as it now exists and take appropriate action.

District Judge David McCoy informed the Court of his intention to increase the District Court Reporter's salary by 8%.

The court approved and acknowledged the boring of County Road 15-904 (Abell Elevator) in order to install a water line.

New hours were approved for the White Deer Branch Library. The new hours are from 1 to 5 Monday, Wednesday and Thursday afternoons and from 9 am to 1 pm on Tuesdays and Fridays.

The Court refused a proposal to grant 1,584 feet of private road to the county. The proposed road is located in Precinct 4.

Information contained in a document concerning P.I.L.T. (Payment In Lieu of Taxes) was reviewed by Judge Roselius. The PLIT concern taxes which have been lost since the Department of Energy obtained the Pantex property in 1943. It was

pointed out that Carson County and the Water District lost \$236,877.49 in taxes from 1943 to 1994 and a \$1,098,464.03 tax loss was suffered by Panhandle ISD in that same time period.

### Frustrated Sheriff Sounds Off

This is not a report from the Sheriff's Department. This letter is based on my opinions and frustrations with our blossoming trend of apathy and indifference towards the concept of law and order.

This past week another "bad guy" was taken into custody in Carson County after breaking the law in another state (South Carolina, in this case). This subject had an extensive criminal history and was in possession of a stolen vehicle and numerous other articles of stolen property and forged documents. The authorities in South Carolina allowed Texas tax dollars to incarcerate and care for a person who had violated one of their taxpayers, but they refused to follow through on the With no charges, the suspect had to be released in Texas thus making us more of a collection agency for stolen vehicles and a repository for criminals than a law enforcement agency.

This same scenario has taken place several times the past year with agencies in Oklahoma, Florida and

Tennessee.

I don't enjoy public indifference when it comes to the need for change in the criminal justice system, but I can understand it somewhat. I certainly don't understand why a police agency in any state would want to send a message to criminals who prey on their taxpayers that you can get away with stealing, assaulting and molesting.

assaulting and molesting. Our society needs to get a grip on reality before we find that we have "civilized" ourselves into extinction. Our forefathers certainly didn't intend to have suspects in criminal matters tortured or abused when they wrote the United States Constitution, but I elieve that they didn't intend to have this great document adulterated to the point that the criminals have more rights than the victims. If you break the law, you should be penalized. Certainly, we don't have the jails available to incarcerate everyone who breaks the law, nor should everyone who breaks the law be locked up, but doesn't it make sense to lock up the people who are a physical danger to society and keep them locked up and then

put the other offenders to

work to repay, rebuild or correct whatever it is that has been damaged?

We know that a large number of criminals cannot find jobs once they are released from prison because they lack sufficient education, yet we don't keep them in prison long enough to complete the education which is available within these institutions. The State of Texas has an exemplary program of education available (funded by our tax dollars) through the Texas Department of Criminal Justice, but it can't make a dent in the problem of illiteracy if the persons don't stay in the program long enough to complete it. In order to stay in the program we have to keep them in jail.

Our entire system of criminal justice and corrections has been molded by the lawsuits brought on by prisoners who have violated the rights of Texas citizens. Their legal defense and appeals are paid by tax dollars while they are being housed, fed and given medical care, again by tax dollars. Juries who decide the cases that affect this system have become more sympathetic of the criminals than they are of the victims.

It's unfortunate that some persons have had terrible childhoods and abusive parents, but does

responsible for their acts? Should innocent people have to be penalized while we analyze the problems of the suspect's youth on television documentaries and talk shows? What is so wrong with being responsible for your behavior? And why should the proceedings of our criminal justice system be televised and treated with no more respect than a soap opera? We may end up with the fate of O.J. Simpson being decided by his share of the Nielsen

ratings rather than by a

preponderance of evidence.

When you have the opportunity to serve as a juror or to vote for persons who write and pass laws that we have to live with, take this privilege seriously. The rising crime rate in our country touches everyone and it should be everyone's responsibility to become involved in the criminal justice system. If you think that we should be more sympathetic towards criminals, then make your feelings known and be prepared to argue your case. Personally, I think we should concentrate our attention on the victims and I am always ready to stand by this belief.







### School To Purchase Computers, Software

McLean Elementary and McLean High School are getting new computers, following action by the Board of Trustees in their regularly scheduled meeting September 13.

The board approved two computer proposals. The elementary building will receive nine days of teacher training, 17 new computers, cabling, and a variety of new software for a total of \$87,730. New programs include an upgrade of Writing to Read, Stories and More, Writing to Writing and Mammals, a multimedia encyclopedia. School officials hope to have the new program on line by January 1.

The high school will receive a total of 24 stand alone computers with upgrades on several more. The current computer room will get all new computers, and an additional computer lab will be set up in the high school. There will also be three "roving" computers for the classrooms. The package, which has been put out for bids, will include monitors, tables, and software in science, math, chemistry, physics, history, and encyclopedias.

In other action, the board agreed to buy meals for all students who must leave on school trips before school is out or before they have time to eat after school.

Disciplinary procedures in addition to the existing policy were presented by high school principal Rick Reeser and approved by the board. The new policies spell out guidelines for detentions and/or suspensions.

Bill Layman, MHS agriculture teacher, presented a list of items he plans to purchase for his program. Funds for the equipment had been approved earlier in the budget.

The board also approved a resolution authorizing the teaching of traditional moral values. Traditional moral values are defined as determining right from wrong, honesty, integrity, accountability, self-discipline,

sexual abstinence, selfrestraint, sincerity, loyalty, love of country, and respect for and value of human life and property.

The board also moved to abate taxes on property owned by the school in McLean City Block 30, Lots 1 through 30, and donate the land to the park project which was developed by the Computer Math class during the 1993-94 school year.

The board also voted to re-appoint Sam Haynes as the Appraisal District representative.

In closing action, the

board briefly discussed starting a pre-school program. Superintendent Stanley Lamb will check into the details of the program.






