Residentes Se Quejan de Intimidación de Policías

Ciudadanos de Brownfield y Abernathy esta semana se juntaron para formar nuevo capitulos de la organización LULAC. Ambas juntas fueron iniciadas por incidentes que le paso a residentes de las ciudades a manos de la policia.

Residentes de Brownfield estan protestando las acciones de la policia por intimidar a los residentes locales. En un caso reciente un prominente residente de Brownfield fue arrestado y intimidado por la policia cuando salio de su negocio. En otro caso un joven de Comanche murio misteriosamente. Segun informes el cuerpo de el joven tenia golpes por todo el cuerpo. La policia dijo que el joven habia murido de una dosis

excesiva de drogas.

Chevo Morales, director del distrito de LULAC dijo que habia varios conflictos en como habia muerto el joven ya que se le reporto una cosa a la madre del joven y otra cosa al reporte oficial. Dijo Morales que se estaban tomando quejas por escrito tocante el incidente ademas de otros incidentes para ser entregados a el director estatal Oscar Moran.

"Despues de que se junten las quejas," dijo Morales, "se entregaran al Fiscal General Mark White.

En otro caso en Abernathy, mas de 350 personas firmaron una peticion pidiendo que se desocupen 3 policias y un ayudante. Los policias nombrados son el Jefe de Policias, Raymond Narron, su esposa Taffy Narron, Johnny Clayton y un ayudante conocido nomas por Jim.

Segun Arturo Torres, nuevo vice presidente de el nuevo capitulo de LULAC, ya se un juntado 7 quejas por escrito y "tenemos otros 10 que tenemos que escribir todavia." Los residentes de Abernathy estan protestando que los policias han discriminado encontra chicanos y negros de la ciudad. La peticion que se entregara a el concilio de la ciudad pide 5 demandas.

1. La resignación de los ya mencionados.
2. Que se ponga alto a que las policias entren a casa y lugares pividados sin razon y sin autorización.
3. Que todo ciudadano que sea arrestado sea dado la oportunidad de llamar a sus familias

Fiestas '82 Looking Good

The rumor is that the Civic Center didn't want the Fiestas Mexicanas to be held there anymore.

The booking department booked the Civic Center to the Ranching Heritage Association on the same dates that the Fiestas usually take place.

Why would the Civic Center book these dates to someone else when "El Grito De Dolores" and Mexico's Independence have been celebrated there for the past two years by the Mexican-American community in Lubbock?

Maybe the Civic Center didn't want the Mexicanos there anymore. "This rumor is a misunderstanding" president of the Fiestas committee, Carmen Salazar said.

Salazar explained that last year's committee should have booked the Civic Center right after the fiestas were over.

"The Ranching Heritage Association center has always wanted it on the same days that we have been using it, and we had always had it booked tentatively," Salazar said, adding that the Ranching Association went ahead and put the required deposit down which assured them the rental of the Civic Center.

Another explanation that Salazar gave was that the booking person was appointed the director of the Civic Center and said "the new booking person said that she didn't realize that we held this celebration on the dates that she booked the Center to the Ranching Association."

Despite this slip up it looks like the Fiestas are going to come out on top. There are several advantages to having the fiestas at the auditorium and coliseum.

"In looking at the setup of the coliseum all the committee members see many advantages," Salazar said.

The first advantage is the circular layout of the coliseum floor. This will enable the people to set up their booths in a circle against the wall.

"The flow of traffic will be much easier with the people walking around the circle formed by the booths," Salazar said.

In the Civic Center the booths were set up in front and in back of each other. This made the people weave in and out to look at the booths.

The second advantage is having the auditorium right next to the coliseum.

"The traditional mass beginning the fiestas will be held in the auditorium away from all the booths," Salazar said, adding that in the Civic Center the mass was held in the exhibit hall where all the booths were set up.

"This was sort of disrespectful because some people were talking and drinking during the mass last year," Salazar said.

The Adelita contest will also be held in the auditorium.

The third advantage is that there will be less security needed at the coliseum because there aren't as many entrances. This will cut down on the expenses for security.

The fourth advantage is that the booths will be cheaper, and last but not least more dancing space for all the dancing lovers!

One complaint that some committee members have is that the parade will be much longer, and a new route will have to be worked up.

"The people that will participate in the parade don't mind having a longer route, and said they won't get tired," Salazar said.

Another complaint is over the admission that the committee will be charging this year.

"The main reason we're charging is to help the rent for the coliseum/auditorium, and to build up a reserve fund for future fiestas," Salazar said, adding that with a reserve fund even better programs could be brought to the fiestas.

Tickets good for the Adelita Contest and three nights of fiestas


will be \$2.50 for adults and \$1.25 for students ages 6-18. There will be no charge for children under six and adults over 65.

Tickets for single events will be \$1.00 for adults and 50 cents for students 6-18.

Civic Lubbock has given fiestas '82 \$7500 to help in entertainment.

"We are currently working on our entertainment and trying to get a big name band," Salazar said.

The Fiestas Committee will have their monthly meeting Tuesday at 7:30 p.m. at Guadalupe Neighborhood Center.



LULAC Plans Upcoming Activities

If you didn't know what LULAC did or what it stands for you are going to find out by all the upcoming activities that they have schedule.

LULAC, League of United Latin American Citizens got special permission to hold their 1st Annual LULAC Softball Tournament on June 5th and 6th. The tourney will be held at the Optimist Boys Club which is located on Indiana & Cornell Avenue. This two day event will be giving 14 teams the opportunity to participate in this tourney. Ricardo Martinez the Public Relations chairman said that 20 teams have applied. "Since we have this many teams already, I guess who ever pays first will be participating in this tourney," said Martinez. The team entry fee will be \$70.

There will be food and cold drinks along with the excitement of live softball. Martinez said that everyone is invited to help LULAC raise funds for its scholarship fund. This money will be used for the operating and

scholarship fund for LULAC. LULAC plans to give ten scholarships this year.

LULAC's membership has tripled this past year and Tomas Garza who is the president of LULAC and Chevo Morales who is the district chairman are very pleased with the membership. Three years ago LULAC's membership was six people and this year's membership is 70 people. "With this many members, LULAC is allowed to do lots of activities and to have things that we have not had before," said Martinez. "For example," said Martinez, "this is the first year that LULAC has had a Public Relations Committee and this will definitely help LULAC, because we not only want to let the mexicanos know who we are but we want all of Lubbock to know us as well." There are ten members in the Public Relations committee. This year LULAC has 12 different committees and each have from 6 to 10 members.

LULAC will be giving their scholarships this coming fall. They have approximately 1800 dollars in their scholarship fund and expect to raise that figure by this fall with the help of all these upcoming activities. People may apply for these scholarships through LEARN Educational Talent Search office which is located at 1203 University.

LULAC is known for school scholarships but now LULAC will be raising money for an emergency assistance program through a 3-Day Radio-thon sponsored by KLFBS Spanish Radio Station. This Radio-thon will be on August 6, 7 and 8th. Three LULAC members will be at this Radio-thon from 6 a.m. to 12 midnight all three days. There will be a "jamaica" (little one) outside of the radio station during this radio-thon. There will be food, soft drinks for sale and members of LULAC will also be there to collect money from the community. During the radio-

thon there will be prizes given to the public. Gifts will be donated from businesses throughout the community.

The purpose of this 3-Day Radio-thon is for LULAC to raise \$20,000 for emergency assistance for the community. LULAC plans to make this Radio-thon a yearly event and expect the funds to increase every year.

This money will be used in many different categories. One is for housing. "Say your house burned down and you don't have a place to stay, we will provide money for motel or something in that manner," said Martinez. Utilities will also be paid for the needy people. For food assistance Martinez said, "We don't want to step on anyone's feet, but say a family goes to the City of Lubbock for food assistance and gets turn down, then LULAC will assist these people." For anyone to ask assistance from LULAC they must go through the procedures first and then to LULAC if are denied. This money is also expected to be used for hospitalization but one must go first to the County Hospital. There will be assistance for funerals but not to pay the whole amount of services. "This category will be very limited for assistance," said Martinez. LULAC will pay long distance calls during a death in the family as one of the services of funeral assistance. Only the immediate family will be allowed there to see.

Professionals such as doctors, mechanics, dentists, pharmacists, plumbers, carpenters plus many more will be asked for donations for this program. For example a lawyer

may donate a \$100 service for legal service, in turn LULAC will give this service to the persons in need of it. LULAC will not only give cash assistance but will help with services as well.

Since LULAC is a non-profit organization and all contributions are tax exempt.

LULAC councils are being organized outside of Lubbock such as Abernathy, Ralls and Brownfield and many other towns. "These councils who are being organized through LULAC members will really help our Radio-thon in August," said Martinez.

On September 5th, LULAC will be having their Fandango Jalapeño "If everyone can have their concerts why can't we," said Martinez who is looking forward to all these events that are being scheduled. Bands from all over Texas will be coming to perform at the Fandango Jalapeño that will be held at the Lubbock Speedway which is located on the Tahoka Highway. People from San Antonio, Corpus Christi, Austin, Dallas, Odessa, Midland and many other places are expected to come for this 2nd Annual event. There will be live entertainment from each band who will be asked to play for a whole hour.

There will be also a car show w during this event. Not only lowriders will admitted to the car show but all kinds of cars will be there to see.

So as you can see the LULAC members are being kept very busy not only for the good of the organization but for the good of the community.

Senator Simpson's Immigration Bill -- A Perilous Political Placebo

First the raids. Then the government-sanctioned intimidation and harassment of bilingual voters in Northern California. Now an immigration bill that is anti-Hispanic through and through.

If everything goes according to Senator Alan Simpson's plan, the full Senate will be voting on the bill next week (May 24). The mood on Capitol Hill and in the White House is that something drastic needs to be done immediately about immigration, no matter what effect it will have on the rights of Hispanic Americans.

When you look closely at the bill, you can see that neither Congress nor the Administration are serious about controlling the flow of undocumented aliens; they just want to look like they're doing something. They just want to make it look like workers from Mexico, El Salvador and Haiti are the people responsible for the fact that 10 million Americans are out of work.

In April, Senator Simpson (R., Wyo.) and Representative Romano Mazzoli (D., Ky.) introduced identical bills in the Senate and the House of Representatives. The bill(s) punished employers who knowingly hire undocumented aliens; provided the foundation for a decent legalization program; expanded the temporary worker program; and changed current law by denying brothers and sisters of U.S. citizens preference when immigrating.

Many Hispanic and civil rights advocates woked closely with federal legislators to improve the bill and delete provisions that would infringe on the rights of minorities. But when the Senate subcommittee in charge of legislation, chaired by Simpson, met on May 6, it was clear that the civil rights of Hispanics were not on the agenda.

The subcommittee passed a series of amendments that will pose grave threats to the rights of U.S. citizens and legal residents, and will deny rights and opportunities to asylees,

individuals who have applications pending with the Immigration & Naturalization Service, and others facing exclusion or deportation hearings.

At the same time, the subcommittee let employers off the hook by vastly reducing paperwork requirements and penalties for violating the law. Simpson said he didn't want to "burden" employers with a lot of paperwork. But when he had an opportunity to give the U.S. Commission on Civil Rights the responsibility to study the potential discriminatory effects of employer sanctions, he voted against it.

These are some of the provisions of the bill that passed Simpson's subcommittee:

State and local police officers can be given the authority to enforce immigration law, if the Attorney General grants the request made by state of local agencies. If this passes, police brutality against minorities and all foreign-looking people will flourish.

Criminal penalties against employers who knowingly hire the undocumented will not be levied after the third violation (as was in the original Simpson-Mazzoli bill) -- but only if there is aptern or practice of violations.

Paperwork requirements for employers will be eliminated for those who hire fewer than four employees. This represents 50 percent of all employees.

Individuals in exclusion or deportation hearings will be denied access to the federal courts, even if they feel their case has not been judged fairly by the special immigration judges who will handle all such proceedings.

Individuals applying for political asylum, such as the Haitians, will not be permitte to file class action suits, but will have to file suits on a case-by-case basis.

These provisions are clearly designed to harass, intimidate and otherwise deprive millions of individuals of their rights -- as U.S.

citizens, asylees, legal or illegal immigrants, and as human beings. They are also designed to make it possible for employers to be exempted from the penalties that are supposed to be imposed if they violate the law.

What will happen if the bill becomes law? Most employers will continue to hire undocumented aliens; the disincentive for them to do so has been lessened. Other employers, uncertain about what the law says and not willing to risk violating it, will avoid hiring people who "look Hispanic" -- even those who are U.S. citizens and can prove it. Even Senator Simpson has sid publicly that "Hispanics have the most to lose from employer sanctions."

While Hispanics will be hurt, so will Asians, Haitians, and other "foreign-looking" citizens and non-citizens.

Imagine what will happen in many partw of the country if local police officers are given the power to enforce immigration law.

The irony is, we are not likely to see a decrease in illegal immigration. The bill is little more than a plicial placebo, an illusionary "cure." It's simply not designed to solve any problems, other than those of image for some federal lawmakers under pressure from their constituents.

El Proyecto De Ley De Inmigracion Del Senador Simpson - Una Capsula Politica Peligrosa

Primero las redadas. Después la intimidación y el hostigamiento, sancionados por el gobierno, contra los electores bilingües en el norte de California. Y ahora un proyecto de ley sobre inmigración que es anti-hispano en toda su extensión.

Si todo marcha acorde al plan del Senador Alan Simpson, el pleno del Senador votará sobre dicho proyecto la semana próxima (Mayo 24). El estado de ánimo en el Capitolio y en la Casa Blanca es que se necesita hacer algo drástico, e inmediatamente, acerca de la inmigración, sin que importe el; efecto que tenga sobre los derechos de los hispano-americanos.

Cuando se mira de cerca al proyecto, puede verse que ni el Congreso ni la administración hablan en serio sobre el control de la corriente de extrajeros indocumentados; sólo quieren hacer ver como que están haciendo algo. Sólo quieren que parezca como que los trabajadores de México, El Salvador y Haití son los responsables del hecho de que haya diez millones de estadounidenses desempleados.

En Abril último, el Senador Simpson (republicano por Wyoming) y el Representante Romano Mazzoli (demócrata por Kentucky) presentaron proyectos de ley idénticos en el Senado y en la Cámara de Representantes. Dichos proyectos sancionarian a los patronos que contrataran, a sabiendas, a extrajeros indocumentados; proporcionarian el cimiento para un programa decente de legalización; ampliarian el programa de trabajadores temporeros; y modificarian la ley actual, negando a

los hermanos y las hermanas de los ciudadanos estadounidenses la preferencia para entrar a este país.

Muchos hispanos y defensores de los derechos civiles trabajaron en contacto estrecho con los legisladores federales para mejorar el proyecto y eliminar las disposiciones que infringieran los derechos de las minorías. Pero cuando el sub-comité senatorial a cargo de la legislación, presidido por Simpson, se reunió el 6 de Mayo, se vio claramente los derechos civiles de los hispanos no figuraban en el programa.

El sub-comité aprobó una serie de modificaciones que plantearán amenazas graves a los derechos de los ciudadanos estadounidenses y de los residentes legales, y negarán derechos y oportunidades a los asilados, las personas que tengan solicitudes pendientes en el Servicio de Inmigración y Naturalización, y a otras que se enfrenten a audiencias de exclusión o deportación.

Al propio tiempo, el sub-comité libró de problemas a los patronos al reducir extensamente los requisitos documentales y las sanciones por infringir la ley. Simpson dijo que no quería gravar a los empleadores con un montón de papeles. Pero cuando tuvo la oportunidad de dar a la Comisión eStadounidense de los Derechos Civiles la responsabilidad de estudiar los posibles efectos discriminatorios de las sanciones a los patronos, votó contra ella.

Esta son algunas de las disposiciones del proyecto, aprobadas por el sub-comité de Simpson:

Puede darse autoridad a los agentes de policia estatales y locales para hacer cumplir las leyes de inmigración, si el Procurador General accede a la solicitud que hagan las dependencias estatales o locales. De aprobarse esto, la brutalidad policiaica contra las minorias y todas las personas de aspecto extranjero florecerá.

No se fijarán penalidades criminales contra los patronos que empleen a sabiendas a extrajeros indocumentados después de la tercera infracción (como se disponia en el proyecto original de Simpson y Mazzoli) - sino únicamente cuando haya una pauta o práctica de

Se eliminarán los requisitos documentales para los que empleen a menos de 4 personas. Esto representa el 50% de todos los patronos.

Se negará el acceso a los tribunales federales a las personas comprendidas en audiencias de exclusión o deportación, aun cuando crean que sus casos no han sido vistos con equidad por los jueces especiales de inmigración que manejarán todos esos procedimientos.

A los individuos que soliciten asilo político, tales como los haitianos, no se les permitirá establecer litigios en acción clasista, sino que tendrán que presentarlos sobre la base de caso por caso.

Esta medidas se destinan claramente a hostigar, intimidar y privar de sus derechos, por otros medios, a millones de individuos - en sus calidades de ciudadanos estado-unienses, asilados, inmigrantes legales o ilegales, y como seres humanos. Se destinan también a hacer posible el que los patronos sean eximidos de las sanciones que se supone deban imponerles si infringen la ley.

¿Que ocurrirá si el proyecto se convierte en ley?

La mayoría de los empleadores continuará empleando extrajeros indocumentados; el desincentivo para que dejen de hacerlo se ha aminorado. Otros empleadores, inseguros acerca de lo que dice la ley y sin disposición de arriesgarse a infringirla, evitarán contratar a personas que "parezcan hispanas" - aún las que sean ciudadanas de los Estados Unidos y puedan probarlo. El propio Senador Simpson ha dicho públicamente que "los hispanos son quienes más tienen que perder como resultado de las sanciones a los empleadores."

Mientras que los hispanos resultarán perjudicados, también lo serán los asiáticos, haitianos y otros ciudadanos y no ciudadanos de "aspecto extranjero."

Imaginense lo que sucederá en muchas partes del país si se da a los agentes locales de policia la autoridad para hacer cumplir la ley de inmigración.

Lo irónico es que no resulta probable que veamos una disminución de la inmigración ilegal. El proyecto es poco más que una cápsula falsa politica, una "curación" ilusoria. Sencillamente no está destinado a resolver ningún problema, más que el de las imágenes de algunos legisladores federales sometidos a presión por sus electores.

Fórmula Uno: La Muerte a 260 Km Por Hora

El corredor canadiense Gilles Villeneuve, falleció en el hospital San Rafael de Lovaina, es la víctima número 28 en la historia de la Fórmula Uno.

Después de siete horas de intentos desesperados, los médicos del centro sanitario San Rafael notificaron la muerte del corredor que sufrió un espectacular accidente en la última vuelta de las pruebas para el G.P. de Bélgica.

'Rotura de vértebras cervicales', ese fue el diagnóstico médico cuando Villeneuve ingresó en el hospital pocos minutos después del accidente.

A 260 kilómetros por hora, a la salida de una curva, el piloto canadiense de la escuadra 'Ferrari', que ha anunciado ya su retirada de la prueba, intentó adelantar al 'march' del corredor alemán Joaquín Mass.

Una trágica falta de entendimiento hizo que Mass se desplazara a la derecha para permitir el

adelantamiento, villeneuve interpretó mal la maniobra, se echó también a la derecha y la rueda delantera izquierda de su bólido chocó contra la rueda trasera derecha del 'March'.

Convertido en un proyectil, el 'Ferrari' salió volando por encima de la pista y fue a estrellarse contra las vallas metálicas de seguridad.

En el trayecto Villeneuve consiguió salir eyectado del vehículo, pero con el cuello roto y el tórax destrozado.

Unos 250 metros más allá, el 'Ferrari' de Villeneuve había quedado convertido en una masa de acero calcinado.

Los supersticiosos no dejarán de recordar un patético detalle. Por vez primera en su carrera, Villeneuve no contaba en esta prueba con la presencia de su esposa Joanne.

Desde el 1 de agosto de 1980 hace casi dos años - el mundo de la

Fórmula Uno no se ponía de luto. Entonces fue el francés Patrick Depailler, durante unos ensayos privados en Alemania Federal, el que encontró la muerte a los mandos de su 'Alfa-Romco'.

Villeneuve ha tenido la trágica distinción de ser el tercer piloto que fallece en Bélgica a consecuencia de una cidente. Antes de él, el británico Chris Bristow (junio 1960) y el también inglés Anthony Hegborne (mayo 1965) encontraron la muerte en el curso de campeonatos oficiales.

Pero es Alemania Federal con cinco accidentes mortales en Fórmula Uno el país que tiene el triste honor de estar a la cabeza de la lista negra de corredores.

La desaparición de Gilles Villeneuve, de 30 años de edad y corredor de Fórmula Uno desde 1977, va sin duda alguna a ensombrecer aún mas el futuro de la Prueba Reina' del automovilismo.



Abeyta, who has been practicing law in Lubbock for numerous years, served in the 173 Airborne Brigade of the U.S. Army Major activity for that Brigade revolved around the Central Highlands of Vietnam. "All activities will be conducted in Honor of all those comrades who died in Vietnam" stated srael Quintana, Local V.V.A. president.

"Notario Publico?" No Such Thing In Texas!!

(Editor's note: The following is the first part of a continuing series on "Notario Publico" or "Notary Public" by Walter LeCroy.

LeCroy is an immigration consultant in Lubbock and has been a personal consultant to attorneys, Albert Perez, Alton Griffin, and Carlton McLarty.

LeCroy was born in Brownfield in 1934, and graduated from Levelland High School in 1953. He attended the University of Texas at El Paso and earned a B.A. in Creative Writing in 1975.

LeCroy, who can speak Spanish, Italian, and English, has been a patrolman for the Lubbock Police Dept., an Immigration Officer, and a Border Patrol Agent in Laredo, Las Cruces, and Presidio. He has also been an Immigration Examiner in Los Angeles, Calif., and Chicago, Ill., and an Immigration Inspector in Ft. Hancock, and Fabens.

He received special training in the Border Patrol Academy in 1962.)

The deceptive term "Notario Publico" sometimes used as an erroneous translation for the term "Notary Public" has been a means by which Notaries Public for many years successfully fleeced, exploited and abused aliens, particularly from Mexico, who were seeking immigration benefits such as residence in the United States. By advertising their services with the Spanish term "Notario Publico", these unscrupulous Notaries Public were able to deceive Spanish-speaking aliens into believing they were obtaining the services of an attorney. In Mexico a "Notario Publico" is a highly skilled attorney, a rung above the ordinary who possesses special skills and licenses. Although an attorney in Texas is not prohibited by statute from using the term "Notario Publico", most do not.

In 1977 the 65th State Legislature amended Section 5 of Title 99 of Vernon's Texas Civil Statutes to prohibit the use of the Spanish term "Notario Publico" in written communications, television, classified ads, stationary, etc., unless the advertisement was accompanied by a clear statement that the Notary Public was not an attorney. Enactment of the law was an outgrowth of the many complaints, especially from Mexican citizens along the Texas-Mexico border against Notaries Public who employed this deceptive means of advertising. The saddest part of the

story is that many of the victims were, in fact, eligible for benefits that were denied them because the wrong form was used, the wrong supporting documents were submitted, or the wrong benefit was applied for. In some cases applications for permanent residence in the United States were filed by applicants who were already United States citizens! Nationality Law is one of the most complicated of all the laws in American jurisprudence, and any seasoned Immigration Officer will tell you that such errors by Notaries Public (and even lawyers) are not uncommon. Many of these Notaries Public are on what the Immigration Service refers to as "suspect third party" lists. That is, they are suspected of aiding and abetting aliens to seek benefits they are ineligible for. They have been known to provide fraudulent supporting documents such as stolen or latered birth certificates, phony job offers, and even arrange sham marriages to circumvent the quota categories of preference for immigrants. Unfortunately, too few of these unscrupulous operators have been prosecuted and may continue to operate. Unfortunately, many clean, bona fide applicants also seek the services of these Notaries Public, but their applications are also held up for months and even years because, once a "suspected third party" is involved in an application, the application, along with all the others is always referred to the Investigations Branch where it may gather dust for months on end before an investigation is even initiated, considering the backlog of such cases in the INS.

In spite of the prohibitions against written, broadcast or telecast use of the term "Notario Publico", there is nothing to stop the Notaries Public from continuing to refer to themselves as "Notarios Publicos" in oral communication. Hence, the deception goes on.

To be a Notary Public in Texas, one need be 18 years old, not be a convicted felon, and must post a bond with a bonding company. He must also pay a small fee to the Secretary of State in Austin for his license. It is easy to see that with such weak requirements, the door is wide open for unscrupulous individuals who recognize the opportunity to prey upon aliens not familiar with the American legal system.

Until better legislation is passed by the State Legislature and tighter restrictions are placed on Notaries

Public, this will continue to be an area tragic exploitation of immigrants to the United States.

Any person seeking assistance in obtaining immigration of nationality benefits should seek a professional Consultant or an attorney certified in immigration law by the Texas Board of Legal Specialization.

Veronica Salazar Specializes in Success Stories

Veronica Salazar writes success stories. To date, she has penned nearly 500 of them. They have appeared as regular columns in the San Antonio Express for 9 years now, rationed out at the rate of one a week. They've also been compiled into two volumes entitled "Dedication Rewarded," published in 1977 and 1981.

The heroes and heroines are, with two exceptions, all Hispanic Americans. Nearly all are Texans.

Salazar's storylines seldom vary. Her subjects are born humble, work hard, have faith, and are rewarded with success.

Horatio Alger with serape and sombrero?

Not quite.

Veronica Salazar's subjects, all drawn from real life, are as different as the 20 million men and women who give this nation its Hispanic cultural spice. Among them are teachers, bankers, community workers, dancers, military personnel, priests...

Her definition of "success" doesn't totally conform to that of her 19th century predecessor, Alger. Material gain isn't a criterion, nor is being masculine or white. Typically, her stories begin:

"For many years, Josefa Elizondo Bartoco was the cake lady for the parish, neighborhood, and family reunions..."

omingo Nick Reyes dropped out of junior high school and ran away from home with the determination that he would never come back until he was a man...

"Eduardo M. Ortiz started his career in the banking industry 33 years ago as a messenger and mailboy..."

From her earliest years, Hortense Gonzalez, has been handling family problems. As the youngest of five children...

Salazar sees each column as having two purposes:

One is to provide role models for Hispanic youth whose hopes and dreams become more attainable by knowing that others in similar circumstances have made it. "A lot of young people have called me up after reading one of the articles and asked to get in touch with the person I profiled," she says. "And the persons always make themselves available."

The second purpose is to create a bridge between Anglos and Latinos. She wants to counter the false "dumb and lazy" stereotype so often portrayed in the media. "We are all born with a talent," she emphasizes.

"One of them has to be Guadalupe Quintanilla," Salazar responds without hesitation. "She dropped out of school in the fourth grade. She returned later—much later—because she felt that the best way to help her children with their homework was to educate herself first." In 1976, Guadalupe Quintanilla obtained her doctorate in education from the University of Houston.

A native of Rio Grande City, Salazar herself grew up dreaming about becoming an interpreter for the United Nations. She attended college in San Antonio, majored in languages, and when San Antonio's HemisFair opened in 1967, she landed a job as an interpreter. There she met Express Publisher Charles Kilpatrick, who needed a bilingual secretary.

On day in 1973 she was complaining to Kilpatrick that Latinos were only considered "newsworthy" by the press when they committed crimes. "Why don't we run more positive stories about Mexican Americans?" she challenged him.

Kilpatrick turned the challenge back to her. If she'd write them, he'd run them.

Promoted to executive assistant to the publisher, she's been writing them ever since.

Salazar's lack of journalism training has been no deterrent to her as a writer. But it may have affected her performance as a "reporter," suggests one colleague.

"So far," he comments, "she's missed the best success story of all—the story of Veronica Salazar."


