

M.A. Bar Resolution Against Thomas

On August 17, 1991, The Mexican American Bar Association of Texas (MABA), at a Board of Director meeting, unanimously voted to oppose the nomination of Clarence Thomas as an Associate Justice of the United States. The Mexican American Bar Association decided to pass this resolution at this time, rather than wait until its annual convention on September 14, 1991 in San Antonio, Texas. WHEREAS, Judge Clarence Thomas has been nominated by President George Bush as an Associate Justice of the United

Supreme Court not only with regard to race and ethnicity but also with regard to the life experiences of the Justices;

WHEREAS, Judge Thomas' philosophy and views nevertheless do not demonstrate affirmative support for the civil rights and constitutional rights which the Mexican-American Bar Association of Texas (MABA OF TEXAS), seeks to protect and to advance, but instead demonstrates serious disagreement with an even hostili-

ty to the fragile civil and constitutional rights of crucial importance to Hispanic in the United States, to wit:

1. Judge Thomas, based on his belief that both the Constitutions and Title VII were intended to be and thus should be color-blind, opposes affirmative action in every form in employment, including voluntary race-and ethnic and gender-conscious affirmative action to

the cause of the rise in Latino poverty rates, states the report released today by the fund. Instead, lack of education and the prevalence of low-paying jobs among Latino parents has led to a rapid increase in poverty among Latino children. As a result, Latino children are becoming poorer faster than black or white children, said Leticia C. Miranda, policy analyst and author of the report.

The percentage increase among Latino children was 29.3% between 1979 and 1989, the latest year for which data are available. Poverty has increased 6.1% among black children and 19.5% among all children in the same period.

Half of the 2.6 million children who became poor in the United States in the last decade are Latino. However, the 7.2 million Latino children in the U.S. represent only 11% of the nation's children.

Although a large majority of Latino families have one or more working parents, income earned is not enough to raise the families out of poverty. "Latino families with children are poor because hard work is not enough to alter their economic vulnerability," the report said.

AP adds that the key factors contributing to high poverty rates include:

- Latino parents' low hourly earnings.

- Latino parents' greater likelihood of not completing high school, which makes their families more vulnerable to economic trends toward markedly lower pay for less educated workers.

- Latino women's smaller likelihood of working outside the home to provide a second source of earnings and offset falling male earnings.

- Widespread and persistent discrimination.

In addition, the report found:

- The actual number of poor Latino children as a percent of population is still lower than the number of blacks. 36.2% of Latino children, 43.7% of black children and 11.5% of white children live in poverty.

More than two-thirds of poor Latino heads of family do not

nave high school diplomas, compared to fewer than half of poor white and black family heads.

- 84.1% of Latino men work, compared to 77.8% for non-Latino whites and 73.8% for blacks. However, just over half of married women in the Latino community worked in 1989, compared to 57% for whites and 64% for blacks.

- Between 1973 and 1989, the median income of Latino families headed by a person under 30 fell by 13%, more than twice the decline suffered by young white families.

News Briefs

Morales Sues Bush

AUSTIN, Texas - Texas sued the federal government Wednesday, demanding more than \$1 billion in federal aid state officials claim will be lost because of a faulty census count that missed some 600,000 people statewide.

The lawsuit names as defendants President Bush, Commerce Secretary Robert Mosbacher, whose department managed the census, and other cabinet departments spending money on programs in Texas.

"This is not Washington's money or Secretary Mosbacher's money that will be withheld from Texas. This is our money," said Attorney General Dan Morales.

The lawsuit, filed in U.S. District Court in Brownsville, seeks correction of the census count, creation of an interest-bearing escrow account into which the federal government could deposit the disputed funds and a court ruling that use of the 1990 census for federal funding is discriminatory.

Morales said the state estimates that over the next 10 years, Texas will lose more than \$1 billion in federal aid to schools, children, the poor, farmers and ranchers, the elderly and others. Many payments are made on a per capita basis and Texas will be shortchanged if the 1990 census isn't revised



to record the true number of citizens, he said.

The 1990 census estimated a Texas population of 16.9 million. State officials say it should be at least 17.5 million, adding that many of those missed were blacks and Hispanics living in urban areas and South Texas.

The U.S. Census Bureau has estimated that its 1990 count missed more than 5 million people nationwide, including more than half a million in Texas.

Texas officials say similar inaccuracies in the 1980 census count cost the state about \$600 million in federal funds. Texas earlier joined New York in a lawsuit seeking to force an adjustment in census numbers.

TX Legislature Moves CDBG Authority

The Texas Legislature has finally gone home from a historic session which saw major reforms in the state's role in providing low income housing adopted. The latest victory for housing advocates was the legislature's decision to take the responsibility for administering the state's CDBG allocation from the Department of Commerce and give the authority to the newly created Department of Housing & Community Affairs.

Consumers Union and the Texas Low Income Housing Information Service led the effort in the special session of the Legislature to move the authority to administer CDBG from the Texas Department of Commerce. The strong leadership of Lt. Governor Bob Bullock was largely responsible for these victories.

Opposition to this move from some county officials was fierce. Many counties use CDBG as a replacement for local funds to provide basic services community wide. Enforcement efforts aimed at eliminating these improper uses by the state and HUD have been inadequate.

The new Texas Department of Housing & Community Affairs was created in the first of a series of sweeping changes toward the state's low income housing effort. Other reforms included the establishment of a state housing trust fund, the allocation of \$18 million for matching federal housing funds, the declaration of a state goal for the elimination of substandard living conditions in colonias by the year 2000, the establishment of the Texas Colonias Task Force, and the authorization of \$150 million of water and sewer bonds for the colonias.

The governor is expected to announce a new board for the Texas Department of Housing & Community Affairs in the next few days. Housing advocates had substantial input into the selection of the new board and nonprofit organizations, tenants groups and poor people will be prominently represented.

The decision to move CDBG to the new department will change the emphasis more toward the direct provision of assistance to poor people and low income housing. A provision in the new agency's enabling legislation requires it to devote at least 25% of its housing related resources to assisting very low income families with their housing needs. Housing and consumer advocates are prepared to argue that this includes CDBG funds. This could mean \$13.5 million of the state's \$54 million of CDBG funds could be redirected into housing for poor families. Under the state's current CDBG plan, now money is earmarked for housing.

Data Show Recessions Not Over

AP reports that new data on economic growth indicate that the recession many analysts thought was ending may not be over yet. The Commerce Department said yesterday that the gross national product fell 0.1% in the April-June quarter when economists had predicted a 0.4% increase.

Last quarter's drop was the third consecutive negative showing of the GNP, which measures the nation's gross output of goods and services. Economic activity fell 2.8% in the first quarter of 1991 and 1.6% in the last quarter of 1990.

The report was seen as strengthening the argument of some economists who believe the economy is in danger of lapsing into a so-called double-dip recession, in which a brief period of revival is followed by a fresh downturn.

Body of Dead Reporter Tested

AP reports that Morgantown, WV, authorities said blood tests revealed traces of a painkiller and an antidepressant drug in the body of a reporter who was found dead while researching corruption in the Reagan/Bush administration.

The body of Joseph D. Casolaro, 44, was found with slit wrists in a hotel room in Morgantown, where Casolaro went to meet a source with information on his investigation into the Iran Contra scandal and allegations that the Justice Department stole a software firm's surveillance product.

State medical examiner, Dr. James Frost, said the tests did not rule out suicide. "The tests so far indicate that he was not incapacitated by any drug they have found," Frost said. "There's nothing so far to indicate that he was knocked out at the time of death."

Casolaro's family members said suicide was unlikely. A House Judiciary subcommittee is investigating the incident.

I Know Who I Am

The world is full of social and political misfits, and we Americans of Mexican descent have our share of them.

In Colorado, 69-year old Francisco Coca refused to appear in court on various charges by stating, "I, Francisco Coca, of Aguilar, Aztlan, do not recognize the jurisdiction of this court because the laws have been made by the European to suppress the poor, straight and innocent native."

His troubles stem from his picking up on a dead wild turkey from a mountain roadside. Apparently the bird had been dead for a while. He and his 16-year old son wrapped the bird to take it home.

A couple of miles away, a Fish and Game officer pulled them over and asked the Cocos if they'd been hunting. No, they answered. He asked to see their rifle. It wasn't loaded, nor had it been fired recently. Seeing the dead bird, he called for backup.

When a second officer arrived, the elder Coca says he walked up to the officer and told him, "Gringo, why don't you go back to Europe and leave us alone?"

Coca took the bird out of his truck, walked 50 yards and threw the bird as far as he could. He and his son drove away. One officer followed them. Young Coca was issued a citation several days later while in school, and the elder Coca was arrested three weeks later. A \$2,000 bond was set, but American-born and raised Coca refused to speak English at his hearing, and as the court couldn't provide an interpreter for seven days, he was held until they could. He refuses to cooperate either with an appointed local public defender or with the regional or state public defenders.

Interestingly, Coca is a plaintiff in a lawsuit against the state of Colorado to keep it from implementing a voter-approved English-only Statute. He cooperates when he wants.

In direct contrast to Coca's position of being an "indigenous" person, we find Theresa Gonzalez and Laurinda Fragoso Owens of San Diego who would do away with the terms Hispanic, Chicano, brown and "people of color."

They write, "Mexicans are Caucasian (white), unless more than 50 percent of their heritage is Indian, in which case, the race thus becomes Mongoloid (yellow) (ak a 'Asian')."

Mexico Trade Debate Shifts to 'Exclusion' of U.S.

Following a flurry of complaints by various Hispanic leaders and organization, the Bush administration appears to be taking steps to increase Hispanic participation in the negotiations of the North American Free Trade Agreement under way among the United States, Mexico and Canada.

In what may be the most significant of those steps, a senior administration official promised this month that "several" Hispanics would be named soon to serve on the private sector advisory committees that counsel the U.S. Trade Representative on trade issues and negotiating positions. The USTR is the lead agency in the negotiations.

"We're very excited about that," commented José Niño, president of the U.S. Hispanic Chamber of Commerce. "Our concerns are being addressed by the White House and the USTR."

Earlier this year, that group and a number of others had encouraged Congress to grant fast-track authority for the NAFTA talks. Since fast-track gained congressional approval in late May, however, many Hispanic have expressed doubts as to whether their concerns were being adequately addressed in the trade talks, which formally began in mid-June.

For example, on May 28

their isn't such a race as 'brown' race," they maintain.

These ladies top their demands with, "We want respect and equal justice." That is, officially they want to be called white -- if, of course, the race police can prove they have more than 50 percent white, Caucasian blood. Sort of like South Africa, I guess. The fact is, there are a lot of "brown" people.

On the one hand, we have Indians (descendents of migrating Asians), who were here when Columbus arrived in 1492. On the other hand, we have the Spanish who came to colonize and intermarried with these same Indians. Questions of cultural and human "genocide" aside, a new people was created, unlike in North America, India, Asia or Africa, where whites did not, for strictly racial reasons, intermarry with local women.

Neither white nor Asian, the new people are something, they are "mestizos" mixed bloods.

Protestations to the contrary, the combination of Spanish and Indian created a new skin color -- brown. I know -- I see it every time I look in the mirror. So do a hundred million other Mexicans and Americans of Mexican descent, plus millions of others in Central and South America.

Modern Mexico has been forged by these brown people. California, Texas and the rest of America have been built, in part, by these brown people, who are increasingly more important in the American social, political and economic fabric.

We, who trace back to the union of Spanish conquistadors and Indian women, can choose one of three paths.

Like the ladies, we can insist on being white if, of course, we can prove at least 50.1 percent white blood. Or we can ignore our white blood and be "indigenous," refusing to participate in America, like Mr. Coca.

Or we can assert ourselves as a new people we of brown skin, of Spanish and Indian blood. We are a unique blend of cultures and races. We are Mexicans and Americans of Mexican descent. We are a very special people, a singular people with cultural and historical ties on both sides of the Atlantic.

There is little, if any, room for Angst in our collective future. I'll leave that to Mr. Coca, Ms. Gonzalez and Ms. Fragoso.

"It has come to my attention," his letter stated, "that your office may not have a Hispanic employee in any significant position. With many qualified Hispanics across the country...it is displeasing and unacceptable that your office not have any employed."

In a reply Torres characterized as "curt" and "shortsighted," Hills responded, "USTR is a very small agency with very little turnover... where target recruiting is not effective if there are only one or two unpredictable vacancies per year."

Some 250 people work at USTR, including 24 at its Geneva, Switzerland, office. Out of the 250, only 151 are permanent employees; the rest are "detailed" from other U.S. government agencies or are student interns.

In recent statement, USTR has pointed out it has at least four Hispanics working in professional positions. In addition, there are "at least eight more Hispanics" from other U.S. government departments involved in the NAFTA talks, a USTR spokesman said.

Hispanics have also expressed concerns about the role Mexico has seemed to expect

Congress is in recess until the second week of September. During this time they will be at their local offices and will be more available to meet with you about your concerns. Here are some of the issues you can discuss with them, many will see votes in September.

Senator Danforth has ended negotiations with President Bush to create a civil rights bill that the President is willing to sign. Danforth will reintroduce his version of the civil rights bill when Congress reconvenes. INTERFAITH IMPACT does not support this bill which is much weaker than the version passed in the House in June. Please urge Senator Danforth and your own senators to support the civil rights bill as it was passed in the House with no weakening amendments.

Senator Ford has promised to bring up the National Voter Registration Act for re-consideration in early September. Please tell your Senators to push for S250.

The United States and Mexico are moving in "blitzkrieg" fashion to finish negotiations for the North American Free Trade Agreement. Senator Riegle has introduced SR109 to exclude several concerns, including labor and environmental standards, from the fast-track process in the negotiations. He hopes to have 30 cosponsors by October. Ask your Senators to cosponsor and support SR 109.

The Senate Foreign Aid Authorization bill includes an amendment in favor of tied aid which would make promotion of U.S. commercial interests a more central goal and would promote inappropriate capital-intensive projects. Urge your senators, especially those on the appropriations committee, to oppose tied aid provisions in the appropriations bill.

You can also contact the conferees from the House & Senate Agriculture and Rural Appropriations subcommittees on the 1992 Agriculture Appropriations bill. Urge them to accept and support the Senate mark of \$2 million dollars for minority farmers in the small-farm technical assistance program. The House provides no money for this important program.

El Debate Sobre El Comercio Con Mexico Cambia Hacia La Exclusion de Los Latinos Estadounidenses

Después de un alud de quejas por parte de varios dirigentes y organizaciones hispanas, el gobierno de Bush parece estar moviéndose, en varias formas, hacia el aumento de la participación hispana en las negociaciones del Tratado de Libre Co-

mercio.

"The Mexican government has hired non-Hispanic lawyers and public relations firms to present its case in the U.S., and then they ask Hispanics to do the same thing gratis," commented a Hispanic leader, who was not identified.

There are indications, however, that while they were not ready to announce it officially, Mexican government officials are seriously considering hiring more U.S. Hispanics.

In what might also be considered a special effort to reach out, Herminio Blanco, Mexico's chief NAFTA negotiator, has agreed to participate, along with Ambassador Hills, in a panel discussion on trade that will be part of the U.S. Hispanic Chamber's mid-September convention in Chicago.

It remains to be seen if these various steps will go far enough in meeting the concerns of Hispanics. Many groups agreed to support the fast-track authorization only with certain conditions attached. The Mexican American Legal Defense and Educational Fund, for instance, said that along with any trade accord, there should be effective retraining programs for dislocated workers, increased attention to environmental problems along the U.S.-Mexico border and a re-examination of U.S. immigration policies relating to Mexico.

As to how Hispanics view the proposed agreement, "The jury is still out."

Anteriormente, es este año, ese grupo y algunos otros habían animado al Congreso a otorgar la autoridad de "carril rápido" para las charlas del Tratado de Libre Comercio. Puesto que ese concepto obtuvo la aprobación congressional a fines de Mayo, sin embargo, muchos hispanos han manifestado sus dudas en las charlas mercantiles, que empezaron formalmente a mediados de Junio.

Por ejemplo, el 28 de Mayo el Representante Federal Esteban Torres (demócrata por California), que votó en contra de la aprobación del "carril rápido," escribió a la directora del USTR, Embajadora Carla Hills, para cuestionar el papel que los hispanos desempeñarán en las negociaciones. "Ha llegado a mi atención," decía la mencionada carta, "que su oficina puede no tener a ningún hispano empleado en alguna plaza de importancia. Por haber tantos hispanos capacitados en todo el país

... resulta desagradable e inaceptable que su oficina no haya contratado a ninguno."

En una respuesta que Torres calificó de "lacónica" y "miope," Hills contestó: "el USTR es una dependencia muy pequeña con muy pocos cambios de personal ... en la que el reclutamiento específico no es eficaz si hay solamente una o dos vacantes pronosticables al año."

Cerca de 250 personas trabajan en dicha dependencia, incluyendo a 24 en su oficina de Binebra, Suiza. De las 250, sólo 151 son empleados permanentes; las demás están "destacadas" de otras dependencias del gobierno estadounidense o son estudiantes internos.

En las declaraciones recientes, dicha dependencia ha señalado que tiene por lo menos a cuatro hispanos que trabajan en plazas profesionales. Además, hay "por lo menos otros ocho hispanos" de otros departamentos del gobierno federal que están involucrados en las charlas del Tratado de Libre Comercio para la América del Norte, dijo un portavoz del USTR.

Los hispanos han manifestado también sus preocupaciones sobre el papel que México ha parecido esperar que ellos desempeñen en las discusiones mercantiles. "El gobierno mexicano ha contratado a abogados y firmas de relaciones públicas no hispanas para presentar su caso en los Estados Unidos, y después piden a los hispanos que hagan lo mismo gratis," comentó un dirigente hispano involucrado que pidió no ser identificado.

Hay indicaciones, o obstante, de que aunque ellos no estaban listos para anunciarlo oficialmente, los funcionarios del gobierno mexicano estaban considerando seriamente el contratar a más hispanos de los Estados Unidos.

The September issue of "D" magazine has an article about the problems of the Dallas school board. The fights there are comparable to the fights here in Lubbock. Now ain't that a coincidence. Of course, the Dallas fight is a little different African-Americans and Chicanos make up a majority on the school board and the school system in Dallas. In Lubbock, African-American and Chicano kids now make up the majority in elementary school but obviously not on the school board. But the numbers are now there and the day is coming...

In the September issue of "Texas Monthly" there is an article about Ernie Cortez. It points out that he is a book hound reading several books simultaneously for his personal study. The article goes on to point out that Cortez is one of most important and powerful men in Texas and yet few have heard of him. Cortez is an organizer who has helped to organize the poor and middle class across Texas.

I have heard a friend up at MIT working on his PhD in economics who is always reading two or three books at a time. When interest in one book slacks off he spends more time on one of the others. If a book does not pan out he tosses it aside and starts up another.

It seems both of these men have simply continued their personal education beyond the classroom. Didn't all of us take a number of different courses with different books in high school and college? And once we quit going to school didn't most of us quit reading and learning? If we want to be a good example to our kids we should be seen reading a book instead of vegetating in front of the TV.

After leaving school I have tried to continue reading but it has always been one book at a time and many months apart. Last week I started my first simultaneous reading. I have returned to school.

What are you reading right now? I am reading a book of Irish poetry, the biography of Cesar Chavez, and a book on Texas criminal procedure.

All of us need to be reading more and watching less TV. All of us need to be reading to our kids and grandkids. It is one habit we all need to get our kids hooked on.







rectify severe workforce underrepresentation, and also including court ordered affirmative action relief to remedy long-standing and pervasive past discrimination;

2. Judge Thomas, consistent with his color-blind theory, rejects, and can find no constitutional basis for, even massive federal government contracting programs which contain modest set-asides so as to include minority business enterprises (MBEs) in this contractual largess;

3. Judge Thomas, again pursuant to his color-blind theory of the Constitutional and of our civil rights laws, has rejected as unconstitutional and unlawful ethnic-and race-conscious inclusion of Hispanics and of African Americans into institutions of higher education, and quite possibly also rejects ethnic-and race-conscious scholarship programs designed to help and to facilitate minority access to higher education;

4. Judge Thomas, on the matter of school desegregation, disagrees with the equal protection premise of Brown I, also disagrees with the Brown I principle that separate is inherently unequal, and opposes effective school desegregation remedies;

5. Judge Thomas, who prefers to address discrimination affecting African Americans not under the equal protection clause but instead under the privileges or immunities clause (which protects only "citizens" rather than "any person"), may find it difficult, if not impossible, to view discrimination against noncitizens as unconstitutional; and

6. Judge Thomas, who has serious misgivings about the presence of any unenumerated right to privacy in the Ninth Amendment, and who has endorsed a right-to-life viewpoint as "splendid example of natural law," seems philosophically opposed to the constitutional right to reproductive choice and even to the constitutional right to privacy itself;

WHEREAS, the purpose of the advise-and-consent process of the United States Senate with regard to nominees to the Supreme Court of the United States is to assure that any such nominee is fully qualified to adjudicate issues involving, and to recognize and to uphold, the civil and constitutional rights of all persons within the United States;

WHEREAS, MABA OF TEXAS's positions on judicial nominees has been based on reviews of the nominees' records, and on whether the nominees's records demonstrate affirmative support for protecting and advancing the civil and constitutional rights of all persons in the United States, particularly in areas of importance to Hispanics;
