Parents Determined to Keep Fighting

Despite recent actions by the United States Justice Department, Five Lubbock parents are insisting that their case will be heard.

"We are not discouraged. If anything, the brief filed by Justice helped our case in that it cited cases that will help us to intervene," said Mary Alice McLarty, one of the attorneys for the parents. "We have to understand that we are entering a new phase of litigation and that our request to intervene was very timely. We asked to intervene as soon as we knew what the LISD was planning to do in order to 'reorganize', as they say," said McLarty.

LISD filed a brief on Tuesday

attacking the personal background of the plaintiff and claimed that the parents were trying to intervene for personal gain. LISD directly attacked the Overton North Association saying that they were the finan-

cial backers of the suit. "That could be the farthest thing from the truth," said McLarty. "Our main source of finance for the suit is the Dunbar International Alumni Association."

According to sources close to El Editor the Dunbar Association has be working deligently to raise funds to prevent the changing of Dunbar to a junior high as the LISD has proposed in its restructuring plan.

LISD claimed that the inter-





Low Medicaid Fees Hamper Care

The N.Y. Times reports poor people on Medicaid are deprived of care by excessively low payments that cause many doctors to avoid the program. The federal Physician Payment Review Commission found the Medicaid program, which insure 27 million low-income people in the U.S., pays much less than Medicare and private insurers for the same services. Forty-four states have problems getting doctors to participate in Medicaid, with low fees being the most common reason cited. The federal government decides how much to pay doctors of

Medicare patients, and has usually stayed close to market rates. But states have wide discretion in setting of Medicaid payments, and often fail to increase fees to account for inflation. The study, conducted with the help of the National Governors Association, is the most systematic attempt to measure disparities between health programs.

The sederal panel reported to Congress that low sees mean Medicaid recipients are less likely to have a continuing relationship with a doctor, more likely to get care in an emergency room or clinic than a doctor's office, and may be at "substantial economic disadvantage relative to their peers."

The commission will make recommendations later this year for changes in how Medicaid pays doctors.

Bush May Deal On Handgun Bill

VASHINGTON - Attorney General Dick Thornburgh said Thursday President Bush would 'look more favorably" toward a handgun control bill if Congress first passes a comprehensive measure to combat violent crime.

A week after former President Reagan endorsed the so-called Brady bill and lobbied Bush to endorse it, Thornburgh reiterated that the administration has some reservations about the legislation.

We have no problem with the concept of a background check for purchasers of handguns," he said Thursday during an in-

terview on CBS-TV. But Thornburgh also said federal law enforcement authorities

don't have our criminal records in shape to ensure that that background check would be accurate and useful."

Momentum has been building for enactment of the legislation named for former White House press secretary Jim Brady, who was felled during an assassination attempt against Reagan on March 30, 1981.

But Bush has been pressing Congress to pass a more comprehensive crime-control measure which, among other things, would authorize the federal government to impose the death penalty for a host of violent crimes.

Dear Mr. Aguero

I am asking for you and your readers help. As you know, our state legislature is worrying with the budget. Everyone needs more money just to provide the same level of services as they provided in the past. It seems that the state's junior colleges, however, are being forgotten and may have their state funds drastically cut.

An example of my concern is a recent proposal, House Bill 10, which cleared the House Appropriations Committee chaired by Rep. Jim Rudd. It would cut \$600,000 from the 1988 appropriations received by South Plains College. That's right, the 1988 appropriations. At the same time SPC has experienced a 24 percent increase in enrollment, which translates into more teachers, buildings and operating expenses.

Only 815 of the college's over 5,000 students are from the South Plains Junior College District which covers all of Hockley County and a small part of Cochran County. The rest of the students come from surrounding communities and

counties. Many are from your community.

South Plains College has three major sources of funding: state appropriations, junior college district taxes and tuition. Tuition will be going up this fall. Taxes in the SPC district will be going up. We must have adequate funding from the state if the college is to continue to grow in order to serve not only our local youngsters, but your young people as well. With SPC's open admissions policies, smaller classes, mix or academic and vocational programs and individualized attention, it is playing a vital role in preparing young people for the future.

As a result, I ask you to contact your state senator and representative and to ask them not to forget funding for junior colleges and South Plains College in particular. South Plains College is important to Levelland and Hockley County but its' fiscal well being is also important to you and the young people from your community who look to a brighter future because of their experiences at SPC.

Thank you for taking a few moments to read this letter and for placing a call to our state legislators. Your support of South Plains College is very important.

"Dances With Wolves" (Baila con lobos), la cinta de Hollywood que se supone que obtenga la mayor cantidad de premios "Oscar" en este año, no es política, según Kevin Costner, director y estrella de la película.

"No estoy en el negocio de los mensajes, sino en el negocio del entretenimiento . . . Estoy de acuerdo con el sentimiento de la cinta, no con la politica," dice él. Costner está al tanto de que la política en el arte es un mal negocio en este

pais. La cinta ha sido descrita como "... un relato bellamente filmado, una saga poética." Pero como cualquier poesía buena, está llena de metáforas y simbolismo que pueden tradpolíticos.

La pelicula es política porque todo arte es político. Hasta el arte decorativo y de la diversión hablan volúmenes acerca de las intenciones estéticas de los artistas y de su arte con relación a la clase económica y la política de una audiencia. El ser apolítico es ser político. La patia ha tenido siempre una influencia sobre la política y la historia de este país.

The AFL-CIO and Its Love Affair with All Things Mexican

It's nice to know that the Democratic Party is zealously protecting the health and working conditions of Mexican workers. It's also hard at work protecting Mexican workers from "exploitation" and protecting the environment of Mexico.

So declared the oldest political party in the world at the Democratic National Committee meeting just concluded in

Washington. The specific object of its attention is the request by our president to extend "fast track" negotiation authority so that a free trade association can be expedited with Mexico. Fast track authority means the president can negotiate an agreement and then send it to Congress for an up or down vote without amendments or congressional meddling.

The Democratic Party, the party of the people, formally opposes extension of fast track presidential authority. It states that a free trade agreement with Mexico would be a "disaster" if American workers aren't protected and that President Bush can't be trusted to protect American workers. Because Bush is so un-American, I suppose.

So sayeth the party of the people. The resolution condemning free trade with Mexico didn't originate from some working stiff, because there aren't any working stiffs on the Democratic National Committee. It originated in the headquarters of the American Federation of Labor/Congress of Industrial Organizations, the AFL-CIO. You know, the organization that represents about one in five workers in the United States and hasn't one Latino in a leadership position.

Not content to object to free trade with Mexico, the AFL-CIO and the Democrats fire on the successful "maquiladora" (mah-key-lah-door-ah) program which accounts for

400,000 manufacturing and assembly jobs along the border in Mexico and another couple hundred thousand jobs on the American side.

A historical note: It was the same AFL-CIO and same mind-set which extinguished a 20-year-old farm labor agreement with Mexico in 1965 that filled farm labor needs for an American at war end for a booming '50s America that fed the world.

The primary contention of the labor leaders is that any agreement with Mexico will cost Americans jobs because American companies will shut down and run off to lower-wage Mexico in a greedy effort to maximize profits at unemployed Americans' expense.

They also claim that companies will run off to Mexico where environmental considerations lag behind those in the United States, thus endangering the health of Mexican workers, as well as any Americans unfortunate enough to live within breathing distance of the Mexican border.

The compassionate leaders of the AFL-CIO also insist that the monstrous exploitation of Mexican workers working along the border at plants owned by American and Japa-

nese companies will continue. One should know that most of the 400,000 jobs involved in this "monstrous' exploitation have been created within the past few years and are filled in large part by mostly young, single women who, in Tijuana at least, make top dollar.

Before maquiladora, we recall that Tijuana, Mexico, was known throughout the world as tje quintessential sin city, 'Poso Del Mundo," the hole of the world, as author Ovid Demaris called it. Prostitution, booze and drugs awaited thousands of sailors and Marines every night just a dozen miles south of the San Diego navy

With maquiladora, the New York Times calls Tijuana "the Silcon Valley of Mexico." In the last fiscal year, the U.S. government collected \$700 million in duties generated by Tijuana's maquiladora plants at one single commercial border gate in San Diego. With maquiladora, thousands of jobs have been created in California, Texas and Arizona.

The AFL-CIO hasn't created one single job on either side of the border. Moreover, neither has the Democratic National Committee.

Are the labor leaders correct? Will Americans lose jobs to Mexicans willing to work for pennies?

Under free trade, have better paid Canadians lost their jobs to Americans willing to work for less? No.

A more pertinent question is, without free trade with Mexico, ahve American jobs moved to Farr East, to China, Japan, Korea, Thailand and Singapore? yes, they have, by the hundreds of thousands. Also, exactly where do these Asians spend their paychecks? Not

In contrast, several studies by the U.S. government and San Diego State University detail how Mexican maquiladora workers cross legally into the United States to spend hald their paychecks. These millions, in combination with the hundreds of million of dollars the maquiladoras pay in duties to the U.S. Treasury, are big bucks. Big Bucks created

Free trade with the United States will accelerate Mexico's economic progress as an equal business partner with the UnitedStates. With the exception of a few workers who would lose their jobs to far-away Asian factories anyway, free trade means more jobs for everyone, American and Mexican.

it means lower prices for American consumers. It means viable competition with the European Community and with Asia. Free trade with Mexico is a win-win situation for eve-

Nevertheless, I commend the fair-minded Democratic National Committee and its puppeteer AFL-CIO for their deep concern for "exploited" Mexican workers and for the current and potential "widespread damage on the environment in Mexico."

Mexico also appreciated their deep concern, I'm sure.

CRAZY HORSE

When will the State of Texas finally do the right thing? I always thought that the government should give all the kids of this state an equal opportunity to an education. Our children would compete and the bright ones, the hard working ones, the ambitious ones would gradually rise to the top to be the next generation of leaders. Sort of a survival of the fittest. And, of course, if the rich kids were too good to go to school with out kids, then they could go to a private school.

Why do rich folks, white folks in some places, have such a problem with equality of opportunity? Why doesn't the State of Texas do the right thing?

Last week in a 5-4 decision the Reaganistas on the U.S. Supreme Court apparently opened Panadora's Box. As I understood the NPR report on KOHM-FM, it said that in trials where coerced confessions were used it would not be an automatic reversal if there was other supporting evidence of guilt. They did say it would be a case by case determination as to whether there was sufficient supporting evidence.

Try to guess the effect of a confession on a jury. A confession

is a guaranteed conviction.

The five justices were the four Reagan and one Bush appointees on the Supreme Court. The four appointed by Kennedy, Johnson, Nixon, and Ford voted against starting down the path to a police state.

If your young son is picked up tonight, beaten by the police in Hereford or Selma, confesses to a crime, and at his trial the DA introduces some off the wall testimony from a drug addict copping a plea, you can bet he will be found guilty. On the appeal, instead of being able to get a reversal because of the coerced confession, there will now be a case by case determination to decide whether the other supporting evidence was adequate to support a conviction. What the hell does all this mean?

Dances With Politics

By José Antonio Burciaga
"Dances With Wolves." the
Hollywood film that is supposed to walk away with the
most gold Oscar status this
year, it not political, according
to Kevin Costner, director and
star of the movie.

"I'm not in the message business, I'm in the entertainment business . . . I agree with the sentiment of the movie, not the politics," he says. Costner is aware that politics in art is bad business in this country.

The film has been described as ". . . a beautifully filmed, poetic screen saga." But like any good poetry, it is filled with metaphors and symbolism that can easily be translated into

political terms.

So I'm eager to disagree with the director's assessment. Everything I see and hear in the arts has a political message, and no film of the Old West has ever had more truth and a more clear, politically charged message than "Wolves." The film, which has already earned more than \$100 million at the U.S. box office alone, has to do with a Lt. John Dunbar of the U.S. Cavaltry, who almost has his leg amputated in the Civil War and then sets out to serve as the lone soldier of an abandoned military post in the West. He befriends Sioux (Lakota) Indians, learns their language and culture, and like a good neighbor helps them. In return, they accept him as a brother and name his Dances With Wolves.

The film is political because all art is political. Even decorative and entertainment art speak volumes about the aesthetic intentions of artists and their art in relation to an audience's economic class and politics. to be apolitical is to be political. Apathy has always had an influence on this country's politics and histo-

"Wolves" is rife with politics because part frontier films, dating back to "birth of A Nation," have been political. often racist. I grew up before television, when the movie houses were filled with shoot 'em up Westerns that never employed real American Indians. Until "Wolves," it was common to find Jews or Latino actors playing Indian roles, and the only Indian "language' one heard were grunts, war hoops and fractured English phrases.

Indians were the bad guys.
I can still hear kids cheering in a movie house at the sight of bluecoats at full gallop, flag waving, trumpet sounding, as they raced to the aid of an embattled cowboy.

In "wolves," real Sioux -who already spoke Lakota or
learned it for the film -- are
employed, and English subtitles become necessary. I cannot help but think of the hightly charged Official English
political movement and how,
despite genocide and the deliberate and systematic destruction of a people and their
culture, the Lakota language
thrives.

For once a Hollywood film shows the reality of American Indian intelligence and sensitivity. It begins to tell their side of the story. "Begins" because it is still a white man's film with a white star, the protagonist being the much touted lone, rugged, American individualist.

This country's love of animals is an underlying theme of the movie. There is a message about yesteryear's environment, from surprise to sunset across the vast expanse of the West, depicted in breathtaking timeless scenes. Dunbar's first duty upon arriving at the abandoned fort is to drag dead deer out of a pond and burn it. the slaughter of the American bi-

son just for their hides is not entertainment but revisionist history, a reminder of what actually happened.

Lt. Dunbar falls in love with young white woman who has been raised from childhood by the Sioux. Her original and offical English painfully comes back so that she and the tribe can communicate with the soldier.

So here, a white woman and a white man suddenly find themselves alone with this tribe of Sioux. Reflections of Tarzan and Jane perhaps, but they are among very decent and gentle natives who nonetheless stand ready to defend the land and their way of life. Suddenly I thought of this white couple representing the tremendous population changes that will soon make whites in California a minority.

By the end of the movie, the white hero and heroine are transformed into American Indians for all practical purposes.

But for the U.S. Cavalty, they are the scum of the earth; they are traitors, and though loved by the Sioux, they are not really Indians.

I could relate to that. As a Chicano, a U.S. citizen of Mexican descent, I'm sometimes disliked by both sides. I'm neither and I'm both.

"Wolves" is great film, made for these intercultural times. (José Antonio Burciaga, an artist and writer at Stanford University, is a regular contributor to Hispanic Link News Service.)







Maradona Says He Will Retire

BUENOS AIRES, Argentina - Is Diego Maradona's soccer career over?

"I've had enough. I'm tired of struggling. I'm retiring for good," the Argentine star, faced with a minimum six-month and maximum two-year international suspension for cocaine use, was quoted as saying in Wedneday's editions of the Milan newspaper Corriere della Sera.

Maradona, the 30-year-old captain of Napoli of the Italian major league and the Argentine national team, gave a brief interview Tuesday during a flight from Rome to Buenos Aires.

Now I want to enjoy life, I want to enjoy my daughters," Maradona was quoted as saying.

Maradona left Italy as the disciplinary commission of the Italian League prepared to rule on his case. Italian League officials found traces of cocaine in his urine after Napoli's game against Bari on March 17.

Maradona and his business manager Marco Franchi have hinted - without offering proof - that the incident somehow is motivated by Argentina's victory over Italy in last year's World Cup semifinal, and Maradona's desire to break his contract with Napoli.

I'm certain that the clouds will be dispelled soon,"
Maradona said in a statement distributed in Rome on
Tuesday by the Italian news agency ANSA. I sincerely

After eluding reporters and photographers at Ezeiza international airport, Maradona told them tersely at his parents' house, "Enough was said on this issue in Italy. I have nothing to add."

There, he celebrated his daughter Dalma's fourth birthday. A TV camera caught him booting a ten-

nis ball soccer-style against a wall and bouncing it off his head.

The Italian League's 11-lawyer disciplinary commission is set to rule Saturday on the length of Maradona's suspension. The suspension automatically will be extended worldwide by the Interna-

ional Federation of Association Football (FIFA), soccer's governing body.

We don't think we have to go into action on a big scale because of this case," FIFA general secretary Joseph Blatter said in Zurich, Switzerland. "The reasons behind it probably have little to do with sports. If everything one reads is confirmed, it is a somewhat tragic case for him personally and as a role model in soccer. But he hasn't been that for a while, because of his general behavior."

Maradona's lawyer, Enzo Maria Siniscalchi, said he expects the minimum penalty for Maradona be-

cause cocaine can't be considered performance-enhancing if taken several hours before a game.

According to the experts who tested Maradona's urine samples, he possibly took cocaine 18 to 30 hours before the Napoli-Bari match.

We will not appeal the sentence if Maradona is given the minimum penalty," Siniscalchi was quoted as saying in today's editions of Milan's sports daily Gazzetta dello Sport.







One-Third of Hispanic Children Use Computers Census Bureau Reports

One-third of Hispanics aged 3 to 17 used a computer in 1989 compared with about one-half of non-Hispanics, according to a report from the Commerce Department's Census Bureau.

Ten percent of Hispanic children were in homes with a computer, and 64 percent of them used it. Twenty-six percent of non-Hispanic children had a computer in the home, 72 percent of them using it. (The level of use for Hispanic and non-Hispanic children was not

significantly different.) Among children enrolled in school, 38 percent of Hispanics used computers compared

47 percent of non-Hispanics.

Among those aged 18 and older. 17 percent of Hispanic 25 percent of non-Hispanics used a computer at home, work, or school.

Eight percent of adult Hispanics had a computer in the home and 54 percent of those having a computer reported using it. The proportions for non-Hispanics were 18 percent and 59 percent.

Among employed adults, 23 percent of Hispanics and 38 percent of non-Hispanics used a computer at work.

About 38 percent of adult Hispanics enrolled in school used a computer, compared with 44 percent of non-Hispanics.

As in all surveys, the data are subject to sampling variability and other sources of error.

unque los Estados Unidos de América son también conocidos como el país de la abundancia, actualmente viven aqui muchas personas que no tienen acceso a los servicios médicos. Nuestra población sin acceso al servicio médico está compuesta por individuos así como por familias enteras que se ven precisados a enfrentar un sinnúmero de obstáculos a la hora de recibir servicios de salud.

De acuerdo al Buró del Censo de los Estados Unidos, hoy en día, la cantidad de norteamericanos que no tienen seguros médicos que los cubran, asciende hasta alrededor de 31.5 millones y 20 millones más carecen de la adecuada cobertura de seguros de salud. Al contrario de la creencia popular de que sólo los desempleados carecen de seguros de salud, la mayoría de los norteamericanos sin estos seguros son empleados a tiempo completo. Algunos de ellos trabajan para companías que proveen planes de seguros, los cuales requieren que el costo sea compartido entre el empleado y el empresario, este excesivo costo hace que algunos servicios médicos no estén al alcance de los trabajadores. Algunos empleados son excluidos de los seguros de salud por una condición médica ya existente. Y otros trabajadores no poseen cobertura de seguros como parte de su paquete de beneficios porque su compania simplemente no puede afrontar los altos gastos para asegurar la salud de sus trabajadores.

También los niños están muchas veces atrapados en el problema de la falta de seguro médico. De acuerdo con las estadísticas dadas a conocer en 1989 por el Buró del Censo de los Estados Unidos, el 21.9 por ciento de los adolescentes

entre las edades de 16 y 24 años, y 15.3 por ciento de los jóvenes menores de 16 años de edad carecen de cobertura de seguros médicos. Sorpresivamente, estos menores de edad forman parte de familias en las cuales uno o ambos padres están empleados. Asimismo los



hispanos están representados con una gran desproporción en las filas de los que no están asegurados. Tal es así que de acuerdo a las cifras procedentes del Buró del

Marcelino Oliva, D.O. Censo, en 1988 el 26.5 por ciento de los hispanos estaban sin seguros médicos en comparación con sólo el 11.7 por ciento de los norteamericanos de la raza blanca.

Otros grupos sociales que carecen del apropiado servicio médico son los desempleados y los trabajadores pobres. Todas estas personas viven bajo el nivel nacional de pobreza, el cual es de \$12,675 dólares al año para una familia de cuatro miembros. De acuerdo con el Centro Nacional para Niños en la Pobreza, con cede en la Universidad de Columbia, (Columbia's University National Center for Children in Poverty) el 23 por ciento de los niños menores de 6 años de edad viven actualmente en la pobreza. El informe también señala que el sistema de Medicaid solamente asiste a alrededor del 40 por ciento de los pobres.

Otros norteamericanos no reciben los beneficios del Medicaid, el programa de seguro médico de asistencia pública pagado por el gobierno estatal y federal, porque ellos no saben como entrar en el sistema o no tienen la información apropiada para llenar una solicitud para este servicio social. Otros no solicitan la ayuda porque confrontan barreras con el lenguaje o porque piensan que el procedimiento para asistencia consume mucho tiempo. Las familias que viven en zonas rurales o en comunidades marginales dentro de las ciudades (inner-city communities) se tienen que enfrentar a obstáculos aún mayores. Los residentes de áreas rurales muchas veces tienen que viajar largas distancias para obtener atención médica y los sistemas de transportación urbana en las grandes ciudades son muchas veces ineficientes a la hora de garantizar el transporte de los ancianos y de los enfermos hacia los centros médicos.

La disponibilidad de los servicios médicos es también un problema. Por ejemplo, los hospitales de las pequeñas comunidades frecuentemente no poseen suficientes doctores o personal especializado, así como también carecen de médicos en los salones de emergencia. También estos pequeños hospitales muchas veces tienen facilidades limitadas para efectuar pruebas médicas.

Desde 1892, los médicos osteopáticos han mantenido la tradición de servir a las personas sin acceso a los servicios de salud, especialmente aquellos que viven en zonas rurales americanas. A pesar de que los médicos osteopáticos sólo forman el 5 por ciento del total de toda la población de médicos en el país, actualmente el 15 por ciento de la totalidad de los médicos que ejercen su profesión en áreas donde la población es de 10,000 habitantes o menos, está formada por los médicos osteopáticos.






