Mexico City to L.A. Plane Crashes

Clean up crews continued to search for bodies in the aftermath of Mexico's worst airplane crash in history.

A Mexicana Airlines Boeing 727, bound for Los Angeles from Mexico City crashed shortly after take off Monday killing all 166 persons aboard.

The plane crashed 90 miles northwest of Mexico City in the El Carbon mountain top. It was scheduled to stop in Puerto Vallarta and Mazatlan before reaching its' destination at LAX.

There are believed to have been at least seven and as many as 25 Americans aboard.

Helicopters began to lift the bodies to a nearby makeshift morgue, while loved ones waited anxiously at the Morelia Mexico airport for word of survivors.

"Unfortunately, there are no survivors," said a Mexicana

spokesman. All aboard were apparently killed on impact.

It will take months before it is determined what caused the accident. One eyewitness reported that the plane appeared to blow up in mid air before it crashed against the mountain peak.

The pilot radioed the air traffic controller that he was losing altitude. Fourteen minutes after take off the airport lost contact with the jet. The Boeing 727, first introduced in 1963, is numerically the most successful civil aircraft ever built. They were last built in 1975.

In 1969, a Mexicana Airlines B-727 crashed in a mountain near Monterrey, Mexico killing all 79 aboard.

Monday's Flight 940 is worst air disaster of 1986.

Names of those who perished are to be released in the next few days.

Denuncia ex-dirigente Izquierdista

Opera claramente en México fuerte columna guerrillera

MEXICO.- Socrates Campos Lemus, uno de los tres mas importantes dirigentes del movimiento estudiantil izquierdista que sacudio a este pais en 1968, aseguro que las matanzas ocurridas en el estado de Oaxaca presentan todos los sintomas de tratarse de un movimiento guerrillero.

"Los problemas economicos que ha venido sufriendo el pais, poco a poco son utilizados por los grupos politicos de oposicion para llevar agua asu molino", senalo Campos Lemus.

El antiguo dirigente estudiantil afirmo tajante: "Hay indicios muy claros de que la guerrilla comienza a aparecer

en Oaxaca. Su accion no es local, ya que tiene una organizacion que abarca el sureste de Mexico y no hay duda de que cuenta con muchos extranjeros, espafios, guatemaltecos, colombianos y salvadorenos".

Socrates Campos Lemus explico que durante un recorrido por la sierra "escuchamos muchas istohistorias de columnas armadas que recorren los pueblos y las rancherias".

"No son imaginaciones de los campesinos, son hechos reales que dan una idea de que en el sureste del apis, las cosas ya tomaron un nivel peligroso para la paz y la tranquilidad de

Mexico", aclaro el antiguo dirigente izquierdista.

Finalizo diciendo que "ya es un hecho que el conflicto centroamericano toca a las puertas de Mexico y sienta sus reales en el sureste. En San Baltazar Chichicapán y en San Vicente Yaxe, hace semanas fueron emboscadas columnas policiales por un fuerte operativo guerrillero. La tática fue clara, con todo el estilo que se viene utilizando en El Salvador: aislar a un pueblo, destruir los pasos y accesos, establecer trincheras y esperar a que las fuerzas regulares se presenten para ser emboscadas".

Fuerza Contra El Terrorismo

NUEVA YORK.— La administracion Reagan, en un nuevo documtno sobre como combatir el terrorismo, se muestra partidaria de un juicioso uso de la fuerza como respuesta a ataques terroristas afirmaron en dias pasados en Washinton fuentes oficiales.

La recomendacion esta incluida dentro de un informe redactado por una comision especial, presidida por el Vicepresidente George Bush, que sera presentado oficialmente en estas semanas, informo el diario The New York Times.

El informe llama a una coordinacion dentro de la administracion sobre las distintas opiniones de como combatir el terrorismo y

recomienda que el Departamento de estado mantenga la competencia para el exterior, mientras la Oficina Federal de Investigaciones (FBI) lo hace dentro de los Estados Unidos.

El director de la comision Almirante James Holloway, propuso por su parte que toda la actividad antiterrorista fuera dirigida desde el Departamento de Defensa, pero el final la decision fue compartirla entre Estado y Justicia.

Otra de las recomendaciones de la comision es la creacion de un comite de alto nivel de coordinacion en la Casa Blanca, yua que asegura qu el terrorismop continuara azotando la sociedad durante, por lo menos, una decada mas.

La comision, que ha

trabajado durante varios meses en este tema, estima que es necesario crear un centro especial de informacion terrorista y aumentar las recompensas por la entrega de datos que faciliten la caputra de los terroristas.

Senala tambien el documento que es necesario concretar acciones de caracter internacional para combatir la ola de atentados terroristas que cada dia causan mas victimas y que ha llegado a convertirse en uno de los graves problemas mundiales de la actualidad.

Hace incapie la comision en que para atajar este mal del siglo XX es necesario hacer "uso juicioso" de la fuerza y no dejarse amedentar por el terrorismo.

Editorial Endorsements

As has been the custom for the past 10 years, El Editor has always tried to play an active role in politics and in endorsing candidates for public offices. We do this in an effort to let our readers know who we think is the best candidate for a certain position and who we feel will work for the interests of our community.

As we make our endorsement we will offer specific attributes that we feel should be present in a public official and what that person's stand should be in order to better serve our community.

MAYOR

Although 11 candidates entered the race for Mayor, we saw that only 4 emerged as viable candidates for the position. Those were: Richard Anciso, Peck McMinn, P.L. Malouf and Dwayne Miller.

The powers that be, including banks, realtors, the Chamber of Commerce and the A-J have endorsed and worked for the election of McMinn, pointing to his involvement in everything from building a putt-putt to President of the Chamber.

In our questionnaire McMinn responded as a true politician would. "Saying many things but committing himself to none."

We agree that Lubbock is in dire need of strong leadership, and it is our opinion that leadership at the public official level can only be obtained through commitment.

Our second choice for endorsement was Ms. P.L. Malouf. In reading and listening to answers given by her at forums and printed matter, she seems open and sincere in her answers. Unfortunately being open and sincere and greeting people with a good socialite attitude does not elect mayors. Ms Malouf would be an excellent chairperson of Civic Lubbock or of the Junior League.

We were sorry not to receive any answers to our questions from Dwayne Miller. He seemed like a good and viable candidate, but we cannot judge when facts are not presented.

Our endorsement goes to Richard Anciso. Although Anciso, in our opinion needs to become better informed on many of the issues facing our community, we feel that his background and actual experience in our community will make him accessible and responsive to our needs. We suggest that you vote for Mayor-Richard Anciso.

City Council—District One

Maggie Trejo and Charlie McQueen are the candidates for this position. McQueen did not even bother to pick up our questionnaire last week but in reading and listening to answers given questions made at forums and in the other newspapers, it is clear to see that McQueen is a typical Reaganite who insists that programs to aid the disadvantaged should be outlawed because everyone should be able to make a living for themselves.

Our endorsement for the District One city council seat goes to Maggie Trejo.

We make this endorsement with reservations. Reservations because in the past 2 years we have seen Trejo go along with the other Council members on some major issues. We have seen little if any protest for funds that should have been allocated for helping the underprivileged when they are used for upgrading city hall. We have not seen a position taken toward city funding for minority organizations such as COMA, who has for the past years been doing the work of the majority Chamber of Commerce for a fraction of the funding. We can also point to the lack of communication between the Chicano organization in Lubbock and Trejo. Although the claim is made that doors are always open, we have always held that it is the responsibility of the public official to serve their constituents rather than visa-versa. Trejo has been our representative for the past two years, we hope that the coming years will see her as a more aggressive and stronger council person who is needed to speak for our community. We urge you to vote for Maggie Trejo for City Council, District One.

City Council District Three

District Three is an area of town in which many of our readers reside. For this reason, it has become crucial that we use our voting power in this box to elect persons that are sensitive and responsible to the needs of our community.

Our endorsement for this seat is George Carpenter.

We support Carpenter for several reasons but first and foremost is because during his term of office he has listened and acted positively toward our requests.

We suggest that you vote for George Carpenter for City Council.

City Council District Five

Gary Bellair and Nina Tramel are the only ones who responded to our questionnaire. Flip a coin—Heads, West Lubbock wins; Tails north and east Lubbock loses.

School Board District One

Si Ronald Reagan Fuera Combatiente

Despues de esto, tambien debiera de emplear sus habilidades de persuacion para convencer a los estadounidenses que

nuestras tropas necesitan permanecer alla durante años.

Este es el precio que deberiamos de estar dispuestos a pagar por una Nicaragua libre y democratica, si es, como lo cree Reagan, indispensable para nuestra propia seguridad nacional. El enviar dinero y jugar con la palabras resulta estrictamente una conveniencia politica.

Si Reagan cree que esto no puede hacerse, como lo ha demostrado, entonces sus habilidades de "gran - gran comunicador" deberian de emplearse para apoyar la propuesta hecha por ocho **NACIONES** latino-americanas que se reunieron hace poco en Carbalada, Venezuela. La propuesta pide la remocion de todos los asesores militares extranjeros, la suspension de maniobras de las maniobras militares, la terminacion del apoyo a los ejercitos guerrilleros, la congelacion del aumento desmesurado de armamentos en la region y el respeto a la integridad territorial de cada nacion.







SANTIAGO DE CHILE.- Chile debe encontrar una salida pacífica a la democracia para erradicar la violencia política, advirtió en días pasados el Cardenal Arzobispo de Santiago, Monseñor Juan Francisco Fresno, en un dramático mensaje de Cuaresma.

"Sin reconciliación y pas cada día se hará mas peligros el camino que Chile tiene que recorrer", afirmó el prelado, aludiendo al "flagelo de la violencia que nos ha atacado con creciente intensidad".

"debemos hacer hoy todo lo posible por conseguir la paz", agregó al recordar su anteriores gestiones de reconciliación, que culminaron en Agosto del pasado año cuando 11 partidos políticos, desde la derecha conservadora a la izquierda marxista, suscribieron un Acuerdo nacional para restablecer la democracia.

El acuerdo, que proponía la realización de elecciones libres, fue rechazado a fines de Diciembre por el Presidente Augusto Pinochet, que en esa ocasión dijo que permanecería en el gobierno hasta 1989.

"En 1985--dijo Monseñor Fresno - con inquietud de pastor y no de político, di pasos tendientes a promover un dialogo que colaborara a una transición pacífica hacia la democracia", advirtió.

Mas adelante, en Valparaíso, dos integrantes de un presunto comando subversivo resultaron heridos de bala en un intento de tiroteo con la policía en pleno centro de este balneario. 140 kilómetros al oeste de la capital, informaron las autoridades.

Otros dos "delincuentes subversivos" lograron escapar y la policía desplegó un operativo en su persecución, dijo la agencia semioficial de noticias orabe.



Columna de Inmigración

Papelito canta

En este artículo quiero discutir un tema que aún cuando no es sobre una área específica de leyes de inmigración, tiene mucha importancia para todos los casos de trámites ante Inmigración. Es la importancia de los papeles y documentos que se presentan como evidencia para probar cada caso.

En este país, uno necesita comprobar los datos de su vida con documentos oficiales, o sea, ni siquiera puede alegar que el nombre de uno es el que es, sin tener los documentos para comprobarlo. En el sistema burocrático se necesita tener documentos para probar: 1) Datos personales: cuándo ha nacido, dónde, quienes son los padres; 2) Situación familiar: si es viudo, casado, etc., cuándo se casó y con quién; cuándo se divorció, en qué corte y en qué estado o en qué país; cuándo nacieron los hijos y en qué estado o país; 3) Domicilio: dónde vive, si es dueño de su casa o si alquila y por cuánto tiempo; 4) Educación: por cuánto tiempo estudio, dónde y qué certificados o títulos ha recibido; 5) El trabajo: qué trabajo ha hecho, en dónde, para quién, y por cuánto tiempo y con qué sueldo; 6) Área financiera: cuál es el ingreso semanal o mensual, cuántos dependientes tiene, si tiene cuenta de banco y qué clase de cuenta y por cuánto tiempo la ha tenido; las deudas que tenga y con quién, y por cuánto; los impuestos que ha pagado, a quién y cuánto; si es o no dueño de casa o finca raíz y cómo, cuándo y dónde la compró, y si tiene carro u otro vehículo.

Para probar estos datos usted puede presentar uno o más de los siguientes documentos (según sea necesario):

Para datos personales: partida de nacimiento, certificado de bautismo, orden de la corte autorizando cambio de nombre, certificado de matrimonio, declaraciones juradas de parientes, si no hay el certificado de bautismo y la partida de nacimiento.

Para probar la situación de familia y el estado civil: certificado de matrimonio, decreto de divorcio, certificado de defunción.

Sobre la educación: diplomas o certificados del colegio o universidad, transcripciones de las notas recibidas.

Para el trabajo: cartas de empleadores o patrones anteriores confirmando cuando trabajó para ellos y en qué cargo, con qué sueldo, copias del formulario W-2 que entrega el empleador cada año en enero mostrando la totalidad de lo que ha devengado el año anterior.

En el área financiera se puede presentar carta del banco donde tenga su cuenta confirmando si la cuenta es de ahorros o cuenta corriente y verificando el estado de la cuenta, recibos de facturas o cheques cancelados, talonarios de cheques y copias de "money orders" y documentos mostrando las deudas y el sistema de pago de ellas.

Para comprobar domicilio se puede presentar la escritura de la casa mostrando los dueños, o contrato de arrendamiento, mostrando los inquilinos responsables.

Para pobrar nacionalidad y residencia se necesita un pasaporte y las visas dentro de este, la partida de nacimiento, cédula de identidad, hoja de servicio militar, certificado de ciudadanía, la tarjeta de residente o documentos que muestren el status de inmigración.

Lutheran Social Service of Texas On the Move to help Hispanics in Lubbock

People of all ages, with all types of concerns, are helped through services offered at Lutheran Social Service of Texas in Lubbock. Through the types of services offered, people of all ages can choose the best option for them.

The unplanned pregnancy counseling is a program through Lutheran Social Service which is free. Girls and women sometimes feel overwhelmed and unable to decide what to do when faced with an unplanned pregnancy. L.S.S.T. offers a supportive, confidential environment in which the individuals can share their feelings regarding the unplanned pregnancy. Women are educated as to their options.

Another service that is offered by Lutheran Social Service of Texas is adoption. In the area of adoption, L.S.S.T. offers several choices. There are three types of adoption; international adoption, infant adoption (traditional or open), and special needs adoption. Special needs adoptions includes minority children, older children, or handicapped children. Some special need adoptions are conducted through a contract with the Texas Department of Human Services. In West Texas, there is a need for minority couples to adopt minority children. The number of minority children in foster care is rising. For this reason, Lutheran Social Service is committed to working with minority families.

A program which gives elderly and disabled adults 24 hour access to emergency assistance is the Emergency Response Service (ERA). Help is available at the push of a button. Most elderly people wish to remain in their own homes or neighborhoods for

as long as possible. Yet, some of them have serious illnesses or disabilities that may suddenly become critical. Some people fall and are unable to get up or to call for assistance.

Emergency Response Service is a system using a device connected to a telephone. By pushing the button on the main unit or the hand held unit, the person sends a signal to the response center, based at the Lutheran Home of West Texas. If the phone is not answered, designated friends or relatives are called on to investigate. Fire, police, or ambulance services can also be called if appropriate.

Lutheran Social Service of Texas has a contract with the Texas Department of Human Services to provide ERS to those persons meeting the qualifications. The monthly service fees are available on a sliding fee scale. Currently, the monthly fee is \$16.25 locally, \$21.75 long distance. The Emergency Response Service is available in Lubbock, Lynn, Terry, Lamb, Hockley, Hale, Floyd, Crosby, and Dickens counties.

Neighborhood House assists families experiencing a financial crisis. The program can assist with rent, utilities, medical services, food, and clothing. Neighborhood House has an after school program for children in the Posey school area which offers classes in computers, arts and crafts, Campfire, and recreational activities.
