Farmworkers Go On Strike

More than 300 farmworkers went on strike January 15, 1981 in the orange orchards on the Rio Grande Valley, and more are expected to join the strikers in the following 12 hours; according to reports by a spokesman of the Texas Farmworkers Union of which is directing the labor organization of this event.

According to the report furnished by a source of information, the requests of the strikers are: First to permit a collective contract that would be negotiated between the farmworkers and the growers; second that the farmworkers be represented by the Texas Farmworkers Union.

The strategy to follow the activities of the strike has changed in its structural form which differs from former strikes lead by the TFWU. "We will not be picketing like on the previous occasions, because the growers of the orchards utilize the police, DPS, and even the Texas Rangers." What we are presently doing in this strike which has just begun is to use the strategy that the workers in Poland are using. With the motive to see if on this occasion and with this method, we will be better heard by the authorities in the Department of Labor and supported by the official syndicate such as AFL-CIO. In that they have ardently helped and have openly supported in press conferences the Polish workers. Now we will finally realize if the Department of Labor of the United States and the official syndicates of this country are—"Lamplight in the street and darkness in his house," said the spokesman of the TFWU in his account directed to this informative source.



## Palomino Guest In Warrior Tournament

## Juez Federal Ordena Cambios En Sistema de Educacion Bilingue

Un juez federal proclamo este lunes pasado que el estado de Texas y el sistema de educacion esta discriminando en contra estudiantes Chicanos. El juez ordeno que se desarrollara un nuevo plan para proveer una educacion igual para todo estudiante que hable espanol y que el plan se efectue dentro de 6 años.

En su declaracion de 67 paginas el juez del distrito William Wayne Justice dijo que el estado de Texas y la Agencia de Educacion de Texas habia discriminado en contra los Chicanos "en violacion de la Enmienda 14 de la constitucion de Estados Unidos."

El juez ordeno que los oficiales del estado se junten con los que pusieron la demanda — LULAC y el American G.I. Forum — para el dia 29 del presente mes para empezar a desarrollar un plan que se pudiera submitir para el dia 2 de Marzo a la corte para inspeccion.

"Estos niños ya han esperado bastante para poder beneficiar de una educacion adecuada," escribio Justice. "Lo mas pronto que se puedan destruir las injusticias etnicas, lo mas pronto que la nacion puede enfrentar el futuro."

Reben Bonilla, presidente nacional de LULAC dijo que la declaracion de Justice era una tremenda victoria para mejorar la educacion de los Chicanos no nomas en Texas pero en todos los Estados Unidos. La demanda se llevo 10 años para determinar.

Justice dijo que el actual plan, que provee educacion bilingue desde kindergarten hasta el grado 3 solamente en escuelas que tienen mas de 20 estudiantes que no hablan bien el ingles no era adecuado. El juez declaro que el costo adicional para proveer educacion bilingue para todos los niños no era razon porque limitar el programa.

"La historia tragica de discriminacion no se va desaparecer en un dia o una semana ni en un año escolar," escribio Justice. "Pero estos niños merecen, cuando me-

nos, una oportunidad para alcanzar ser productivos y alcanzar un lugar en la sociedad americana. Miles de niños Mexico Americanos van a quedarse educacionalmente desahilitados si no son dado la oportunidad de ser educados en su propia idioma y no tendrán la oportunidad que todo americano toma de facil.

La declaracion de Justice noto que 44 por ciento de todo Chicano en Texas sufren de dificultades severas en leer y que 47 por ciento de todo Chicano no termina la escuela secundaria. Esto es comparado a 15 por ciento de los anglos que no terminan la secundaria. Dijo el juez que solamente el por ciento de los Chicanos entran al colegio comparado a casi 50 por ciento de los Anglos.

Justice tambien noto que el desempleo entre Chicanos es dos veces lo que es en otros grupos y dijo que esto es solamente una de las manifestaciones que causa el problema.

## Sube El Costo De Alimentos En Mexico

MEXICO.—Apenas anunciados los alaríos mínimos que regirán para la mayoría de los trabajadores mexicanos durante 1981, se desató una serie de aumentos de precios de artículos y servicios de primera necesidad.

El Partido Mexicano de los Trabajadores y el Partido Socialista de los Trabajadores denunciaron que aún concediendo el aumento de salarios, el trabajador mexicano promedio sólo gana la mitad de lo que necesita para vivir.

La relativa felicidad provocada por el aumento del 39 por ciento en el salario mínimo, anunciado el 1ero. de enero, duró poco. El diario gubernamental El Nacional informó sobre diversos aumentos de precios.

Un estudio del Partido Mexicano de los Trabajadores indicó que un trabajador en la ciudad de México necesita 19 dólares diarios para poder subsistir con una familia pequeña. El nuevo salario mínimo es algo más de 9 dólares diarios.

## Piscadores de Citricos Salen En Huelga

Más de 300 trabajadores asalariados del campo salieron en huelga el día de hoy (jueves 15 de 1981) en los huertos de naranja en el Valle del Rio Grande, y se espera que otros tantos se unan a los huelgistas en las proximas 12 horas; según informes de un vocero de la UNION DE CAMPESINOS DE TEXAS, la cual esta dirigiendo la labor organizativa de este acontecimiento.

Según el informe proporcionado a esta fuente informativa, las peticiones que los huelgistas estan haciendo son en primer lugar: Que se admita un contrato colectivo que sea negociado con los trabajadores y el patron y que estos primeros (los trabajadores) sean representados por la Union de Campesinos de Texas.

Según el comunicado, la estrategia a seguir sobre las actividades de esta huelga han cambiado en su forma estructural a diferencia de las huelgas pasadas dirigidas por el TFWU.

"No vamos a estar en linea de "piqueteo" como en las ocasiones pasadas, porque los dueños de los huertos nos hechan la policia, al DPS y hasta los Rangers de Texas". "Lo que estamos haciendo actualmente en esta huelga que acaba de principiar es usar la estrategia que los Trabajadores de Polonia estan utilizando, con el motivo de ver si en esta ocasion y con esta estrategia somos escuchados por las autoridades del Departamento de Trabajo y apoyados por los sindicatos oficiales como el AFL-CIO, puesto que estos han ayudado arduamente y han salido en conferencias de prensa apoyando a los trabajadores Polacos. Ahora nos daremos cuenta en realidad si el Departamento de Trabajo de Estados Unidos y los organismos sindicales oficiales de este pais son "candil de la calle y oscuridad de su casa", dijo el vocero de el TFW en su comunicado dirigido a esta fuente informativa.

## Los Hispanos y Los Cuerpos de Paz

Los Cuerpos de Paz ("Peace Corps") han salido adelante. Este año cumplimos 21 años de servicio al extranjero.

Como director de los programas que envuelven 1,600 voluntarios al servicio de 21 naciones de Centro y Sur América el Caribe, considero que éste es el momento de corregir los errores pasados y de lograr una mayor participación de los hispanos en nuestros programas, especialmente en América Latina.

Durante las dos décadas que los voluntarios de los Cuerpos de Paz han servido a los pueblos hispanos, muy pocos latinos han estado envueltos en el esfuerzo. En algunas áreas, su participación ha sido nula.


En general, los Cuerpos de Paz han llevado personas blancas a los países visitados. Seis por ciento de los 5,700 voluntarios activos pertenecen a grupos minoritarios. Menos

de dos por ciento de éstos son hispanos.


Este desequilibrio afecta a los Cuerpos de Paz y a los Estados Unidos pues promueve una imagen errónea de América. No estamos demostrando lo diversa que es la sociedad americana — sus muchas razas y gentes.

Necesitamos nuevas maneras de reclutar voluntarios. Hay que hacer ver a los hispano-americanos que los Cuerpos de Paz estan accesibles, y que benefician tanto a los países que sirve como a la comunidad hispana en América y a los voluntarios mismos.

Tradicionalmente, los esfuerzos de reclutamiento de los Cuerpos de Paz no han alcanzado a la comunidad hispana. Noventa y cinco por ciento de todos los voluntarios provienen de colegios y universidades, mientras que sólo cinco por ciento de los graduados de las universidades son minorías. A la vez, por supuesto, nuestros reclutas son escogidos de entre ex-voluntarios — de los cuales pocos

son minorías. Tenemos que buscar voluntarios en las iglesias hispanas, en la comunidad, entre los comerciantes, en las comunidades agrícolas, los centros comunales, y en los colegios de la comunidad y escuelas vocacionales con alta matrícula de hispanos.

Tenemos que llegar a los hombres y mujeres hispanos retirados — así como a otros americanos de edad avanzada — quienes desean hacer algo productivo el resto de sus

vidas. Esto significaría que cuando los Cuerpos de Paz sean interrogados acerca de los hispanos, la respuesta será ofrecida por una persona hispana y no por otra — bien informada pero ignorante sobre asuntos latinos.

La mayoría de los miembros de los Cuerpos de Paz opinan que el ajustarse a una nueva cultura y el aprender un nuevo idioma toma uno de los dos años de servicio del voluntario.

Los voluntarios latinos tienen una ventaja en los países de habla hispana pues ambos comparten ciertas características culturales como la comida, la música o las tradiciones. No hay necesidad de entrenarlos por seis u ocho semanas en el idioma. Los voluntarios hispanos pueden hacer una excelente labor en América Latina.

Parte de mis planes como director regional de Latino América es aumentar notablemente el número

de voluntarios y administradores hispanos en los Cuerpos de Paz. También debemos aumentar el número de contratos y programas otorgados a las firmas hispanas. Al presente estamos trabajando para hacer una realidad la meta de incrementar la representación hispana en los Cuerpos de Paz.

El servir en los Cuerpos de Paz educa al individuo y mejora las oportunidades de empleo de este. Yo sé de firmas que prefieren emplear a un ex-voluntario de los Cuerpos de Paz que a un individuo con un Doctorado en Relaciones con el Extranjero.

Mi extensa labor en los países de América Latina me ha enseñado que los problemas de los pobres en estas naciones son los mismos que enfrentan los pobres de América. Luego de dos años de trabajo voluntario en el exterior, una persona está mejor preparada para trabajar en las comunidades de los Estados Unidos. Y aunque decimos que la caridad comienza en casa, el saber resolver problemas no necesariamente se aprende aquí.

Nosotros los hispanos debemos reconocer que nuestra comunidad — por ejemplo, Robstown, Texas — se extiende más allá de los límites de la ciudad. Debemos ampliar nuestros horizontes y usar nuestras destrezas al nivel municipal, estatal, nacional e internacional pues los sucesos que ahí ocurren afectan nuestras vidas.

Solo participando en las diversas actividades del género humano haremos sentir nuestra voz y seremos respetados.

# Las Multitudes Extranjeras

## Vistas Desde Una Botella Termica

Normalmente es señal de mala conducta el criticar un producto antes de que salga de la línea de ensamblaje, pero estoy infringiendo las reglas en el caso del informe que la Comisión Secreta sobre Política de Inmigración y Refugiado está planeando "revelar" al presidente y al congreso el primero de Marzo.

"Revelar" es una palabra inadecuada. Hasta ahora, el 90 por ciento de lo que se va a recomendar a modo de planes para nuestra política futura de inmigración ha sido "filtrado" por el personal de la nales públicos del propio presidente de la Comisión, Theodore Hesburgh.

En mi calidad de enlace congresional de la Liga de Ciudadanos Latino-Americanos Unidos (LULAC), he observado a la Comisión en acción durante la mayor parte de su existencia. He conferenciado con representantes de otros grupos hispanos en todo el país y tratado de medir el efecto que algunas de las recomendaciones — en caso de que el Congreso las adopte — tendrán sobre las familias hispano-americanas.

Pero mi preocupación va más allá de la sustancia de lo que la Comisión se propone recomendar.

Revisemos: La Comisión fué creada por el Congreso para efectuar una evaluación completa de la maraña de nuestras leyes de inmigración al estilo de Rube Goldberg. Se le pidió que preparara recomendaciones administrativas y legislativas que crearán un instrumento sólido, del mundo real, para llevarnos — como una nación entre muchas — al siglo 21.

Pero sus intenciones se vieron trastornados por dos errores. El primero fué algo sobre lo cual no podía hacer mucho. La Comisión nació desproporcionada — sobrecargada con miembros de la Cámara y del Senado.

La mitad de sus 16 miembros procedían de esas dos cámaras. Cuatro más llegaron del gabinete presidencial. Solamente los últimos cuatro — nombrados por el presidente — arribaron sin antenas enfocadas hacia las encuestas de opinión y la conveniencia política.

Tristemente, durante la existencia de la Comisión, el público se vió lanzado al interior de un chubasco anti-extranjero que todavía crece en intensidad. En estos días, los inmigrantes no tienen que hablar para que se les identifique como recién llegados a nuestra tierra. La mayoría tienen el color de las hojas de otoño, y son fácilmente identificables en el trabajo.

Ahora que los empleos no están muy abundantes, nuestros representantes congresionales oyen con regularidad de sus electores en sus distritos, acerca de los "extranjeros que se apoderan de los empleos estadounidenses" — aún de aquellos empleos que ningún estadounidense quiere.

En apariencia reaccionando al furor público, la Comisión buscó una solución política al asunto. Trató de hacerle el trabajo al Congreso.

La inmigración es un fenómeno cultural con pautas e implicaciones mundiales. Es demasiado complicado para resolverlo con tarjetas de identificación, campos de radar y cercas que le cortan los dedos de los pies a las personas. La humanidad, en todas partes, fluye a través de las fronteras nacionales, sin que se le cuente ni se le controle. Los 15 millones de refugiados que reconocen las Naciones Unidas son únicamente una gota en el balde. Muchas naciones — incluyendo a México — tienen que hacer frente a poblaciones desmesuradas, potencialmente explosivas.

Los problemas internacionales necesitan perspectivas internacionales. Los vecinos, cercanos y lejanos, deben hallarse íntimamente involucrados desde el principio.

La Comisión estudió unos cuantos asuntos especiales, definidos estrechamente, de consecuencia internacional. Escuchó a unos cuantos expertos "extranjeros" y a unos cuantos "expertos" estadounidenses en asuntos extranjeros. Pero, en total, se reunió dentro de una botella térmica y estudió el problema asomándose al cuello.

Su enfoque de túnel se reflejó en el hecho de que ni siquiera una de sus doce audiencias tuvo lugar en una ciudad de la frontera entre los Estados Unidos Y México, un mundo bicultural que hay que experimentar para comprenderlo.

Las recomendaciones del personal de la Comisión, presentadas en su reunión pública final en Washington el mes pasado, ni se retiraron ni clasificaron la documentación y el testimonio voluminosos proporcionados y los asuntos planteados por los comisionados individuales estuvieron más adornados con emoción y prejuicio personales que con hechos y lógica. Se hizo evidente que los comisionados no estaban preparados con muchos de los detalles delicados referentes a la reunificación de las familias, las disposiciones excluyentes, la legaliza-

ción, las sanciones a los empleadores y los programas de trabajadores temporeros.

Sus votos parecían hallarse influenciados más por las nociones preconcebidas y las encuestas de opinión pública que por los datos prácticos y la investigación estadística. Lo más conspicuo fué que dejaron de enfocar el asunto como de calidad internacional.

Para su crédito, la Comisión se las arregló para cuantificar el asunto de los trabajadores indocumentados de mejor forma que lo hay hecho cualquier grupo anteriormente. Eso

ayudó a desinflar las exageraciones desmedidas del pasado, divulgadas por individuos tanto del gobierno como de fuera de éste. Es de esperarse que haya hecho enmudecer a algunos gritones.

Desgraciadamente, ahora está volcando todo su trabajo en el reino de la política — donde la gritería es un modo de vida — sin haber proporcionado el conocimiento y el análisis preliminar ponderado que son esenciales para que los estadistas de batan un curso de acción y un plan que

resulten, a largo plazo, del mejor interés para este país y para el mundo.

SUPPLEMENTING MEDICARE COVERAGE

Medicare covers most major health care costs but it doesn't pay all your medical expenses. For that reason, many private insurance companies sell health insurance policies to supplement Medicare.

If you are thinking of buying private insurance to supplement your Medicare protection, we suggest that you closely examine the benefits offered by the policy. Some policies will pay for services which are not covered by Medicare. Some pay the deductibles and other dollar amounts that Medicare does not pay. But others may provide the same coverage you have under Medicare and won't pay any benefits if Medicare does. Make sure you don't buy a policy which is unnecessary or which duplicates your Medicare protection.

are just becoming eligible for Medicare and you already have private health insurance, you may want to get in touch with your insurance agent to discuss your insurance needs in relation to Medicare. Don't cancel any private insurance you have now if you aren't yet eligible for Medicare—especially if you have dependents who are covered under your present policy.

You also should know that no private company or agent selling insurance to supplement Medicare is connected with the Federal Government. Some companies use names, designs, or envelopes that can give the impression they are connected with the Government in some way.

To help Medicare beneficiaries decide whether they need private supplemental insurance, the Health Care Financing Administration has published a pamphlet called *Guide to health insurance for people with Medicare*. The pamphlet explains what Medicare covers, describes the kinds of private insurance supplements available, and provides useful information to beneficiaries considering the purchase of supplemental insurance. Free copies of the guide are available at social security offices, and some senior citizens' centers.

### Oakland To Deal Pastorini

SAN DIEGO (AP)—Oakland Raiders boss Al Davis, disenchanted with Dan Pastorini, is trying to unload his hard-luck quarterback, according to a source close to the team.

A West Coast national television network commentator said Davis has told him Pastorini is "gone. It's just a matter of where." The commentator, who is close to the Raiders, said Davis was trying to get the best deal for Pastorini.

The Raiders are in position to deal Pastorini because of the comeback of quarterback Jim Plunkett, who passed for two touchdowns and ran for another in Oakland's 34-27 victory over San Diego for the American Football Conference championship Sunday.

Plunkett's performance led the Raiders into their third Super Bowl. They play National Conference champion Philadelphia for the National Football League championship Jan. 25 in New Orleans.

Against the Chargers, Plunkett completed 14 of 18 passes for 261 yards. He connected on touchdowns pass plays covering 65 yards with Raymond Chester and 21 yards with Kenny King, and ran 5 yards for another score. Mark van Eeghen, who rushed for 85 yards, added a 3-yard TD run and Chris Bahr kicked field goals of 27 and 33 yards.

Watching from the sidelines was Pastorini, who has had nothing but problems since being acquired by Oakland.

The major reason for Davis' displeasure with the 10-year veteran, who hasn't played since suffering a broken right leg Oct. 5, is Pastorini's off-the-field escapades, including a run-in with a Houston sports writer, an auto accident, his posing nude in a national magazine, a police report that drugs were found in his car and his alleged possession of the bottle of liquor on a Raiders' charter flight against team policy.

Pastorini was acquired from Houston before the 1980 season in exchange for quarterback Ken Stabler. Although Plunkett outperformed him during the pre-season, Pastorini was handed the starting job. When Plunkett took over following the injury, the Raiders were 2-3. Plunkett guided the team to nine victories in their remaining 11 regular season-games and to playoff victories over Houston and Cleveland before beating San Diego and putting Oakland into the Super Bowl.

Although Pastorini has been healthy and working out for nearly two months, he has not been activated. Davis, according to the source, had considered activating him but after the incident with the liquor bottle, he changed his mind, called in the quarterback and told him

### Texas Tech Sets For SWC

The Texas Tech Red Raiders will take to the road for a crucial two-game Southwest Conference set beginning Saturday in Houston. The Raiders meet Rice at 7:10 p.m. Saturday and then go against Baylor in Waco at 7:30 p.m. Monday.

Texas Tech is 9-4 for the season and tied for second place in the SWC with a 3-1 mark. Rice is 5-7 and 1-2. Baylor is 8-5 and 3-0 going into a Saturday home game against Arkansas.

The Tech-Rice game Saturday night is being televised by Metro Communications.

The Rice-Baylor road trip was a disaster last year for the Raiders. Tech was in third place in the SWC with a 7-4 record, having just knocked off nationally-ranked Texas A&M. But Rice first turned the tables on the Raiders 71-61 and then two days later Baylor administered its most lopsided win in the 54-game series, 79-56.

Tech leads 41-14 overall, including a 16-12 mark in Houston. In SWC play, Tech is on top 36-10 and Tech coach Gerald Myers has won 20 of 23 outings.

The Raiders hold a 34-20 advantage against the Bears and a 17-13 margin in Waco. In SWC play, Tech leads 30-16 and Myers is 17-4 against the Bears. Baylor's win last year broke a 10-game Tech winning streak.

Tech is 8-0 at home this year but only 1-4 away from Lubbock at the halfway point in the season.

In games played on television, Tech is 34-20 since 1958 when Tech beat Missouri 80-70 in a nationally televised game. This year, Tech has lost to Houston and beaten A&M on TV.

Despite starting the shortest lineup in the league, Tech is among the SWC leaders in rebounding. Tech has lost

the board battle only four times in 13 outings, including a 25-24 deficit in the last game against TCU.

Tech's four SWC opponents have shot over 50 per cent against the Raiders. Opponents have a combined field goal shooting percentage of 55.8 per cent in SWC play while Tech is hitting 52.2 per cent. But the Raiders are going to the line with frequency. Tech as made 54 of 72 (75%) while SWC opponents have sunk 34 of 53 (64.2%).

Head coach of Tech, Myers said, "Against TCU, the key for us was our defense and hustle. We were sloppy in the first half and couldn't get anything to fall. In the second half, we played good defense and Bubba and Clarence really carried us on offense. We had to get out of our zone defense because it was not helping our transitive game and we needed a change. We need to concentrate now on Rice. We sure can't be cocky after what happened last year."

Junior Jeff Taylor has the team lead in scoring average (14.9) and individual game highs of steals, field goals attempted and nine free throws made against Texas. Taylor is shooting 56.7 per cent from the field and has been the game's high scorer five times.

Starters for the Raiders will be Clarence Swannegan, Ben Hill, Jeff Taylor, Bubba Jennings and Steve Smith.

Rice starters will be Donald Bennett, Rickey Pierce, Kenny Austin, Bobby Tudor and Tyrone Washington.

The following will be the Baylor starters: Tommy Teraat, Terry Teagle, Joe Copeland, Pat Nunley and Jay Shakir.

After the two-game road trip to Rice and Baylor, Tech will play North Texas State in Denton on Thursday, January 22.

## Moore Named Head Coach For Texas Tech Red Raiders

If the marriage between Jerry Moore and Texas Tech wasn't made in heaven, it must have been right in the outskirts.

The Red Raiders' recently-named head football coach has the characteristics to make him one of the most popular men ever to run the red and black football show.

One local newspaper writer quickly noticed the public's affection after Moore had been on the job only a few days.

"He's saying the things people want to hear, and the great thing is he means every word," the writer pointed out.

His credentials are just what the doctor ordered.

First, he has a solid Texas back ground. He was born and raised in Bonham, he played football at Baylor and coached as an assistant at SMU and as head coach at North Texas State.

Second, he has been a fixture in a successful program. As offensive coordinator at Nebraska from 1973-78, he helped the Cornhuskers to a 56-16-2 record, including 5-2 in bowl outings.

Third, he knows West Texas and West Texans. At Nebraska, his recruiting area was West Texas. "I've always had very good results with West Texas players," Moore said. "I'd say there's only been on or two that didn't work out but I've almost batted 100 per cent in West Texas."

"These are tough, hard-nosed football players. They've been good players for me who performed best in big games. Just look at Junior Miller (now at Atlanta), Kelvin Clark (Denver), and Rick Berns (Tampa Bay)."

Fourth, he likes Lubbock. "This is a dream come true for me to be able to come to Lubbock. I'm really looking forward to raising my family here," Moore said.

Fifth, he is known for his exciting brand of offense. "This past year we averaged snapping the ball about 80 times a game and we'd throw an average of 30 times a game."

A smile quickly appeared on the face of Ron Reeves, who was standing nearby. "That sounds fine with me," Reeves said. "Shoot, I'll throw it 60 times a game if he wants."

Moore said he is partial to the I formation, which may suit Reeves' quarterbacking talents just fine.

"You've got to use what talents you've got, but primarily we will be an I formation team. We don't just drop straight back, though. We'll sprint out a lot, roll out and throw on the corner. I don't want the quarterback to run 25 times a game, but we'll be running some option."

Even with limited resources at North Texas State, Moore managed to keep his offense on the move. The

1980 Mean Green averaged 383.7 yards per game, almost 100 more than the 1980 Red Raiders. NTSU rambled for 573 yards against Louisiana Tech and 475 yards against SMU.

Despite the transition, Moore sees no big problems with recruiting. "We're at an advantage because we had already been in the homes of many of these kids. You have to remember North Texas State tries to recruit the same players many of the SWC schools are trying to get."

Moore, 41, earned 14 letters at Bonham High School before going on to Baylor to become one of the nation's leading pass receivers and captain of the '60 Bear Gator Bowl team.

He coached as an assistant at Corsicana for four years before going with Haden Fry to SMU from 1965-72. It was then on to Nebraska with Tom Osborne and then to North Texas as head coach in 1979. The NTSU team was 5-6 the first season but 6-5 last fall, despite playing only two games in Denton and losing to such bowl outfits as Houston, SMU, Brigham Young and Miami.

Moore retained two coaches from Rex Dockery's old staff: defensive coordinator and secondary coach Jim Bates and recruiting coordinator Taylor McNeel. Many believe their retention in the Tech program was a stroke of genius since Bates' defense was one of the stingiest in the Southwest Conference last year and McNeel is very close to the recruiting pulse.

Moore brought six coaches with him from North Texas and has one more vacancy to fill. The six new Tech assistant coaches are:

Richard Ritchie, 25, offensive coordinator and running back coach. He captained three NIAA national championship teams at Texas A&I, quarterbacking them to 39 straight victories. A graduate of Mineral Wells High School, he was an assistant coach at Texas from 1977-79.

David Krischke, 28, receiver coach. An All-Stater at Houston's St. Thomas High, Krischke played three seasons at SMU at wide receiver. He was recruiting coordinator at SMU, Michigan State and Oklahoma State before joining Moore at NTSU.

Rob Best, 31, offensive line coach. He earned 11

in 1969-71 as a wide receiver and tight end. The Dallas Jefferson grad began his coaching career in 1973 as an assistant at Dallas Adamson. In 1976, Best went to NTSU where he coached defensive backs as a graduate assistant. He coached the Mean Green tight ends in 1977. Left coaching for a year and then hooked up with Moore at North Texas.

Ron West, 23, offensive line coach. He played tackle and guard at Clemson and was an assistant defensive line coach at Livingston (Ala.) State in 1979 and joined Moore's staff in March 1980.

Dean Slayton, 44, defensive line coach. A graduate of Carlisle High in Price in East Texas, he played two years at Tyler Junior College before earning All-Missouri Valley Conference honors at Tulsa in 1956 and 1957. He was head coach at Howard Payne in 1972-78 and served as an assistant at Howard Payne in

1969-71, UT-El Paso in 1963 and at various high schools in Texas and Oklahoma.

Clarence James, 30 defensive end coach. He played running back and wide receiver at Langston (Okla.) and signed a free agent contract with the Packers before beginning his coaching career in 1973 as an assistant at his alma mater, Okmulgee (Okla.) High. He was an assistant for four seasons at Lamar High in Rosenberg and then joined Moore in '79.

Moore and his staff quickly hit the recruiting trail after their arrival in Lubbock, but Moore left one departing thought.

"I'd like to see a sea of red everytime we play at Jones Stadium. We want to go out every week and give it everything we have. We want to make people dread coming to Lubbock and Jones Stadium to play the Red Raiders."

## Eagles Over Cowboys For NFC Title

Wilbert Montgomery was full of surprises Sunday, since he had reinjured a knee during practice week before the game Sunday against the Dallas Cowboys. Montgomery rushed for 199 yards and one touchdown as the Philadelphia Eagles defeated the Dallas Cowboys in a 20-7 win Sunday and won the National Conference championship and now will go to Super Bowl XV.

Montgomery became the first runner to gain 100 or more yards against Dallas in 29 playoff games. Also he came within 2 yards of the NFL playoff ground-gaining record set by the Eagles' Steve Van Buran in 1949 against the Los Angeles Rams. Philadelphia's coach Dick Vermeil said the knee still was sore just before game time.

Montgomery scored the Eagles' first touchdown on a 42-yard run only just two minutes left in the game.

Eagles' quarterback Ron Jaworski ran a super offense against the Dallas Cowboys' defensive linemen. Jaworski had only one wide receiver out of three that they have. Charley Smith, the team's top receiver was not playing Sunday since he had a double fracture of the jaw, and his substitute was Scott Fitzkee who was listed reserve due to a broken foot.

The only hope that the Eagles had was to run in order to defeat the Cowboys and that's exactly what Philadelphia did.
