The following documents, or copies, will be accepted as proof of residency: Voter registration card, driver license, utility orphone bill, property tax CONCERNS statement or receipt, school tuition receipt or valid proof of liability insurance. One of these items must be presented whether the motorist is obtaining registration by mail or in person. House Bill 1969, enacted by the Texas Legislature in 1993, authorizes the collection of a 25-cent fee by tax assessor-collectors in counties where motorists must show proof of residency. This fee is compensation for the mandatory need to confirm the required residency documentation. plans to construct additional holding pens, and make loading and unloading stock easier for the employees and customers.

The company has made arrangements with livestock truckers to set up. 'Receiving Stations' in Alpine, El Paso, and Dell City. These stations will enable stockmen to bring animals to the sites, and not have to deliver their stock long distances themselves. They can economically ship small numbers of stock, along with their neighboring producers, in truck loads.

Gray said they have received sale stock from as far away as Deming, New Mexico, and McCamey, Texas. Other receiving stations are planned in the future.



A major challenge for parents who want to save for their children's college education is that no one can say with certainty how much they should put aside. What seems like an adequate amount today may well turn out to be inadequate by tomorrow, when a child heads out the door to begin his or her college career. Even with that, saving up for tuition expenses is still likely to cover only about one-fifth of the costs for a young Texan's higher education, according to some estimates. And students who, borrow heavily for college face years of loan repayments, a fact that discourages many from pursuing their education, which in turn costs the state in lost productivity and individual earnings. Under the direction of the Comptroller, families should be allowed to "contract" for two or four years of their children's future higher education at today's prices, with the money deposited in a special account, which could ten be pooled with other state assets for investment purposes. The Legislature should also create a scholarship program to benefit needy Texas students through a publicprivate partnership. Our other recommendations include a Parents' Bill of Education Rights to let Texans know what they should expect from their children's schools and what current law allows in the way charter schools and other local solutions for local problems. We encourage public school districts to study the feasibility of creating work site schools wherever appropriate to

#### GROUND WATER **OWNERSHIP**

There are several doctrines of ground water ownership in the United States. Texas uses the Common-Law Doctrine. This means that overlying Beneficiaries under age landowners have absolute ownership of percolating ground waters under their property, with ground water used or sold as private property. (This is the opposite of surface water. which in Texas is owned by the State.)



1 cup sliced celery Combine flour and salt in paper bag. Drop in beef, a portion at a time, and shake until coated. In heavy kettle or pot, brown beef over low heat in hot oil. Stir in water, tomato sauce, and seasonings. Cover 1-1/2 hours. Add vegetables; cover; simmer until vegetables are done (about 45 minutes) Yield: 6 servings

usually lower the level nicely. The third factor is

smoking. Nicotine is a stimulant and irritant for the heart and forces the heart to work harder. Smoking causes the blood to clot and plug the arteries more easily and the lung damage also causes more work for the heart. It is very important to stop smoking; there are now many aids to help you quit including stopsmoking classes and medicines. Together, these are fairly effective.

Check your blood pressure and cholesterol once a year, avoid smoking, and exercise regularly. Doing these things will give you a healthier heart. 'C'




