The growing problem of domestic violence was cited Friday evening in both county communities, Denver City and Plains. Prior to home football games in both towns, county officials read proclamations addressing the grief, pain, and often, deaths occuring in families across the nation.


The dual announcement was supported here by PHS Student Council members, who passed out purple ribbon adortags recognizing Domestic Violence Month. The recognition is a joint effort by the county and communities, and the Women's Protective Services, serving this area from home offices in Lubbock.

Yoakum County Soil and Water Conservation District members presented local producer Dwayne Canada the annual Goodyear Tire Co. Conservation Farmer of the Year award at a meeting here Wednesday morning. In accepting the award, Canada made a brief and succinct statement; " I have been farming here for 28 years, and I've already made two good crops!"

Don Burgess was returned to the office of Director, Zone III, of YCSWCD, elected by nomination from the floor and a vote by acclamation. He will serve another four year term.

Guest Speaker State Representative Gary Walker opened the meeting with a brief review of some of the issues to be addressed by the legislature when it convenes in January, 2001. He said state mandated re-districting will be a thorny problem, and our West Texas area will probably lose representation to faster growing areas in the east and south portions of the state. He feels confident current House Speaker Pete Laney will keep the position through 2002.





# **DPS turns to DNA** for catching crooks

In June, the Texas Department of Public Safety (DPS) achieved a landmark in the state's ongoing battle against criminals: the first conviction brought about entirely through evidence contained in DPS' Combined DNA Indez System (CODIS).

CODIS is a statewide repository of DNA information based on tecnology developed by the FBI. Since 1996, persons convicted of or incarcerated for sex crimes in Texas have been required to furnish CODIS with blkood samples used to prepare DNA profiles - as unique to each individual as fingerprints - for inclusion in the database.

The Texas Legislature broadened the reach of Codis in 1999 by authorizing DNA sampling of anyone convicted of murder, aggravated assault, house burglary or indecent exposure, and

some probationers. CODIS information is available to law enforcement officers throughout the nation.

The CODIS database contains more than 7,500 DNA samples and is growing rapidly. It was strengthened by utilizing short tandem repeat (STR), a technology allowing DPS to obtain DNA samples from minute or degraded biological eveidence previously unusable in investigations. With state and federal funding, DPS has complex machines for its labs to make DNA profiles of evidence from as far back as the 1970's.

The first conviction from CODIS information involved a 42 year old Texan, already serving a sentence for indecency with a child, whose CODIS data matched evidence found at the scene of a 1983 sexual assault of two girls in Granbury.

# Texas ups the ante on highway work

construction work in Texas is outsourced to private firms. The Texas Department of Transportation, however, has learned the hard way both incentives and penalties are critical to getting the work done on time and under budget.

On Highway 59 in Houston, penalties of \$2000 a day for late work were not enough to get the job done. Some sections were completed four years behind schedule.

To save money, most highway A new \$250 million project on Houston's Southwest Freeway in 1999 will assess penalties of up to \$14,000 a day if work is not done on time. Incentives are also available if work is finished ahead of time.

> Transportation officials in Kansas are using a similar approach to guarantee the smoothness of state highways. In Ohio, contractors must sign a warranty for construction and repair work done on any interstate or multi-lane road.





In the third period, the Buffs ran nine straight running plays, the last a one yard touchdown. The PAT was good for a 25-0



#### **TSA MO GA Celebrates** "Texas Heritage" Program



The hunter fires relentlessly into the swarms, thinkething, "I'll have a big mess for sup-


