

#### Attention holiday drivers County Court Thanksgiving travelers should slow down, buckle up and drive

sober!. They should expect to see plenty of Highway Patrol troopers on Texas roadways. They will be looking for drivers who are speeding, driving while intoxicated or who are not properly restrained, or have passenhers who aren't buckled up.

"Thansgiving should be a happytime," said Col. Thomas A. Davis, Jr., director of DPS. "Don't turn the holiday into a tragic time for you or others because of bad driving decisions."

During the Wednesday through Sunday Thanksgiving period last year, DPS troopers wrote 14,686 tickets for speeding, 3,358 tickets for no insurance. They wrote 2,138 tickets for no seat belts and 298 tickets for child restraint violations. DPS has a no-warning policy for seat belt and child restraint violations.

Troopers also arrested 613 people for DWI and issued 60 tickets for minors operating a vehicle after consuming alcohol. "If you drink you should not drive. Be sure to designate a driver who has not been drinking," Col Davis said.

DPS is participating in Operation Care-Combined Accident Reduction Effort- a nationwide effort by police agencies to reduce fatalities on major interstate highways during holiday weekends. Since roads will be crowdeded DPS reminds drivers to allow themselves plenty of time, and avoid bad driving habits that lead to road rage, such as; not using turn signals\* driving in passing lane\* tailgating, flashing lights, honking\* high beams in traffic. When confronmted with aggressive drivers, DPS recommends; Put your pride in the back seat and move aside\*Do not speed up, block lanes, slam or tap on brakes\* report extreme cases of reckless driving\* do not retaliate, gesture, or make eye contact\* make sure everyone is buckled up.

# Crime Cases

Six criminal cases were heard in County Court November 15, with Judge Dallas Brewer presiding and Criminal District Attorney Richard Clark representing the State.



# Candidates for housing project selected, contractors to present bid proposals by December 1

InPlains City Council's November 13 meeting number one agenda item was the final selection of three residents named first place choices and one alternate for the new housing grant program sponsored by the City and South Plains Association of Governments. Finalist selected by the council, in the order chosen, were residents Juanita Crawford, Marie Ortiz, and Lucia Hernandez, with Patricia Hernandez named the alternate should one of the others decline prior to start of construction.

City Administrator Terry Howard said council's judging was based on criteria set by the State, including items such as age, annual income, and condition of the property which will be razed as a site for the new homes. The new houses will have a maximum

# Student Councils meet with **Commissioners Court**

A joint delegation of both the Plains and Denver City High Schools student councils recently made a presentation to the Yoakum County Commissioners Court, providing information about formation of a joint project of the two county schools. The group will be known as the Yoakum County Teen Coalition Against Destructive Driving. They are working jointly to decrease the number of teen traffic fatalities in the South Plains area.

" Each year there are more than 6,200 teens killed in vehicle accidents. This is the number one killer of teenagers in the nation. It isn't just alcohol related accidents - alcohol accounts for only twelve percent of the auto accidents involving teens. Many other factors are involved. Our joint goal is to get all 61 schools in the Region 17 Education Service Center at Lubbock involved in the coalition. The coalition has received a great deal of publicity in the area as a result of the recent eight teen fatalities from traffic accidents in recent months. 

FROM THE EDITOR: What ever your political leanings are, Democrat, Republi-

I've always believed in periodic re-evaluations, and in course corrections as the results warrant. For those of us entrusted with public office, there is nothing like an election to provide information on what changes are needed.

The election results were a strong reminder of who works for whom in a democracy. We work for the people - not the other way around. Public officials must adhere to our principles and beliefs, but we also should remember who we work for, and who has the final say.

On November 7, control of both houses of Congress was turned over from the Republicans to the Democrats. It's safe to say voters made a similar judgement about the way things were going in Washington as that of Houston's wife and mother-in-law. They wanted change.

As a Republican I've been asked what I learned from the election. My short answer is this: our principles are sound, but we've strayed from them. Complaints about complacency and non-responsiveness reached critical levels. Business as usual in Washington frustrated a growing number of voters, and the majority party was held accountable.

One source of frustration was the re-emergence of 'earmarks', projects for their own districts sponsored by individual lawmakers. This "pork-barrel" spending was attacked by Republicans in their successful 1994 Contract With America and a cleanup soon followed.

But in recent years, with Republicans in charge of Congress, earmarks have returned with a vengence. The Congressional Researche Service counted some 16,500 earmarks in 2005 spending bills, at a cost of almost \$50 billion. This is unconsciable, and the public knows it. I hope Congress knows it now, too.

I've heard many complaints about backroom deals in Washington, both in Congress and the rest of government. I've long believed the public should have far more information about the way decisions are made, so they can make an informed judgement. In the coming Congressional session. I plan to work across party lines to open access to government information, particularly through reform of the Freedom of Information Act.

I believe voters were also angry at our seeming inability to come to grips with the even bigger problems of over spending, particularly on enti-

Another major factor in the election was documented cases of unethical behavior by Congressmen, their aides, and lobbyists that in some cases crossed over into outright criminal conduct. Of course, officials from both major parties were caught up in these charges. But the voters rightly demanded change, and the party in power was held accountable.

Frustration over Iraq was also part of the election. Some Democrats have called for a withdrawal from Iraq, either immediately or through a set timetable. In my view, that is not the correct course of action, nor is it in the long term interest of our country or the world.

Most Americans realize Iraq is part of a larger war against Islamic terrorism, what some have called the major struggle of the 21st Century. They realize the conflict will be long, costly, but they know it is a battle that must be joined to ensure

the safety and security of our country.

I believe the American people are looking for confidence that we have a plan to win this war, not merly to carry it on. President Bush is now re-evaluating our approach. My hope is Democrats, now in a Congressional majority, take their criticism of our Iraq operation to a positive level, and work constructively with the President on a plan to win the war against ter-

Some commentators have suggested the Republicans lost the majority because we were too conservative, and others have said we have not been conservative enough. In my view, the core Republican principles remain sound; limited government, individual responsibility, and opportunity for all. We have to do a better job in the future of advocating, and delivering, on these principles.

I am priviliged today to occupy the U.S. Senate seat first held by Sam Houston, a man whose career in public service for our state and its people will likely never be matched. Gen. Houston was serving in the U.S. Senate when he was baptized at the Independence Baptist

Church. The church pew in Independence where Houston sat during services has been preserved so visitors may view it. It serves a a testimony to man's power to turn weaknes into strength, and his ability to learn from missteps of the past. That power is as strong today as it was 150 years ago.

(Annual average salary, nationwide)



# **Templeton Cons. wins** Manager-at-Risk bid for county jail project

The county moved a bit closer to the start of construction on the Yoakum County Law Enforcement Center in the November 20 session of Commissioners Court. A final report to County Judge Dallas Brewer from Burns & Gill Architects. Inc. indicated comparative data from Templeton Construction submitted a proposal of \$406,735 to oversee construction of the \$5 million project, a bid \$85,685 lower than the bid from A&S Construction. Following discussion from the court members, it was unanimously voted to accept the Templeton bid. The actual start date of the state mandated project has not been determined.

County Clerk Debbie Rushing requested approval to purchase badly needed letters and numbers for the advertising sign in front of the courthouse, originaly obtained from the Plains Chamber of Commerce. She also requested approval to purchase another display case for inside the courthouse corridor. The present two cases ar always filled to capacity, and the new display case would be reserved for officialb documents only. The

court approved purchase of both items for a total cost of \$1,268.78

Present long term cloud seeding evaluation I started needs improvement which I believe is available at nominal cost. In Yoakum County, we need to increase rain gauge density by adding in-expensive gauges to areas smaller than county wide. In addition, instead of monthly, the new gauges need to be read to measure each significant rain event. By comparing what is calculated for each gauge area and assumed to reach the ground with what did reach the ground will allow a better evaluation of seeding benefits. I am available to read the new gauges as often as needed at no cost. I will discuss these changes with SandyLand after some requested expert input.

Seeding evaluation is really in a state of flux. Some projects continue and thought to be successful, some have been stopped (High Plains and North Plains), some continue not knowing if successful or not. The above changes will help Yoakum County decide which of these is the right one.


