

Recorded votes should be important campaign issue

** The following, written by Paul W. Watler, is from the Winter, 2006 issue of The Freedom of Information Foundation of Texas. It details an issue which, again, should be addressed by the Legislature in the upcoming called special session - or sessions.

Vigilance in open government in Texas rests is the hands of the Legislature. The bedrock freedom of information laws in Texas are statutes passed into law and periooically amended by state representatives and

But the Legislature has fumbled the opportunity to take a stance for public accountability. In 2005, for the second consecutive regular session, the Legislature did not enact rules to change state law to require recorded votes on all amendments and bills.

More than 88 percent of Texans polled say they want the state to join the 40 others that require openness through this important procedure. Yet the Legislature has failed to rise to the challenge of public transpar-

Particularly troubling is the lack of leadership in the House of Representatives. Speaker Tom Craddick failed to lend his considerable clout to make this common sense, good government measure the law of the land. The leadership team in the House exudes an air that says

nuisance detraction from long time legislative prerogative.

Of course, there were some exceptions to the indifference shown by the House leadership. Highly respected Republicans including Rep. Delwin Jones of Lubbock, Rep. Bob Hunter of Abilene and Dallas area Reps. Tony Goolsby and Dan Branch were notable in their support for recording votes.

Lt. Governor David Dewhurst has been far more active in attempting to bring 21st century accountability to an institution accustomed to doing business the old fashion way, With Dewhurst's active support, significant progress was made toward making record votes the law of the land rather than a hollow deal.

SB 1140 was passed UNANI-MOUSLY last session by the House, a bill requiring legislators to record nearly all their votes, but the meaure died in the house.

While the 2005 session ended in disappointment for supporters of recorded votes, it began with greater promise. Early in the session, both houses enacted rules making it easier, not mandatory, for lawmakers to obtain record votes on bills. The ineffectiveness of this modest step is aptly illustrated the record-vote movement is a by the fact the House of Representatives cast only 10 more recorded votes in 2005 than in 2003.


The primary election for the Legislature will be March 7 this year, followed by the November General Election. This is the season for citizens and electoral boards to get a commitment for good government in our statehouse. Every candidate should be asked: Do you favor a law or constitutional amendment requiring recorded votes? If not, how can you justify Texas has less openness in its legislature process than 40 other states? What will you do to see that the legislative leadership makes recorded votes an open government priority?

Lawmakers in Austin set the standard for open government. Senators and representatives should let the sun shine on their own work and at the same time send an important message across Texas.

State boards and commissions, school boards, city councils, county commissioners, water districts and numerous other elected and appointed bodies who see transparency in the statehouse will be encouraged to do public business in the open.

It is now up to the citizens to send representatives and senators to Austin to make recorded votes the law of the land.

CSW to host survivor of 9-11 terrorists' attacks

The Spring Jack Maddox Distinguished Lecture Series, hosted by College of the Southwest at Hobbs, will present Lieutenant Colonel (Ret.) Brian Birdwell Tuesday, March 7. He will take the stage at Tydings Auditorium on the Hobbs High School campus, 800 N. Jefferson at 7:30 PM NM Time. 1915 26 1915 2000

Birdwell is a survivor of the terrorist's attack on the Pentagon on September 11, 2001. After American Airlines 77 crashed into the Pentagon, just feet away from his second floor office, Birdwell was thrown to the ground and engulfed in flames. Of the burns that consumed 60 percent of his body, nearly half were third degree burns. While Birdwell fought for his life, his wife, Mel, was fighting to maintain their faith and their family. Because of their devotion to God and each other, Birdwell and his wife, along with their son, remained solid in their spiritual convictions and integrity throughout this incredibly difficult ordeal. After enduring more than 30 operations and months of hospitalization and multiple skin grafts, Birdwell has made miraculous recovery. Birdwell communicates a compelling message of enduring hope, unwavering faith, undying patriotism, and unconditional love.

Birdwell is a native of Fort Worth and a graduate of Lamar University, graduating as the Distinguished Military Graduate therough the Army ROTC program. He began his military service at Fort Sill, Oklahoma, served 18 months in South Korea, and upon his retirn met his wife Mel, and they married in 1987.

In 1990 while stationed in



Germany he was deployed for Operation Desert Shield and earned the Bronze Star for action in the Persian Gulf War. He would later earn his Master's Degree at the University of Missouri, served in Central America in the aftermath of Hurricane Mitch, later graduated from Command and General Staff College in 2000, and reported for duty at the Pentagon.

Following the terroist attack Birdwell was awarded the Purple Heart for his 9-11 wounds, and upon his retirement in 2004 he received the Army's Legion of Merit for service to the nation.

He now serves as the President of Face the Fire Ministries, a 501C3 non-profit, which serves critical burn survivors and our nations wounded service men and women. He is the author of Refined By Fire which chronicles his physical and spiritual journey in the aftermath of the terroists' attack. His book will be available for purchase.






