

Criminal cases in County Court

Five criminal cases were heard in County Court March 29, with Judge Dallas Brewer presiding and Criminal District Attorney Richard Clark representing the State.

Alberto Tarango Jr. pled true to the State's motion to revoke supervision from a prior cause of purchase/furnish alcohol to a minor. He was sentenced to 60 days in jail with credit for 26 days served. A bail jumping/failure to appear cause was adjudicated.

Monte Lloyd Paxton pled guilty to reckless driving, a class B misdemeanor. He was fined \$200 and must pay \$326 court costs. David Martinez served as his attorney, and Trooper Robert Munsell was investigating officer.

Reginald Charles Williams pled guilty to bail jumping/failure to appear, Class B misdemeanor. He was sentenced to 90 days in jail with credit for 123 days served. A driving with invalid license cause was adjudicated. Investigating officer was Deputy Nancy Baize.

Rosa Marie Clark pled guilty to wrong, fictitious, altered or obscure license plate. She pled guilty and was sentenced to pay a fine of \$100 and \$261 court costs. Bill Helwig served as her attorney, and Deputy Inoe Valdez was investigating officer.

Israel Palomares-Martinez pled guilty to a first DWI, b.t. .123/.121, open container. He was sentenced to 120 days in jail, suspended and probated 24 months. He was fined \$600, must pay \$226 court costs, \$300 appointed attorney fees and \$25 time payment fee. He will serve 24 hours community service, six days in jail with credit for 18 days, must attend weekly AA meetings and complete the DWI first offender program. Warren New was his attorney, and Trooper Brad Taylor was investigating officer.

Cowboy Cross Country Runner Chases Down \$4000 Scholarship From LCU



Abel Ramos, center, last week signed a contract with Lubbock Christian University, granting him a \$4,000 scholarship, representing the university on their cross country team. Behind Abel are his brother, Zachary, a member of the Cowboy cross country team and who participates in other sports; his mother Yvette, an instructor in Plains Elementary. On the back row are Coach Todd Davis, head cross country coach, who helped the Cowboy team advance to state competition in 2004, where they won the state title with Abel leading the way, and back to state in 2005; Abel's dad Freddy, employed locally by Cebridge Cable; now retired former head track coach Evertt McAdams, who has assisted the cross country program many years. Abel won All-State honors twice in the grueling event. This is the first athletic scholarship offered a Plains High student in a number of years.

Commissioners Hold Routine Session

In the April 3 session of Commissioners Court, County Clerk Debbie Rushing sought approval to purchase a Network Server Printer, non-budgeted in the equipment line item. The CTSI firm offered an installed printer to meet all the office needs for \$1509, and the Clerk would use \$450 in already allocated funds towards the purchase. The request was approved.

Pat McNabb, head librarian for both county libraries, delivered a report on a recent trip to Boston to attend the Bill and Melinda Gates Conference. The conference was attended by 148 librarians from across the nation. The Foundation paid all expenses for the conference and tours of the city. McNabb said both county libraries would soon be receiving two more badly needed computers from the Gates Foundation. Four units are now available for public use at each library, and both normally have waiting lists of would be users. County employee Danny Steffens and

Greg McCravy have volunteered to build new tables for the two new units.

Judge Brewer sought approval of the purchase of an office chair for \$400. He reported the chair had been originally ordered and approved for payment in September, 2005, but was not delivered until March, 2006.

Lisa Palmer, Investigator in the Criminal District Attorney office, reported a public auction would be held later this month for equipment formerly used by the now disbanded Drug Task Force, including four vehicles. She said firearms from that department had been sold except for those with no value, which had been destroyed. The court approved the auction.

A bid of \$200 was accepted on property in Denver City described as E80' Lots 13--18, Block 55 Old Town, owned by Yoakum County Property in Trust. The approved bid for the described property was from its prior legal owner and taken for non-payment of taxes.

Strong showing continues in Cowboys race for district title at halfway mark

The Cowboys baseball team is having a great start this season. They were winners in the tough Eunice, New Mexico tournament, and are now leading our district with a 4 and 0 record.

Guest speaker Kacy Richards, in-coming Tsa Mo Ga President Sarah Field, and current President Debbie Rushing Spears



Dental benefits available to children in CHIP

Young children in the Children's Health Insurance Program (CHIP) now have an even bigger reason to smile. Starting April 1, CHIP is expanding to include dental benefits, including regular checkups and other critical dental services.

Dental benefits for children in CHIP include routine checkups, cleaning, X-rays, sealants, fillings, tooth removal, crown/caps and root canals.

Families with children enrolled in CHIP will receive a letter and handbook explaining the dental benefits, a member ID card and a directory of participating dentists.

CHIP provides health care coverage for children in families who earn up to 200 percent of the federal poverty level. That's \$40,000 a year for a family of four. In addition to dental services, CHIP covers doctor visits, immunizations, hospital care, behavioral health services, surgery, x-rays, physical, speech and occupational therapies, prescription drugs, vision services, emergency services and transplants.

To start an application or get more information about CHIP, call 800-647-6558. Assistance is available in English and Spanish from 8 am to 8 pm Central time Monday through Friday.

Birth, Death Certificates Now Available Online

Birth and death certificates can be ordered online, Texas Department of State Health Services (DSHS) recently announced. Previously, the certificates could be requested only by mail, fax or by visiting the DSHS vital records unit in Austin or one of 490 registrars' offices around the state.

Certificates may be ordered on line at www.texasonline.com DSHS Chief Officer Randy Fritz said, "Customers needing the certificates should find the speed and convenience a real timesaver."

He clarified while certificates may be ordered online they cannot be downloaded or printed. Online ordering a birth certificate for a birth occurring within the last 75 years is limited to the individual for whom the certificate is requested and to the mother or father of that individual.

Online ordering of death certificates for deaths that occurred within the last 25 years is limited to surviving spouses, a parent of the deceased and to certain funeral directors.



From The Hack

Been doing some weird, some interesting newspaper reading lately. I know that left me fatally open for a smart mouth to mumble. "Must not have been in CCN", and that would be correct.

Friend Lee Roy McCravey brought by an old issue of the Yoakum County Review, edited by one Wendell Faught, dated September 24, 1959, in which my young sister, then Dana Dyer, along with other members of that year's freshman class, were humiliated by having to wear outlandish dress and hairdos in an upper-class 'welcoming' assembly by their older classmates. The boys, very seldom works of God's artistic talents, were ridiculous in very short skirts and outlandish makeup. The girls, Bless Their Souls, were even more hideous. Uglier clothing could not be found in an New Orleans alley following Katrina. My sister should be on bended knee thanking upstairs the Review was in such weathered condition I was unable to scan and reproduce those photos. On second thought, perhaps I should express my gratitude for the ravages of time... If those pictures had appeared in these lily white pages, I would no longer be privy to free room and board when I have to visit Lubbock.

The Review also displayed a number of pages which normally fascinate all of us in much advanced stages - Prices Back Then! A man I would become rather well acquainted with later, one Lloyd Allsup, then owner of the Chevrolet dealership in Denver City, paid

for a quarter page ad extolling the beauty, comfort, economy, and costability of Chevy's newest hot off the assembly line product, THE CORVAIR! Knowing Lloyd, I feel certain he thought they were priced way too low.

And by the way - in 1959, Foodway Stores were offering 12 bottles of Cokes for 39 cents, five pounds of sugar for 39 cents, balogna (it should be spelled baloney, then and now) could be had for 49 cents per pound. Even more incredible - Moore & Oden were touting a slinky looking dress making ladies "look a full size smaller" for only \$10.95. Can you imagine the pandemonium that same ad would produce today.

This edition of the Review had to sell extremely well in Denver City, if that hamlet had subscribers there. It featured the still talked about fisticuff session between attorneys Vernon Townes, a friend now departed, and his attorney partner Paul New, a friend still swinging a golf club with me on occasion. They had been accused by then County Judge Don Hancock of ordering stationery and supplies for their law office and sending the bill to the county. They were a bit miffed, and chose to pay an unfriendly visit to Hancock and his law office partner Claude Freeman. Harsh words were exchanged, and Townes and New proceeded to thump upon Hancock and Freeman, until a peace making deputy calmed things down. I have heard slightly different versions of the episode from both Vernon and Paul while losing money to them on the course. They related the story in much more interesting style and language.

In another newspaper, I read an even more fascinating bit of information: The current newest and largest cruise ship, the QE 2, is said to consume one gallon of diesel fuel for every SIX INCHES it moves!

Admittedly, I do not know the exact distance from New York City to, say, London, but let's say it is 1,200 miles - QE2 would guzzle over 38,000,000 gallons of fuel - that's even more than one of those ugly, high dollar Hummer vehicles!
