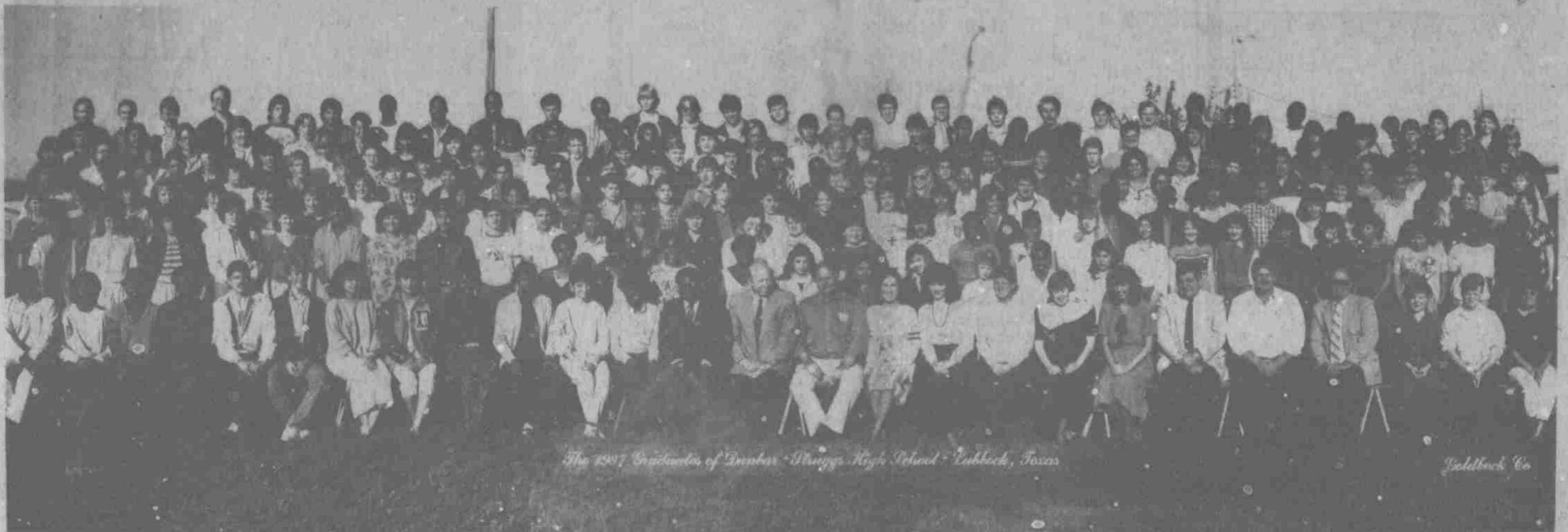

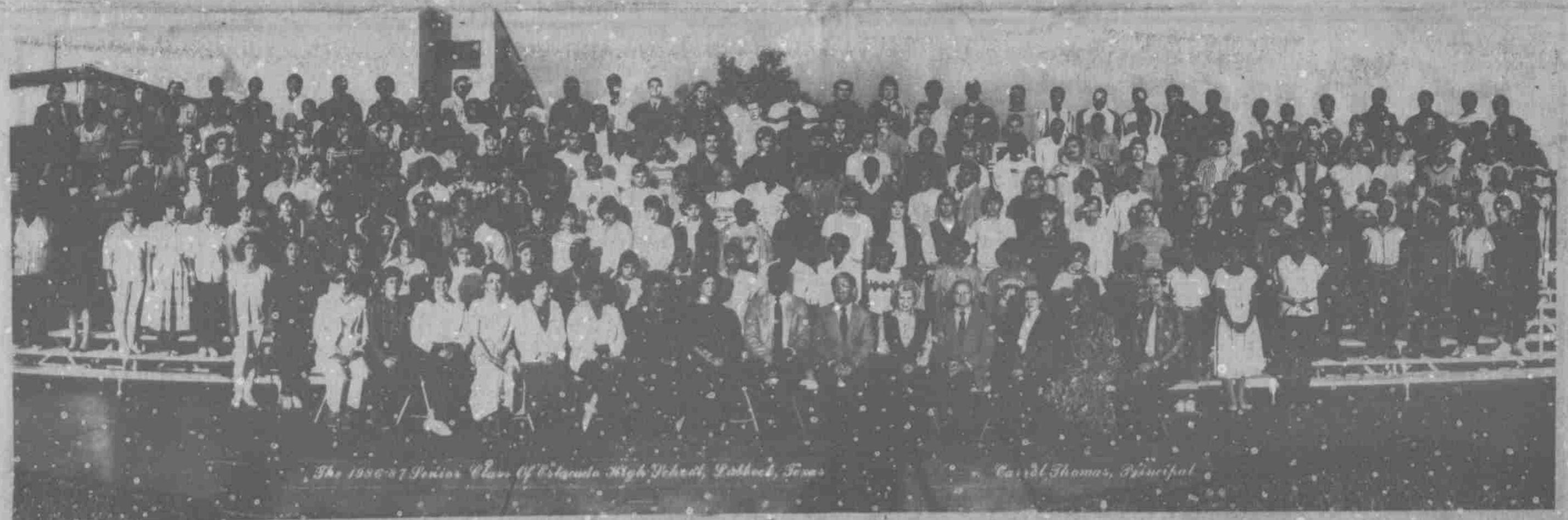

## Unitary Status And Re-Segregation

In their expensive headlong rush to obtain a declaration of unitariness from the federal district court, a majority of the Lubbock Independent School District trustees appear to believe that they will have a green light for re-segregation once such a court declaration has been issued.

Of course, they don't put it that way. Segregationists never have put it quite that bluntly since the days of George Wallace, Bull Conner, and like racists. Now the language is more subtle. Here in Lubbock there is talk of better football "feeder" school arrangements, the "efficiency" of the magnet programs, whether closing Dunbar would be the best use of the LISD's available resources, and the like. And of course, there is the talk of saving all that money from not having to run all those yellow school bus routes required by the federal court's desegregation orders.

But what all that comes down to, as we all know, is that our white brothers and sisters are getting ready to change things back to the way they were before the desegregation litigation. Or at least, they intend to change things as much as they dare. And the direction of that change will be toward re-segregation of our schools, not toward maintaining a unitary school system.

If the trustees actually think they can get away with that, they are sadly mistaken. Even with their high-powered law firm and the \$110,000 services of Kent Hance, they are apparently not getting the right slant on the law. A court declaration of unitariness is not a blank check for re-segregation. The purpose of court-ordered school desegregation is not only to achieve, but also to maintain, a unitary school system (a system that does not have a dual set of schools, with one for whites and the other for ethnic minorities).

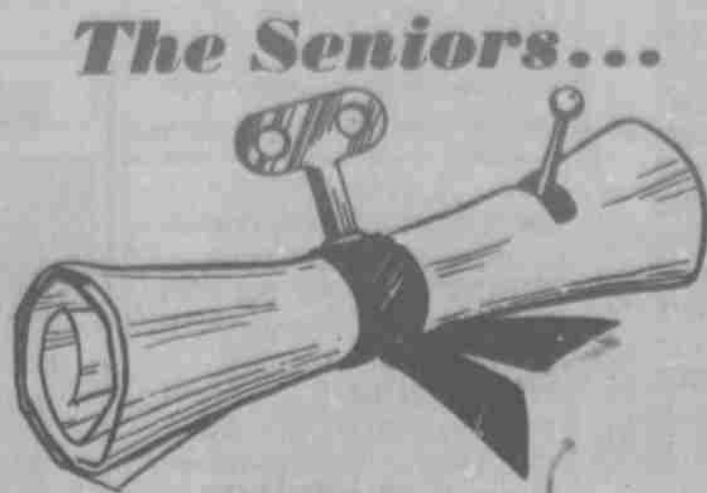
Having been pulled by the ears into federal court and forced to desegregate its segregated schools, the LISD is under a duty to maintain desegregated schools from now on. Obtaining a declaration of unitariness will not change that duty.

Gary Bowen, to judge from his many public statements about the federal courts not having the power to tell him what to do, is clearly confused on the legal and constitutional issues. We think he needs to call in Kent Hance and get some of Kent's \$110,000 legal advice about how the Constitution of the United States works, what the 14th Amendment is all about, and what the federal courts can do to straighten out loud-mouth, blustering local office-holders who may be temporarily in charge of a community's school system. There are a whole lot of things the federal courts can do to stop racial segregation in schools, and Kent either already knows that, or for some of that \$110,000 he can do some research and figure it out, and then tell Gary Boren.

It is true that the U. S. Department of Justice has backed down and failed us in this situation. The LISD has been able to take advantage of the Reagan administration's hostility to civil rights, and persuade the Justice Department to cover down on the Lubbock case. We wouldn't be surprised if the Justice Department actually joins the LISD in asking the court to declare unitary status. What a switch from the days when Bobby Kennedy was Attorney General and the Justice Department stood tall for the rights of all Americans! But the Justice Department is not for real justice these days. And it is not for justice in the LISD case, not any more.

At first, the Department of Justice fought hard for us in the LISD case, and it won. But we can no longer count on, or trust, the Justice Department. It has caved in and sold out, in effect, on the LISD case.

As we have pointed out in these pages many times before, the Justice Department has been writing letters to the LISD for over two years, complaining about the re-segregation that is taking place in the Lubbock schools. The Justice Department

has complained about the re-segregation at Hutchinson junior high, the segregation and ineffectiveness of the magnet program at Slaton junior high, and the lack of a junior high for the children who live in the central part of the city. The Justice Department has complained about the ineffectiveness of the Estacado High School magnet program. It has raised these points over and over again in its letters to the LISD.

But the Justice Department won't go to court for us. It sits on its hands and watches silently while the three Hispanic women who have tried to intervene in the case stand alone trying to make the federal court understand what is going on here. The Department won't seek a hearing to present these complaints to the court. We think it is obvious that Lubbock's white majority managed to reach some official in the Department of Justice with the power to tone down the complaints and to order the federal attorneys handling the case to back off. In any event, we are going to have to take political action to protect our children's rights, or maybe go back to federal court. We cannot count on any further help from the Department of Justice. We are going to have to act on our own to protect ourselves from the "new" LISD and its much sought-after "unitariness" status.

One of the most shocking aspects of this present situation is that racial discrimination has surfaced within the LISD board of trustees itself. Linda DeLeon is being relegated to second-class status by Gary Boren and the white majority. Reports have reached us, and are circulating in the community, that Ms. DeLeon is being denied access by the LISD's own lawyers to correspondence from the Department of Justice and other papers and records related to the desegregation case. Boren and his confederates (no pun intended) are preventing Ms. DeLeon from having access to papers and information that Boren himself and some other trustees get to see and can use freely.

The whites (except for Ms. Leota Matthews, of course, who often votes with Ms. DeLeon) get to see the papers, but the Hispanic trustee does not. We wonder whether Ms. Billie Caviel, the Black trustee, gets to see those papers? We wonder whether she even wants to see them? So, in this good day in 1987, we have racial discrimination being actively practiced within the LISD board of trustees.

And what about the Lubbock media and this sorry spectacle? Has one TV station covered the selective denial of information to Ms. DeLeon? No. Has the daily newspaper? Of course not. It is a typically hushed-up non-event. It didn't happen, as far as Lubbock's courageous media are concerned, at least as of this writing.

This brings us back to our point that we are going to have to act to protect our rights, and we are going to have to do it on our own. Nobody else will do it for us. The Lubbock media can cover car wrecks and fires, but not the racially motivated withholding of information by the LISD board and its lawyers from the Hispanic trustee. The Justice Department can write letters and have friendly meetings with LISD lawyers, but it won't stand up for our rights in court anymore. And while all this goes on, Lubbock's white majority just looks the other way, as it always does in these situations, until it is hauled into court and made to clean up its act.

Martin Luther King, Jr. reminded us that "Freedom is an expensive thing." So it is. We must be ready to pay the price to protect the freedom of our children to attend schools which are not racially segregated. This may mean political action and court action, but it has to be done. Too much has been gained in Lubbock to give it up now.

## South African Violence Intensifies

(NIS) -- The South African Defense force has intensified its repression in the northern region of Namibia, killing, kidnapping and committing what one church-sponsored news organization calls "fresh evidence of a reign of terror."

The London-based Namibia Communications Center (NCC), which gathers and distributes news about South African occupied country to religious publications in the U. S. and Europe, recently released a series of reports on escalated violence by the South African military and the paramilitary force, Koevoer. Several of the incidents involved attacks on civilians by South African soldiers who claimed to be pursuing guerillas of the South West Africa Peoples Organization (SWAPO).

An estimated 100,000 South

African troops are stationed in Namibia, in violation of an International Court of Justice ruling issued 20 years ago calling for the apartheid government troops to withdraw. Over the past two decades, SWAPO has responded to the illegal South African occupation by activating a military wing, the Peoples Liberation Army of Namibia (PLAN).

Most of the military activities between South Africa and PLAN are reported in the north. The region, home for nearly two thirds of the Namibian population, borders southern Angola. That area has been ravished by direct assaults from South Africa and the U. S. -- backed Angola rebels, UNITA. Northern Namibia has been under a South African-imposed dusk to dawn curfew for nearly a decade.

One of the most recent South African assaults reportedly resulted in the death of three Namibian women. The NCC, citing dispatches from church workers in the Onamuyi area, reported that the incident occurred after South African troops attempted to ambush SWAPO fighters. Eyewitnesses said that two South African armed personnel carriers drove from the bush to a nearby village "with their guns blazing in all directions."

The soldiers reportedly fired into an open field, fatally wounding a young girl who was there eating her lunch. The vehicles proceeded into a homestead, smashing into a hut and killing two elderly sisters. Three others were injured.

In another incident reported in late March on the Angolan side of the border, a young man was hospitalized and treated for burns suffered after being thrown into a fire by South African soldiers.

"He asked me whether I understood Afrikaans, and I replied in the negative," reported the 23-year-old man, Leonardo Haikali. He said that his interrogator, accompanied by two Black Namibian soldiers, was demanding to know about SWAPO guerillas.

"The white soldier told the Blacks to make a fire. He ordered me to sit in it, and when I refused, he threw me into the flames. Each time I struggled to get up, he would kick me back in," said Haikali during an interview from his hospital bed.

Much of the reported civilian village repression is attributed to the counterinsurgency unit Koevoet, the Afrikaans word for crowbar, Koevoet, formed by South Africa in 1980, includes Black and white Namibian police forces and mercenaries from South Africa, Europe and other

#### "THE ORDINANCE OF BAPTISM"

We believe that Christian baptism is (a) the immersion in water of a believer; (b) in the name of the Father, the Son, and the Holy Ghost, with the authority of the local church; (c) to show forth in a solemn and beautiful emblem our faith in the crucified, buried and risen Saviour, with its effect in our death to sin and resurrection to a new life; (d) that it is prerequisite to the privileges of a church relation and to the Lord's supper; (e) in which the members of the church, by the sacred use of bread and the fruit of the vine are to commemorate together the dying love of Christ; (f) preceded always by solemn self-examination.

\*\*\* (a) Acts 8:36-39. "And the eunuch said, See here is water; what doth hinder me to be baptized? And Philip said, If thou believest with all thine heart, thou mayest. . . . And they went down both into the water, both Philip and the eunuch; and he baptized him. And when they were come up out of the water, the Spirit of the Lord caught away Philip."

Matt. 3:6. "And were baptized of him in Jordan, confessing their sins."

John 3:23. "And John also was baptizing in Enon near to Salim, because there was much water there: and they came, and were baptized."

Rom. 6:4-5. "Therefore we are buried with him by baptism into death: that like as Christ was raised up from the dead by the glory of the Father, even so we also should walk in newness of life. For if we have been planted together in the likeness of his death, we shall be also in the likeness of his resurrection."

Matt. 3:16. "And Jesus, when he was baptized, went up straightway out of the water. . . ."

\*\*\* (b) Matt. 28:19. "Baptizing them in the name of the Father, and of the Son, and of the Holy Ghost."

\*\*\* (c) Rom. 6:3-5. "Know ye not, that so many of us as were baptized into Jesus Christ were baptized into his death? Therefore we are buried with him by baptism into death: that like as Christ was raised up from the dead by the glory of the Father, even so we also should walk in newness of life. For if we have been planted together in the likeness of his death, we shall be also in the likeness of his resurrection."

Col. 2:12. "Buried with him in baptism, wherein also ye are risen with him through the faith of the operation of God, who hath raised him from the dead."

\*\*\* (d) Acts 2:41-42. "Then they that gladly received his word were baptized: and the same day there were added unto them about three thousand souls. And they continued steadfastly in the apostles' doctrine and fellowship, and in breaking of bread, and in prayers."

Matt. 28:19-20. "Go ye therefore and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost: Teaching them to observe all things whatsoever I have commanded you: and lo, I am with you alway, even unto the end of the world."

\*\*\* (e) I Cor. 11:23-28. "The Lord Jesus the same night in which he was betrayed took bread: And when he had given thanks, he brake it, and said, Take, eat: for this is my body, which is broken for you: this do in remembrance of me. After the same manner also he took the cup, when he had supped, saying, This cup is the new testament in

my blood: this do ye, as oft as ye drink it, in remembrance of me. For as often as ye eat this bread, and drink this cup, ye do show the Lord's death till he come."

\*\*\* (f) I Cor. 11:27-28. "Wherefore whosoever shall eat this bread and drink this cup of the Lord, unworthily, shall be guilty of the body and blood of the Lord. But let a man examine himself, and so let him eat of that bread, and drink of that cup."

Two grievous errors about baptism can be found in the religious world today. (1) The idea that one is regenerated or saved through baptism, is a terrible error. (2) Some believe in a Spirit baptism at the time of salvation, that puts one into a universal church, which they call the body of Christ. Some who hold the second doctrine have eliminated water baptism altogether. The others then hold to there being two baptisms, yet the Bible says there is only one baptism. Eph. 4:5

The ordinances are not sacraments as many non-Baptists teach. There is no saving power in the ordinances, nor do they bestow grace or merit. Yet, we are commanded to keep them, as they have been delivered. I Cor. 11:2

#### I. THE ORDINANCE OF BAPTISM.

A. It Requires A Scriptural Subject. (Candidate)

1. Baptism is for the believer—the saved. Acts 8:12; (a)-1 Acts 8:36-39; 10:43-47
2. Only those who had received the word (of salvation) were baptized. (d)-1 Acts 2:41-42

B. It Requires A Scriptural Mode. (Method)

1. Baptism comes from the Greek "baptizo", which means to immerse, dip, plunge, bury, etc. It never is used to indicate sprinkling or pouring.
2. All the Scriptural examples indicate immersion. (a)-1 Acts 8:36-39; (a)-2 Matt. 3:6; (a)-3 John 3:23; (a)-4 Rom. 6:4-5; (a)-5 Matt. 3:16

C. It Requires A Scriptural Authority.

1. Baptism is to be performed in the name of the Trinity. (b)-1 Matt. 28:19
2. God sent the first baptizer. John 1:6
3. Jesus and all twelve of His disciples were baptized by John the Baptist. Acts 1:21-22
4. Jesus gave His disciples authority to baptize. John 4:1-2
5. Those disciples (apostles) were placed in the Church first.
6. Jesus gave the commission to His Church. Matt. 28:16-20. That kind of church is the only church that has the authority to baptize.
7. This authority is exercised through the pastor or pastors and missionaries of that church. A minister apart from the local church has no authority to baptize.

D. It Requires A Scriptural Purpose.

1. 1 Pet. 3:21; Rom. 5:14. Baptism is symbolic and pictures certain Bible truths.
1. It pictures the death, burial and resurrection of Christ. (c)-2 Col. 2:12
2. It pictures the death of our old life; to sin, the burial therein; and the resurrection to walk in newness of life. (c)-1 Rom. 6:3-5
3. It pictures our putting on of Christ. Gal. 3:26-27
4. It declares our belief in the Triune God. (b)-1 Matt. 28:19
5. It is the door way into, or the prerequisite for Church membership. Acts 2:41

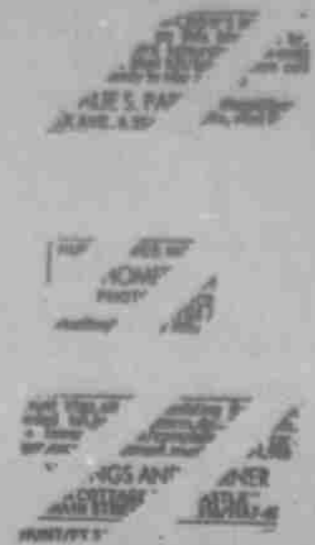

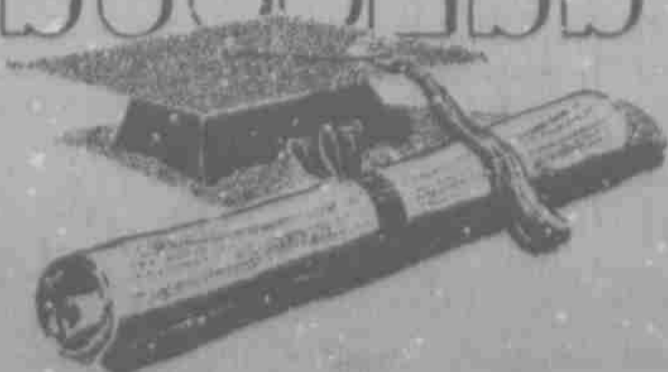

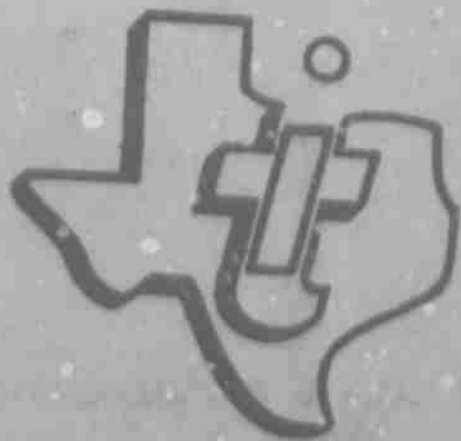

countries. In one recent Koevoet incident a 16-year-old girl suffered a broken arm and head injuries after being interrogated about movement of SWAPO combatants. The NCC said she reported being grabbed and beaten with a tree branch.

Another episode reported in late March involved the abduction of a man from a Lutheran Hospital who was being treated for a gunshot wound to the thigh.

A large contingent of armed Koevoet drove into the hospital grounds and seized the patient, Nathaniel Shikongo, as he sat in a waiting area of the x-ray department. The NCC reported that hospital staff were not told where Shikongo was being taken, and in early April his whereabouts were still unknown.

Other recent charges of Koevoet rapes and attacks of women in the region have filed women in the region have been filed with the South African-installed Ovomboland Tribal Administration. Critics of the apartheid occupation predict that those complaints will see little redress.

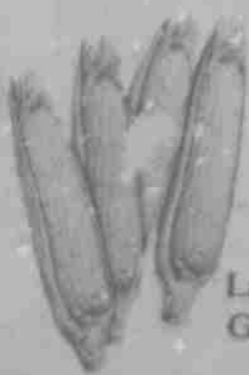
