

# **Migrant Farm Workers** Settle Lawsult

A class action law suit against two more Lynn County farmers was tenatively settled on last Monday.

Three migrant farm workers filed a federal class action law suit against 24 Brownfield area farmers in July, 1987 alleging that for thre years the farmers failed to comply with the disclosure and record keeping requirements of the Agricultural Worker Protection Act and failed to comply with Texas field sanitation laws. The complaint also alleged the three migrant workers were not paid the minimum wage

of \$3.35 per hour. Recently, a tenative settlement against J. A. Evans of the Evana & Clem partnership was forwarded to United States District Judge Cummings for review and approval. On Monday, June 27th, a similar tenative

settlement with Meeks Farms Partnership and Laverne Meeks Farms was forwarded to Judge Cummings.

"We were able to settle this portion of the case because the parties and their attorneys were willing to put their personal feelings aside and simply evaluate the case soley on the merits," said Texas Rural

Legal Ald staff attorney Stephen C. McIntyre. "The settlement of the

claims against Evans and the Meeks will not affect the continued litigation against the other 21 farmers," said McIntyre. The proposed class settlement with Europe

# \$2.3 Million Committed To Lubbock

The Lubbock Convention & Visitors Bureau and local association representatives secured four major conventions this past week for Lubbock in 1989, 1990 and 1992 which will bring in an estimated 9,700 delegates and pump a combined \$2.3 million into the city's economy.

Convention Bureau, Civic

Services Center representatives were accompained by Councilmembers Joan Baker, T. J. Patterson, and Maggie Trejo to Austin to bid on the 1990 Institute of Mayors, Councilmembers. Commissioners. and "Lubbock was successful in securing the convention over San Antonio and Arlington based on their West Texes hospitality and successful track record

The convention will bring estimated 1,200 an delegates and their families from across the state to Lubbok=in June 1990 and inject \$294,000 into the economy, based on an average of \$70.00 per day expenditure and average stay of 3.5 Jays.

### **On Energy Plan**

### Meets Here

State Representative Terral Smith, Republican Austin, announced that the House Select Committee on a Statewide Energy Plan will hold a Public Haaring July 8, 1968 in Lubbock, Teras. The Committee will meet at 10 a. m, in the Senata Room of the University Center at Texas Tech University.

The Committee will examine alternatives to current metnods of electrical generation and the transmission of electricity throughout the State. Urging public Input, Rep. Smith stated: "Texas is currently facing the problem of excess generating capacity with low demand in some regions of the state, while other regions need additional electricity to meet consumer demends.

Because of the changing environment that exists in the electric industry today. the Committee will be evaluating the policies affecting electric rates to insure that all lexans raceive the lowest possible cost of electricity without compromising the reliability of the system. "If we are to continue to promose Texas' economic growth and development, we must guarantee lower electric rates for both industry and the private consumer," Rep. Smith added.


business and he was what they called a 'trusty man.' They were married in Cameron, the parents of two girls, the oldest girl died at birth, Laura, the youngest girl, lived.

They stayed in Cameron for a while until Granville arrested c white man with booze who delcared he was going to kill him when he got out of jail. He had saved up \$1,500 which he had given a store keeper to keep for him but he would not give the money back to him. He had to fige to Austin by night to save his life and got Captain Abeal and soliders to bring him to Waco. They campod at Lover's Leep until he could lind a job. Those were dark days for him, his wife and a small child. He first worked at a larm, owned by a Mr. Helm, the father of Mrs. John F. Seurick. Finally, he found a better job with R. B. Compton, who was in the underlaking outliness. In 1682, he purchased four lots on the corner of Second and Jones Streets, built a home for his family and became one of the Founders of the SI. James Methodist Church.





### CAMP-OUT COOKING



Tomato slices

# It Needs To Be Sald by the Mystery Writer

Has the east Lubbock community reached it's potential in growth? Has the majority become satisfied with the way things are, or is there a serious concern for improvements? In looking at our community over the past years, there are indications we are on a holding pattern, waiting for someone other than ourselves to bring about the needed improvements. Yes, Lubbock is changing, but east Lubbock is not. Take away the tearning downof unserviceable structures that creates the vast amount of vacant land, and you will have the same east Lubbock of 20 years ago.

Across town, new structures are continuously being built. On the western boundary of our community, a major highway construction is being created, but what is a road? From that interstate highway, travelers will past, only to see a spotted community, not worth stopping as there is nothing to stop for. Unless you have a specific reason for coming to east Lubbock, people just don't come to see the sights. Homes, shopping facilities, offices, eating and entertainment facilities are necessary items within a progressive community. After dark, our community looks like a small town in the middle of nowhere. Most homes are darken and appears deserted. The low intensity street lights creates a very gloomy picture. True, residential areas should not be a glowing circus, but life should appear somewhere within the community after the sun goes down. Somewhere within our community there should be signs of life after dark. Drive down Slide Road, 50th Street, 34th Street going west after University, this is what makes Lubbock look live after dark. Why can't Quirt (or as I prefer to call it MLK Drive), East Broadway or East 19th Street have sufficient businesses, with neon signs aglow, to make our community look alive.

When day light appaars, the spotted locations of our east Lubbock businesses, the general appearance of second hand buildings and a lack of attractiveness are very depressing. Just as downtown Lubbock is being looked at for revitaliation, east Lubbock needs to be looked at for vitalization. Oh how sweet it would if Blacks could supply the planning, financing and operating of the needed improvements within our business sector. Howver, only a radical, naive tool would even consider our accomplishing this without the Whites.

For that reason alone, we need to form our own study committee to decide what, where, when and how we want our community. Then actively work with those people that can produce and provide the support to keep the business operating. One or two Blacks on City wide committees on not generate the interest of the City in east Lubbock. It took Mr. Richardson over 10 years to generate City interest in the Black Chamber. It has been over 30 years since any new housing development has been built in east Lubbock and now it is still only a paperwork proposal. We need to know if there are federal, state, county or city funds available to help our cause. We need to know the whys and where forths as to why no one will build in east Lubbock. Our community is being left cut because we don't know how to get around the obstacles being placed in our path.

## Black News Briefs

Brawley Case Controversy Swirls New York, N.Y.: Controversy swirled last week throughout much of New York state as a result of charges and counter charges related to the Tawana Brawley case. Brawley is the 16 year old

Black girl who was found in a plastic bag last November with racial epithets and animal feces smeared on her body. Brawley claimed she had been abducted and sexually assaulted by six white men over a four day period. The case drew national attention. But then under the advice of New York City lawyers C. Vernon Mason and Alton Maddox and activist minister Al Sharpton, the Brawley family refused to cooperate officials with state investigating the case. But for the past two weeks charges have been leveled that Brawley's story is at least partially false and that Mason, Maddox and Sharpton know this and have simply used the case to advance their own careers and prestige. However, the three have countered that their accusers, two former aides, are lying and mentally incompetent. Meanwhile, the controversy appears no closer to resolution today than it did last November.

### Major Civil Rights Lawsult Dropped in Los Angeles

Los Angles, Calif.: A 25 year old lawsuit designed to desegregate Los Angeles schools was dropped last week by civil rights officials who said "desegregation remedies that worked in the past would not work today." The major factor which rendered the lawsuit out of date was demographic: Although Blacks accolunt for around 20 per cent of the city's population, Los Angeles public schools are nearly 65 per cent Black, 17 per cent white and the remainder mostly Asian. These figures prompted NAACP general counsel Grover Hankins conclude: "It's obvious the mix of minorities is not conducive to the type of desegregation of the 1970's." The situation in Los Angeles is reflected in major cities throughout the nation. AAAABBAAAA

# AN EDUCATOR'S OPINION Toward English-Plus'

More than a few economists have noted that when executives of major U.S. corporations are asked what language they expect their sales representatives to master, the answer is almost invariably "English." When the same question is put to Japanese business executives, the answer, more often than not, is "Japanese—and the language of our customers."

That contrast of philosophies is at once revealing and disturbing. It suggests that our national

ambivalence toward linguistic diversity is not only educationally misguided but economically short-sighted.

Nowhere is this ambivelence more clearly manifested than in our attitude toward bilingual education. Students with limited English pro-

ficiency (LEP) are among those least well served by our nation's schools. They are victims—victims of the erroneous view that allowing non-English-speaking students to receive instruction in their own language while they develop mastery of English will splinter American society.

No evidence supports this irrational fear. And yet, 13 states have translated this fear into "English-Only" mandates. These measures, in turn, have fueled education policies that inhibit and in some cases entirely forbid—even the most minimal accommodations to children for whom English is still a strange new language.

These policies send an often devastating message to our non-English-speaking students: Your language does not fit the American norm, so you had better adapt—and learn to absorb lessons delivered in a language you are still striving to master.

This message erodes selfesteem. It stymies academic achievement. It stigmatizes children. And, ironically, it retards the development of English proficiency. A substantial body of

> research now supports the claim that the more intensive the instruction in students' native language, the better their performance on English-language tests in reading, writing, and math.

Bilingual education is not a frill. Bilingual programs have the potential to make today's student with limited

English proficiency tomorrow's linguistically gifted, multilingual American citizen who enriches our national life and invigorates our economy.

We need these programs. Our nation will best be served not by an English-Only movement, but by an English-Plus movement.

So long as we regard the native language of students striving for English proficiency as a liability rather than an asset, we will continue to threaten their self-estecm and squander their potential. The result will be an America of lesser stature, an America that is poorer—socially, culturally, and very likely economically.

### Boston To Integrate Its Public Howsing

Boston, Mass.: City officials in Boston last week announced a plan to end years of racial segregation in its public housing system. The action came in part as a result of pressure from the federal government. Historically, the city had routinely passed over Blacks awaiting public housing in precominantly white public housing projects, especially two in South Boston where anti Black feelings run high. However, under the plan announced by Mayor Raymond Flynn those two projects and others would now admit Black tenants. Flynn celled upon the city to make "a clean break with the past" and carry out the housing integregation peacefully. But it remains unclear as to how soon Blacks will start moving into predominantly white housing projects.




