





NOTICE OF CLASS ACTION AND HEARING **ON PROPOSED SETTLEMENT**

State Farm Insurance Companies has agreed to settle an employment discrimination class action now pending in federal court in Houston, Texas. The lawsuit claimed that State Farm discriminated against women, blacks and Hispanics in the recruitment and hire of insurance sales agents and field claims representatives between 1975 and 1983. The proposed Consent Decree affects only State Farm's Texas Region, which covers roughly the southern half of Texas, including such cities as Houston, San Antonio, Austin and El Paso,

1. The Proposed Consent Decree. A settlement fund of \$11.5 million will be established to satisfy individual backpay claims. The money will be distributed through a claims procedure administered by the Houston office of the Equal Employment Opportunity Commission. Individual claimants may recover up to \$100,000 or more from this fund. In order to be entitled to an award, a claimant will be required to meet certain qualifications and follow the agreed-upon claims procedure.

2. The Affected Classes. The following persons may file claims under the proposed Consent Decree:

All women, blacks, and Hispanics who were not hired within 18 months after applying or constructively applying for a Trainee Agent position in State Farm's Texas Region at any time from Japuary 1, 1975 through December 31, 1983;

All women and blacks who were not hired within 18 months after applying for a Field Claims Regresentative Trainee position in State Farm's Texas Region at any time from January 1, 1979 through July 1, 1983; and

All women employed as claims secretaries or inside claims representatives in State Farm's Texas Region who applied for promotion to Field Claims Representative Trainee positions at anytime from January 1, 1979 through July 1, 1983, but were not selected within 18 months of their initial application.

3. Rights of Class Members. If you are a member of one or more of the classes listed above, you have four options:

- A. You may participate in the settlement proceeding.
- (h. B. You may request exclusion from the class and the settlement.
 - C. You may object to the proposed Consent Decree.
 - D. You may do nothing.

4. IMPORTANT NOTICE TO POTENTIAL CLASS MEMBERS WHO HAVE RECEIVED NO NOTICE THROUGH THE MAIL. Mailed notice has already been sent to the last known addresses of those individuals believed to be potential class members. If you believe you are a class member, but received nothing in the mail similar to this notice within the last month, then you must notify the EEOC if you wish to participate in the class. To notify the EEOC, please call the EEOC Claims Counselor at the following toll-free number: 1-800-253-1175 or in Houston 650-1557. Once the EEOC has been notified, your name will be placed on the class mailing list, and you will receive further notices and instructions by mail. Failure to notify the EEOC will result in your receiving no further notice regarding this action.

5. If yor wish to object to the proposed Consent Decree, you must mail written objections to either Mari Mayeda, counsel for plaintiffs, or A.L. Dent III, counsel for State Farm, at the addresses listed below, no later than January 15, 1991. A hearing will be held regarding the fairness of the proposed Consent Decree on January 28, 1991 at 9 a.m. and persons who have mailed written objections will have an opportunity to voice objections at the hearing.





Calling the Guys Who Call the Game

Professional football on television is a funny business.

Watch any National Football League game on television these days and you're likely to hear more attempts at comedy than you would on a rerun of "Cheers." Somewhere along the way, much of the serious art of calling a football game has been lost.

I make no secret of the fact that I'm of the old school when it comes to football, and that includes sportscasters. My all-time favorite was Ray Scott, who used to announce Green Bay Packers' games. Ray had an intimate knowledge of the game and a straight-ahead delivery that left little room for one-liners. After listening to him call a game, you came away with a little more knowledge about football.

Of course, Pat Summerall and John Madden, the most famous sportscasting team today, both have great minds for football, too. Madden will make some great observations on things that have little to do with what's going on down on the field.

Don't get me wrong. I think Madden and Summerall, who have now been together on CBS for 10 years, do a heck of a job. It's just that Madden's lighter side secms to have inspired every other color man to become a regular stand-up comic.

Dan Dierdorf, the color man for ABC's "Monday Night Football," sometimes goes in the opposite direction. Dierdorf is too prone to praising players' efforts for being "incredible," "unbelievable" and "the best," when their feats are often just the result of poor play by the opposition. Many times, what Dierdorf means to be great insights are not grounded in good football.

Believe it or not, I miss Howard Cosell on Monday nights. Sure he used too many big words, but he really knew a lot about football. Sometimes I'll turn off the sound on television and listen to the radio broadcast of "Monday Night Football" with Jack Buck and Hank Stram. Those guys are about as old school as you are likely to find in this day and age.

Why Blacks Feel Threatened

Several days ago, a Philadelphia newspaper editor suggested that Black welfare mothers should be "encouraged" to stop reproducing sexually, by implanting in their arms the new, fiveyear birth control device. To many African -Americans, this was yet one more indication that the Black community was under antiack, targeted by a new, more sophisticated form of white racism.

In politics, the Bush administration ignored the advice of prominent Black Republican such as former Secretary of Transportation William T. Coleman and Secretary of Health and Human Servicyes Louis Sullivan by vetoing the 1990 Civil Rights Bill. The excuse vien by Bush, that the legislation made it too alligent for employets to defend themselves against charges of rucism, in effect appealed to the white supremacist wing of the Republican party. On this issue, Bush was closer to David Duke than the majority of Ameri-Canatolion

The ink of the vetoed hill was harely dry before the next racial controversy, the new policy which would deny Federal Huds to colleges which awarded scholarships to minority students on the basis of race. Black and Latino educators for decades to athletes and others with speical. skills. Nearly all scholarships for minority students were not based narrowly on rice, but on economic need as well as other important crriteria. The sharp reacttion against this new policy forced Bush into a quick turnabout, declaring that scholarships specifically for moully new rites could be drawn from private fundss. But in effect, the entire episede implied that Blacks, Hispanies and other people of color should be excluded from higher education. For African-Amerians, these two incidents seemed to symbolize the out of an entire histoical period, the Civil Rights Movement for democracy in America. For many years, a sense of opternism and hope pervaded Black politics. The movement from racial segregation to full particaption within the American mainstream was taken for granted. Now, all the evidence points to a deterioration in the economic and model status of Blacks in American life; and the Bosh administration seems willing to push ministrities over the abyss. Forexample, in terms of health care, an alamping gap has been Spanied or between Africanfirmpsicans and whites. According to the National Center for Health Statistics, the life expectancy for Black men has fallen to 64.9 years, helow retirement age. Milflops of Black women dren't receiving adequate prenatul care, and infant-mortality rates are not surprisingly twice the rate for Blacks than whites. Another recent health study found that Blacks, who represent only 13 percent of the total U.S. population, now account for 80 percent of all prematore deaths - that is, deaths of individuals between the ages of 15 ;to 44 years - bo-

hildren learn their most critical lessons before they ever walk through the schoolhouse door. During the preschool years, youngsters develop the basic learning skills, the social skills, the inquisitiveness, and the attitudes that shape their development and achievement through the school years and beyond.

We've known this essential truth for a long time. From the work of such child-development theorists as Piaget, Montessori, and Erikson, we know that the foundation for future learning is laid during children's earliest years. Studies of Head Start participan's have demonstrated that good preschool programs increase the likelihood that disadvantaged children will graduate, enroll in postsecondary schooling, and find employment. There's aburdant evidence that high-quality early childhood education-not just custodial care-is crucial for children's development.

Yet what we have in the United States today is a profound failure to meet children's developmental needs. Early childhood education in this nation is a hedgepodge of public and private daycare centers, nursery schools, childcare homes, and babysitters of widely differing quality, huge variation in cost, and limited availability.

The shorage of high-quality carly childhood programs is particularly devastating given the momentous change in our country's economic and family senaciare. In 1950, only 14 percent of America's . children under the age of five had mothers in the labor force. The U.S. Consus Bureau predices that in 1995, 80 percent of children nuder age six will have mothers working ounide the home.

Most American families are no longer able to meet their childrearing needs alone. The news stevies of young children left in locked cars and a spey houses are symptomatic. A family : ability to caroll its children in quality programs resus. an a combination of luck, appres-

Oakland, California, provides a model of an excellent early childhood program funded by the state and run by the public schools. The 2,500 low-income children enrolled in Oakland's Child Development Centers develop social skills, basic mach and language concepts, and confidence through child-initiated learning. Because the Centers are part of the school system and located next door to elementary schools, excellent communication links CDC and school staff.

"You can tell who the CDC children are," an Oakland elementary teacher told me recently. "They start elementary school with the basic building blocks for learning. Too many others start school behind-with no building blocks, no social skills, and little language And this negative start spirals through their school careers."

Imagine if we made high-quality, public preschool education available to every child in America. All children would have the opportunity to develop the skills and attitudes critical to school success. And we could establish important continuity between the preschool and early elementary years.

Cottrell: Drug case kept quiet

College hid trustee's conviction, he says


Comer Cottrell, the man who brought Paul Quinn College to Dallas, on Monday accused the school's president of covering up the board chairman's felony drug conviction.

Cottrell, who owns the former Bishop College campus to which Paul Quinn moved from Waco last year, said President Warren Morgan knew about Chairman Robert Lee Pruitt's conviction before it was publicized last week.

Morgan denies it. Pruitt, Texas bishop for the African Methodist Episcopal Church, was arrested in July after police found him crouching in bushes near a reputed Oak Cliff crack house. Police said he held a bag containing six rocks of crack cocaine.

Pruitt, convicted Nov. 1, was given two years' probation Dec. 19. He appealed the conviction Friday.

Saying he questions "the whole governance of the school," Cottrell called for an emergency meeting of the board. Morgan said a regular board meeting is scheduled for Jan. 22, so there is no need for an earlier session. Cottrell, complaining that neither Pruitt nor Morgan had returned his phone calls, satd, "I don't know what's going on over there. The president had known over a period of time and had not brought it to the attention of the

Morgan said he learned of the conviction by reading the newspaper.

"Prove it," he said of Cottrell's charge. "I was in Arizona when it broke, and that's the first I'd heard of it."

But Walter Knowles, Pruitt's attorney, said Morgan knew about the conviction at least two days earlier.

"He wasn't quite aware of it, in detail, until a couple days before it came out," Knowles said. Then he added, "He wasn't aware of it. There were very few who knew, He wasn't part of a cover-up."

He wasn't part of a cover-up." Knowles said his client told few people about the incident because he did not want to damage the reputation of the school or his church. He said Morgan and other school officials learned of the conviction shortly before the news media did.

"Someone gained knowledge of it, and they leaked it. Once they gained knowledge of it, it was like wildfire," Knowles said.

While school officials deny prior knowledge of the case, court records show that a prominent leader of the African Methodist Episcopal Church was aware of Pruitt's legal troubles. The Rev. James Anderson,

The Rev. James Anderson, who presides over the Austin area's 23 AME churches, helped Pruitt secure his \$2,500 bail, court records show.

Anderson, identified as a friend, is one of three references on Pruitt's pretrial release bail papers. The papers also list Anderson's sister and a cousin as references.


Anderson said Monday he did

not report Pruitt to church officials, but he said some of them knew about the conviction.

13th Amendment Celebrated

1990 celebrates the 125th anniversary of adoption of the 13th Amendment to the U.S. Constitution, which abolished slavery. This marks a century and a quarter of freedom for all people in our country, regardless of race, sex or religion.

The amendment was ratified on Dec. 18, 1865, soon after the Civil War ended and two years after Abraham Lincoln's Emancipation Proclamation. It took the question of slavery out of the hands of the individual states and proclaimed, "Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction."

The 13th Amendment was soon followed by the 14th, which granted full citizenship to black Americans. Both gave blacks the same rights as those enjoyed by other Americans, thereby upholding the basis of our Declaration of Independence, which proclaims the equality of all men, the primacy of people over government and the dignity and worth of each individual.
