### Students Responses:

:During the week of March 16 - 20, 1992, the Lubbock High School Black History Class, joined by several associate members from three area high schools, made a tour of Historically Black colleges and universities in Texas and Western Lousiana. It was the first tour of its kind to be successfully completed.

The intent of this tour was to motivate students to seek some form of higher education, whether at a Black college or university or not. Also, the trip put to rest many myths surrounding Black colleges and universities.

For instance, some students continue to labor under the false-hood that Black colleges and universities are inferior to other institutions. However, Jasheiba Humphreys, a senior at Estacado High School, reported "the tour made me want to attend a Black college when I might not have before .... I realized that Black colleges have as much to offer as other schools. It seems that despite financial troubles, in some cases, our colleges are still attractive to those seeking higher education."

According to Robert Jenkins, a Lubbook High School senior and president of the Black History Class, "the most attractive quality was the "flavor" ...... it felt like coming home."

Despite higher-than-ever attendance rates at most of the institutions, a few were struggling just to exist. Bishop College, for instance, had only 97 students enrolled when the class toured its campus. As a final word, the writer would like to add that we must continue to support our predominately Black colleges and universities. In the words of Sherasa Maione, a senior at Monterey High School, "We should make a conscious effort to keep them in operation."

# Justice Objects To LISD Election Plan For New Districts

Souces to El Editor Newspaper said late Tuesday afternoon that the U.S. Department of Justice has objected to the changing of election districts in the plan submitted by LISD for approval this year.

The plan had drawn objections from minorities throughout Lubbock because of the inclusion of once sepecific election box, bo. 11, that has traditionally voted against minorities in District 2 which is currently represented by Trustea Billie Caviels and includes most of East Lubbock.

\*Both Linda DeLeon and I have been in constant communication with the Justice Department to try and convience them that Box 11 will prevent a real representative from District 2 to be elected." said Bidal Aguero who was an original plaintiff to enable single member districts in Lubbock.

"The facts are there. For the past 2 or 3 elections, the people of Box 11 have consistantly voted against minorities regardless of their qualifications. I don't really know why Billie agreed to include Box 11 in this district," added Aguero.

The Black Press!!

Since 1827, Samuel E. Cornish and John B. Russwall published the first recorded issue of the Black newspaper. "Freedom's Journal", meny contributions have ben made by the Black press.

Cornish, a Black Episcopal minister and Proswurm, the first Black college graduate, began comething positive for the Black

Flusswurm stated: "We want to plead our own cause." Black newspapers have been doing just that for the last 164 years. backing and attacking leaders in the communities they serve, despite major competition from the larger, general population daily newspapers.

Advertising dollars are spread among TV, radio, daily newspapers, magazines and billboards. Struggle for our fair share has been rather difficult for the Black community newspaper.

Some advisers are, however, learning the advantage of using the Black press.

The role of the Black press, first of all, is to provide a medium of expression ... for the African American Community. The Black Press was a bastion of Civil Rights support; it set out to break down the doors of segregation. When advertises sry, "Well, Black people read the daily papers, so I advertise in the daily, Black people also read The Wall Street Journal; The U. S. A Today. You're not advertising there! If you want to specifically target the Black community, you need to advertise in tha Black newspapers. And advertisement in the Southwest Digest says "We want to be in your community." It's still difficult to get some white merchants to understand that!


An advertisement's effectiveness is directly proportional to the believability the reader holds in the newspaper. Tony Brown Journal has higher believability than Art Buckwald in the Black community. Most Blacks will pay more attention to what they see on BET ihan what they see on C. N. N.

So even if they advertise in the major daily papes, the advertisement has more equitbility and believeability with the audience if its in the Black newspaper.





## Education plan should stress quality

The people of Texas Jernand just two basic fundamentals from our public education system - quality and fairness.

Texans want quality schools and they want a fair method of funding those schools.

Those are broad issues and they give us a ict of negotiating room as we try once more to develop a fair system of financing public education. Three times the courts have struck down attempts to devise a system that ensures quality in our schools and fairness for all children.

This time a spirit of compromise, regotiation and reasonableness must prevail. At stake is the future of our children and grandchildren.

My staff is developing a plan which I will announce shortly. Speaker Lewis has already proposed a plan and there will be others that merit serious consideration. I am willing to look at all

We can, and should, be willing to negotiate about the definitions of quality and equity, about the amount of money that is required, about how best to return decision-making to parents and teachers at the campus level, and about how we can hold schools and school districts accountable for their progress.

The range of negotiables includes administrative costs, textbooks, organization of instruction, instructional time and state and local policies.

But I must emphasize that there are two non-negotiable items in the education debate: the needs of students, and student performance.

If we are going to convince the taxpayers of this state that all this talk about education and money is more than just a bait-andswitch public relations job, we must produce results. To give them those results, we've gut to get out of the lawsuit business and back to the business of educating children.

That's the job I expect us to accomplish in a special session of the Legislature I will call this spring. If we are to address the bigger issue of quality education during the 1993 regular session of the Legislature, we must resolve the issue of finance now.

Admittedly, the odds are against us. This is an election year and there are no easy votes when it comes to education finance. But I don't believe that any legislator wants to go home and say we failed our children.

With that in mind, here are the broad outlines that we must work with to successfully resolve this education finance issue:

1.) We must provide rewards for quality - that is, provide

incentives for improving each school. 2.) We should not cap local spending. If taxpayers choose to

spend more money to enrich their schools, they should be able to do so.

3.) We must produce a system that is revenue neutral. 4.) We must develop a system that is statewide in nature.

5.) We must pass a constitutional amendment, or we will end up in court again.

This is not a long list. I'm not interested in drawing lines in the dirt, and choosing up sides. I have left as much coom for negotiation as possible.

We cannot simply pass a constitutional amendment that says, in effect, equity is whatever the legislature says it is. . . because then we invi the federal courts into our schools. Since we are currently having a devil of a time dealing with federal court interference in our prison system and our mental health, mental retardation system, I don't want to even crack open the door of public education.

So what we need is a constitutional amendment that can go before the voters in November. That constitutional amendment should give us a clearer definition of equity, and come hind of





"The cup which my father hath given me, shall I not drink it?" John 18:11.

James L. Kelso, a Professor of Old Testament History and Biblical Archaeology, says the "cup" was widely used in Bible tims in figurative language. The cup ws symbolic of the kind of life experience which God (ne) Host pours out for his wo '1. For the saints there was the cup of the blessing of God (Ps. 23:5). For the wicked there was the wine cup of the wrath of God (Ps.11:6) The cup also represents drunkness and other liticit pleasures (Prov. 23:31; Jer. 51:17).

In Jeremiah 13:7, we read of a cup of consolation, taken from the Jewish custom of sending it to those in mourning or condemned prisoners (Amos 2:8). There was the cup of salvation (Ps. 116:13) or of deliverance that was used solemnly in the temple by the priests or privately in the family. In Psalm 9:6; 75:8 and Jeremiah 25:15, w read of the cup of tribulation. It was to this cup that our Lord referred in J ohn 18:11.

Christ Jesus took a well undestood figure and applies it to Himself and His word are invested with deep and tender meaning by the fact triat only several hours earlier He had given a cup to His disciples, and in the drinking they should commemorate for ever His dying love.
