Lubbock Central Appraisal District appraises all taxable property in Lubbook County for each taxing juris diction as of January 1st each year. The 1996 estimated value of each property will be mailed to property owners by May 24, 1996. The 1996 estimated texable value of Lubbock County is 4.75% above the 1995 certified taxable value. Approximately 56% of the increase is due to new property added to the appraisal roll for 1996 with the remainder being due to reappraisal of all type: of properties. The average value of a residence in Lubbock County in 1995 was \$54,722 and the estimated average for 1995 in \$54,833.

There will be approximately 110,120 appraisal notices mailed by May 24, 1996. The notices will inform property owners of proposed values for the 1996 tax year. Each property owner should receive one of the two types of notices that will be mailed. Standard notices will be letter size that will compare the 1995 information to the proposed 1996 values and will give an estimate of taxes based on the 1996 value. The remaining notices will be a postcard that compares the 1995 and 1996 values. Pat Brownd, Director of Appraisal for the District said the letter size notices will be received by property owners when the following conditions occur:

1. Real and Personal Property 1 If the 1996 proposed value is higher

than the 1995 value b. If the property owner filed a timely

rendition c. If 1996 is the first year the property becomes taxable such as a new home

build in 1995 d. If a property changed ownership in 1995

The appraisal notices have a number of important statements that each owner should read along with the market and taxable values. Owners should watch for mportant dates, correct mailing address, the proper taxing units assigned to the property, agricultural productivity value if applicable and any exemptions granted by taxing units.

Brownd stated that property owners who have questions or want to discuss the value placed on their property should contact the appraisal district office as soon as possible and before June 24, 1996. The district's staff will review your property with you and answer any questions you may have. When the value of the property is questioned, owners will be asked to submit any evidence they may have regarding the actual market value of the property. If a difference of opinion remains after contacting the appraisal district, the owner has the right to file a written NOTICE OF PROTEST with, and present conclusive evidence to the Appraisal Review Board. This protest must be filed at the district on or before June 24, 1996.

Property owners may protest any of eight specific actions of the appraisal district. The eight actions are:

* the appraised or agricultural value of the property * unequal appraisal of the owner's

r-operty. * inclusion of the property on the

appraisal records * denial of a partial exemption

* denial of agricultural use, or openspace valuation

* identification of the faxing unit or units in which the property is taxable * determination that the noticed party is the owner of the property

* a determination that a change in use of agricultural land has occurred

Property owners may also protest any other actions of the appraisal district that apply to and adversely affects them. However, the ARB has no authority over tax rates or a taxing unit's spending and may not hear any protests of those matters. Brownd said the Appraisal Review Board will begin hearings on Jame 27, 1996. State law requires all protects to be filed by June 24, 1996 and requires all protests to be filed by June 24, 1996 and requites the ARB to approve the appraisal records by July 20th.

The letter-size appraisal notice also includes estimated tax rates and estimates taxes for the proposed 1995 values. The estimated rates and taxes, as required by law, are only estimates that. would raise the same total revenue that a luxing unity raised last year from properly taxed had year. The postcard notice does not contain the estimated tux information. The actual 1996 tax rates cannot be set by the taxing units' governing bodies until after the Appraisal Review board approves the appraisal records and the Chief Appraisor certifies appraisal rolls to the tax on units upon completion

EDUCATING OUR CHILDREN: THE FAILURE OF INTEGRATION by Bernice Powell Jackson

As I travel around the country people often ask how they can get involved and do something about racial and economic injustice. Often my response is to get involved with their public schools because public schools are often the intersection point between these interconnected and troubling

issues which threaten to tear this nauon apart.

For African Americans education has a historical importance. Slaves were forbidden to learn to read or write and even after slavery, education was denied to many African Americans. Some states, such as Missouri, denied African Americans the right to public education long after slavery ended; others chose to provide only inferior education, spending much less per pupil, paying black teachers much lower wages and providing only used textbooks and dilapidated

In spite of this (or because of this), my African American ancestors cherished education. Indeed, education and entertainment and sports were the only way out of the ghetto for most African Americans.

Thus, it is not surprising that for black Americans in the 1950's integrating education was a top priority. It was not that the lawyers, educators and psychologists who led the battle in the Brown vs. Board of Education decision believed that sitting next to a

white child would make a black child smarter as Clarence Thomas has been known to say. Rather, they believed that if black children had access to the same educational settings as whites and were able to attend integrated schools that they would develop relationships with white children which might open new doors for both sets of children.

But the hope, and dreams of those who fought for integrated schools have not really been realized for the vast majority of children of color in this country. Indeed, a recent article in Time magazine pointed out that after two decades of progress toward school integration, often by using bussing, the separation of black children is fast approaching the pre-bussing levels of the 1960's. According to that article, one-third of black public school students in this nation attend schools where the enrollment is 90-100% black, Hispanic, native American or Asian American. In the nation's 1 ortheast half of all black students attend such schools.

Clearly, just attending an all-black school is not all bad. Some cities have begun Afrocentric schools designed to instill pride and self-esteem for African American children and many of these schools are succeeding. But the question of how African American and other children of color learn to interact with European American children in our diverse nation cannot be easily addressed in an all-black school.

For many school systems there is another question

as well. In many cities middle class white families have moved out of cities in order to avoid having their children attend school with children of color. Unfortunately, the same is true of black middle class families, some of which are moving to the suburbs. The families left behind in the cities are poor, most often families of color many of whom face a dizzying array of social problems from unemployment to health problems, from lack of parenting skills to homelessness. With lower tax dollars available, city school systems suffer crumbling buildings, broken bathrooms, fewer books and materials and little assistance in dealing with the overwhelming problems their students bring to school every day.

There are no easy solutions to the problems of education. Perhaps bussing has not always worked. Perhaps court-ordered desegregation plans have been unworkable. Perhaps integration has led to lower expectations for students of color by insensitive or, even hostile school systems.

But one thing is for sure. All children in this nation, including millions of children of color, have a right to a good education. They have a right to expect that when they graduate they will be prepared for higher education or for work. Until every child in American reaches his or her potential, we all suffer and our nation's future is jeopardized.

It disturos me to see our young minority male students sitting in class on a daily basis as they passively while away their time drawing pictures of marijuana or hemp, forty-five magnum guns, gang symbols and their gang names as well as calling themselves 'playas' and/or 'pimp.' This is what can be seen on books, papers, etc. on which they should be doing heir school assignments. They also wear jewelry portraying


these things. The thing that is really disturbing is the fact that when these students are disciplined or chastised, you can see them doing the same thing the next day if not sooner.

What does this tell us about our minority male students? First of all, it says that the young minority male students are consumed with what seems to be gang activities or they 'wannabe.' Secondly, it tells us that these students have no respect for law and order. Third, these students do not have their minds on academic affairs. Fourth, some type of depro-

gramming counseling is needed for these students. What can we do to help these minority male students? Plenty can be done, but it will be time-consuming and it

requires plenty of patience, and in some instances, money. First, parents need to tune in to what their sons are doing or want to do, and either be a good role model or a very persuasive teacher and counselor. Secondly, parents need to find out what their sons are doing at school before the school sends for them when they have done something wrong. Third, minority males need to know that they are expected to excel in all of their undertakings in the academic arena, not just sports. Making a living at sports is mostly a pipe dream and vocations of substance should be their first line of pursuit. As ment makes offenders become hardened criminals. a last resort, for the hard core, hard-to-turn-around, minority males, efforts should be made to place them in institutions

where they can learn the value of a regimented Lifestyle where they are taught the value of hard work, its rewards, and civility. This can cost money, but will be worth every penny in the final analysis. It will mean more to the child in the long run than detention centers, boot camps and schools of intervention which deal with a part of the child. They need 'whole Child' treatments. It is time that we get 'in cinque' and spend tax dollars for this kind of institution rather than to continue to build places for punishment. Too often, punish-
