## **Medicare Prescription Drug Discount** Cards: Which One Should You Pick?

The new Medicare law that was signed into law in December 2003 makes major changes to the nation's health insurance program for people age 65+ and some persons with disabilities. The most important part of the law is a new benefit to help people in Medicare with their prescription drug costs. This assistance will go into effect in two stages. The first stage begins in May 2004 when you can sign up for a discount card to help with some drug costs. This is a temporary program that phases out when the second stage of assistance; a Medicare drug benefit, goes into effect on January 1, 2006. Once this begins, the discount cards will no longer be used.

In the meantime, starting in June 2004, discount cards with a Medicare approved seal will save you about 10-15 % on your total prescription drug costs. Medicare will contract with private companies to offer these cards. The cost for a card will be no more than \$30. This card is optional - you do not have to get a discount card if you don't

However, if you decide to get a Medicare-approved discount card from a private company, you may pay less for your prescription drugs than you do now. Discounts will vary by card, and each plan will be slightly different. For example, some cards can only be used at certain pharmacies.

With many different cards available, and different discounts offered for different drugs on each card, how do you decide which card is the right one for

Start by making a list of the medicines you currently take, and include how much you pay each month for each prescription drug. Then, as you learn more about the different Medicare-approved discount drug cards that are available in your area, find out which cards offer the best discounts on the

drugs you need. Here are some important facts for you to consider:

\* You can only get one Medicare discount drug card at a time. · If you already have a different discount card; you can keep that card. You can also get a Medicare discount card. Use whichever one gives you the best deal.

· If you are in a Medicare+ Choice plan, your plan may decide to offer a Medicare discount drug card. If it does, you can only choose that card. If your Medicare+Choice plan does not offer a discount drug card, you can choose any available Medicare discount drug card. • If you are in a state Medicaid program with drug coverage, you

will not be able to get the discount card. · If you have drug coverage through an employer or former employer, you may not need the

discount card. · If you have a Medigap plan with drug coverage, you may get lower prices using the card. The card should not affect your drug cover-

If you have a low income, you can get additional help- If your income is less than about \$12,000 a year for one person, or \$16,000 for a married couple, you may get up to \$600 to help pay for pre-

scription drugs in 2004 and again in 2005. Also, you will not have to pay a fee for your discount card. While you have money on your card, you will have to pay a low copay (5%-10%) each time you use it. If you use up the \$500, the card can still be used for discounts.

If your drugs are already covered by Medicaid, you can not get the discount card. If you have drug coverage from an employer or the federal government, you cannot get the special low income features of the discount card.

Medicare-approved discount drug cards may be able to save you money on the medicines you need. Each card, is different, and will provide different discounts on different drugs. It's important to figure out which discount card will provide the most savings for you. Before choosing your Medicare-approved discount drug card, shop around to see which card best meets your needs.

Medicare will give you more information as the benefits start. Medicare has a web site (www.medicare.fiov) and a tollfree telephone number (800-MEDICARE or 800-633 4227 or TTY 877-486-2408). For those who prefer to get help in person, there are counseling programs that can provide direct assistance.

## BB Warns of Gypsy Roofers

Lubbock, Texas, May 3, 2004 - The gypsy roofers are back, according to Nan Campbell, president of the Better Business Bureau of the South Plains (BBB). These are some of the same travelers that we warn the South Plains about from time to time.

It has been reported to our office on more than one occasion within the last few days that itinerant roofers are going door to door, catching the homeowners off guard by telling them that their "roofs" need to be repaired. The rooters ask for payment, up front, to paint or seal the roofs. Part of the scam is to use a name of a

local company making them look legitimate

"The BBB advises extreme caution in dealing with itinerants that come to your door to sell you a roofing job or any kind of product unless or until you check them out first," stated Campbell.

This is a typical scam of the gypsy itinerant roofers who drive brand new, unmarked trucks, don't wear any uniform or carry any identification with them as would be typical of a local company. They also are able to catch senior citizens at home during the day and we especially want to warn our seniors to be on the lookout.

These schemers are all part of the gypsies that go all over the country seamming people out of their hard-earned money. Best advice is to JUST SAY NO and heed the following tips!

. DO NOT pay up front always pay after the work is completed and never pay with cash - make a check out to the company;

· ask for local references; \* verify the legitimacy of the company with the BBB;

· get at least three bids from local companies that do the same or similar work, and

· if it sounds too good to be true, then it probably is.

#### Susan Combs Receives American Cancer **Society True Grit Award**

Austin - On Friday, May 7. the American Cancer Society presented Texas Department of Agriculture (TDA) Commissioner Susan Combs with their True Grit Award in honor of the Commissioners leadership role in the fight against childhood obesity.

"The True Grit Award is the highest advocacy recognition bestowed by our organization," said Jon Hornaday, Chair of the American Cancer Society Texas Division Board. "We are proud of the Commissioner's work to reduce obesity among Texas children," he said. The award presentation was made during the organization's Texas Division board of directors meeting.

Commissioner Combs has been a powerful advocate for improved child health. After shifting the management of the Child Nutrition Program from the Texas Education Agency to the TDA, Combs made sweeping policy changes to restrict and even prohibit the sale of soft drinks and "Foods of Minimal Nutritional Value" on middle and elementary school campuses.

About one-third of all cancer deaths in the US each year are due to nutrition and physical activity factors, including obesity. American Cancer Society guidelines recommend maintaining a healthful weight throughout life by balancing caloric intake with physical activity and losing weight if you are currently overweight or obese. Obesity among children has more than doubled since 1970 and is now one of the most pressing public health issues in Texas.

The True Grit Award is presented each year to an elected official for

"remarkable courage, perseverance and true grit" on a pub-Tie policy issue of significance to the mission of the American Cancer

Previous winners have included State Senator Judith Zaffirini, Congressman Lloyd Doggett of Austin, and El Paso Mayor Pro Tem Larry Medina and most recently the Dallas City Council for their support of a strong clean air ordinance.

The American Cancer Society is the nationwide community-based voluntary health organization dedicated to eliminating cancer as a major health problem by preventing cancer, saving lives, and diminishing suffering from cancer, through research, education, advocacy, and service.



# Focus on the Family Applauds FDA Decision on "Plan B"

#### Ruling "sound medical judgement and common sense"

Colorado Springs, Colo, Focus on the Family Senior

Gordon Earll issued the following statement today in
response to the Food and
Drug Administration, decision to nct allow over-the-

counter sales of "Plan B" commonly known as the "morning-after pill":

"Despite intense lobbying by radical feminist groups and pro-abortion forces, the U.S. Food and Drug Administration placed the health and safety of American women and teenagers ahead af political ideology with its announcement tare yesterday.

'The FDA's decision to reject Bart Laboratories' request to sell 'Plan B' over-the-counter without medical supervision represents sound medical judgment and common sense. Focus on the Family is relieved that the FDA comprehended the potential lisk to young women and fulfilled its appointed role to protect them — despite immense pressure to do otherwise.

"The proposal would have allowed teenage girls (or younger) to purchase the drug without parental involvement or knowledge. The effects of repeated use of the drug, especially on developing adolescent bodies, are unknown. 'Plan B' consists of two high doses of oral contraceptives - pills that are usually available only by prescription after a medical examination and with continued physician oversight. It simply does not make sense for higher doses to be exempt from the same supervision - regardless of the age of the female."WASH-INGTON - The U.S. Small Business Admini strati on today announced a new procurement program that will boost federal contract opportunities for service-disabled veteran-owned small businesses. The interim rule will be published tomorrow and is effective immediately. The Federal Acquisition Regulatory Council concurrently released regulations implementing The program.

"President Bush has made it a priority to reach out to all of Americans entrepreneurs, and we have a special responsibility to make an effort for those who sacrificed for our safely and freedom," SBA Administrator Hector V. Barreto said. "We have made a strong effort to do precisely that. Federal contract dollars to service-disabled veterans increased from \$298 million in fiscal year 2002 to \$510 million in FY2003. But we want to do more. The regulations being issued today will ensure that those great Americans who served our country proudly continue to have fair and open access to contracting opportunities."

The new rule will amend the relevant sections of the Code of Federal Regulations, adding provisions that will allows contracting officers to restrict contract awards to service-disabled veteran-owned small businesses when there is a reasonable expectation that two or more service-disabled veteran-owned small businesses will submit bids at a fair market price. It also allows awards of sole-source contracts to service-disabled veteran-owned small businesses when there is not a reasonable expectation that two or more service-disabled veteran-owned firms will submit bids and the anticipated contract price does not exceed S3 million, with the exception of manufacturing contracts where the contracting threshold is \$5 million.

small businesses to self-certify as service-disabled veteran-owned businesses. Any challenge to a firm's status as a small business or standing as a service-disabled veteranowned small business must be referred to the SBA for resolution. The SBA will rely upon existing Department of Veteran's Affairs or Department of Defense determinations regarding status and will help enforce penalties for false representation


