Amarillo Citizens State Position on School Desegregation-Bussing in State

(Editor's Note: The following is a statement by Concerned Citizens of Texas, residents of Amarillo, on how they feel about the school desegregation and school integration in the State of Texas.)

"In this area of school desegregation and school integration, there are many of us who are confused, angry, dissatisfied, frustrated, and down right incensed because of the way our lives and the lives of our children, of our educators, and our communities have been and still are being manipulated, exploited, and dominated by administrators, and other government officials, as well as officials in education, social, civic, and fraternal organizations. All of these persons seem to think that they have the responsibility to provide "quality education" for all Americans, or they are the ones who have been designated to help make the so called "American Dream" become a reality at the expense of our minority groups. We are sick and tired of having these demands coming from our President, HEW, School Boards, HEW investigative teams, and whoever they are who have taken it upon themselves to annihilate everything which is different from the majority culture. All of their planning and maneuvering is one without any consultation with citizens involved."

The report went on to add: "In most cases, regardless of what administrators say, the minority schools are closed solely because white parents do not want their children to attend schools in the minority neighborhoods, and many white teachers simply do not want to teach in the minority community. Many of them are given choices to teach in the minority communito or not; while these choices are not given to minority teachers when they are forced to cross over into the all white schools.

"It is hard to believe that a Nation which prides itself on Justice, Decency, and Honesty; a Nation which tries to solve the problems of the Whole World, a Nation which can become involved in Moon business, and can even send men to the moon, cannot

Citizens Invited to City Schools During American Education Week Here in City

Lubbock Public Schools extend an invitation to citizens to visit the schools this week which is being observed nationally and locally as American Education Week. Many schools will have open houses and other programs designed for parents, but visitors are welcome each day during the regular school hours.

American Education Week has been held annually since 1921. and is sponsored by the National Congress of Parents and Teachers, The American Legion, the National Education Association, and the U.S. Office of Education.

In an emergency executive ses- | sion of the City Council Wednesday morning, Bill Blackwell, city manager of the City of Lubbock since February, 1967, was relieved of his position. Assistant city manager Bob Wilson responded to the situation by presenting his resignation, effective immediately, and indicated that he would probably go into private business in Denver, Colorado.

Action came after 90 minutes of deliberation in the closed session. There was a 4-1 vote in the dismissal, with Councilman Morris "Moe" Turner opposing the firing.

Mr. Blackwell used choice words after learning of the decision, saying, "It's a lot of mickey mouse operation, it's a bad day in city government when this type of thing happens in city government."

Mayor Granberry announced the outcome of the closed meeting in the council chambers when he said, "It is the consensus of the City Council that in the best interests of the City of Lubbock that the city manager be terminated." He also said that Blackwell will receive 30 days severance pay and vacation time that he has accumulated.

When asked about specific reasons for Blackwell's release, the mayor said: "The situation was such that we felt a change was necessary." The mayor did not give specific reasons why the city manager was dismissed.

Blackwell, who recently had a vote of confidence from the city council, said he was told of the Council's decision about 30 minutes before the executive session was recessed to allow a statement to the press.

"I asked for reasons," he added, "and received nothing that I could understand except that I had not carried out policies on the council staff."

The staff he was talking about was relieved of their duties and sent back to their positions prior to being hired as aides for the council.

N.B. McCullough, director of utilities was appointed acting manager. He had served in this capacity before Blackwell was hired in 1967.

For Blackwell, this was the fifth time in his three years here as city manager that he had faced sudden elimination. Never-the-less the sudden dismissal sent shockwaves through City Hall.

McCullough, new acting city manager, himself was surprised by the sudden move when he was called from the coffee shop at city hall about 10:15 a.m. and informed by the council of his new position. McCullough said he did not, plan to change anything."

What Is a "Jive, High-Siding" Nigger?

A jive, high-siding nigger is one who poses like he is Black. He is underneath a colored man, one who masquerades as a Black man. In earlier days, many of you may recall, he would have been called a "civil rights prostitute," in that he used every opportunity to integrate himself with white people. He is the guy who is sufficiently educated because he stayed in schools and universities while the kids in the street opened the college doors for him. Once a few financial grants were made available to Blacks, he was first in line to show his worthiness and need.

Having left the college campus after six and a half years, he is now the expert on Black affairs in the white company or the showcase Negro that proves the company is an equal opportunity employer. He is often referred to as the "corporate nigger."

There is one thing, however, that this individual is not—and that is dumb. He knows how to maintain the precise degree of militancy and civility, so that his employers can assure themselves that they have a respectable Negro. He may wear a carefully coiffered natural hairstyle and he can say "Right On!" with the right combination of fervor and confidence.

He is an expert on Black politics, ghetto life styles, hip language and the Black Panthers. There is nothing he can do better than explain to naive white folks what's wrong and/or right, with Lubbock, Amarillo, Midland, Odessa, Big Spring, San Angels and even Bullard, Texas. Whenever any discussion touches upon Black people, he becomes a learned authority, holding his white audience spellbound.

He is very careful about his appearance. His secret nightmare is that white folks may detect that he has BO. On the other hand, on the street hurrying to work with his genuine alligator attache case, he may easily be mistaken for a foreign diplomat or a big-time operator with some government program. Although he spends thousands of dollars on frivolities, he rarely contributes to Black causes or organizations in his own community.

The jive, high-siding nigger really digs white folks. He loves their brashness, their self-confidence, their knowledge of a world he perceives dimly. He apes white folk's ability to consume—cars, wine, women—all of the symbols of good living.

Mr. Jive High-sider is often the only Black man of status employed by the large bank or insurance company, not to mention other establishments depending on the location. In many cases, he is the first and only Black employed. A favorite position assigned to him is assistant director of some department, but as such he is only permitted to hire lowly

staff. All really important positions and decisions regarding salary are made by white supervisors. He is in a unique position to cut down struggling Black brothers, however, and he does so with impunity.

Whenever the rest of us attempt to use the institutions in which these men work, we must deal with him for the institution has hired him for this purpose. In his role as liaison between the Black applicant and the institution, Mr. Jive High-sider wields an iron hand. He must show that he is astute and trustworthy, so he will carry out the orders of the institutions to the letter.

We know that he has got to fool the "man", we know that he is just jiving, but the fellow is still a dangerous man when he used his position to cut down other Black folks on the outside. Essentially, he is a selfish individual, who places top priority upon his own individual achievement, and doesn't mind sacrificing the liberation of his people for his own creature comforts.

The irony of Mr. Jive High-sider is that white folks will cut him down when he has become alienated from his people, thus, at the time when he has most successfully done the bidding of white folk, he becomes expendable and is fired.

Black Tech Students Have Right Idea

The Black sisters and brothers of Texas Tech University have the right idea about "getting themselves together." It appears as though they are out to get somethingsdone this year. This editor, who had the opportunity of talking with some of them last Sunday, was rather impressed with the positive steps they are making at this time.

Under new leadership, and a new name, the group seems to have a lot going for it. These young Blacks, who are a part of one of the largest universities in the Southwest Conference, can make a lot of things happen if they continue to move in the right direction.

There's so much a group of young, talented, ambitious Black brothers and sisters can do. It is time, however, for these young Blacks to realize

that they must continue to condition themselves in the right direction. They must also realize that they cannot continue to live in the past, but must move ahead boldly setting symbols and images of what a Black student can do and is doing.

This editor feels, without any doubt, that these young people will be a credit to Texas Tech University as well as the Lubbock community. It's time for a drastic change in the attitudes of young Blacks; and these brothers and sisters should be among those who will be a great part of that change.

Good Luck, Black brothers and sisters. We are behind you and your efforts. Remember, you can't go anywhere but up. Right On!!

Halloween-Holiday or Horror?

What will it be this Halloween in Texas, trick-or-treat—or tragedy?

If you're driving your car October 31, the answer can be largely in your hands, says the Texas Insurance Advisory Association (TIAA).

Halloween is a popular holiday in the Lone Star State. Nearly all of the state's approximately 2,100,000 elementary school children will become trick-or-treaters for a few hours, romping through their neighborhoods with little on their minds but the next treat.

The TIAA reminds that while it can be a joyous time for kids, it is also potentially dangerous for them.

The TIAA offered the following safety tips to motorists and parents of trick-or-treaters:

To motorists—Drive slowly and warily. Watch for children darting out between parked cars. Tap your horn occasionally on dimly-lighted residential streets. Be extremely cautious while backing out of driveways.

To Partnts—Escort your littlest ones. If your children are going as a group, give the oldest a flashlight. Dress the kids in bright clothing or stick reflective tape on their costumes or trick-or-treat bags. Use a scissors to widen the eye holds in their masks. Urge them to look up and down before crossing.

We Are Insane

I would like to start off by saying all Black men are insane, and that includes myself.

Furthermore, it is safe to say that there never has been a sane Black man in this society. Almost any living thing would quickly go mad under the unrelenting exposure to the climate created by a white racist society. Sometimes I get



the feeling that the climate itself is the catalyst, that it reacts with the fluids in a Black man's brain cells he needs to develop into a sane representative of humanity.

As a general rule, the white majority has no idea that its irrational behavior has created the monster it calls the "Race Problem," which would be better if referred to as 22,000,000 insane Blacks.

I see no reason to apologize for my insanity. As a matter of fact, I am proud of it. Any Black man who is not insane—the way things are—ought to have his head examined. Our madness is proof of our humaness. As you may recall from history in school, the whites made a big fuss over a relatively little thing, "taxation without representation." They regarded it as an intolerable injustice, and that let them to organize a new country based on fair play and equality—for whites only.

They rarely miss a chance to show a Black man that he cannot expect the same.

The recognition of our madness should be a great strength and comfort. Instead of just plain crazy, we should be crazy like a fox. It should release us from some of the subtle tyrannies that can combine with the less subtle to accelerate a Black's insanity until he is a shell of a man. How much of a man could we be in our own eyes if we accepted our former slave masters' notions? One of his favorite subtle tyrannies goes like this: "Sure, we know the blacks should be equal, but they just aren't ready yet."

By the clear light of my insanity I can see that white America has raised a lie into a principle. According to the basic law of white American society-of humanity-equality is the natural condition of man. No one has to pass a test, and no man-white, black, green or poka dot-is given any right to appoint himself judge of another man's "readiness."

Another of white America's subtle tyrannies, designed to keep things as they are, goest like this: "Why don't the blacks pull themselves up by their bootstraps? You know, like the Irish, Jews and other minorities did."

But what's overlooked is that the Black man doesn't have the boots, much less the boot straps, to pull himself up by. All minorities have not been tolerated alike, simply because other minorities have never been quite so visible as the Black. Most looked like the man himself, so much so that many of them have joined his conspiracy against the Blacks. It is equally difficult for Mr. Charlie to hear the false note in his harping on ungratefulness. "You complain about not having a decent place to live," he says, "So we build you a whole new neighborhood of decent places—with low rent to boot, but what happens? You break the windows, defile the rooms, and practically tear it down overnight!"

In his scorn, he never listens when you try to explain that moving Black folk from an old ghetto into a new ghetto is not facing the problem. That opening a low income rental project for Blacks still leaves them locked out from the kind of jobs, dignity and advanced education that would one day enable them to get something better through their own sweat. That is is impossible to take pride in any charity while still struggling against a system that prevents you from rising to a level where you can develop pride in yourself. The remarkable thing about white America is that it believes its own lies. And that, of course, means it would be futile and stupid of Black men to expect white America to effect changes that really mean anything. He moves only as far and only as fast as fear forces him. Somewhere, deep in his bones, he knows that if he were placed in such a rediculous position, he would fight.

I know there is only one way to put things right in this society. The question is, when will white America be man enough to face it?

I am insane, but I'm not insane to the point that I fail to realize that people are human, regardless of race, creed, color, religion or anything else.

see the injustice of stripping the minority communities of their only educational facilities, and dehumanizing minority students, educators, parents, and the remainder of their citizens. It is most difficult to comprehend how an enlightened Nation as America claims to be, can condone all white schools in every community, and shouts vociferously that black schools or brown schools must go, even though they know why they are all black or all brown, even when American laws are being disregarded by those citizens of privilege. All who are guilty of this program of perpetual educational and cultural annihilation of minorities, should do some soul searching, and read 2 Samuel 12:1-12.

"For too long, the minority groups of America have been silent, while we were being manipulated as political pawns in the hands of unscrupulous, politically, expedient minded men and women who ruthlessly go about the business of promoting cultural abandoment of everything and everybody who are different from the all-powerful majority.

"To many white Americans,

integration means that everything that is not white is worthless, of no value, therefore; it must be abandoned, discarded, changed, or converted into something which will be acceptable to the "white majority." This practice has been and still is evident in this matter of school desegregation, school integration. We know that it is the same in every other area of American life.

"To Black Americans and other minority groups, integration means to combine the cultures of all for the good of all, to make into a unified whole, and not at the expense of any one group. It means removing the myriad of restrictions, removing the unholy gentlemen's agreements, discarding the dehumanizing practices, and abandonment of unwarranted deception all which keeps us from being what God intended us to be and what we want, and must be.

"As Texans, let us join forces with citizens all over the state and work for an honest effort in school desegregation, school integration which will not favor one race over another. Promote re-evaluation of HEW.

"Let us take a stand against closing minority schools. Work for reopening of minority schools and see that all races attend. Advocate that all new schools be built in areas which make them accessible to all races.

"Work for the increased employment of more minority teachers, principals, administrators, clerks, aides, cafeteria personnel, custodians, nurses, and other staff on all levels elementary, secondary, college, and universities.
