Rapper T.I. Ordered Back To Prison For 11 More Months

ATLANTA (AP) — Federal authorities have ordered the rapper T.I. to report directly to a federal prison in Arkansas by Noember. 1, 2010 to start serving his 11-month prison sen-

U.S. Marshal Beverly Harvard on Tuesday ordered T.I., whose real name is Clifford Harris Jr., to report to the Forrest City low-security prison where he served parts of an earlier 10 month stint on federal weapons charges.

A federal judge in Atlanta

sentenced the rapper this month to serve another 11 months in prison for breaking his federal probation after he was arrested on September. 1, 2010 in Los Angeles on drug charges.

Prosecutors in Los Angeles said Monday they will not file a felony drug charge against the

T.I. also submitted to a drug test after his arrest and tested positive for opiates, according to reports, leaving the judge little choice but to lock him back up.

"I am greatly honored to be apart of HFWF. Under the guidance of Mr. Rodgers, and as a humble servant, my desire is to be an example as we, HFWF, visits the prisoners in whom are part of society," says Mr. Harris.

Washington, DC (Black-News.com) -- America's Wire today released a Q & A with Shirley J. Wilcher, director of the American Association for Affirmative Action, who maintains that the more than 90,000 employment discrimination complaints filed at the Equal **Employment Opportunity Com**mission last year clearly demonstrates that affirmative action is still needed in the United States

In an exclusive interview with Pulitzer Prize-winning journalist Kenneth J. Cooper, Ms. Wilcher criticized ill-defined diversity programs at some colleges and companies, urged federal investigations of employers that have stopped advertising jobs in minority-oriented publications and rejected proposals to limit affir-

mative action to native-born African-Americans or low-income members of minority groups.

"Clearly, there have been attacks on affirmative action so much that people are even afraid to even use the term anymore," Ms. Wilcher says. "We've even had debates within my group, the American Association for Affirmative Action - should we change the name? So far, the group view is we will not change the name because it has somehow fallen out of favor."

Adds Ms. Wilcher: "Some [employers] now are assuming that if you went to an Ivy League school and you are African-American, you were admitted through affirmative action and you're not as good. So you're still a victim if you graduated from Harvard or Penn or Yale. Somehow they can't quite believe you're good enough even though nobody [else] takes your

Furthermore, she notes that the George W. Bush administration had prohibited civil rights officials from using the term "affirmative action."

Mogul brothers offer rich advice in tough times

(CNN) - Michael and Steven Roberts are business moguls navigating the global recession, but they say the lessons they have learned could be applied to any business owner.

"We've had to do the entrepreneurial shuffle," says Michael, chairman and CEO of the Roberts Cos., based in St. Louis, Missouri.

The two African-American brothers and business leaders estimate their current holdings -from hotels to TV stations -- are worth \$1 billion. Now, in a time of economic uncertainty, their billion-dollar empire is vulnerable.

"As we began to get hit hard [by] the recession, we looked at what are the better assets for us to sell in order to create liquidity, and this year we sold our communications tower company for about \$90 million," Michael says. "Your businesses are like your children. As you grow them and mature them, at some point you may feel you have to let them go."

For Michael and Steven (who takes on president and COO duties at the company) doing well in the recession is relative. Michael says, "If you want to say we've survived and done well, yes, but had there not been a recession we probably would have done exceptionally well."

They're immensely successful, but they say for the rest of black America to follow suit people need to be exposed to

more examples of black entrepreneurial excellence.

"Black folks need legacy," Michael says. "Our own socalled black history only talks about civil rights and slavery and completely ignores capitalists who happen to be of African-American descent ... the type of history that would generate a level of confidence to our black students to think, 'Maybe I can start a business."

The brothers got their business start in a historically black neighborhood in St. Louis. There, they grew their business from a one-room office to an empire of commercial real estate, TV stations, telecommunication companies and more.

OJ Simpson's Appeal Is Denied By Nevada Supreme Court

LAS VEGAS (AP) — The Nevada Supreme Court refused Friday to overturn O.J. Simpson's armed robbery and kidnapping convictions, rejecting a claim that prospective jurors were dismissed because they were black.

Simpson attorney Yale Galanter planned to take Simpson's appeal to federal court after his 2008 conviction in the gunpoint heist in a Las Vegas hotel room was upheld.

"This is but the first step in a very long line of appeals that Mr. Simpson has before him," Galanter said.

Galanter was trying to reach Simpson in prison but had not yet spoken to the former NFL hall-of-famer, actor and advertising pitchman.

I'm extremely disappointed," added Malcolm LaVergne, another Simpson lawyer. "I thought we had a very strong appeal."

The court said all eight separate issues raised in the appeal some alleging misconduct by prosecutors and the judge were without merit.

"We felt that we were on solid legal ground and that Judge Glass made appropriate decisions during the trial," Clark County District Attorney David Roger said.

Separately, the court ordered the conviction of Simpson's codefendant Clarence "C.J." Stewart to be reversed and a new trial held. Stewart's lawyers successfully contended that Simpson's notoriety had hurt Stewart's ability to get a fair trial.

"This is no disrespect to O.J., but O.J. kind of made his own bed over the years," said attorney Brent Bryson, who represents Stewart. "My guy was kind of taken along for the ride."

Bryson planned to meet with Clark County prosecutors to determine the next legal steps while trying to get Stewart released from prison. Roger said his office would decide how to proceed in the next few weeks.

Simpson, 63, is serving nine to 33 years at a state prison in Nevada.
