TPA feel that these candidates would work best for Texas and with the African American community to

# From the Desk of Parson D.A. Smith A Disillusioned White Male

# Outreach Prayer Breakfast

The members of the Outreach Prayer Breakfast met last Saturday morning, September 3, 2010 in the home of Sister Christene Burleson, who has been sick for a while. At this report, she's feeling much better.

Thanks be to God! The morning lesson was taught by Sister Elnora Jones, our dynamic teacher. Her subject was "A Shepherd, A Pastor's Heart." I Samuel 17:37; John 10:1-18.

The question is: What is a shepherd/pastor's reaction to his sheep? A shepherd is one of the oldest professions in the world. In the 23rd Psalm, David talks about being a good shepherd, one who watches over and takes care of the sheep. A shepherd's job, often times, he would lie down with t he sheep in order to protect them from wolves and other wild beast that would destroy, scatter the sheep. If a shepherd lies down with sheep, he will smell like sheep, but it's the shepherd's duty and responsibility to watch over the sheep.

A shepherd must realize that the sheep doesn't belong to him. He just has been appointed to care for the sheep. He's just the co-shepherd. David, in the 23rd Psalm, states that the Lord is my shepherd. He leads me beside the still water. A shepherd has to feed the sheep with the true word of God. To make sure the sheep don't get distracted or scattered by every wind of doctrine. Sheep have to be led. David says, he leads me in the path of righteousness for his name sake. Sheep are fragile and defenseless, therefore, they have

# **SCHOOLS REMAIN** SEGREGATED!

BOSTON, MA - A new report published by researchers at Northeastern University ranking public, primary schools in the 100 largest U.S. metropolitan areas finds that New England has four of the top 10 most segregated areas for Hispanic students. Springfield, Mass., is ranked second in the nation behind Los Angeles.

The report shows that 73 percent of Hispanic students in Springfield would have to switch schools for enrollment to become desegregated.

The researchers also found that segregation was highest for black students, particularly in older Midwest and Northeast metropolitan areas concluding that in Chicago, Milwaukee, New York, Detroit, and Cleveland, over 80 percent of black students would have to move to another school in order for the metro area to be completely desegregated.

"This year, students returned to schools that remain largely separate and unequal," says Nancy McArdle, adjunct associate professor in the Institute on Urban Health Research at Northeastern's Bouvé College of Health Sciences. "Many people are surprised to see that Springfield, Boston, Hartford, and Providence rank in the top 10 of most segregated areas for Hispanic children."

Overall, researchers found that black and Hispanic children are disproportionately segregated and concentrated in highpoverty schools compared to white children throughout the country's major metropolitan areas.

Some of the report's key findings include:

· Enrollment is already "majority-minority" nationally but differs substantially across regions, with the West being almost two-thirds minority.

· Residential segregation and school assignment plans lead to high levels of school racial segregation, particularly for blacks.

 Metropolitan areas with the highest school poverty rates are concentrated in California and the Deep South.

• 43 percent of black and Hispanic students attend schools with poverty rates over 80 percent, compared to 4 percent of

white students. • Even within the same metro areas, black and Hispanic students attend schools with dramatically higher poverty rates

than whites or Asians. Bridgeport and Hartford have the largest disparities. Based on 2008-09 school year data from the National Center for Education Statistics, the re-

Health Research; and Theresa Osypuk, assistant professor of health sciences.

In addition, researchers point to links between racial isolation and concentrated poverty. They said children in high-poverty schools face large challenges, such as lower student graduation rates, less involved parents, and less experienced teachers.

To address inequalities, they said national policies must lead to stronger enforcement of fair housing laws, improving school and neighborhood quality, and allowing students to cross district boundaries to attend better schools.

"Schools should be designed to prepare all our students to excel," said Acevedo-García. "The fact that such gross levels of disparity continue in American public schools must not be met with apathy or acceptance but be confronted to ensure that our children and our nation can thrive in an increasingly diverse and challenging world."
