Since there are many in our community who are struggling to make ends meet, here is some important information which may be of use, especially since the holiday season is approaching. This information was made available by Lubbock City Councilman Victor Hernandez, District 1. Here it is:

211 is the telephone number people call when they don't know who to call about government and social service programs. 211 is an information and referral service (they are not a direct provider) which means they will let the caller know who to call about their needs. For example, if you dial 211 and you select option1 then you can ask about the following: 1) help

finding food or food bank vouchers; 2) medical and prescription assistance; 3) help paying a utility bill; 4) locations to find clothing; 5) affordable counseling services; 6) help with housing; 7) assistance with child care; 8) military resources; and 9) resources for the elderly.

For Thanksgiving and Christmas dial 211 for: 1) THANKSGIVING BASKETS - 211 staff locates agencies and site information where Thanksgiving baskets will be distributed to those who qualify; and 2) CHRISTMAS ASSISTANCE -211 staff locates agencies and site information where Christmas assistance is available. Assistance ranges from coat drives, holiday vouchers and toy drives.

Lubbock Man's Brother: Reverend Kenneth Earl Henry, Sr. Succumbs In Decatur, Ga.

DECATUR, GA. - Reverend Kenneth Earl Henry, Sr., of Decatur, Georgia, died Thursday, October 28, 2010, following a 4 month battle with cancer. He was surrounded by his family and loved ones at the time of his passing.

He was born in Palestine, Texas, to Ophelia G. and Reverend Enoch W. Henry, Sr., on December 27, 1932. Rev. Kenneth Henry graduated from Lin-High School, Palestine, Texas, and received degrees from Jarvis Christian College, Hawkins, Texas (BA); and Yale University, School of Divinity, New Haven, Connecticut (B. Div. and S.T.M.). He was married to Dr. Pearl L. Henry (Smith).

Rev. Henry was Associate Professor of Church History at the Interdenominational Theological Center (ITC), Atlanta, Georgia, where he taught for more than 30 years, retiring in 2003 (awarded Professor Emeritus 2010). He co-authored (along with Mark Ellingsen), a history of ITC, in a r recent publication titled, Making Black Ecumenism umenism Happen: The History of the Interdenominational Theological Center at a Paradigm for Christian Unity, Atlanta, Georgia; ITC Press, 2008. He was a founding member of the Ray of Hope Christian Church (Disciples of Christ), Decatur, Georgia. Reverend Henry was a guest lecturer and speaker at colleges, universities, churches and church conferences nationally and internation-

Reverend Henry's accomplishments and honors include: ordained as a minister in the Christian Church, Disciples of Christ (1956), first African American to serve as First Vice



Moderator of the Christian Church; active board member for several national-level church organizations (Council on Christian Unity, Division of Overseas Ministries, Campbell-Stone), inclusion in the Encyclopedia of African American Culture and History. Vol. 2, ed. Jack Salzman, David Lionel Smith, and Cornel West. 769770, New York: Simon and Schuster Macmillan, 1996; and induction into the Jarvis Christian College Hall of Fame (1996).

He is survived by Pearl Lean Henry (wife), Decatur, Georgia; Valarie Henry (daughter), Atlanta, Georgia; Kenneth E. Henry, Jr., (son), Minneapolis, Minnesota, and his sisters, Annie L. Fain (Palestine, Texas), Mattie Henry Ester (San Francisco, California); Ruthye M. Jackson, Palestine, Texas, and Bettye J. Cannon, Atlanta, Georgia; and his brother, Dr. Charles E. Henry, Lubbock, Texas.

Synopsis of LISD Board Meeting

In a called meeting of the Lubbock ISD Board of Trustees, ballots from the November 2 bond election were canvassed with a final election outcome of 16,537 voting for the proposal and 15, 828 voting against, a difference of 709 votes. The board approved orders authorizing the issuance of bonds up to \$45 million. Within certain parameters, the board gave administration the authority to issue Building America Bonds or tax-exempt bonds or a combination, as is most advantageous to the district. The Building America Bonds are part of a federal program, effective through late December, which can provide some refund of interest to the district, under certain conditions.

The former Martin and Ballenger Early Childhood Centers were sold, with Ballenger going to the South Plains Community Action Association for \$250.111

and the Martin property going to received for Stubbs Early Childfamilies served.

Advanced academics got a boost via the approval of two initiatives which will be funded, in part, by the Helen Jones Foundation and the C H Foundation. The board approved an agreement with Advanced

John T. Stevens Succumbs In Pembroke Pines, Florida November 2, 2010 After Illness

John Theodore Stevens, Sr., age 86, made his heavenly transition on Tuesday, November 2, 2010 in Pembroke Pines, Florida after a prolonged illness which he fought valiantly. Born February 2, 1924 in Detroit, Michigan to John and Helen Stevens, he was affectionately known as "J.T." to friends and colleagues throughout the nation and "Poppa" to his grand children. J.T. lived a life that captured the spirit of giving and concern for others. Although he travelled many difficult paths of segregation and discrimination, his gift of humor kept those around him jubilant and greatly helped him during his sunset years to enjoy with others the many fruits of his sacrifices and labor.

J.T.'s lifelong devotion to the Episcopal Church taught him to serve and honor his fellow man. At age ten, he was confirmed at Saint Cyprians in Detroit and served as acolyte and in other roles. His family joined Christ the Good Shepherd in Los Angeles where he worked in many capacities over 30 years including: Senior Warden, Board Member for the Good Shepherd Manor, Finance Committee, Men's Group and Verger. He attended Holy Sacrament Church in Pembroke Pines, Florida the past six years.

J.T.'s received his early education in Detroit and graduated from Northwestern High School after which he attended the Ford Motor Apprentice School, Wayne State University and the University of Detroit. He was drafted into the United States Navy as a second-class machinist mate and after honorable discharge, returned home and in 1951 was joined in holy wed lock with his sweetheart, Jimmie Rose Phillips. John and Rose were blessed with two children, John, Jr., and Sandra Jeanne. As



parents, they worked together for 48 years, until Rose's untimely death, teaching them the principles of faith, diligence and commitment to serving others. Today, John, Jr. and Sandra are ordained ministers.

J.T. embarked on a business career that would ultimately result in helping countless numbers of people and organizations. In 1954, he joined Anheuser-Busch, Inc., the world's largest brewery, as a branch salesman. He progressed from special representative to regional representative and was assigned to Los Angeles in 1971 as a district manager. In 1980, he was appointed to manager of special field markets for the Western region, the position he held at retirement in 1994.

Over his 40 year career as a salesman, business executive, and community activist, J.T. was a catalyst for progress and development of social and economic conditions, educational opportunities and political thought. J.T.'s work was not just about improving the community and selling product, but about making friends. He received many awards and honors and was particularly proud of receiving an honorary doctorate in humane letters bestowed by Shorter College in Arkansas in 1987. His

New York (CNN) - The mother of an emaciated toddler found dead in her Brooklyn, New York, home has been charged with homicide, according to the district attorney.

raise awareness about diabetes and the threat it poses to our next generation. According to the Centers for

Disease Control and Prevention (CDC), type 2 diabetes (formerly known as adult-onset diabetes) has increased among children and adolescents in the last two decades. Today, more than 180,000 persons under the age of 20 in the United States have type 2 or type 1 diabetes.

There are serious implications to this dangerous trend. The CDC reports that diabetes is the seventh-leading cause of death in the country. It can lead to serious complications such as blindness, heart and blood vessel disease, foot and leg amputations, and kidney damage which may require dialysis.

What is Diabetes?

Diabetes affects the body's ability to use blood sugar for energy. There are two primary forms that affect children: type 1 and type 2.

Type 1 diabetes develops when the body's immune system destroys pancreatic beta cells, which make the hormone insulin that regulates blood sugar. Type 2 diabetes usually begins as a disorder in which the cells do not use insulin properly. As the body's need for insulin rises, the pancreas gradually loses its ability to produce it.

Risk Factors

The first step in controlling diabetes is early diagnosis and knowing the risk factors. Children who develop type 2 diabetes are typically overweight or obese, and have a family history of the disease, according to the CDC. Most are American Indian, African American, Asian, or Hispanic/Latino.

Many people with type 2 diabetes have no obvious symptoms or may experience some of the same symptoms as type 1 such as increased thirst and hunger (especially after eating), frequent urination, unexplained weight loss, fatigue, dry mouth, blurred vision, headaches, frequent or recurring infections and cuts that are slow to heal.

To confirm if a patient has type 2 diabetes, a doctor will order a fasting plasma glucose tolerance test.

We Can Make a Difference

High-calorie, high-fat foods and lack of physical activity can literally tip the scales and push an at-risk individual into diabetes earlier in life. Consistent exercise and a healthy diet can fight obesity and may lower the risk of diabetes. As adults, we must teach children at an early age about the importance of proper nutrition and exercise, and also practice these healthy habits ourselves.



George W. Bush Says He Forgives **Kanye West**

NEW YORK - Kanye West now says he "didn't have the grounds" to call George W. Bush a racist, and the former president said Wednesday that he appreciates the rapper's regret.

Bush appeared in a live interview on the Today show, part of a book promotion tour, and also said that his conscience was clear when it came to recognizing ahead the financial problems at the end of his administration.

In his book, Decision Points. Bush wrote that it was a low point in his presidency when West declared at a fundraiser to benefit Hurricane Katrina victims that "George Bush doesn't care about black people." In an interview taped Tuesday with NBC's Matt Lauer, West said he would tell Bush that he was speaking in a moment of frustra-

"I didn't have the grounds to call him a racist," West said. "I believe that in a situation of high emotion like that we as human beings don't always choose the right words."

Shown a tape of West's remarks, Bush said he appreciated them and forgave him.

Charles Rangel guilty on 11 ethics charges

has been found guilty on 11 ethics charges, ending a twoyear investigation into his personal finances.

A special eight-member panel of the House ethics committee, after deliberating for roughly six hours, found that there was "clear and convincing evidence" that Rangel had violated House ethics on 11 of the 13 charges he faced heading into a rare public ethics trial.

The panel deadlocked on one charge, and then folded another charge into a different count.

Rep. Zoe Lofgren (D-Calif.), the chairwoman of the full ethics committee, oversaw the trial. She indicated that the votes were unanimous, meaning all four Democrats on the bipartisan panel ruled against Rangel.

Rangel, who has been defiant through the entire two year investigation, is still refusing to accept the outcome of the ethics

"How can anyone have confidence in the decision of the Ethics Subcommittee when I was deprived of due process rights, right to counsel and was not even in the room?" Rangel said in a statement. "I can only hope that the full committee will treat me more fairly, and take into account my entire 40 years





The list of punishments Rangel faces range from a "letter of reproval" all the way up to expulsion, with a formal reprimand or censure considered the most likely op-

RICHMOND, Va. - When Jessica Page visited Hampton University in March, she considered the trip a formality. She had already made up her mind to attend the school, considered by many a jewel among the nation's historically black institutions. Then she saw the campus.

The dorms weren't as sleek as she had pictured. Buildings seemed antiquated. Was this "The Real HU" she had heard about?





Actor Wesley Snipes Argues For New Trial in Florida

OCALA, Fla. (AP) - Federal prosecutors on Monday asked that Wesley Snipes' bond be revoked if a judge refuses to grant the Blade actor a new trial on tax-related charges. Snipes' defense attorney asked for the new trial during a two-hour hearing in federal court. Daniel Meachum argued that two jurors had sent him e-mails recently claiming three other jurors had determined Snipes' guilt before the 2008 trial began.

Snipes faces three years in prison for his conviction on three tax-related counts. He was acquitted of a handful of other counts.

Snipes, star of the 1992 film

White Men Can't Jump, has been free on bond while appealing the conviction. He didn't attend Monday's hearing.

Meachum said he wanted the jurors to be interviewed about whether they had perjured themselves by stating during jury selection that they didn't have preconceived opinions about the case.U.S. District Judge William Terrell Hodges didn't say when he would rule. But the judge questioned whether interviewing jurors two years after the trial would violate the "black box" of privacy in which jury deliberations occur. The judge also asked whether a new trial should also include the counts on which

"I'm not a hater," he said.
"I don't hate Kanye West. I was talking about an environment in which people were willing to say things that hurt. Nobody wants to be called a racist if in your heart you believe in equality of races."

The former president said he accepted some blame for the financial meltdown that occurred at the end of his administration, but he criticized Congress for refusing to regulate the government-controlled mortgage buyers Fannie Mae and Freddie Mac.

"My conscience is clear when it came time to recognizing an impending problem," he said. One of the most difficult things about the crisis was having to explain why the government had to bail out big financial institutions, he said.

Bush said he supported extending tax rate cuts passed during his administration, but joked that "they might have a better chance of being extended if they were called the Lauer tax cuts.

He refused to be drawn into a discussion about whether he believed an Islamic center should be built near the site of the 2001 terrorist attack in Manhattan.
