LISD Announces Policy For Providing Free & Reduced-Price Meals

The Lubbock Independent School District has announced its policy for providing free and reduced-price meals for students served under the National School Lunch Program. Each school or the central office has a copy of the policy, which may be reviewed by any interested party.

The household size and income criteria identified below will be used to determine eligibility for free and reduced-price benefits. Students from households whose income is at or below the levels shown are eligible for free or reduced-price meals. Foster children who are the legal responsibility of the state agency or court are eligible for free meal benefits regardless of the income of the household with whom they reside.

Application forms are being

distributed to all households with a letter informing household of the availability of free and reduced-price meals for their children. Applications also are available at the administration office in each school. To apply for free and reduced-price meals, households must fill out the application and return it to the school. Applications may be submitted anytime during the school year. The information households provide on the application will be used for the purpose of determining eligibility and verification of data. Applications may be verified by the school officials at any time during the school year.

For school officials to determine eligibility for free and reduced-price benefits, households receiving Supplemental Nutri-Assistance Program tion

(SNAP) benefits (formerly Food Stamps)/Temporary Assistance for Needy Families (TANF) only have to list their child's name and SNAP or TANF eligibility group number. An adult household member must sign the application.

Households that do not list a SNAP/TANF eligibility group number must list the names of all household members, the amount and source of the income received by each household member, and the last four digits of the Social Security number of the adult household member who signs the application. If the adult who signs the application does not have a Social Security number, the household member must indicate that a Social Security number is not available by writing the word "None," "No Number," or some indication that the person does not have a Social Security number. The application must be signed by an adult household member.

Under the provisions of the free and reduced-price meal policy, Free and Reduced Clerk will review applications and determine eligibility. Parents or guardians dissatisfied with the ruling of the official may wish to discuss the decision with the reviewing official on an informal basis.

From the Desk of Parson D.A. Smith **Racism Is Alive and Well In Lubbock, Texas**

Closet racism in America since the election of President Obama has opened its doors and is presently spreading like a wild fire across an open prairie in America. 

NAACP Mourns the Loss of Sarah Moore Greene

Baltimore, MD - The NAACP mourns the passing of Sarah Moore Greene, a long time activist and former member of the NAACP National Board of Directors. She was 102. A memorial service will take place today in Knoxville.

"Sarah Moore Greene acted as Knoxville's conscience for much of the twentieth century," stated NAACP Chairman Roslyn M. Brock. "When she joined the NAACP National Board of Directors she brought with her years of experience fighting injustice, and left an indelible mark on the Association. She will be truly missed by those who learned from her - her students, but also her colleagues, family and friends."

"Sarah Moore Greene was a, brave and talented civil rights icon," stated NAACP President Todd Jealous. Benjamin "Whether she was conducting a sit-in at a segregated restaurant, or sitting in the mayor's office to negotiate fair treatment, Mrs. Greene was consistently effective and persistently active. We extend our deepest sympathies to her family and friends."

Mrs. Greene, the daughter of a former slave, taught in Knoxville for years before becoming the first African American to serve on the Knoxville City School Board. She became a civil rights icon for her work leading sit-ins and fighting discrimination and segregation in her community.

Mrs. Greene served on the National Board of Directors from 1972 to 1997. She came

on the Board to fill the unexpired one year term of Arthur Spingarn. She also served as president of the Tennessee NAACP State Conference and secretary of the NAACP Knoxville Branch.



Vector Control staff have been spraying for mosquitoes for several months and have increased targeted spraying around areas where WNV-positive mosquito pools have been detected.

WNV is a disease of birds. Humans and horses get exposed to the virus when they are bitten by mosquitoes that have fed on infected birds. The infected mos-

Prevention is key in eliminating the risk of exposure to mosquitoes. Citizens can further reduce exposure with the following activities:

symptoms.

Remember the 4 Ds when enjoying outdoor activities.

Dawn and Dusk, DEET, Drain, Dress

1. Avoid being out when mosquitoes feed - usually at Dawn and Dusk.

2. Wear protective clothing. Long sleeves and pants when outdoors. (DRESS)

3. Use appropriate repellant and according to instructions on the label. Spray clothing with repellent as mosquitoes can bite through thin fabric. Apply repellent to exposed skin. CDC guidelines recommend repellents containing up to 35% DEET for adults, up to 10% DEET for children. Repellents can irritate the eyes and mouth so avoid applying to children's hands.

4. Avoid perfume - they attract mosquitoes.

Protecting the Home:

1. Install or repair window and door screens to keep mosquitoes from indoors.

2. Get rid of standing water around the house. Mosquitoes need water to breed. Empty plant saucers, pet dishes, and any containers, such as old tires that have collected water. Change the water in kiddie pools and birdbaths daily. (DRAIN)

3. Keep yard mowed. Mosquitoes hide in tall brush and grasses. 4. Residents are asked to report problem areas with mosquitos by



There is a lot of talk and even a few groups working to 'save' young men, especially young Black men. One of the reasons being that the houses for correction, or jails have an excessive number of Black men as residents. In addition, correctional institutions are being constructed every day and the fact is that these constructions outnumber those being built for learning, or schools.

There is a lot of lip service and only a few learned studies that highlight the reasons why so many young men are traveling down the wrong path. I have not done a study, but I have not done a study, but I have observed and concluded that one of the reasons that young men are having so many problems is old men. What are the old men doing to lead young men astray? There are several things that they are doing.

The first thing that old men are doing to lead young men astray is nothing. They are not around to guide the young men. Chances are that they had no guidance and do not see why it is necessary. These men are completely satisfied with who they are regardless to their status in life. A few have been successful in whatever they have done and consider themselves 'self-made men.' Ironically, they feel that young men can do the same thing that they did. They see no need to help. The second thing that is wrong with old men is that some of them feel that they are right about everything and with them, a young man either see it 'their way or the highway.' Many mothers put up with this attitude to placate their husbands at the expense of their sons. Boys have minds and should be given an opportunity to express themselves sometimes. - Parents should listen and together some decisions about what to do or not to do can be decided. The third thing about old men is that some set such poor examples of what is right and wrong in their home until a young man



can only know and understand what he sees. A man who abuses his wife and children is not the model to grow with. Young men from this kind of home have a tendency to be like their fathers. This can lead to very serious consequences, especially if they connect with a female with a very different outlook.

The fourth thing is that men with morals, standards and all of the characteristics that are desirable in men, are not doing enough to help young men to grow into model citizens. The clubs and organizations that foster ideals for young men need more male volunteers. Good men could offer a hand to young men or even one young man in the neighborhood. In large cities, men know their neighborhoods and most of the children in it. It is not difficult to observe where some help is needed and will probably be accepted. Old men: get 'in cinque' and save our young men. Our women need to nudge our men to help.


Covenant Health will host the next Diabetes Support Group meeting on Monday, September 10 at 6 p.m. at the Knipling Education Conference Center.
