



The African Methodist Episcopal Church, the oldest Black religious denomination in America, heard First Lady Michelle Obama deliver the keynote address at the 49th Session of the General Conference on June 28, 2012 at the Gaylord Opryland Resort & Convention Center in Nashville, Tennessee. President Barack Obama addressed the AME Conference in 2008 when he was a U.S. Senator.

Host Bishop of the Conference, Presiding Prelate Vashti Murphy McKenzie, stated, "We were extremely honored First Lady Michelle Obama shared her thoughts at this quadrennial meeting. Mrs. Obama's commitment to family as the Mother-In- Chief is encouraging to women around the world and her leadership in fighting childhood obesity has been embraced by many of our congregations in the United States."

Nashville is part of the 13th Episcopal District, which comprises Tennessee and Kentucky. The last time the 13th District hosted the General Conference was in 1996 in Louisville, KY., and this year is the first time the conference has been held in Nashville since the late 1800s. The mission of the AME Church is to minister to the spiritual, intellectual, physical, emotional and environmental needs of all people by spreading Christ's liberating gospel through word and deed.

Every four years the AME Church assembles for the General Conference when delegates and leaders from around the world are charged with the responsibility to discuss, debate and pass significant legislation that will impact the mission and ministry of this great Zion.

The African Methodist Episcopal Church has a membership of more than three million people worldwide with an even broader range of influence. There are approximately 7,500 churches throughout North and South America as well as Europe, Africa and India. The Church has established and supports 12 higher education institutions, helping those with diverse backgrounds to obtain formal educational opportunities. The Church was founded in 1787 in Philadelphia, PA, and in 1816 the AME Church became an official religious denomination. Bishop Gregory G.M. LISD School Board Approves \$186 Million 2012-13 Budget

At their meetingThursday morning, June 28, 2012, the Lubbock ISD Board of Trustees approved a general fund budget of \$186,493,822 for the 2012-13 fiscal year. This is a balanced budget with anticipated revenue matching the budgeted appropriations. Superintendent Karen Garza, Ph.D. attributed the ability to provide a balanced budget and a three percent pay raise for teachers, in the midst of state funding cuts, to the execution of the long-range financial plan begun two years ago. Chief Administrative Officer Berhl

Robertson, Ed.D. said the district has been able to save hundreds of thousands of dollars through more efficient use of resources, such as the consolidation of campuses and implementing tighter staffing controls. The district eliminated more than 20 percent of the central office workforce in 2011.

In other action, the board approved a resolution to sell the property and gymnasium of the former Tubbs Elementary School to the City of Lubbock for use as a park/ recreation fa-

Texas Tech Sets Summer Enrollment Record

Texas Tech University set a record for summer enrollment with 11,316 students enrolled as of the 15th day of classes (June 25), the official reporting day. This is the first time more than 11,000 students have been enrolled for a summer semester.

"The growth of our university over the last several years is a testament to the faculty, staff and students in making Texas Tech a desired choice in higher education," said Guy Bailey, Texas Tech president. "We continue to experience tremendous growth in our student population and are doing so by recruiting the highest quality student."

The university is coming off of a record spring enrollment, which reflected more than 30,000 students in a spring semester for the first time. The fall rollment total in school history. In the last decade, enrollment increased more than 25 percent.

"This record summer enrollment is vital in enhancing our influence and attaining adequate funding from the state," said Chancellor Kent Hance of the Texas Tech University System. "Our continued enrollment growth over the last several years, specifically the consecutive enrollment records set in the last three fall semesters, last four spring semesters and last two first summer semesters, is the realization of the hard work put in by our entire team."

The summer semester is the first of three-straight semesters in the legislative "base" period. Funding for higher education in fiscal years 2014 and 2015 are based on enrollments in 2012 2011 count of 32,327 students is summer and fall semesters and

It is amazing how the conversation that we have with our peers change as the years pass. Beyond the Rhetoric By Harry C. Alford When we Took **Indianapolis** Public

Schools

The Hoosier Minority Chamber of Commerce was in a groove. We defeated the discriminatory game played by United Air Lines and the State of Indiana. Our relations with Indianapolis Mayor Stephen Goldsmith were great. Contracting for Black owned businesses in the city was growing immensely. I had to think hard as to what might be the next opportunity. Then we got the news Dr. Shirl Gilbert was going to become Superintendent for Indianapolis Public Schools District. He would be the first Black school superintendent in the city.

We met with Dr. Gilbert and got the strong feeling that he was ready to make big changes. That gave us the confidence to move forward. The IPS Board was comprised of four Blacks and three whites. As we went on it was determined that since we were developing our construction contractors and recruiting major Black firms to put offices in Indianapolis, construction should be the starting point.

We met with the IPS Business Manager, Rodney Black. As we sat down, I said to Mr. Black "It is time for IPS to hire a Construction Management firm" He replied, "There are no Black Construction Management firms!" OK, it appears that we are going to have to play hardball. I suggested a follow up with me and two bona fide and qualified Black construction firms. Two weeks later we met again. I brought in Powers & Sons Construction based in Gary, Indiana. They were represented by their CEO Mamon Powers Jr. The other firm was Batteast Construction based in South Bend, Indiana and Robert Batteast Jr. represented them. These multi-generational firms were high quality but they had been blocked from doing business in Indianapolis until we started our advocacy. Mr. Black was reticent as they made their presentations. As they closed I "dropped" this on the guy: "Mr. Black you have been exclusively hiring a firm that is smaller than both of these firms and less qualified. Pluš that IPS is being charged 5% of cost which is far greater than the market rate of 3%. The Board is not going to like that." He looked enraged as I continued, "Listen here! Dr. Shirl Gilbert becomes Superintendent on February 14, 1992 and you will have given the next Construction Management contract to a Black firm. I don't care which one but they must be Black and I have just put two Black firms right before your eyes. If you don't hire a firm by that time, I will seek your firing. That's right

On the morning of February 14, I got a call from Mamon Powers. He happily said, "Your style worked! Rodney Black just called me and said be at his office by 2:00PM to sign the next Construction Management contract". Dr. Gilbert was being sworn in at 5:00PM and Mr. Black was no fool after all. We broke the "ice" and now was the time to seize the procurement giant known as Indianapolis Public Schools District.

Dr. Gilbert came in with a roar. The District just budgeted fourteen schools for major renovation and he proposed a brilliant idea. The architectural and construction management contracts for these fourteen schools would be delivered through one massive competition. The top two firms in each category would get seven schools each and all firms were invited to participate in the competition. There were 32 construction companies in the competition and half as many architectural firms. The selection committee was predominantly Black. They should be as the school district was about 75% Black - it's only fair.

For Construction Management: #1 was SR Smoot Construction, a Black owned firm out of Columbus, Ohio and #2 was Powers & Sons and For Architecture: #1 was Blackburn Architects, a Black owned firm locally based and #2 was Woods Architects, another local Black owned firm. We slam dunked them!

The White establishment, especially the White contractors, were livid. They tried to influence the School Board which had to approve the selections. Their vote went down along racial lines 4 - 3 our favor. The school headquarters was standing room only when the final vote made by Superintendent Gilbert was to be announced. Dr. Gilbert looked at everyone in the room and finally spoke, "This school system has been conducting business for over 80 years and has never had a construction management firm or architectural firm manage a complete project. I stand here today to say that this practice has come to an end. I approve the recommended choices." Victory was ours! We now had a Black school district acting responsibly.



Justices rule for underage killers sentenced to life without parole



The Supreme Court ruled Monday, June 24, 2012, against giving sentences of life without parole to two convicted underage killers.

Washington (CNN) -- The Supreme Court ruled Monday, June 2, 2012, that two men convicted of killings committed when they were 14 cannot be sentenced to life in prison without at least the possibility of parole.

The 5-4 ruling is a victory for defenders of juvenile offenders, affirming recent high court rulings against harsh criminal sentences.

Justice Elena Kagan said it would be wrong for states to ignore the chance that these nowadult inmates may someday be rehabilitated

"The mandatory sentencing schemes before us violate this

asked Alito during oral arguments in March.

He wrote the tough dissenting opinion, supported by Chief Justice John Roberts, and Justices Antonin Scalia and Clarence Thomas.

"When the majority of this court countermands that democratic decision (by state legislatures), what the majority is saying is that members of society must be exposed to the risk that these convicted murders, if released from custody, will murder again," said Alito, who delivered his dissent from the bench, a rare privilege typically granted in only the most contentious of cases.

In Kuntrell Jackson's case, he was outside acting as a lookout when the Chickasaw County, Arkansas, robbery took place. It was a 15-year-old boy who shot the female clerk when she refused to turn over money. The actual shooter later pleaded guilty and was sentenced to life with the possibility of parole.

Stevenson said there was a real question whether Jackson had an "intent to kill" during the botched robbery, perhaps allowing for a lesser sentence.

But Arkansas Assistant Attorney General Kent Holt said the sentence of life without parole was still appropriate, arguing the defendant could have received the death penalty if he had been an adult at the time of the crime. "A legislative judgment has been made with regard to drawing a baseline for all murderers, whether they are juvenile murderers, whether they are getaway drivers," Holt said. "And when you counsel or aid or do anything that gets you liability for being a capital murderer, then that is the minimum sentence" -- life without parole, with no exceptions.

Supreme Court Upholds President Obama's Healthcare Mandate

Washington, DC -- The Supreme Court on Thursday upheld the vast majority of President Barack Obama's historic health care overhaul, including the hotly debated core requirement that virtually all Americans have health insurance.

The 5-4 decision means the huge overhaul, still taking effect, will proceed and pick up momentum over the next several years, affecting the way that countless Americans receive and pay for their personal medical care.

The ruling hands Obama a campaign-season victory in rejecting arguments that Congress went too far in approving the plan. However, Republicans quickly indicated they will try to use the decision to rally their supporters against what they call "Obamacare."

Stocks of hospital companies rose sharply, and insurance companies fell immediately after the decision was announced that Americans must carry health insurance or pay a penalty.

Breaking with the court's other conservative justices, Chief Justice John Roberts announced the judgment that allows the law to go forward with its aim of covering more than 30 million uninsured Americans.

The justices rejected two of the administration's three arguments in support of the insurance requirement. But the court said the mandate can be construed as a tax. "Because the Constitution permits such a tax, it is not our role to forbid it, or to pass upon its wisdom or fairness," Roberts said. The court found problems with the law's expansion of Medicaid, but even there said the expansion could proceed as

long as the federal government does not threaten to withhold states' entire Medicaid allotment if they don't take part in the law's extension.

The court's four liberal justices, Stephen Breyer, Ruth Bader Ginsburg, Elena Kagan and Sonia Sotomayor, joined Roberts in the outcome.

Justices Samuel Alito, Anthony Kennedy, Antonin Scalia and Clarence Thomas dissented.

"The act before us here exceeds federal power both in mandating the 'purchase of health insurance and in denying non-consenting states all Medicaid funding," the dissenters said in a joint statement.

Kennedy summarized the dissent in court. "In our view, the act before us is invalid in its entirety," he said.

The legislation passed Congress in early 2010 after a monumental struggle in which all Republicans voted against it. House Republicans announced in advance of the ruling they would vote to wipe out whatever was left standing by the justices,

and GOP presidential candidate Mitt Romney has joined in calls for its complete repeal.

ney will use it to continue campaigning against "Obamacare" and attacking the president's signature health care program as a tax increase.

"Obama might have his law, but the GOP has a cause," said veteran campaign adviser Terry Holt. "This promises to galvanize Republican support around a repeal of what could well be called the largest tax increase in American history."

Democrats said Romney, who backed an individual health insurance mandate when he was Massachusetts governor, will have a hard time exploiting the ruling.

"Mitt Romney is the intellectual godfather of Obamacare," said Democratic consultant Jim Manley. "The bigger issue is the rising cost of health care, and this bill is designed to deal with it."

Justice Ginsburg said the court should have upheld the entire law as written without forcing any changes in the Medicaid provision. She said Congress' constitutional authority to regulate interstate commerce supports the individual mandate. She warned that the legal reasoning, even though the law was upheld, could cause trouble in future cases.

"So in the end, the Affordable Health Care Act survives largely unscathed. But the court's commerce clause and spending clause jurisprudence has been set awry. My expectation is that the setbacks will be temporary blips, not permanent obstruc-

principle of proportionality, and so violate the Eighth Amendment's ban on cruel and unusual punishment," Kagan said.

Justices mull whether life without parole appropriate for underage killers

The high court in 2005 banned the death penalty for those under 18 who commit aggravated murder. Then, five years later, the justices said juveniles found guilty of non-homicides could not receive life without parole.

The spotlight has now turned on the youngest of killers and the question of whether a national consensus has developed to treat them differently regarding a lifetime of incarceration.

The separate appeals involved an Alabama boy who, with an accomplice, robbed a neighbor and then beat the man to death and set his house on fire; and an Arkansas youth who was part of a group of teens who robbed a video store where the clerk was blasted to death with a shotgun. Both defendants are now adults serving their sentences.

Both were tried and convicted as adults and received the minimum sentences allowed under state law for felony capital murder.

About 2,500 prisoners are serving life sentences without parole for crimes committed as juveniles, at least 79 of whom were 14 years or younger at the time, according to the Equal Justice Initiative, which is representing the two men before the high court.

In his argument to the court, Attorney Bryan Stevenson had urged the justices not to "give up" on child offenders, who he said are fundamentally different from adults. He said that while they must be held accountable for their actions, youths are also works in progress, emotionally and developmentally.

Stevenson said firmly that all those under 18 at the time of their crimes deserve the chance for parole someday. He said the often-terrible facts of a murder can overwhelm any mitigating factors like a defendant's age, especially for jurors who may be unaware that a young person's brain and self-control are often not fully developed, and their living environment can play a role as well. "You would say that a person of 17 years and 11 months who commits the worst possible string of offenses -- and demonstrates great maturity -- still cannot be sentenced to life imprisonment without parole?"

Alabama Solicitor General John Neiman told the court that states deserve discretion to set punishments for the worst of offenders, even teenagers.

Complicating matters, several justices at argument noted differences between the two cases before them. Neiman said the murder committed by Evan Miller in Alabama was especially "gruesome." The boy and his accomplice had smoked marijuana with the victim in his trailer. The 52-year-old man burned to death after the mobile home was set ablaze.

The cases are Miller v. Alabama-(10-9646) and Jackson v. Hobbs (10-9647).

NAACP Statement on Supreme Court Ruling on Life Without **Parole for Juvenile Offenders**

The NAACP released the following statement on today's decision, June 24, 2012, by the Supreme Court of the United States to ban mandatory sentences of life in prison without parole for juveniles:

"This is a big step forward for the American justice system," stated Benjamin Todd Jealous, President and CEO of the NAACP. "When it comes to juveniles, life sentences without possibility of parole indeed constitute cruel and unusual punishment. Judicial discretion is extremely important in these cases, but the NAACP will continue to fight until the sentences are banned outright."

Today the high court struck down laws in 29 states that mandated a life term for murderers, including those under age 18. While the Court did not categorically ban juvenile life without parole in all circumstances, Justice Kagan wrote for the majority that, "given all that we have said in Roper, Graham, and this decision about children's diminished culpability, and heightened capacity for change, we think appropriate occasions for sen- ing equal opportunity in the pubtencing juveniles to this harshest lic and private sectors possible penalty will be uncom-

mon." Racial disparities remain extremely pronounced in the Juvenile Justice system. African American children are 10 times more likely than their white peers to be sentenced to life in prison without the possibility of parole

"We remain concerned that racial disparities will continue to be evident as courts exercise discretion in making this assessment," stated Jealous. "If past sentencing is any guide, this most severe sentence may remain all too common for children of color."

In 2005, the Court banned the death penalty for juveniles who commit aggravated murder. Then, in 2010, the justices held that juveniles found guilty of non-homicides could not receive life without parole.

Denver, CO -- A 21-yearold man was arrested for investigation of first-degree murder, after a veteran Denver policewoman who was raising her 12year-old daughter alone was shot and killed during a free jazz festival, police said Monday.

Police Chief Robert White said investigators were not sure if Officer Celena Hollis was the target of the shooting when she answered a call about a disturbance in the park.


