16-pound newborn hits it big with birth record

He's the largest baby born at Longview hospital, and may be the biggest ever born in Texas.

LONGVIEW — The latest addition to Michael Brown and Janet Johnson's family is too big for his britches - literally.

When the Longview woman went into Good Shepherd Medical Center for a scheduled Cesarean section on Friday morning, she knew she was going to give birth to a big baby.

She just had no idea how big. When her son, JaMichael Brown, was born at 9:05 a.m., he weighed 16 pounds, 1 ounce — about 4 pounds more than doctors predicted.

The baby is the largest born at Good Shepherd Medical Center. Hospital officials believe he may be the largest baby ever born in Texas, but it will take several days of combing state records to make that announcement offi-

"We're just amazed," Johnson said. "I can't believe he's that big. A lot of the baby clothes we bought for him will have to be returned. They're already too small for him to wear."

The baby also emerged with a full head of hair, and the newborn nursery didn't have diapers big enough to fit him, she said.

JaMichael's father said the nurses told him the baby is a size most infants don't attain until they are between 3 and 6 months

JaMichael is Johnson's fourth child. He joins older sisters who are 18, 16 and 10.

Johnson had gestational diabetes during her pregnancy, and JaMichael is spending his first few days of life in the neonatal intensive care unit in order to regulate his blood sugar. The baby otherwise seems to be basically healthy, she said.

Deb Miller, a registered nurse working in the maternal care unit, said JaMichael is by far the biggest baby she's seen in her seven years at Good Shepherd Medical Center.

"I'm happy," Johnson said. "We'll be here for a few more days, and then I'm looking forward to bringing JaMichael home and just loving on him."





"A Colored People In The Woodpile" (This is a Re-Run)

Walter Williams, a professor of economics at George Mason University and whose writing is distributed by Creators Syndicate and who is one who sees modern blacks through the eyes of white people and in my reading of his many writing is what many blacks call a WFN.

Williams' column was in the Other Views of the AJ this past week. The title of his story was "Silence about black racism betrays civil rights efforts."

It's hard to digest the writing of Williams for he has constantly portrayed himself as an "Uncle Tom" who not only could, but would eat ten miles of Mr. Charlie's digested racist rubbish while drinking from his discriminatory fountain of injustice for poor ignorant white people and blacks who were only trying to achieve and retain a piece of the American pie.

Williams' wrote that things have changed from when he was a boy and evil upon white people today are mostly committed by black people rather than the other way around. It takes some large "soup coolers" to say some "you know what kind of stuff" like that in his column.

Williams said: "Today ...most racist assaults are committed by blacks. What's worse is there are blacks, still alive, who lived through the times of lynching, Jim Crow laws and open racism who remain silent in the face of it. (That a lie!)

Williams goes on to say that last year, four black Skidmore College students yelled racial slurs while they beat up a white man because he was dining with a black man. Skidmore College's first response was to offer counseling to one of the black students charged with the crime.

According to interviews and court records obtained and reported by Denver ABC affiliate (Dec. 4, 2009), black gangs roamed downtown Denver verbally venting their hatred for white victims before assaulting and robbing them during a four-month crime wave. (He forgot to mention how white racist Republicans and Tea Partiers treated President Barack Obama in Colorado).

This "Tom" like actor goes on to say that earlier this year, two black girls beat a white girl at a McDonald's, and the victim suffered a seizure. And he noted that Chicago Mayor Rahm Emanuel ordered an emergency shutdown of the beaches in Chicago because mobs of blacks were terrorizing families. (However he failed to mention the white Chicago mobster who was living very well in California who had killed a great number of people and had something near a half of a million dollars in cash when arrested by the FBI a few days ago.)

Williams also noted that racist attacks by blacks on other races were not just limited to whites. He noted that in San Francisco, five blacks beat an 83-year-old Chinese man to prior to publication day.

death. They threw a 57-year-old woman off a train platform.

Williams goes on and on pointing out how black teens beat other races. Then he points the blame finger by saying: "These racist attacks can, at least in part be attributed to the black elite, who have a vested interest in racial paranoia." If this was not insulting enough to the black community, this piece of barnyard ground cover goes on to say that the elite includes "a president" who has spent years aligned with people who have promoted racial grievance and polarization and appointed an attorney general who's accused us (who in the hello is the US) of being "a nation of cowards" on matters of race and has refused to prosecute black thugs who gathered at a Philadelphia voting site in blatant violation of federal voter intimidation laws.

One might ask: "Who appointed this COON like Black actor by giving him some money to be the Uncle Tom critic of Black America? He definitely appears to be the (???) well colored boy in the woodpile.







President Obama Raises More Than \$86 Million For Re-Election Campaign

WASHINGTON - President Barack Obama collected \$86 million combined for his reelection campaign and the Democratic party during the past three months, giving him a large fundraising advantage over the Republican field seeking to challenge him in 2012.

Obama campaign manager posted early Wednesday that it raised more than \$47 million and the Democratic National Committee brought in more than \$38 million through the end of June, building a foundation for advertising and get-out-the-vote efforts in next year's election. Obama's team had set a public goal of \$60 million combined

As expected, the fundraising totals outpace Republicans, who have collectively raised about \$35 million so far, although some candidates have yet to release their results. At the same time in 2007, 10 GOP presidential hopefuls had raised more than \$118 million, according to the Center for Responsive Poli-

Former Massachusetts Gov. Mitt Romney leads the GOP field in fundraising, pulling in more than \$18 million during the past three months. An independent fundraising group supporting Romney's presidential bid has raised \$12 million this

Following Romney, former Minnesota Gov. Tim Pawlenty collected \$4.2 million and former Utah Gov. Jon Huntsman brought in \$4.1 million, with about half coming from his personal wealth. Minnesota Rep. Michele Bachmann, a tea party favorite, has not yet released her fundraising totals.

Obama's advisers have told donors privately they hope to



match or exceed the \$750 million they raised in 2008, anticipating a stiff challenge from Republicans amid rocky economic conditions. Obama has acknowledged he will need to re-energize supporters who were inspired by his message of hope and change three years ago but may be discouraged by the economy and the pace of change.

"We have reason to be proud of what we've built so far but it's going to get tougher from here," Messina said in the video, estimating outside spending by GOP groups could exceed \$500

Messina said more than 550,000 people donated money to the campaign during the first three months, a large increase from about 180,000 donors to Obama during the first half of 2007. The campaign has actively courted small donors, hoping to show that the president is in a good position for the 2012 campaign and capable of generating broad financial support.

About 98 percent of the donors gave \$250 or less. Messina said the average donation was about \$69.

Obama broke his previous fundraising record of \$33.1 mil-

lion during the same quarter in 2007 and surpassed finance efforts by his predecessors. President George W. Bush launched his re-election bid in mid-May 2003 and raised \$34.4 million through June 2003. In his first complete fundraising quarter, Bush raised another \$50 million, bringing his total to nearly \$85 million by the end of September 2003.

Obama's team had said it hoped to collect a combined \$60 million for the campaign and the DNC for the three-month fundraising period that ended June 30. Obama opened his reelection campaign in early April and his advisers said the initial fundraising efforts were crucial to building a strong campaign.

Messina said the money is building the campaign's ground game more than a year before Election Day, saying the campaign has "more grassroots support at this point in the process than any campaign in political history." Obama's team has opened 60 field offices across the nation and held more than 31,000 face-to-face meetings with volunteers.

Campaign finance reports are due Friday, and Messina estimated the Obama campaign's report would exceed 15,000

Obama has held dozens of fundraisers for his campaign and the Obama Victory Fund, a joint fundraising account set up by the DNC and Obama's campaign. At Victory Fund events, the first \$5,000 of a donor's contribution goes to the presidential campaign and the remainder goes to the DNC, up to a maximum of \$30,800 a year.

Their bottom lines for me, then, became simple. Get rid of me. And they're not finished."

Throughout the book, he levels criticism at the aggressive Wayne County prosecutor, Kym Worthy, who charged him as well as two judges who heard the case as it went through the court system.

Kilpatrick is open, however, about the affair with one-time chief of staff Christine Beatty and falsehoods he told, even in front of the Wayne County Circuit Court judge who would decide his future and his freedom.

"I stood before Judge David Groner, who requested my plea. 'I lied under oath,' I said, 'with the intent to mislead the court and jury and to impede and obstruct the fair administration of justice," Kilpatrick writes. "For the record, I lied when I made that statement. The real reason I lied under oath was because l didn't want my wife to know l cheated. But be clear. There was absolutely no justice to obstruct in the whistle-blowers' suit. The case was manufactured. I was just cornered."

Kilpatrick, 41, eventually pleaded guilty to obstruction of justice and no contest to assault and served time in the county jail. Groner sent him to state prison last year for not adhering to the terms of his probation, which called for the truthful disclosure of his finances. The former mayor is set to be paroled within weeks from state prison for violating probation in the 2008 criminal case.

The book, co-written by Khary Turner, is set to be released Aug. 1. Groner has ruled that any book profits intended for Kilpatrick, his relatives or other agents must first be applied toward \$860,000 in unpaid restitu-

The board ratified the administration's selection of two current employees as new principals to fill vacancies created by the retirement of the current principals. Lori Andrus, now an assistant principal at Estacado High School, will be the new principal at Parkway Elementary. Ruby Jackson will be the principal at Hodges Elementary where she currently serves as the assistant principal.

Amador Vasquez was introduced as the new mathematics coordinator, replacing Pam Summers who also retired at the end of the school year. Vasquez is currently a math education specialist at Region 1 Education Service Center in Edinburg and previously served as secondary math coordinator for La Feria Independent School District. He has taught all high school math courses and has extensive experience with curriculum development, grant writing, data analysis, and integration of instructional technology in the mathematics classroom. A West Texas native, Vasquez grew up in Southland and earned a degree in mathematics from Texas Tech University.

Utilizing grant funds set aside for that purpose, trustees approved the purchase of programspecific computer hardware and software items and curriculum materials. Also approved was the purchase of four portable buildings, each containing two classrooms, to expand classroom space and fulfill the district's long-range plan of phasing out some of the very old and less efficient portable buildings.

Also approved were the demolition of the former Stubbs Early Childhood Center, which was closed last year, and the building east of Lubbock High School which was once Calvary Baptist Church. A plumbing company has occupied the church building for many years and it had fallen into extreme disrepair. There is no specific timeline for demolition. That will be determined once the contractor is selected. Superintendent Karen Garza, Ph.D. said, "This really is a safety issue for our students. By removing the dilapidated building and expanding the Lubbock High cafeteria to the east, we will be able to accommodate a closed campus at


