# Ivy Taylor named San Antonio Mayor

"A newspaper for 21st Century representing the Black Community's Ideas and Ideals since 1977"

San Antonio, Texas -- The City Council appointed Councilwoman Ivy Taylor, Tuesday, July 22, 2014, to become San Antonio's next mayor.

She did not win a majority of the council vote, as her colleagues split 5-3 over her and Councilman Ray Lopez.

Lopez then withdrew from consideration, saying that it was important for the city to move forward.

Mayor Julián Castro then submitted his official letter of resignation, reading it aloud in council chambers.

He then congratulated Taylor for becoming the city's new mayor. She is the first African-American woman to hold the seat.

She pledged to "work with everyone" to make San Antonio a great city. She thanked her family from traveling to San Antonio for Tuesday's meeting and her husband and daughter for their support.

When Taylor began her speech at the beginning of the process, she ran down a list of accomplishments and said she would like to serve in the interim role to continue moving Castro's vision forward. Taylor mentioned the streetcar, balancing the city budget, working toward a resolution to police and fire health benefits, and rebuilding relationships with the lesbian, gay, bisexual and transgender community following her vote against the revised non-discrimination ordinance passed last September.

Members of the community, including those from the LGBT community, spoke at the special council meeting before votes were cast, telling the council who their interim mayor of choice is and why. From the podium, Daniel Graney told the council that he feels passionate

one in the city should be treated equally and fairly.

"We need a face that is a welcoming one that embraces fairness and equality," Graney said. "I therefore respectfully implore you to appoint an interim mayor who championed and voted for including LGBT protections in the NDO last year and is committed to furthering its implementation expansion."

Following the council meeting, Taylor answered questions about repairing those relationships.

"I've always been committed to working with everyone in our community, even though we may not always agree on every issue," said Taylor. "I've talked with them about some of the things they'd like to see moving forward as far as implementation and I pledged that I'd be willing to work on that."

Many in the LGBT community lobbied actively against Taylor because she voted against the nondiscrimination ordinance and because of remarks she made prior to her vote against the ordinance. (See related links below.) However, she did have a handful of LGBT supporters who felt she should not be denied the position because of that

In remarks posted on Facebook, Chad Reumann, a governor for the local chapter of the Human Rights Campaign said, "I hope we as a community can regroup and now focus on how we can work with Mayor Taylor. I had hoped for something else. Yet I know now we must try and work together."

She's the first Black female elected as Mayor of San Antonio, Texas!

# Wendy Davis, Battleground Texas and Texas Democratic Party Launch Unprecedented Coordinated Voter Protection Program

Focus on Voter Registration, Education and Early Voting; will Deploy Lawyers and Experts to Fight Unfair or Discriminatory Practices on and Before Election Day

FORT WORTH - The Wendy R. Davis for Governor Campaign, Battleground Texas and the Texas Democratic Party launched an unprecedented statewide voter protection program today.

"I've spent my career fighting for hardworking Texans and against any effort to silence their voices in the voting booth," said Senator Wendy Davis on a call with volunteers this morning. "That's why we are fighting to make sure every eligible voter can exercise their right to vote, and we are working together to make sure every vote is counted."

The program will span across Texas, and is the first time democratic groups have run a statewide voter protection program this large or this coordinated in Texas. It will have four components:


\* Voter registration: The program will focus on registering as many eligible voters as possible before the October deadline and has already deployed 8,000+ deputized volunteers to register voters in counties throughout

\* Voter education: Through coordinated political, communi-

cations, digital and field programs, the program will educate voters on election rules, logistics, voter ID, and will work with officials to help ensure voters get acceptable ID by election

\* Promoting early voting: The program will educate eligible

voters on how to cast their ballots early by mail - which they can do beginning in early September. In October, the program will also begin to monitor the inperson early voting period, run a state-wide election protection hotline, and will place well-to Continue on Page 7



# How People of Color Can Improve Their **End-of-Life Healthcare**

The day my father died from prostate cancer — Jan 11, 2011 — is the day I decided that no family should ever experience the same pain. That day everything changed for me. I had worked for seven years at an organization whose sole focus is end-of-life care, yet I had not had even one conversation with my father about his end-of-life wishes. It was truly a wake-up call, an eye-opening experience I hope I never have to repeat.

Imagine sitting in a hospital room with your unresponsive father, your five siblings on one side of the bed, and his new wife and her five children on the other side. People on both sides thought they were best equipped to speak on my father's behalf. The sad reality is that none of us — not one of the 12 people in that room - had a clue about what he wanted. He had no advance directive, had never had a serious conversation about his end-of-life wishes, not even with me, an end-of-life care advocate.

Since that fateful day threeand-a-half years ago, I have learned that horrible situations at the end of life are far too common in this country, especially in the African-American community.

Unlike many of the other disparities that impact the African-American community, this is one we have more control over. It starts with having a conversation. Unfortunately too many of us are not having that discussion. In fact, 20 percent of African-Americans have not talked to anyone about their endof-life care wishes, according to research conducted in 2003 by

the Duke Divinity School and the National Hospice and Pallia-Care Organization (NHPCO).

African Americans underuse palliative and hospice care. They make up only eight percent of patients who participate in hospice care. At the same time, white Americans make up about 83 percent. Far too often, people associate hospice with "giving up" and "the place one goes to die." That is just not the case; hospice actually fosters good end-of-life care, and the earlier the patient accesses these services, the better off he or she is. Palliative and hospice care are one of the best ways to ensure a good death, whatever that may mean to each individual.

Africa Americans' end-of-life choicesc are also influenced by the importance of spirituality. As the New Living Translation of the Bible (Proverbs 27:12) says, "A prudent person foresees danger and takes precautions. The simpleton goes blindly on and suffers the consequences." Being prepared is not disrespectful to one's religious faith and personal beliefs.

At the end of life, African Americans are no different than anyone else in this country. We die too. We also want autonomy, choice and peaceful life endings We must step up as a community and start thinking and talking about end-of-life decisions, because without it we suffer.

Death is inevitable, so whether you want every treatment option available or none at all, it's im-







# Robert Newhouse, Dallas Cowboys Rusher in 1972-83, Dies at 64

Robert Newhouse, a running back who played in three Super Bowls with the Dallas Cowboys and threw a touchdown pass to help win one of them, died at the Mayo Clinic in Rochester, Minnesota. He was 64.

The Cowboys said on their website that Newhouse died two days ago of complications caused by heart disease. He had been at the Mayo Clinic since November.

Newhouse, who spent his entire 12-year National Football League playing career with the Cowboys coached by Tom Landry, worked for the team -mostly as director of alumni relations and player programs -from his retirement in 1984 until

He ran for a career-high 930 yards in 1975 and had six touchdowns in 1980, though by that time he had been supplanted as Dallas' top rusher by Tony Dorsett.

In the 1978 Super Bowl



against Denver, the Cowboys were leading 20-10 with seven minutes remaining in the game when Newhouse took a pitch and threw a 29-yard scoring pass to Golden Richards that completed a 27-10 Dallas win. He was the first running back to throw a touchdown pass in the Super Bowl.

Newhouse's survivors include his wife, Nancy, and four children, the Cowboys said.



# Fox Panel Trashes Republicans On Border Crisis

WASHINGTON -- A Fox panel on Sunday, July 27, 2014, strongly criticized Republicans for resisting immigration reform and calling to quickly deport thousands of children who are currently in U.S. custody after fleeing violence in Central America.

During a segment on "Fox News Sunday," host Chris Wallace pressed the panel, made up of USA Today columnist Kirsten Powers, Conservative Washington Post columnist George Will and Fox News' Brit Hume and Juan Williams, about who should take the blame for the current border crisis and what could be done to resolve it. Powers said that Obama had changed his position on whether a 2008 law offering immigration hearings to undocumented children should be altered, but she had scathing words for the GOP.

"The Republicans don't really seem to want to work on immigration until it comes to deporting children," Powers said. "This is the only thing they really have been willing to do at this point, is just to say, 'We'll pass the bill to deport children, but we won't talk about any sort of broader comprehensive immigration issue.

Will agreed.

"I think Kirsten is largely right.

My view is that we have to say to the children, 'Welcome to America. You're going to go to school and get a job and become Americans.' We have 3,141 counties in this country. That would be 20 per county. The idea that we can't assimilate these 8-year-old criminals with their teddy bears is preposterous.

"These young people are a social group of people who are being threatened by the gangs and whose lives are at stake," Fox contributor Juan Williams added. "Even young evangelicals this week, in writing to Congress, said, 'You must consider these children as children and give them due process."

# Black GOP Staffer Fired After Complaining About White Privilege On Facebook



Some things are common knowledge. The sky is mostly blue if you don't live in Los Angeles. Water is wet if you can still find it in Texas. White people — particularly those who espouse conservative beliefs — don't want to be reminded of their White privilege.

I assumed most people who reach a certain arc of adulthood know to carry these truths with them, but in the case Regina V. Ross Roundtree (pictured), that last fun fact is a newly lesson learned following her abrupt firing from the Penny Bacchiochi (pictured above) for lieutenant governor campaign. Roundtree, a paid consultant, was let go of her duties once word got out that she wrote a Facebook post complaining about her employer's opponent, Heather Bond Somers, making jabs about her and essentially exploiting the perks of White privilege.

The post — now deleted —

featured Roundtree claiming:

"People think what they think,
but help the party out and don't
plaster your complete sense of
privilege. This is an example of
what is sometimes phrased as
'White privilege.' The way
Heather talks. The arrogance
and belittlement of Penny's and
her family's feelings or any
other person who has experi-

enced racism. Our feelings or the fact that we may say something is an embarrassment to the party."

Somers' campaign manager, Jon Conradi, responded in a statement:

"The Heather Somers campaign calls on Bacchiochi to immediately disavow herself of these divisive comments which have no place in the Republican Party or in public discourse."

Well, I'm not about to get axed for talking about White privilege, so let's just keep this party going.

The Somers campaign's response is - for lack of better phrase — typical "White people s\*\*t." As in, the Somers campaign can release campaign ads that speak to certain issues that stoke the fears of GOP primary voters - who love Black people about as much as David Duke wants to call Fantasia his soul mate - and dismiss Bacchiochi's discussion of the problems that come with having an interracial family -Bacchiochi's husband is Black. But don't you dare talk about racism and White privilege. No, no, no, that's divisive and Michael Jackson already told us that it don't matter if you Black or White so stop bringing up old stuff.

In an editorial, the New Haven

Register sided with the nowfired Black GOP staffer, writing:

From what we've seen of the nasty three-way Republican race for lieutenant governor so far, Roundtree's comments are both accurate and well within the bounds of discussing the issue of race and the job for which she was hired — outreach to people of color who feel the Republican party is clueless about their experiences and needs.

Somers' reaction to the Facebook post on Thursday further proved Roundtree's point. And the fact Bacchiochi felt she needed to quickly fire her over it shows that Connecticut Republicans remain clueless about conversations of race.

Mind you, Roundtree was hired to help Republicans reach out to minority voters in Connecticut's cities. We can now confirm how that is of little importance to the Republican Party of Connecticut.

Worse, Somers reportedly complained to the New Haven Register in an editorial board meeting about forcing the integration of public schools. Why? Well, she "wished students in her town would just check 'other' when identifying race so it wouldn't be an issue." It's always White people telling people of color to get over a burden

# John Wiley Price pleads 'not guilty' while shackled before judge.



**DALLAS** — Dallas County Commissioner John Wiley Price and three associates have pleaded not guilty after being arrested by FBI agents Friday, July 25, 2014, ushering in a new chapter in what is arguably the most high-profile public corruption investigation in Dallas his-

Sarah Saldaña, U.S. Attorney for the Northern District of Texas, announced the specific charges at an 11 a.m. news conference. She said for more than a decade, Price sold the power of his office in "a shocking betrayal of public trust."

A 106-page federal corruption indictment, filed under seal on July 23, is now public. It outlines a million dollar web of mail fraud, tax fraud, bribery and other malfeasance allegedly led by Price, who faces up to 30 years in prison if convicted.

Also charged is Price's top assistant, Dapheny Fain, who surrendered to the FBI Friday morning, according to her attorney Tom Mills.

Political consultant Kathy Nealy, a close Price associate, is also a defendant in the case. Her attorney could not be reached. Nealy was expected to surrender Friday.

A fourth defendant, Christian Lloyd Campbell, is also charged. According to the indictment, he is a consultant who worked with

Price was arrested at an office building north of downtown Dallas around 8 a.m.; it's unclear what he was doing there.

Price, Nealy, Fain and Campbell made their initial appearances before U.S. Magistrate Judge Paul Stickney Friday afternoon at the federal courthouse in downtown Dallas.

They came into the courtroom wearing handcuffs and shackles. All four of them pleaded "Not Guilty." Price was dressed in business attire when he confidently and adamantly claimed his innocence.

Nealy and Fain are both filing paperwork to have the government help them pay for their legal counsel.

The four were then expected to be released pending trial, which may not occur for a year or more.

In the indictment, the government says Price and his co-conspirators accepted \$950,000 in bribes in exchange for Price voting favorably for companies bidding for get county contracts.

According to the government,

here's how the scheme worked Nealy, a political consultant, worked on behalf of large companies seeking multi-million dollar contracts with Dallas County.

Nealy told those companies she could get them favorable votes at Commissioners Court. And that's exactly what they got from Price.

The government alleges that in exchange for bribes paid through Nealy, Price voted in favor of her clients. He also allegedly provided the businesses with confidential information that other bidders did not get.

In exchange for the votes, the government says Nealy funneled bribes to Price, many paid just before or after key votes. The indictment says Nealy also provided Price with cars, real estate and income from rental proper-

According to the government, these were large county contracts, with one set of companies getting up to \$17.5 million in county business.

The government says Price, Nealy, and Price assistant Daphney Fain used 31 bank accounts in an effort to move money around in way that would not be





# **NAACP Statement on July Unemployment Numbers**

WASHINGTON, D.C. -- A variety of occupational sectors and demographic classifications From Dedrick Asante-Muhammad, Sr. Director of NAACP Economic Department:

"For the first time since 1997, the economy has added 200,000 or more jobs for six straight months. The labor market is slowly recovering from the depths of the "Great Recession." The unemployment rate within the African American community is 11.4 percent, down from the 13.5 percent in June of 2013. The 2 to 1 employment disparity between African Americans and whites is not closing and appears to be a permanent part of the economy. This disparity, as well as the disparity found in Latino unemployment, must be addressed. Stronger and better quality job creation, particularly in communities that are suffering persistently high unemployment levels, is essential before we can be on a sustainable path to economic recovery."

#### Highlights:

•Overall, black unemployment was up again this month to 11.4% after a sharp drop in last month's report, however it is still far lower than the 13.5% of June of last year.

·Black adult unemployment remains more than double white unemployment (5.3%).

•Black teen unemployment rose to 33.9%, this is less than twice as high as white teen unemployment at 18.3. White teens are far more likely to be working or looking for work, with an employment to population ratio of 29.9%. On the other hand, black teen employment to population ratio continues to decline. This month just 16.5% of black teens were working or looking for

work. New data has cast doubt on the assertion that these teens are seeking refuge in school, with both the Wall Street Journal and the Economic Policy Institute noting that many black youths are neither in the workforce nor in school.

•With 209,000 jobs added this month the gains were in line with average over the past year. However, revisions to the already good numbers for last month added about 15,000 more jobs to that report.

•The biggest gainers were again the highly diverse professional and business services sector (47.000), manufacturing (28,000), retail (27,000), and construction (22,000) sectors. The black workers in these sectors are typically concentrated in non-union, low paying positions. Despite the name, the Professional and Business Services sector is comprised largely of low wage positions. These include waste removal, security, and office support.

•Health care, another highly diverse sector which often pays minority workers much more than others, added just 8,000 net jobs. This continues a trend of a slowdown in the rapid expansion of the health care sector over the last two years.

•The gains in employment are uneven across educational achievement groups, with college graduates approaching the unemployment levels they experienced pre-2008, while those with a high school diploma or less have far higher unemployment than they did pre-reces-



ocratic election judges working alongside their Republican counterparts in each precinct, fle the voice of Texans." and will deploy poll watchers as needed to guard against possible voter suppression or intimidation. Outside the polls, election monitors will answer voters' questions and identify problems such as long lines and voter harassment. The program will also run a voter protection hotline to quickly identify any issues that arise on Election Day, and will have a total of eight command centers, located in Austin, Corpus Christi, Dallas, El Paso, Fort Worth, Houston, McAllen and San Antonio.

"We believe elected officials should represent every single eligible voter," said Jenn Brown, Executive Director of Battleground Texas, "and that every Texan should have a say in who makes our laws. That's why we're going to do all we can to ensure that Texas' elections are free, fair and accessible come election day."

Historically, voter turnout has been low in Texas, and in 2012, nearly half of eligible Texas voters didn't vote. Additionally Texas Republicans, with Greg Abbott at the top of their ticket, have been working to make it more difficult to vote: passing unfair laws meant to prevent voter registration drives, implementing strict voter ID laws that a DC federal court has already struck down as discriminatory, and trying to repeal the Voting Rights Act - a landmark law that protects your right to vote.

"The right to vote is the cornerstone of our democracy, but Republicans continue to scheme against Texas' growing and diverse population," said Texas Democratic Party Chairman Gilberto Hinojosa. "Texas Democrats know your vote is your voice, and the voter protection
