

### **Democratic Party Names** Max R. Tarbox As Nominee For **Texas House District 83**

Texas House District 83 met late Friday afternoon, August 22, 2014, and selected Lubbock attorney, Max R. Tarbox, as their nominee to appear on the November ballot to replace Charles Perry. A formal announcement of his candidacy was made Monday, August 25, 2014, at the Law Offices of Max Tarbox located at 2301 Broadway in Lubbock. Kenny Ketner, the Lubbock County Democratic Chair, said, "We are pleased to announce that Mr. Tarbox will be our candidate in this important race for the Texas legislature. Max comes from deep West Texas roots, and has a distinguished record in business and as a local attorney."

Max Tarbox was born in Lubbock, Texas. His father was the first All American football player for Texas Tech who later went on to become a World War II hero as a pilot with Doolittle's Flying Tigers, and later served as a Member of the Texas House of Representatives from Lubbock in the 1960's.

Mr. Tarbox graduated from Coronado High School in 1966, then attended college and received his degree from the University of Texas where he was a member of the Naval Reserve-Officer Training Corps. After graduating from college, he was commissioned as a Naval Officer and served on a destroyer. Afterwards, he was sent to foreign language training where he became fluent in Vietnamese. He later served a tour of duty in Vietnam as a Lieutenant in the Navy. Following his service in the military, Mr. Tarbox received his law degree from Texas Tech and a Masters in Business Administration from the Thunderbird School of Global Management in Arizona where

The Democratic chairmen for he received a degree in International Finance and was trained to speak Chinese. After working international business he moved home to Lubbock to manage and own Elmer's Weights which manufactured sporting goods in Wolfforth, Texas.

In 1986, he sold the company, and Max has been practicing law since that time specializing in the area of business reorganizations. Max is married to the former Carol Griffin and has two children, James, who is an M.D., and Lizzy, who lives in the Dallas/Fort Worth area. Carol and Max have 4 grandkids.

In accepting the Democratic nomination, Mr. Tarbox said, "I am humbled and pleased by this nomination, and pledge to run a vigorous campaign for the House seat. I have been active in the Lubbock community for many years, and look forward to making sure the needs of West Texas are heard in Austin."

The theme for Tarbox's election is "Invest in Texas." Tarbox announced his priorities for the next legislative session:

a. He will make sure our infrastructure is properly restored, maintained and improved.

b. He will fight to ensure that funds lost from budget cuts in our public school systems are restored and that future funding is increased.

c. He will support the institutions of higher learning in our district to make sure they receive proper treatment, funding and respect by our state legislature.

d. He will participate in efforts by our state government to ensure that our farm and manufactured products find foreign markets.

The election for House District 83 will be held on Tuesday, November 4, 2014.

4. Child's enrollment in Head Start or Even Start.

On August 28, 2014 NFL
Commissioner Roger Goodwell
announced harsher penalties for
NFL players who violate the
Personal Conduct Policy regarding assault, battery, domestic violence, or sexual assault. First





# In Cinque

The conversation that you see on the television, written media, internet, and with individuals that you may not even know, is about the problems in Ferguson, Missouri. Back in 2009, the subject was Oscar Grant who was shot on New Year's Day by an officer in Oakland. That incident spawned the movie "Fruitvale Station' in 2013, the year in which Trayvon Martin's murderer was acquitted for murder and manslaughter. Trayvon was killed in 2012. Now, there is Michael Brown, unarmed, just as Oscar and Trayvon which has brought forth he latest protest about racial injustice. The families of Brown and Martin are expected to join the Brown family today in an effort to quell the

Americans, regardless to their color or kind, have lived with some form of racial injustice since the beginning of this great nation. Ethnic groups have been protesting for ages to gain equality. The Jewish community, the German community, The Polish community, the Black community, the Hispanic community and most recently, the Lesbian Gay Bisexual Transgender community is struggling for equality. History has recorded its moments of protest and victories for all of these groups. The ongoing problem lies in the existence for many years of that "peculiar institution," slavery, which keeps raising its ugly head, one way or like Dallas, Texas, New York the other when it comes to Black equality.

Over the years, even with the liberation of the Black man and the rights he has secured through protest after protest, there is still something about that slave mentality, which makes it a major, major issue when a Black person is killed by a White person, especially if it is a young, unarmed Black male. Black Rage is the result of such actions. Of all the

books that I feel everyone should read is the one written by William H. Grier (Father of comedian David Allen Grier) and Price M. Cobb by that same name, Black Rage. These two Black psychiatrists published this book in 1968, and when I was in the classroom, all of my Sociology students had to read this book. Black Rage gives an in depths look into the nature of Black rage as a result of their studies into the effects that history has had on the American Black man. If you can wrap your head around the essence of this work and internalize it, then we may be able to move forward and examine why Blacks kill

It is wrong for anyone to kill anyone. This is especially true when the victim is unarmed as they have been the case of the several Black youths murdered in the past five years which have garnered national public attention and rightly so, but it seems that no one is keeping track of the young Black males and females that are being killed each year by a Black person, youth or otherwise. There was no national protest when the young girl from Chicago was killed shortly after her return from White House honors. Who is protesting the nine year old killed on the street in Chicago recently? Young Blacks are killed every day in large cities City, Baltimore, Maryland, Los Angeles, California, New Orleans, Louisiana, Chicago, Illinois, Detroit, Michigan and others not mentioned. We talk about saving our youth, but for the most part, talk is what we do. It is time to get 'in cinque' and put into play the necessary tools to cut out the Black on Black crime. Protest that.

### Statement on the school funding lawsuit

Lubbock ISD is one of more than 600 school districts across Texas that entered into the lawsuit against the State of Texas. We joined the Texas Taxpayer and Student Fairness Coalition lawsuit because we believe the school finance system in Texas is inadequate and unconstitutional. We anticipated Judge Dietz would rule in favor of Texas school children, and we are pleased that the Court issued that ruling today, Thursday, August 28, 2014, This case is far from over, with an appeal to the Texas Supreme Court anticipated. We believe the pressure of the lawsuit was a factor in the Legislature restoring some of our funding last session, and we will continue to work with our legislative delegation to create more equity in the school finance system.

### NAACP Legal Defense Fund Challenges Discriminatory Texas Photo ID Law in Trial This Week

New York -- This week, beginning on Tuesday, September 2nd, LDF's political participation team started trial in Corpus Christi, Texas challenging the state's discriminatory voter ID law (SB 14). In 2013, LDF intervened in this lawsuit, United States v. Texas, now consolidated with Veasey v. Perry, to strike Texas's discriminatory photo ID law under Section 2 of the Voting Rights Act and the U.S. Constitution.

Under Texas's photo ID law, concealed handgun licenses are acceptable forms of photo ID to vote in-person, but student IDs are not. Texas's photo ID law is a solution in search of a problem, as a person is more likely to be struck by lightning than to see someone attempt to vote fraudulently at the polls.

What is known, however, is that hundreds of thousands of registered voters in Texas lack the kind of photo ID required by SB 14, a disproportionate number of whom are people of color. Nationally, only 8% of white voting age citizens lack a gov-

ernment-issued photo ID compared to 25% of African-American voting age citizens.

Despite the fact that another federal court in 2012 determined that Texas's photo ID law was the most discriminatory in the country under Section 5 of the Voting Rights Act, Texas immediately implemented that law following the U.S. Supreme Court's devastating decision in Shelby County, Alabama v. Holder, which effectively dismantled Section 5's protections.

Below are more updates about LDF's work to preserve and expand voting rights:

•In a letter to Alabama's Secpressed grave concerns about the State's failure to count at least 286 ballots from the June 3, 2014 election due to Alabama's recently implemented photo ID law. LDF's letter also points out that, while large numbers of ballots in majority-black counties were discarded, election officials are not even applying the law in some majority-white counties.

•LDF filed an amicus brief in

the Arkansas Supreme Court in support of a lawsuit challenging the constitutionality of the state's voter ID law. The brief describes the significant burdens that the law places on thousands of Arkansans without photo ID, such as requiring poor Black people without cars to drive as far as sixty (60) miles round trip or go on bus trips that can take all day to reach voting sites.



Schedler, LDF's successful lawsuit against Louisiana agencies for their failure to comply with their obligations under the Naretary of State, LDF has ex- tional Voter Registration Act (the "Motor Voter Act"). LDF won a federal court decision finding that in contravention of the Act, Louisiana has failed to fulfill its federal obligations to provide voter registration services to individuals receiving public assisleaving countless Louisiana citizens effectively disenfranchised.


they were, were simply bugging me to death.

### Police officer accused of sexually assaulting women on duty

OKLAHOMA CITY (AP) Residents of a neighborhood where an Oklahoma City officer is accused of sexually assaulting women said Saturday, August 23, 2014, the allegations make

them distrust police. Investigators say Daniel Ken Holtzclaw raped one woman and either fondled others or forced them to expose themselves. They say he made others perform sex acts on him.

The women were all black and between the ages of 34 and 58, but it's not clear if race played a role in the alleged crimes. Police documents show that some were picked up off the street, while others were assaulted after being pulled over for traffic stops.

Formal charges against the police officer could come by Friday., August 29th.

"I'm already scared of them anyway," 34-year-old Seantah Graham said of police.

She pushed her 1-year-old daughter across a lightly traveled boulevard in the racially mixed, working-class neighborhood of modest brick homes and

"They've pretty much got power in the palm of their hand. And it's your word against theirs," Graham added.

Another resident, Tammy Bell, 45, said the officer was "taking advantage of his shield"

when he allegedly assaulted the women. Bell said she and others in the neighborhood on the city's northeast side had heard rumors about the alleged crimes weeks before Holtzclaw was arrested.

Police were slow to react, she said.

"They didn't want to think it was the police doing all this. They kind of laid it to the side," Bell said.

The investigation began — and Holtzclaw was immediately placed on leave — when police said a woman complained in June that Holtzclaw had sexually stop on a boulevard about two miles north of the state Capitol. The alleged incident prompted police to check other contacts Holtzclaw had with the public since beginning street patrols about 18 months ago.

Officers identified seven victims and eight incidents before accusing Holtzclaw of crimes including rape, sexual battery and indecent exposure.

### **Beverly Hills Police Mistake Black TV Producer For Bank Robber And Arrest Him**



As countless police officers continue to negatively objectify Black men, the case of prominent Hollywood producer Charles Belk (pictured) is a shining example of how out of control the situation has become. Belk was reportedly leaving an L.A. eatery last Friday, when he was suddenly swarmed by six Beverly Hills police cruisers and the then reportedly handcuffed without explanation for six hours because he allegedly "matched the physical characteristics of the second suspect and was in the area of the bank shortly after the robbery," a police press release stated according to KTLA.

The 51-year-old Harvard grad and award-winning executive claims he was not told why he was arrested, denied a phone call, and barred from speaking to his attorney at length.

Belk, who posted a Facebook picture of himself, handcuffed and sitting on a concrete curb in the hot blazing sun with two White officers standing guard over him, was booked on a \$100,000 bail. He says that the officers treated him contemptibly and only released him when they realized he looked nothing like the accused robber.

The photo of Belk, which has been shared via the social network some 30,000 times, is also accompanied by his written outrage at the way he was targeted:

"I get that the Beverly Hills Police Department didn't know that I was a well-educated American citizen that had received a B.S. in electrical engineering from the University of Southern California, an MBA from Indiana University ... and an executive leadership certificate from Harvard Business School," Belk's statement read. "Hey, I was 'tall,' 'bald,' a 'male' and 'black,' so I fit the description."

"Within an hour, I was transported to the Beverly Hills Po-Headquarters, lice photographed, fingerprinted and put under a \$100,000 bail and

accused of armed bank robbery and accessory to robbery of a Citibank." "What I don't get ... is why, during the 45 minutes that they had me on the curb, handcuffed


in the sun, before they locked me up and took away my civil rights, that they could not simply review the ATM and bank's HD video footage to clearly see that the 'tall, bald-headed, black male' ... did not fit MY description."

What did the Beverly Hills police department have to say about their faux pas?

The department reportedly referred to the Belk incident as "regrettable," according to KTLA, and released the following statement:

"The Beverly Hills Police Department regrets the inconvenience to Mr. Belk, but was under obligation to thoroughly verify that he was not the suspect before releasing him."

There were two alleged robbers involved in the bank heist, Brianna Kloutse, 47, who is suspected in 11 recent bank robberies in the Los Angeles area was placed into custody last Friday. The other robbery suspect whom police mistakenly thought was Belk is still at large.

### Funding an Unfunded Funeral

Unfortunately as a funeral director, I often see families who have lost a loved one without the necessary funds to provide for his or her final expenses. The problem is that there is a dead body and something must be done within a short period of time, to properly accomplish final disposition with kindness, dignity and respect.

What are survivors finding themselves in this very undesirable situation supposed to do for funds? If the funeral home accepts credit cards, the survivor can utilize his or her pre-established credit and then make the necessary payments to the credit card carrier. For some reason, I find that survivors do not like this option. It is possible that most of them think the interest is too high, or they do not carry enough space on their credit cards to be able to afford such a substantial expense.

The funeral funds, however, must be provided before services can be rendered. If the next of kin is unable to raise the necessary funds through his or her own credit, they may choose to ask additional family members and friends to contribute. This can be embarrassing and many survivors do not care for this option either.

Some families are under the misconception that if they refuse or cannot provide the necessary funds, the government will cover their loved one's funeral expenses. While it may be true



lodged by Friday. Holtzclaw had not been previously disciplined in his three years with the department.

Holtzclaw remained at the Oklahoma County Jail on Saturday in lieu of \$5 million bond, according to jail records. No attorney was listed for him.

Holtzclaw joined the police force after graduating with a criminal justice degree from Eastern Michigan University. He was also a standout football player and tried out for the Detroit Lions after he was not taken in the NFL draft. He was cut from the team, though.

Ashfaq Baig, 67, said Holtzclaw used to come into the Checkers Convenience Store where he works looking for a snack or a cold drink but was not a regular customer. The store is located on Oklahoma City's northeast side near the Oklahoma Health Center, a network of hospitals, medical clinics and physicians' offices.

Baig said other customers had told him about rumors that a police officer was abusing residents in the neighborhood. He said Holtzclaw's arrest has eroded people's trust of the police force.

"When you need directions, you go to a police officer. Now, we can't trust anybody," Baig said. "It's very hard."

and the aggressive police response to the demonstrations that followed have sparked a national conversation about race and law enforcement. Now that much of the national media has moved on -- a point that was repeatedly made by speaker after speaker at a rally in a nearby park on Saturday -- activists are working on channeling the anger exposed in the wake of Brown's death into concrete changes to policing tactics in the St. Louis region.

Some of the most recognizable faces from the past three weeks of protests were out on the scene on Saturday, including Brown's family members, Missouri state Sen. Maria Chappelle-Nadal, St. Louis Alderman Antonio French, Ferguson Democratic committeewoman Patricia Bynes and Edward

Jesse Hill, 55, said many women in the neighborhood did not go out at night because of concerns about being assaulted. Hill said she does not think race was a factor in the alleged crimes.

"It's about power now," said Hill, who is black. "When you see a cop, you don't know whether to stop or not. There's no service like there used to be. They don't care."

Holtzclaw was one of four police officers named in a wrongful death lawsuit in January. It was filed by the mother of Cliff Armstrong, an Oklahoma City man who died in police custody.

Armstrong died at a hospital

Armstrong died at a hospital in May 2013 after scuffling with officers. A medical examiner's report said his death was accidental, caused by a methamphetamine overdose, but that the altercation with police may have been a contributing factor.

The case is pending in federal court, but Holtzclaw and the officers were cleared of criminal wrongdoing

Brown's mother, Lesley Mc-Spadden, wore a T-shirt bearing an image of her son that read, "A Bond Never Broken." She was protected by suited-up members of the Nation of Islam as she and Brown's father, Michael Brown Sr., made their way across town. Spread out across the route were tables stacked with shirts with slogans like "I survived the Ferguson riots" and "I am Mike Brown." There were also booths where protesters could register to vote and petitions calling for the indictment of Darren Wilson, the Ferguson police who shot Brown dead on Aug. 9.

The crowd, which numbered over 1,000 people, made its way from the Canfield Green apartment complex, where Brown died, to West Florissant Avenue, the epicenter of the protests and the home of businesses that were looted. Then the protesters marched up Ferguson Avenue, in the direction of the police station. As rain poured down, they headed to Forestwood Park, where a massive tent and a stage on loan from the St. Louis County Parks Department were set up.


The crowd was mostly black, but it included plenty of white demonstrators as well. One of them was Michael Maresco, 50, a Ron Paul supporter from Richmond Heights, Missouri, who was carrying a massive rainbow

Lesley McSpadden, Michael Brown's mother, looks at the spot where her son was killed three weeks ago.


Tea Party flag and said he was there to call for police accountability. Another was Janet Cuenca, a 76-year old retired teacher, who rode a motorized scooter and wore a shirt that read, "I can't believe I'm still protesting this crap."

Police officers kept a light touch as the demonstrators blocked streets, wearing only normal uniforms and driving regular police cars. Heavily-armored, military-style vehicles were nowhere to be seen, nor were officers in riot gear or canisters of tear gas.

"Should be a nice anti-me rally," Ferguson Police Chief Tom Jackson told The Huffington Post. Indeed, speakers on the stage called on both Jackson and Ferguson Mayor James Knowles III to resign their positions.


Anthony Shahid, an older gentleman who has been out in the streets wearing chains during the protests and who marched next to Brown's mother on Saturday, called on the crowd to stop their cars along the highway on Monday as an act of civil disobedience. He said people should stop at 4:30 p.m. for four and a half minutes, meant to represent the four and a half hours Brown's body lay in the street after his death.


