



City Entered Stage 1 Water Restrictions October 1st

The City ended Stage 2 water restrictions and entered Stage 1 on Wednesday, October 1, 2014. The combination of rain events throughout the summer, increases in surface water supplies, and seasonally lower water usage patterns in the coming fall months were major factors in the decision.

The following watering restrictions apply with Stage 1:

·Landscape irrigation is restricted to two (2) days per week. Irrigation schedules will be based on the last digit of the address:

o Monday & Thursday - 3, 4, 9, 0

o Tuesday & Friday - 1, 5,

o Wednesday & Saturday -2, 7, 8

•Irrigation should provide a maximum of 1.5 inches per zone per week.

·Irrigation should occur without significant water runoff, which can be accomplished by correctly cycling the sprinkler system and allowing time for the water to soak into the landscape between irrigation events.

•All City of Lubbock operations will adhere to the water use restrictions.

·Hand watering, soaker hoses, and drip irrigation systems are allowed on a daily basis regardless of the time of the year.

Also from October 1st thru March 31st, restrictions regarding the time of day that watering can occur end. In addition, irrigation may only occur when

temperatures are above 35°F, so

"Oh," she said, not knowing how to answer that.




My comfort rests in the fact that God is closer to me than my cell phone.

Whites (Not Blacks) Represent The Largest Group of People Moving to Low Income Areas -- and Other Little Known Facts



One in four Americans now live in poverty areas, according to the U.S. Census Bureau. The number of people who have been forced to move to poverty areas has greatly increased in the past 14 years. Why?

What's behind the increase in poverty?

The housing crash, loss of jobs and the country's financial crises has left many with no alternative but to move into poverty areas. Many people have lost their homes and now find themselves in a situation where they need to live where they can afford. This often means either moving where housing prices are low, or turning to subsidized housing

and low-rent apartments, which often places them in poverty areas.

Who is being affected?

White Americans make up the largest increase of people moving to poverty areas. The number of whites moving into poverty areas increased from 11.3 percent in 2000 to 20.3 percent in 2012, almost doubling in 12 years. Overall, the number of people moving to poverty areas increased from 49.5 million in 2000 to 77.4 million in 2008-2012. Some areas of the country are worse than others. The percentage of people living in poverty in the state of Mississippi is 48.5 percent, while in

New Hampshire it is 6.8 percent. The downward spiral

The real concern is that many people who have moved into poverty areas will find it tough to get out. Poverty areas offer fewer job opportunities, higher crime, fewer decent schools and fewer health care programs. These will be challenges to those who want to turn things around to get out of poverty.

Although poverty has actually decreased in some areas such as Louisiana, West Virginia, Alaska and Hawaii, it has increased overall and particularly in states such as Arkansas, North Carolina, Oregon, and Tennessee.



you get your students to become so motivated about the song? They seem to really love it!



Did NFL Fine Colin Kaepernick for Using N-Word?



It appears that San Francisco 49ers quarterback Colin Kaepernick may be the first player fined by the NFL for using the N-word on the field.

Kaepernick was fined \$11,025 by the NFL last week for "direct[ing] abuse language toward" an opponent in the fourth quarter of the 49ers Week 2 matchup against the Chicago Bears, but the league did not provide any additional details. FOX Sports NFL Insider Jay Glazer reported that referees have said that Kaepernick directed the N-word at Bears defensive lineman Lamarr Houston.

Kaepernick, without going into any detail about what he was accused of saying, told reporters he planned to appeal the fine and that he had not done or said anything to warrant it.

being penalized for "inappropriate language."

The incident happened after Kaepernick threw the first of two late interceptions that helped spark the Bears' 28-20 come-from-behind victory. As he celebrated Kyle Fuller's interception, Houston jawed with Kaepernick, who shoved the 6'3", 300-pound lineman and appeared to send a response his way.

Houston initially said publicly that he did not hear anything from Kaepernick, focusing instead on his own comment to the quarterback. "I said, 'Nice pass," Houston told the Chicago Tribune.

Glazer's report went public, however, that Kaepernick did indeed use the N-word and curse at him.

"He was just saying inappropriate language," Houston told the Chicago Tribune after the Bears beat the Jets in Week 3 on Monday Night Football-a game in which Houston himself was flagged for using inappropriate language toward an official. Asked if he was insulted, Houston said it was "a cultural thing."

"I don't know," Houston said when asked about Monday night's penalty. "[Umpire Tony Michalek] thought I cussed at him, but all I said was 'Back up' because he was all up on Willie [Young] and I just told him to back up some. I guess he was intimidated by it or whatever." The quick, decisive action by NFL brass to fine Kaepernick counters the league's abysmal handling of the domestic-abuse allegations levied against several

We recently did an interview with Mrs. Pendleton and here's what she had to say:

BlackNews.com: Hi, Mrs. Pendleton! Wow! We were really amazed at what we saw on YouTube. Congratulations for all of your success!

Odori Pendleton: Thank you so much!

BlackNews.com: Can you tell us what is your background? And how did you become an elementary school music teacher?

OP: Both of my parents were educators, and my mom especially taught me that being a teacher surpassed the classroom and went into the community. I went on to earn a degree in Music Education and Performance at Virginia Tech University, and as a college student, I had the opportunity to travel to England, Ireland, South Africa, Jamaica and the Bahamas for different music projects. After graduation, becoming a music teacher was a no-brainer for me.

BlackNews.com: So how did you come up with the idea to create the song "Teach Me How To Study" based on the song "Teach Me How to Dougie"?

OP: It was a team effort. A colleague of mine, Nitasha Clark, who is a student specialist, was using a state program initiative called "I'm Determined" with some of the 5th grade students. The template for that initiative was brought to the school by our principal, Mr. Harnish Brewer, and it consisted of implemented lessons on study skills, goal setting and the integration of a motivational song. Nitasha and the classroom teacher she was working with felt that there needed to be something to help solidify the program for the students. She came across different versions of "Teach Me How To Study" on YouTube, and after getting approval from our school's administration, she mentioned this to me. I shared with her my research, and told her that I would love to participate. Then, my husband (who is a music hobbyist) and I started putting an original version of the "Teach Me How To Study" song together

Today, all of the students in Kindergarten through 5th grade know and love the rap, and they can perform it on demand.

BlackNews.com: How did the parents feel when they heard/saw their children singing the song?

OP: I think the parents were excited to see the school do something so different and relevant. Parents were videotaping our performance with their phones, and smiling from ear to ear. The parents tell me that their children come home rapping "Teach Me How To Study" all the time.

BlackNews.com: What other creative music projects have you done with your students?

OP: Well, myself and other teachers at Occoquan Elementary School often take creative approaches that others are using to a whole new level of creativity. Our goal is always to have the students reap the benefits.

In addition to the rap song for the students, I teamed up with the SOL pep rally team to write another song (but this time for the teachers) that answers to the students' "Teach Me How To Study" song.

So, my husband and I, with the help of two of his friends, wrote "Taught You How to Study" to the tune of "Started From the Bottom" by Drake. We also made a music video that features our principal and all the teachers at my school rapping the song. That video can also be YouTube viewed on (www.youtube.com/watch?v=8 RMXg1qs8LI).





Eric Holder Retires as Attorney General

Washington (CNN) -- Attorney General Eric Holder announced Thursday that he will resign after six years at the helm of the Justice Department.

Holder has agreed to remain in his post until the confirmation of his successor.

"In the months ahead I will leave the Department of Justice," Holder said at the White House, thanking President Barack Obama for the "greatest honor of my professional life."

Obama announces Eric Holder's resignation

Who might replace Eric Holder? Though he's stepping down, Holder said that "he will
