

Monasch sues for damages of \$136,500 and Montgomery sucs' for \$25,000.

According to the petition, the plaintiffs complain of deprivation by defendents, under color of law, of rights, privileges, and immunities secured by the Constitution and laws in

violation of the 5th and 14th Amendments. The plaintiffs seek damages for the loss and deprivation of such rights, the denial of due process and equal protection of the laws.

The petition states that Mayes, acting arbitrarily and capriciously, disregarding organization and personnel administrative responsibilities of SPAG and applicable justification.

The petition continues, plaintiffs followed greivance procedures as advised by Edward Paul, Equal Employment Opportunity officer of SPAG, and requested a hearing before a grievance committee. Thompson allegedly appointed Heck to serve impartially on the grievance committee. The petition states that Heck had a conflict of interest in this capacity. On April 14, Heck denied plaintiffs the right to present evidence in support of their grievances, ruled that the grievance committee would not hear plaintiff's evidence, which included evidence effecting the qualifications of Heck to serve because of conflict



Brother Britt will tell you that it takes a lot of an effort to secure a frequency from the Federal Communications Commission (FCC). They (FCC) just don't give away frequencies baecause you happen to be of ebony pigmentation. You must show justifiable cause for the securing of such a frequency. We know, Britt, has done so!

## CONGRESSWOMAN YVONNE BRAITHWAITE BURKE

When State Department matters arise the Congressional Black Caucus person to contact immediately is Congresswoman Yvonne Braithwaite Burke. Her address is below; and she may

be reached through 302-225-1691, the Caucus office. Mrs. Burke should also be contacted when we need more black federal judges in any area. These are among her many areas of concern. But she has a primary responsibility within the Congressional Black Caucus for these areas

The following is a fuller word picture of Mrs. Burke as the ready and brilliant resource, open and available to serve your needs.

Yvonne Braithwaite Burke was elected to the House of Representatives from the Twenty-eighth (then Thirtyseventh) Congressional District in Los Angeles, California, on November 7, 1972. Mrs. Burke, former Chair of the Congressional Black Caucus, was the first woman to be elected to Congress from California in twenty years, and the first black woman ever elected to the House from her state. She presently serves on the House Appropriations Committee with assignments on subcommittees handling HUD-Independent Agencies, Department of State, Justice, Commerce, The Judiciary and Related Agencies, and the District of Columbia. Mrs. Burke also serves on the Select Committee on Assassinations and as the Chair of the Select Commit ee on the House Beauty Shop.

A native of Los Angeles Mrs. Burke graduated from Manual Arts High School, received a Bachelor of Arts degree in Political Science from the University of California at Los Angeles and Juris Doctor's degree from the University of Southern California School of Law. She holds honorary Doctor of Law degrees from Virginia State College and Atlanta University. Mrs. Burke was admitted to the California

Bar in 1956, soon after she received her law degree. From 1966 until her election to Congress, Mrs. Burke

represented the Sixty-third District in the California State Assembly. She served as Vice-Chairperson of the 1972 Democratic National Convention in Miami Beach In the 1976 Democratic National Convention, Representative Burke served on the Drafting Subcommittee of the Democratic Platform Committee and was very active in drafting the Party's Platform.

Since assuming office, Mrs. Burke has personally introduced over twenty bills and major amendments. The "Burke Amendment" bound federal pipeline funds to the enactment of an affirmative action program. The bill introduced by Mrs. Burke that has stirred the most national interest is the proposed Equal Opportunity for the Displaced Homemakers

Act. Mrs. Burke serves on the Board of Directors of the United Negro College Fund, The American Civil Liberties Union, Americans for Democratic Action, and numerous other organizations.

Mrs. Burke has received many awards for her varied civic and governmental works. She has been selected "Woman of the Year" by the Los Angeles Times and the National Association of Black Manufacturers. Time Magazine selected her as one of America's 200 future leaders. She has also received Achievement Citations and Merit Awards from a variety of organizations.


True, Blacks in west Texas don't prounounce their words like their white brothers and sisters. Blacks get down to their own basic grammer so those in their community can relate to what they are saying. At the same time, the language spoken by Blacks is not foreign to the business community of Lubbock.

Instead of criticising Brother Britt of what he is not doing, let's put our arms around him so this frequency may become a reality. This could be done by starting a letter writing campaign to FCC complaining about the lack of Black radio programming in this part of the country. Without positive input, those persons in Washington, D.C. can't feel the pulse of what we feel is important for us. As you may note, anytime a local white owned radio station files his renewal application to FCC, they always come by the Black community looking for the "so called Black leaders" and say: "We need to interview you about the problems of the community." Why can't we, on our own, write our own letters, and let FCC know that we are unhappy with what is going on down here and request that more consideration be given to the efforts of Brother Britt.

If this is done now, we'd get some fast results. Can yu imagine several thousand letters addressed to the Federal Communications Commission about the importance of this Black owned radio station. After making this appeal to FCC, then we can start a financial drive to raise the proper capital (money) to operate this station for three (3) years, allowing local Black citizens to receive dividends on their hard earned money invested. While awaiting for their money to grow in the area of communications, think of the benefits we (Blacks) would receive for something owned by us.

Think about it! The next time you see Brother William H. Britt, who is a local policeman, patrolling around town, tell him: "Man, I am behind your efforts and will get my letter off to FCC today.

The in results would be great. The Black community would benefit greatly as well as the city of Lubbock and the South Plains of Texas. There's no doubt in our minds, a Black owned radio station is needed here!!!

# **BLACK ASSISTANT** POLICE CHIEF IS A **GOOD IDEA HERE!!!**

It would appear it would make a lot of cotton pickin' sense if the Lubbock Police Department would hire someone from the Black community to be an assistant police chief. When we say, hire someone from the Black community, we are talking about hiring someone who would be qualified to perform a positive job for the department and citizens of the city of Lubbock.

The hiring of someone from the Black community would be a positive move, and it would bring the Black community closer to the duties and goals of the Lubbock Police Department. Citizens of the Black community would become more aware of the problems which would face a policeman, and would breate a positive relationship with the police departmeni.

Since a great percentage of those persons who are arrested by the local police department are Black, it would be of great importance to have someone (Black) high up in the department.

If there was no one local, in the police department's opinion, then let's go outside the community and find someone who would meet the qualifications.

The most important thing to do now is to start an effort to see that Lubbock has someone from the Black community who is in a position to give positive input to the Black perspective.

Therefore, an assistant Black police chief would be the beginning for something great for our city and police department. We think some serious thought should be given about this kind of move here.
