CANNING PLANT RUNNING AT TOP SPEED

2,000 Cans Put Up Last Week; May Be Increased

The canning plant has been running at top speed for the last week and has a full schedule booked for the near future. In fact, there is more to do this week than can be handled, but Mrs. Charlie Williams is anxious for those who desire this service to continue to bring their orders in.

Last week over 2,000 cans of plums, peaches, squash, beans, roasting-ears and hominy were put up.

Yesterday 800 cans were processed. With the large number the first day of the week the total for the entire week should exceed that of last week, Mrs. Williams said.

The regular crew has been cut down and will remain so until after August 1, at which time the full allotment of 10 persons will go back to work.

According to Mrs. Williams, the same crew never works with each other for any length of time, and this continual switching around handicaps the speed for maximum output.

An interesting feature of the plant is that the vegetables are picked in the morning and canned the same day.

THE QUESTION: What do you think of crop conditions.

THE ANSWERS:

JIM HAIL: I went to Estelline yesterday morning, then to Turkey, back to Tampico and then cut across to Oxbow and Lesley. It all looks good. There is a little burning near Newlin, but it's mighty pretty from Estelline to Parnell. The feed around Lesley and in that section needs rain. It's too early to do any predicting, but I'll tell you if we get any rain in about a week and then some more late in August, we'll make more cotton than we have certificates for.

W. M. WALKER: Things are looking good, but in some sections they're needing rain. The Hedley territory hasn't had as much rain as we have around here, but give it a fair chance and Hedley will be going after we've quit. Rain is also needed east of here. Around Newlin, where the rains have been fairly heavy, things are looking fine. I really haven't had a fair look at the crops west of here. It's entirely

County's Planning Board in Session

NEW TAX BILL IS APPROVED BY COMMITTEE

WASHINGTON, July 30.—The House Ways and Means Committee today formally approved the new \$275,000,000 tax bill.

Chairman Doughton, North Carolina, said he hoped to get the measure on the floor tomorrow and "passed by Saturday."

The bill embodies new taxes on inheritances and gifts in addition to those now levied on estates and gifts. It increases taxes on individual incomes, corporation excess profits and graduated levies on corporation net incomes.

\$791,000 Spent On Utility Bill By Gas Company

WASHINGTON, July 30.—Expenditures of the Associated Gas and Electric System opposing the utility holding company bill were estimated today at \$791,000, including a fee of \$25,000 to the law firm of Patrick J. Hurley, secretary of war in the Hoover administration.

The figures were presented to the Senate Lobby Committee from a list of the system's expenditures assembled by company officials and committee investigators.

Charges Oil Unrest To Price Cut Rumor

AUSTIN, July 30.—Ernest O. Thompson, chairman of the Railroad Commission, today charged in a statement to the legislative investigating committee that unrest in the oil industry resulted directly from rumors of price cuts coming out of New York.

He said the state's battle for the right to control its oil resources is "almost won."

CLOTHING IS STRIPPED FROM KIDNAPED GERMAN

KALGAN, Inner Mongolia, July 30.—Dr. Herbert Mueller, German newspaperman, who was kidnaped by bandits three weeks ago, today reached Poachang, northeast of here.

He had been stripped naked.

THE HALL COUNTY PLANNING BOARD, organized last week-end for the purpose of promoting and otherwise assisting projects in the county under the Works Progress Administration, is holding its first meeting here this afternoon.

Chairman S. T. Harrison called the session to order at 2:30 o'clock in the Commissioners Court room.

Although no announcement was made of the progress the board expects to make at its first meeting, it was believed at noon that a definite program will be established.

Representatives to the District 17 meeting at Lubbock tomorrow were expected to be named.

The board is composed of county, precinct and city officials, civic leaders and several business men from each section and city in the county.

FARMERS FACE TIE-UP OF COTTON

Bureau Holds Back Tags After Court Decision

WASHINGTON, July 30.—A federal court decision paralyzing the movement of one-fourth of the nation's cotton crop brought the Texas cotton advisory committee to Washington yesterday to seek relief.

Federal Judge Randolph Bryant of the North Texas district recently enjoined the internal revenue bureau from forcing a Texas cotton ginner to collect the AAA ginner's tax and, as a consequence, the bureau stopped issuing ginning tags. The suit was filed on behalf of the Texas Cotton Ginner's association.

Complete Tieup Feared
Although tags for 25 per cent of Texas' estimated 3,000,000-bale crop have been sent from Washington, delay in issuing the rest will mean, the committee said, "a complete tieup" of Texas cotton after the present stock of tags is exhausted.

Department of Agriculture officials said that since Texas normally produces about one-third of the nation's cotton, at least 25 per cent of that total would be effected by Bryant's decision.

Headed by their chairman, C. H. Day of Plainview, the committee sought conferences with the agriculture and justice departments and the revenue bureau to find some way out of the dilemma but reported no progress at the end of their first day.

Halt Tag Issuance

"We are informed after a conference with officials of the bureau of internal revenue that no additional bale tags, beyond those already issued, would be furnished Texas ginner," the committee said in a statement. "Bale tags covering only about 25 per cent of the prospective Texas crop have been issued."

"This decision by the bureau, growing directly out of the injunction, means that Texas cotton farmers face a complete tieup of their cotton after the present stock is exhausted. Cotton may be ginned after that time but it cannot be transported since it would lack bale tags necessary for such transportation. As a result of the injunction obtained by the Texas Cotton Ginner's association, the Texas farmers will be unable to dispose of most of their cotton until after the supreme court has passed on the validity of the act in question. Most cotton buyers purchased the staple for sale outside the state or for export."

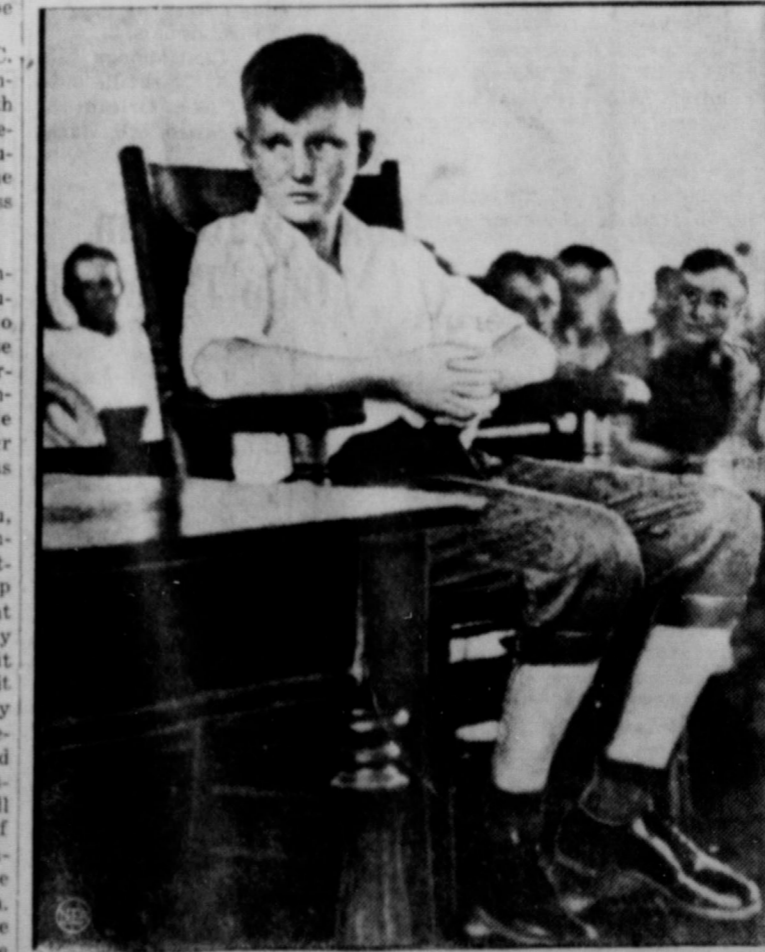
Couple Is Killed in Crash; Child Unhurt

NEW PARK

MEMPHIS has a park that has never been in use, and that probably only a few people here remember, according to F. V. Clark, secretary of the Chamber of Commerce. It is Jeff Davis Park, consisting of one block, on South Fifth Street between Robertson and Cleveland, which belongs to the City of Memphis.

Already there are some trees on this plot, and with some work done here this park site, now idle and useless, could be reclaimed and made into a pleasant and attractive spot for that section of the city, Mr. Clark believes.

Here's another one for the County Planning Board! Progressive towns and cities are having civic property of this kind reclaimed. It could be done at little expense through the aid of the Works Progress Administration.

We believe idle park sites should now be beautified and made to serve the people, as they were originally intended by those who founded them. We should not feel that beautiful parks should be restricted to the so-called exclusive sections of this or any other city. They should be established in the less developed sections of the town, for they probably are needed worse here than elsewhere.

While we're on the subject of beautification, don't you believe that an immediate beautification program at Cyclone Stadium would be a worthy undertaking, also? If we understand it correctly, a section of the land purchased by the school board is planned as a community playground. Trees and flowers and grass over the entire plot, where they would not interfere with baseball diamonds and football fields, certainly would add to the attractiveness of the already outstanding athletic park.

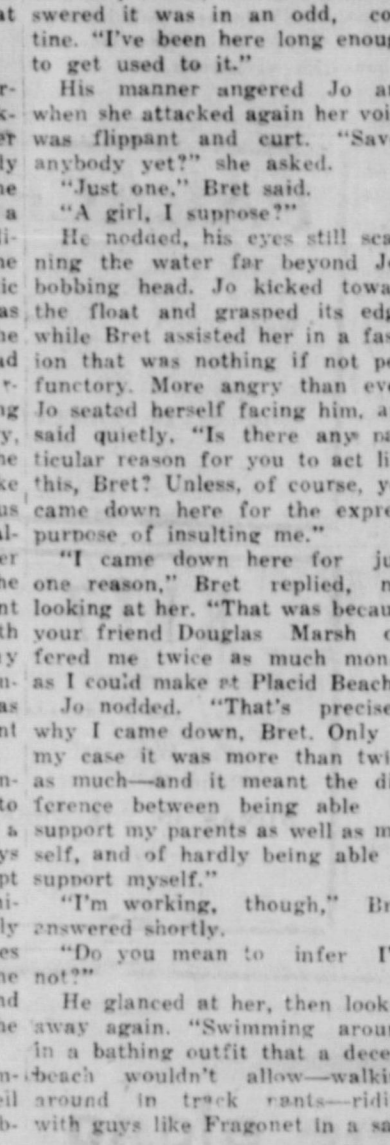

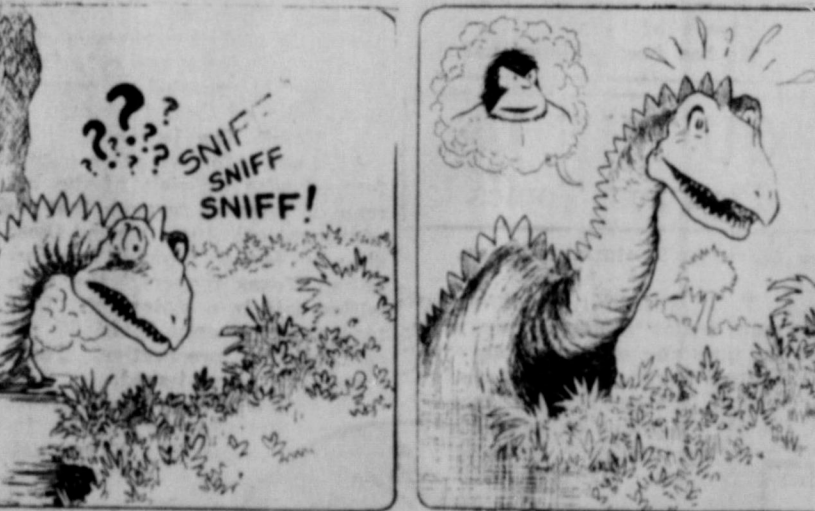
